TOPIC

Changes in Living Arrangement codes for entering in MMIS.

I. Background

Living arrangement (LA) codes are entered on the MMIS/RLVA screen and are used to determine when an enrollee is eligible for payment of a specific claim. The LA codes were recently reviewed to evaluate if all necessary living arrangements were represented by existing codes. This review resulted in an update to the LA codes in MMIS.

II. Introduction

This bulletin will:

- Identify LA codes that will be eliminated beginning September 1, 2006
- Identify new LA codes that will be added beginning September 1, 2006
- Clarify the definition of some specific LA codes
- Provide updated LA Code Charts for use when entering LA codes on MMIS

III. Action Required

A. LA codes being eliminated September 1, 2006

1. Code 47 – RTC/ICF-MR

Regional Treatment Centers (RTC) have not included intermediate care facilities for persons with mental retardation or related conditions (ICF-MR) since November 2002. This code is no longer needed and will not be valid effective September 1, 2006.

- a. DHS will provide a list of enrollees with LA code 47. Verify the actual living arrangement of any enrollee identified on the list and enter the correct LA code on the MMIS/RLVA screen.
- b. After August 31, 2006, a message will appear and the eligibility screen will be locked if LA code "47" remains on RLVA. Verify the correct living arrangement and update RLVA to update eligibility.

2. Codes 65 and 66 – Foster Care

These codes have been removed from the living arrangement list found in the MMIS user manual. Code 80 (Community) is used to designate residence in a foster care setting licensed under Rules 1, 4, 6, and 8.

• No action is required.

B. New LA codes beginning September 1, 2006

1. Codes 70-77 – Juvenile Correctional Facilities

Eight new LA codes (70-77) have been added to specify the placement option for a juvenile residing in a correctional facility.

- a. Contact the facility prior to assigning an LA code to determine the facility type. Some correctional facilities have both secure and non-secure units. Verify in which unit the juvenile resides.
- b. Enter the appropriate code on MMIS/RLVA when a juvenile is identified as residing in a correctional facility.

2. Code 49 - Sexual Offender Program and St. Peter Forensic Unit-IMD

- a. Code 49 has been added to identify LA for persons in:
 - Rule 26 St. Peter Regional Treatment Center (RTC) sex offender beds
 - Rule 26 Minnesota Sex Offender Program (MSOP) in Moose Lake
 - St. Peter RTC Forensic (Security) Unit
- b. Enter the appropriate code on MMIS/RLVA when an enrollee enters one of these facilities.

C. Clarification of LA Code Definitions for codes 51, 54, 61, 68, 69, and 80

No action is required for these codes unless an enrollee has moved to a different living arrangement. The descriptions of these codes have been modified but do not change the LA code for the enrollee. The codes are listed here for clarification only.

1. Code 54 – Rehab Option Facility for Children

Code 54 was previously defined as SED RES TX (Severe Emotional Disturbance Residential Treatment). The new name for this type of facility clarifies the change in status of these facilities. Residents of these facilities are eligible for MHCP coverage.

2. Codes 51 and 61 – Chemical Dependency Facilities

Codes 51 (IMD) and 61 (non-IMD) definitions have been updated to reflect that they are now licensed under Rule 31 instead of Rule 35.

3. Codes 68 (City or County Jail and 69 (Other Correctional Facility)

Correctional Facility Codes 68 and 69 have been updated to clarify that these only apply to Adult Correctional Facilities. Juvenile facilities are now coded 70-77.

4. Code 80 - Community

Code 80 applies to the following living arrangements:

- Private Residence
- Homeless
- Car
- Homeless Shelter
- Hotel/Motel
- Campground
- Medical Hospital <=30 days
- Maternity Shelter
- VA Facility. Veterans receiving care through the Veterans Administration (VA) may qualify for MHCP coverage of medical services not provided by the VA.
- Child Foster Care Rules 1, 4, and 8
- CD Halfway House. This is a chemical dependency halfway house that offers only halfway house services and no other level of chemical dependency treatment.
- Detox-only facilities. Chemical detoxification is the only service offered by these facilities.
- Halfway House, non-CD. Privately operated facility of any size or a stand alone publicly operated community residence with 16 or less beds for persons transitioning from a correctional facility to the community.

Note: when a publicly operated halfway house has more than 16 beds it should be coded 69 (Adult-other Correctional Facility).

• Non-Medicaid Medical/Nursing Facility. Persons residing in these facilities and eligible for a health care program would not have the facility costs paid and would not be on long-term care budgeting.

D. MMIS/RLVA screen

This screen must be coded with the appropriate living arrangement code to ensure that claims are paid correctly for individual enrollees. The new LA codes will be available beginning September 1, 2006.

Update the LA code for enrollees as directed in the specific sections above.
