# Title IV-E Per Diem Rates for Children's Residential Foster Care Facilities and MA Percents for Residential Facilities with Mental Health Certification

#### **TOPIC**

Quarterly list of per diem rates and percentages for the Title IV-E eligible group residential facilities and Rule 4 placing agencies effective April 1, 2006 and list of MA percentages for eligible children's group residential facilities with mental health certification.

### **PURPOSE**

Inform county agencies of per diem and percentage rates to use when claiming Title IV-E federal reimbursement for group residential facilities and Rule 4 agencies per revised lead county contracts. Inform counties of percentages to use when claiming MA federal reimbursement for eligible children's group residential facilities with mental health certification. Provide forms for use in reporting rate changes, lead county contract renewals and facility closings.

#### **BACKGROUND**

For purposes of Title IV-E claims, DHS has published, on a quarterly basis, a list of recognized per diem rates and percentages for specific children's group residential facilities. These figures are used in completing the Title IV-E Foster Care Program Abstract (DHS-2570) according to DHS Bulletin No. 02-32-10 (October 1, 2002). Claims are then submitted through CSIS or through the use of DHS-provided software. In addition, DHS lists children's residential facilities with mental health certification that are eligible to receive MA in order to assist counties in claming federal MA matching funds.

The per diem rates are established when the lead county (host county) establishes or amends the lead-county contract and properly notifies DHS using form DHS-2825.

Percentages in this bulletin are effective for dates of service in federal fiscal year 2006 (October 1, 2005 through September 30, 2006). DHS calculates the percentages using time studies and cost reports from the participating facilities. These percentages represent the portions of the per diem which are federally reimbursable under the requirements of Title IV-E.

### OVERVIEW OF ATTACHMENT A: PER DIEM RATES AND PERCENTAGES

Each page on Attachment A has the same format. All pages contain the same column headings. However, not all of the columns contain data, as each page does not have the same required data elements.

Residential facilities which have been reviewed and approved as Title IV-E eligible facilities appear in this bulletin as:

- Group 1 Children's Group Residential Facilities with Mental Health Certification
- Group 1 Group Residential
- Group 1 All Other Facilities
- Group 2 New Facilities
- Group 2 All Other Facilities
- Group 2 Out-of-State Facilities

Some facilities that have submitted cost reports or participated in the group-facility time study moved from the Group-2 list (which uses median percentages) to the Group-1 list (which uses facility-specific percentages).

### • Group 3 – Correctional Family Foster Homes

Group 3 (formerly known as Rule 1 Group Family Foster Homes licensed by Department of Corrections) is now comprised of the family foster homes licensed by Department of Corrections that were grand-parented in prior to the December 2004 implementation of the foster home portion of the Children's Residential Facilities Rule. These homes have been assigned an automated number for submitting a claim. Claims for these homes must be coded as "FAMILY" for the provider type. These homes are eligible for Title IV-E reimbursement at the basic plus

difficulty of care (DOC) foster care rates, as published in DHS Bulletin No. 05-32-09, (September 1, 2005), *Annual Foster Care Rates for 2006*.

Additional details on the Group 1, 2, and 3 lists are included in the *DHS Updates Requirements* for the Title IV-E Foster Care Abstract and Claiming Process Bulletin No. 02-32-10 (October 1, 2002).

### • Group 4 – Rule 4 Child-Placing Agencies

Group 4 is used to recognize the "administrative" per diems of eligible Rule 4 placing agencies. The Rule 4 placing agencies appearing in Group 4 have chosen to participate in the Placing Agency Time Study (PATS), and therefore a portion of the administrative fee charged to counties for children placed in family foster homes through these Rule 4 agencies is eligible for Title IV-E reimbursement.

Group 1 - Children's Group Residential Facilities with Mental Health Certification are eligible for MA reimbursement as well as Title IV-E. The "Approved MA%" is the percentage of the per diem eligible for MA reimbursement. This data should *not* be entered into the Title IV-E Abstract software. MA claims must be submitted to MMIS. The MA information is published in order to assist counties in claming federal MA matching funds.

### OVERVIEW OF ATTACHMENT B: NOTICE OF PER DIEM RATE CHANGE

Attachment B, known as DHS-2825, is the form required when submitting changes to current facilities and/or programs regarding contracts and per diems. It is also required when requesting Title IV-E eligibility approval for new facilities and/or programs.

### OVERVIEW OF ATTACHMENT C: TITLE IV-E FACILITIES CHECKLIST

Attachment C, known as the Title IV-E Facilities Checklist, must be submitted when requesting Title IV-E eligibility for new facilities and/or programs.

### OVERVIEW OF ATTACHMENT D: FACILITIES LICENSED BY CORRECTIONS

Attachment D was added to this bulletin in response to county requests for more information about facilities licensed by the Department of Corrections. This attachment lists all of the Juvenile Correctional Facilities that are licensed by the Department of Corrections. The facilities are listed alphabetically and include the location and security status of the beds. Please remember that **not all of these facilities are Title IV-E eligible**. If a program from a Correctional Facility is Title IV-E eligible, it will be listed on Attachment A.

### **ACTION REQUIRED**

### • Use Current Per Diem Rates

Title IV-E claims must reflect the per diem rates shown in Attachment A for service dates of April 1 through June 30, 2006. This replaces Attachment A of Bulletin No. 06-32-03 (March 27, 2006) which included the rates effective for service dates of January 1 through March 31, 2006.

### Follow Procedures for All New Facilities

For new facilities and/or programs to become Title IV-E eligible, counties must submit:

- Form DHS-2825 *Notice of Per Diem Rate Change* (Attachment B);
- The Title IV-E Facility Checklist (Attachment C):
- □ A copy of the group facility license; and
- □ Informational material on the facility and the programs that are offered.

For new Rule 4 placing agencies **and/or programs** to become Title IV-E eligible, counties must submit:

- □ Form DHS-2825 *Notice of Per Diem Rate Change* (Attachment B); and
- □ A copy of the Rule 4 license.

The eligibility determination process can take time; therefore, DHS recommends that lead counties submit the required materials within the first 30 days of the calendar quarter.

If all of the requested documentation has been received within the first 30 days of the quarter, determination can be made in that same quarter. Approval or denial notifications, with an explanation for denials, will be sent to the lead county.

In some instances, further research or follow-up may be required to determine eligibility. If this is the case, it may delay the determination process and result in a later effective date.

### • Notify DHS of Per Diem Rate Changes

County agencies must notify DHS of per diem rate changes involving covered group residential facilities and Rule 4 placing agencies. For Title IV-E claiming purposes, DHS will implement changes in per diem rates on the first day of the first full calendar quarter for which the rate is effective.

Lead county human service agencies must notify DHS of per diem rate changes for all facilities appearing on the DHS lists of Group 1 "Participating Group Facilities," Group 2 "New Title IV-E Eligible Facilities," and Group 4 "Title IV-E Eligible Rule 4 Placing Agencies" (Attachment A). Form DHS-2825 is to be used for this purpose (Attachment B).

County human service agencies must submit form DHS-2825 by the thirtieth day of a quarter in order for the new per diem rate to be used in Title IV-E claims for that quarter. Notices received after this deadline will be recognized for Title IV-E claiming purposes as becoming effective on the first day of the quarter following receipt by DHS.

DHS recommends that lead counties negotiate per diem rate changes to be effective on the first day of a quarter and that these changes cover the entire quarter. Counties should then notify DHS using form DHS-2825 within the first 30 days of that quarter. This will maximize federal Title IV-E revenue to all counties. The form DHS-2825 must be signed by the director of the lead county or an official authorized to sign for the director.

EXAMPLE 1: The lead county contract specifies a new rate effective July 1, 2006, and DHS receives the rate change form (DHS-2825) on or before July 30, 2006. The new per diem may be used for Title IV-E claims for service dates of July 1, 2006 and after.

EXAMPLE 2: The lead county contract specifies a new rate effective July 1, 2006, and DHS receives the rate change form (DHS-2825) on July 31, 2006. The new per diem does <u>not</u> become effective for Title IV-E claims until October 1, 2006.

EXAMPLE 3: The lead county contract specifies a new rate effective July 2, 2006, and DHS receives the rate change form on or before July 30, 2006 (perhaps even on July 3). The new per diem does not become effective for Title IV-E claims until October 1, 2006.

### • Notify DHS of Lead County Contract Renewal

Lead county human service agencies must also notify DHS if a new lead county contract has been negotiated--even when the per diem rate has not increased--or if an existing contract is extended. Form DHS-2825 is to be used for this purpose also. The *Notice of Per Diem Rate Change* Form (DHS-2825) has been modified and now contains space to record per diems of Rule 4 placing agencies.

### • Notify DHS of Closed Facilities

A county agency is asked to submit a written notification to DHS when staff knows that a facility or placing agency has closed or is in the process of closing. Please include the date of closure.

#### Procedures for Out-of-State Facilities

To keep accurate records of out-of-state facilities, DHS is asking that the lead county submit form DHS-2825 (Attachment B), along with documentation identifying the facility as Title IV-E approved by its home state and include a copy of the facility's current license(s) and the facility's program description.

To keep the list of out-of-state facilities current, please submit copies of license renewals. If the license expires, the facility will be removed from the list.

### USE CORRECT RULE CODE FOR EACH TYPE OF FACILITY

Each claim must be identified using the correct rule code.

### **Rule codes for Family Type Claims**

### • Rule Code 1 for Family Foster Homes Licensed by DHS

Use rule code 1 for Family Foster Homes licensed under the authority of DHS.

### • Rule Code 4 for Child Placing Agencies

Use rule code 4 for child placing agencies licensed under the authority of DHS with a Rule 4 license.

### • OT1 Code for Family Foster Homes Licensed by Corrections

Use the code **OT1** for approved Family Foster Homes licensed by the Department of Corrections. These Family Foster Homes will appear in Group 3 - Correctional Family Foster Homes (Attachment A).

### • OT2 Code for Indian Family Foster Homes

Use code **OT2** for Indian Family Foster homes licensed or approved by the tribal governments. (When using this code, enter the exact phrase *INDIAN* in the license number field.)

### • OSH Code for Out-of-State Family Foster Homes

Use code **OSH** for Out-of-State family foster homes that have been licensed by the State where the home is located. (Enter the exact phrase *O of S* in the license number field when using this code.)

### **Rule codes for Group Type Claims**

# • Rule Code 5 for Children's Group Residential Facilities with Mental Health Certification

Use rule code 5 for Children's Residential facilities with Mental Health Certification, licensed under the authority of DHS.

### • Rule Code 8 for Group Residential Homes & Shelters

Use rule code 8 for Group Residential homes and shelters, licensed under the authority of DHS.

### • Rule Code 22 for Transitional Living facilities

Use rule code **22** Transitional Living facilities, licensed under the authority of DHS with a Rule 22 license.

• Rule Code 31 for Group Residential facilities with Chemical Dependency Certification
Use rule code 31 for Group Residential facilities with Chemical Dependency Certification, licensed under the authority of DHS with a Rule 31 license.

### • CP Code for Group Facilities Licensed by Corrections

Use the code **CP** for approved Group Residential Facilities licensed by the Department of Corrections with Correctional Program Certification. These Group Facilities will appear in Group 1, "All Other Residential Facilities" (Attachment A).

### • OSF Code for Frequently Used Out-of-State Facilities

The frequently used out-of-state facilities appear in Group 2 of the bulletin (Attachment A). DHS no longer categorizes these facilities as similar to either the former DHS Rule 5 or Rule 8 type facilities. All approved out-of-state facilities now appear on the same page and now have the new ruled code **OSF**.

### • TR Code for American Indian Facilities

Use the code **TR** for all tribal-approved American Indian group residential facilities.

### USE CORRECT LICENSE OR AUTOMATION NUMBER

### • Assigned Automation Numbers

The DHS auditing process requires the use of a license number or a code number equivalent to a license number for each placement type. For this reason, all facilities and group homes coded as Tribal, Corrections, or out-of-state have been assigned a Title IV-E automation number. Corrections have automated numbers that begin with "DC," out-of-state facilities begin with "OSF," and tribal-approved facilities begin with "TR." Please note that the automation numbers for all out-of-state facilities were updated effective October 1, 2005.

Each Rule 4 placing agency has a DHS-assigned provider ID license number. For Rule 4 placing agencies having more than one administrative per diem included in the governing lead county contract, each per diem has been assigned a unique sub-code.

### • Sub Codes

Sub codes have been assigned to facilities that operate multiple programs under the same DHS license number. Correctional facilities are also defined by sub codes when more than one program is operated by the same facility. The sub code is a one-character extension of the license number. Please pay attention to the dates of service for each claim when determining which rule code and sub code to use on the Title IV-E Abstract.
