EXPLANATION OF SUMMARY STATISTICS

Minnesota Statutes, section 252.46, subdivision 8, requires the Department of Human Services (DHS) to periodically calculate and distribute several summary statistics for day training and habilitation (DT &H) payment rates. The statistics can be found in Attachment A.

The summary statistics are computed using DT&H rates that were effective October 1, 2005. The statistics include all private nonprofit and state-operated community services (SOCS) programs. They do not include private, for-profit providers, as these types of vendors are excluded from the statutory rate setting process.

The statistics are based on the per diem rate, which is equal to a program's full day rate plus its transportation rate. The regional and statewide averages are weighted using the calendar year 2004 projected full day and partial day service data supplied to DHS by vendors. For programs new in 2004, annual projected units of service are taken from the program's rate application.

The summary statistics are used to calculate limits for new program rates, and for variances to existing program rates. Each type of rate is explained in the sections below. The statistics (Attachment A) are underlined in the text.

For individual rates by regions see Attachment B. For an alphabetized list of programs and individual site rates, see Attachment C.

RATES FOR NEW PROGRAMS

The maximum rate allowable for a new program is calculated as follows. The vendor must know or calculate how many clients will enter the program during its first year. Every projected client is assigned a rate for averaging purposes. Clients who meet certain criteria are assigned a rate equal to 200 percent of the statewide average per diem. All other clients that have not been shown by the vendor to meet the criteria above are assigned a rate equal to 95 percent of 125 percent of the statewide median per diem OR 95 percent of 125 percent of their regional average per diem, whichever is higher. This means that to qualify for the 200 percent rate, clients must be identified in advance of requesting a rate for the new program.

After each client is assigned a rate, the rates are averaged. (For example, if a new program has five clients that meet the 200 percent criteria and ten other unidentified clients, the average would be calculated by multiplying five times the 200 percent rate and ten times the 95 percent of 125 percent rate and adding the two products together, then dividing by the total number of clients, 15).

This average is the maximum rate DHS may approve for the new program. However, the program is not guaranteed the maximum rate. DHS may only approve a rate based on the vendor's budget which is submitted with the rate application. See Bulletin # 01-56-28 (Attachment D) for a copy of the new program rate application.

RATE VARIANCES FOR EXISTING PROGRAMS

The maximum allowable rate variance for an existing program is based on the current rate and the list of allowable expenses the vendor submits with the rate variance application. The vendor's total allowable expenses, (minus the program's reserves in some cases), are divided by the program's annual units of services adjusted for utilization factor. This quotient is the maximum allowable adjustment to the program's per diem rate, provided the adjusted rate falls below 95 percent of 125 percent of the statewide median per diem OR 95 percent of 125 percent of their regional average per diem, whichever is higher. See Bulletin # 01-56-28 (Attachment E) for a copy of the rate variance request application or contact Deb Schauffert for an Excel format.

Upon the vendor's request, the county in which the licensed service is located may submit a rate variance request to DHS. A needs determination must be completed with the rate variance request which lists the criteria, set in law, for the rate variance. See Bulletin # 04-56-06, Attachment A. Both the rate variance and needs determination forms need county signature before the DHS can act on the request.

These summary statistics use rates effective 10/1/2005.

Per Diem is the full day rate plus the transportation rate. For those programs that do not operate full days, the per diem is the part day rate plus the transportation rate.

Minnesota Statutes, section 252.46, limits the per diem rate counties can recommend for new programs and for the rate variances within existing programs.

Regional and statewide averages were weighted using actual full and partial day units of service data supplied to DHS by vendors. Partial day rates were counted as 3/4 of a full day, so the number of partial day units reported by a program was multiplied by .75 and the result was added to the number of full day units to obtain total service units. For new programs, total service units were estimated to be the Annual Service Days multiplied by the Total Cap.

The averages include all private non-profit and state-operated community-based (SOCS) programs. They do not include private for profit as these types of vendors are excluded from the statutory rate-setting process.
