BACKGROUND

The suggested schedule is based on the estimated 2008 state median income for a family of four published in the *Federal Register*, March 28, 2007, Volume 72, Number 59, pp. 14579-14581. Adopting this schedule does not prohibit a county from using other fee schedules based on ability to pay for specified social services or programs, establishing property limitations or limiting the liability of third party contributors.

The suggested schedule is not to be used to establish income eligibility or fees for those social services with provisions specified in law or rule such as the Consolidated Chemical Dependency Treatment Fund; clients of the Child Care Assistance Program; the cost of services for certain children who are in 24-hour care outside the home, or who are determined eligible for Medical Assistance without consideration of parental income or assets; and children from birth through age 2 who receive case management services at no cost to the parents.

Prior to the Children and Community Services Act (CCSA) of 2003, county social services agencies submitted their biennial Community Social Services Act plans, including social service fee schedules and policies, for approval by the commissioner. County biennial CCSA plans are submitted for the commissioner's approval, but no longer include fee schedules and policies for review. County agencies have discretion on their fee policies within the law.
