## Cost of Care Rates as of July 1, 2007

## BACKGROUND

DHS calculates interim charges on a per diem basis for each fiscal year (July 1 thru June 30) by dividing the sum of all anticipated costs by the projected patient days. Rates are an average of all services provided by each program.

Effective July 1, 2007 the charges for care are as follows:
