## MARKET APPROACH

### Comparable Sales:

- 1. 671 No. Western. Sold Jan. 23, 1961, \$4,000 cash. Comparable appearance and lot size. Subject is larger but does not have garage. Superior location.
- 2. 9 Douglas St. Sold June 13, 1961, \$3,000 cash. Smaller lot and space heater, but comparable size, appearance and location.
- 3. 886 Armstrong. Sold Aug. 26, 1959, \$5,500, terms. Same size but poorer condition, part basement and stove heat. Considerably better location and had garage.

Mention should also be made of 51 E. Indiana, listed for \$5,500 in 1960 but not sold. Larger house, smaller lot.

64 W. Indiana, 5 room semi-bungalow just listed for \$4,000. Half bath and stove heat, smaller lot. Not likely to be sold for listed price.

#### SUMMARY

After adjustments on these comparables and others investigated, it is felt the indicated Market Value of subject property is \$4.750.00.
