## SPACE NEEDS

City staff has been working recently to identify numerous options involving remodeling and new construction that would achieve the space needs to adequately house the wide variety of municipal functions. This review has been based on an analysis of needs in terms of usable area, location, operational layout, and cost. The following descriptions cover the options considered, and the attached chart lists the comparative work areas and costs:

### Option 1

- Construction of 6,000 square feet on the south side of the existing City Hall. Such an expansion of the south wing would house all administrative operations including Park and Recreation and the Manager's Office.
- Police functions would spread out into some of the vacated space including the existing Park & Recreation Offices as well as the lower level Community Room. Police would then operate on two floors with administration upstairs and patrol (including dispatch, booking and detention) on the lower level.
- The current Council Chambers would be enlarged into the space vacated by the Manager's Office. The larger chambers could then be designed as a more multi-purpose space.
- A community center would be constructed on the property adjacent to the municipal pool to meet the recreation and senior space needs.

While this option provides a centralized location and maximizes use of existing space, there is concern regarding over-utilization and squeezing too much on a single site of limited size. The City Hall complex is already plagued with periodic parking problems which would increase due to the fact that the administrative expansion would require removal of a site access and Fire Department parking.

### Option 2

- The Police Department would relocate in the South Fire Station with construction of a second floor across the vehicle bay area. Again, the department would operate on two floors.
- A new fire station would be constructed further south on a more centrally located site.

#### Option 2 Cont'd

- Existing City Hall would be remodeled to accommodate the administrative offices.
- A community center would be constructed near the existing municipal pool.

A central question in this scenario involves the degree of benefit derived by a fire station located further south.

#### Option 3

- Construction of a community center and police complex on the site adjacent to the existing municipal pool.
- Remodeling City Hall for use by the Administrative Departments. Fire Department Offices would be relocated to this building for sharing of administrative services and reduce the remodeling needed at the South Fire Station as programmed in the 5-Year CIP.

#### Option 3A

- Construction of a community center and City Hall complex on the municipal pool site.
- Remodeling existing City Hall for Police Department use. Fire Department could also be relocated in this building to form a Public Safety complex.

Both Options 3 and 3A meet the ultimate space needs of all City departments as presently outlined. Questions instead revolve around whether City Hall or Police is more compatible with the community center and which can make better use of the existing building.

#### Option 4

Involved reuse of Fair School for Community Center and Police functions jointly with the City of Robbinsdale. This option has not been pursued due to Robbinsdale's reluctance and cost factors associated with remodeling of the building.

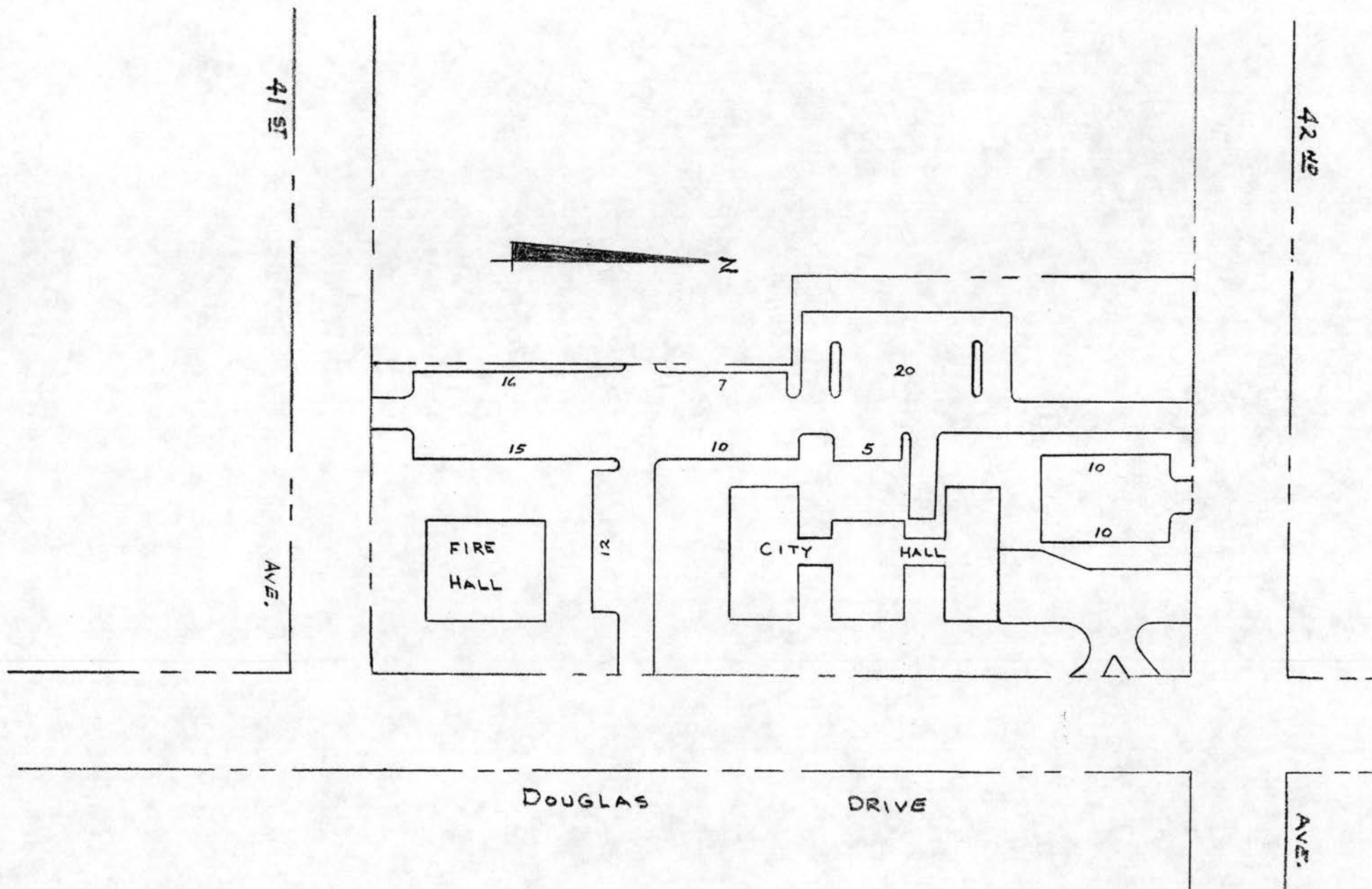

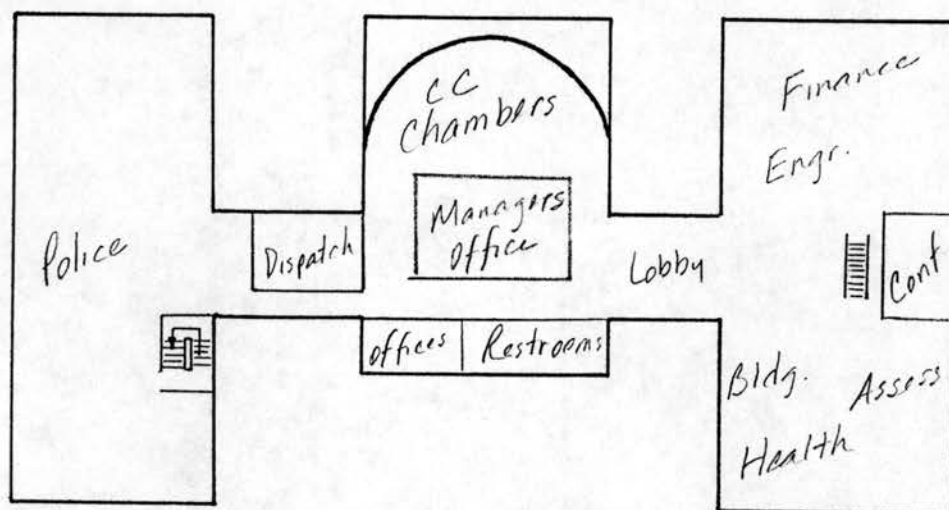

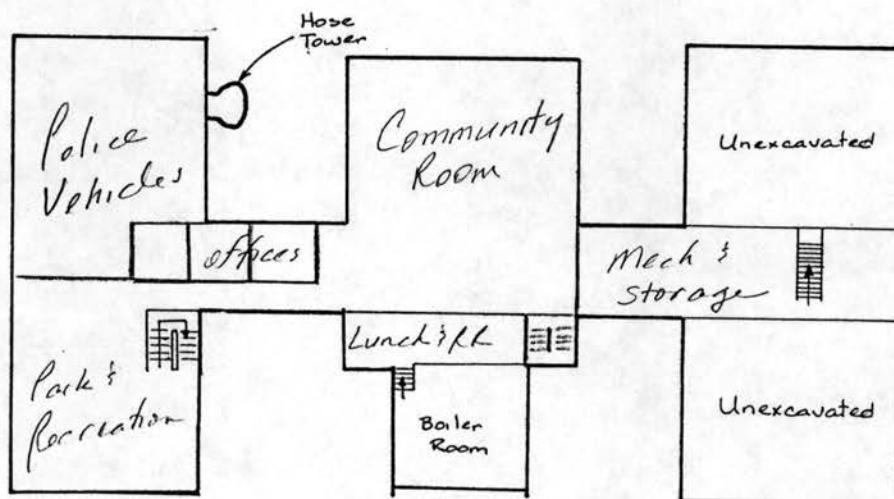

RE: Pros/Cons of Park & Recreation Office at the new Community Center.  
Examination of Proposed Gymnasium Space.

OFFICE LOCATED AT COMMUNITY CENTER:

PROS

1. Close to the major operations of pool and community center - majority of Department programs will be on-site.
2. Professional staff can better supervise the on-site activities.
3. May eliminate the need for additional staff both clerical and professional.
4. Center will be the community focal point and the ID for the Department.
5. All professional staff located under one roof.
6. Professional staff will be in heavy contact with program participants and thus more in-tune with community needs.
7. High visibility for staff for communication with part-time instructors and participants.

CONS

1. Duplicate purchase of some major equipment (copy machine, mail machine).
2. Money for deposit must be delivered to City Hall daily.
3. Added expense for LOGIS hook-ups.
4. New construction is more expensive than remodeling construction costs.
5. Decentralized Department head - not close to City Manager and other city departments for daily contact.
6. Residents would have to make 2 trips: could not register for a class and pay water bill at same time.

The proposed 8000 square foot gym should adequately meet the community needs now and into the future providing the community center is not combined with another community and that the building constructed so that additional gymnasium spaces could be added if the need arises.

While generally I think it is a bad policy to approve most variances, I believe there is justification in this case and that actually approving this or continuing this variance puts the sign closer into being in compliance than it is at its present time.

- Item 4: Consideration of a request to permit 24 hour parking on Florida Avenue between 27th and 29th Avenues from the McKenna Management Company.

I would concur with the Public Works Director's recommendation on this application. I think that if you start granting these you'll just be opening the flood gates and I think that there are probably literally hundreds of people around town that could think of many good reasons why they should be allowed to park on the streets. It seems, however, that when you stick with the ordinance and tell them that they can't they all find places to get off of the street.

- Item 5: Consideration of City of Crystal Insurance Renewal.

Attached please find a memo from Nancy Deno. I concur with Nancy's recommendation relative to the renewal of the insurance including workers' comp. I think taking a little bit of a gamble to possibly receive a much lower premium is well worth it, particularly when there is a cap on the top as to how much we could lose and we do have the money budgeted. I also would like to mention that we did take a look at going to a higher deductible for other coverage. However, upon reviewing it, we didn't think that the reduced premium was sufficient to justify taking the chance of having to pay the full deductible and doing all the administration that we would have to do. We will look at that further in future years.

- Item 6: Consideration of establishing no parking zones on 32nd Avenue, west of Douglas Drive.

Attached please find a memo from the Public Works Director, Bill Monk, relative to this. I concur with Bill's recommendation on this item. In fact, I would recommend that if we continue to have complaints and problems in the area, we would mark the whole area "no parking" and then make the business operate on its own property.

- Item 7: Consideration of the installation of stop signs at the following locations: Cloverdale at Hampshire, Jersey at 46th, Quail at 54th, Adair at 34th, 46th Place at Jersey, and Scott at 53rd.

I've reviewed the recommendation with the Public Works Director. He indicates that all the stop signs being recommended are being recommended because of obstruction to view or other hazards



which make the signs necessary. They have not been partitioned for and he has indicated that he is trying to establish new policy whereby stop signs that he feels are needed for safety or other reasons could be installed strictly with his recommendation. Those which he feels are not needed because of visibility and problems, etc., he'll ask that petitions be submitted on them and the Council make the decision on those. I would concur with Bill's recommendation on these signs. I recommend that Council approve.

- Item 8: Consideration of establishing a backflow valve reimbursement program in areas impacted by high sewer flows.

I concur with the Public Works Director's recommendation on this. There is a potential for up to \$25,000 in costs to the City but from my experience in St. Anthony and neighboring city of Columbia Heights, when we had some severe flooding problems from rainstorms back a few years ago not many people really took advantage of the programs.

- Item 9: Consideration of Feasibility Study for the 1988 Seal Coating Program and scheduling Public Hearing for May 3, 1988.

Again I have reviewed this with the Public Works Director and he indicates that recommendation is pretty much standard procedure except for the paragraph relative to assessment. I frankly concur with Bill on his recommendation relative to assessment. I am not sure in many cases whether you are located on a corner or how big your lot is has anything to do with how much you use the street. Some modification of our present policy could be justified, I feel. Action recommended: approval and scheduling of public hearing.

- Item 10: Consideration of increasing fees for overnight incarcerations.

Attached please find a memo from the Police Chief relative to this. I concur with the Police Chief's recommendation relative to increasing the cost. I think it would be very interesting to find out what this does to the number of incarcerations we get from other cities. If it has any affect on lowering that it might make some difference when we look at jail needs with the space study program.

Item 11: Consideration of a temporary Sunday On-Sale Liquor License for an event at the Elks Lodge #44 for April 10th.

We don't have the application yet. We expect to have it in time for the meeting but it appears that as long as the Council approves we can grant licenses like this. The City Attorney is reviewing the whole process right now and might want to recommend some steps that we should take or an ordinance. We'll be prepared to discuss that at the meeting.

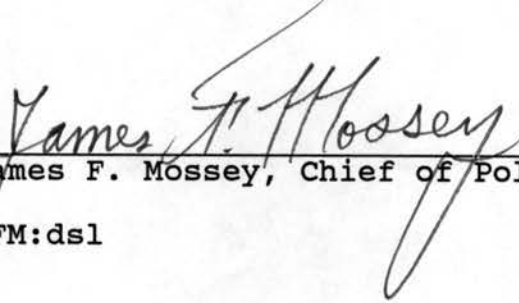

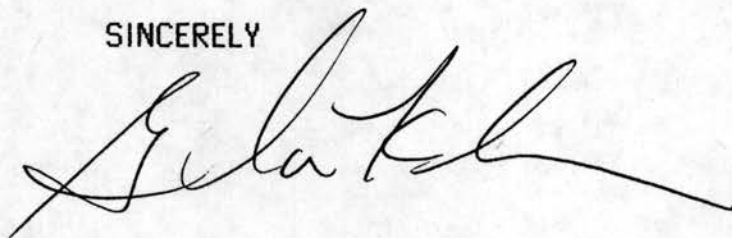

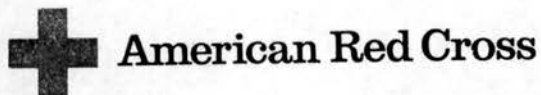

Consideration of this rezoning request was continued by the Council on February 16 (see attached memo) with notifications sent to area residents at that time. The original staff report is attached and includes a brief recap of the Planning Commission action (1/14/88 update) for Council review.

Also attached is a letter from MnDOT concerning their right-of-way needs for the upcoming TH 100 improvement project. Based on the Highway Department's preliminary findings, a forty (40) foot wide R/W strip will be needed to facilitate the current highway design that includes six (6) thru lanes as well as frontage roads.

Should the noted R/W needs remain unchanged as preliminary highway design is completed, the site in question at 3401 Vera Cruz would have to be acquired by MnDOT. While this situation has a tremendous impact on the site, the question involving the long term land use of the western half of the property remains unchanged if only in terms of future reuse of the site.

The issue of site improvements is also impacted by the State's R/W plans. If the rezoning is approved, the City would have to modify the attached agreement to delay installation of the improvements until after the R/W issue is resolved.

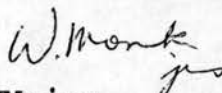

The property at 3401 Vera Cruz is occupied by a 10,000 square foot commercial building with limited parking and in need of site improvements. At present the east 150 feet of the parcel is zoned B-4, Community Commercial, while the west 96.75 feet is zoned R-1, Single Family Residential.

The owner proposes to rezone the west 96.75 feet from R-1 to B-4 so the long standing business use will conform with the underlying zoning. This application is a resubmittal of the one reviewed by the Planning Commission in November except that the owner has agreed to perform the standard site improvements outlined in the attached agreement. This rezoning request does not involve the single family residential property located at 3402 Welcome Ave. N.

Approval of this rezoning application will perpetuate the residential/commercial proximity, traffic and parking issues associated with the oversized building located on this site. However, the rezoning is a land use question and this office has trouble visualizing a residential use on the west end of this property even if the parcel were vacant given the closeness of the highway and the commercial/industrial uses across the street.

Permitted commercial uses with a B-4 zoning district are listed in Section 515.37, Subd. 2, of City Code.

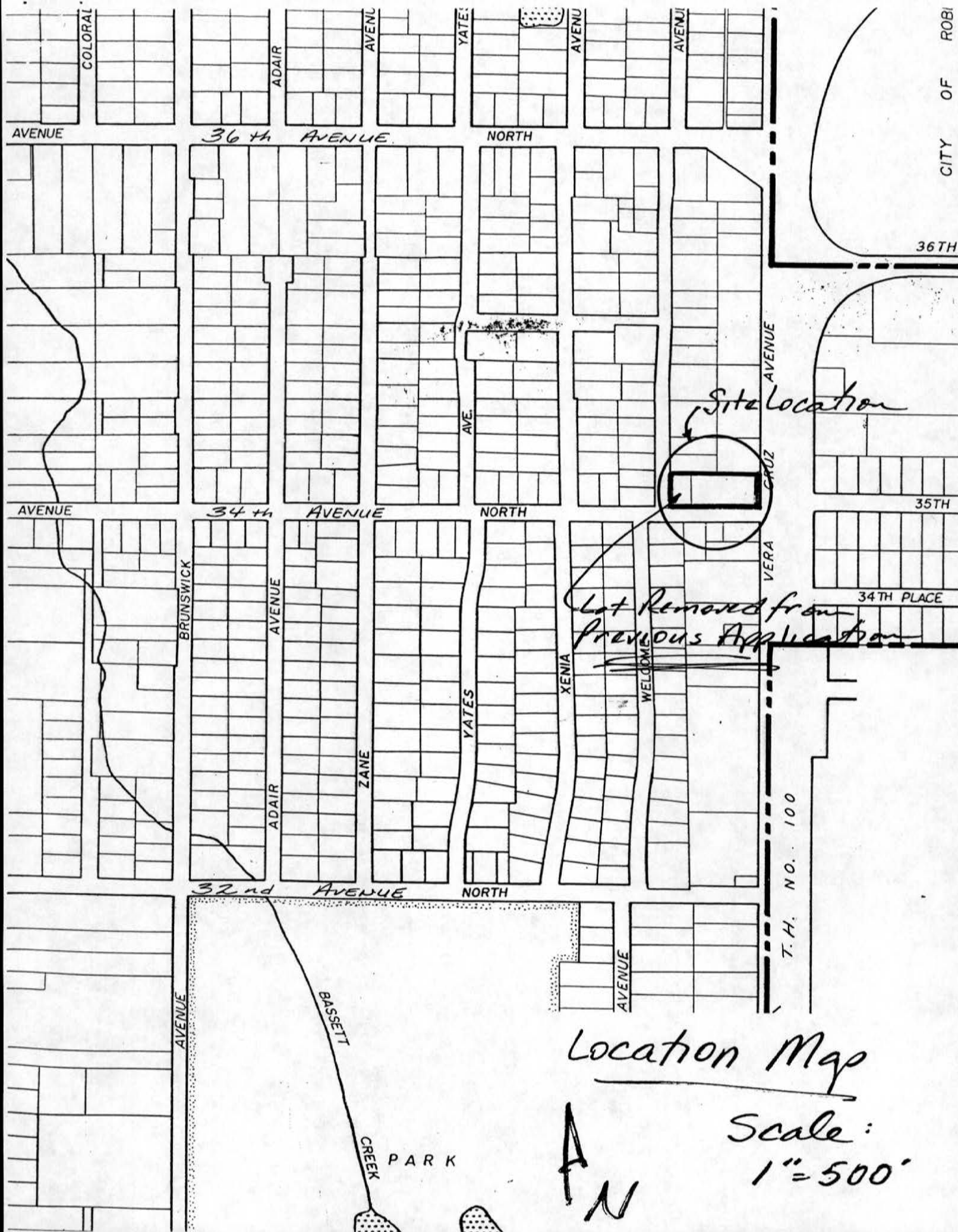
In reconsidering this rezoning proposal, a motion was forwarded by the Planning Commission to approve the request with findings that the rezoning will not significantly change the current parking and usage situation, the land to be rezoned is not suitable for residential purposes and the site improvements will substantially improve the property. This motion failed on a 4 to 4 vote and no further action was taken.

Re: Rezoning of Property at 3401 Vera Cruz  
Page 2

This rezoning request is the same one denied by the Council on December 1. The situation has been complicated since that time, however, by the State's announcement that TH 100 will be reconstructed between 29th and 39th Avenues. The impact of those improvements is still unclear as relates to property abutting the frontage roads on both sides of the highway.

The State's improvement plans will undoubtedly have some impact on the land use issue involved with this property. However, this office believes the issue of site improvements figures more prominently in terms of whether MnDOT will need to acquire additional right-of-way in this area. It would be senseless to require site improvements costing \$20,000 only to have the State propose major reconstruction within the next few years.

For that reason, this office recommends this item be continued until the council meeting of February 16; so a formal response can be solicited from MnDOT concerning the impact of their project on this site. Even though preliminary design has just been started, some indication of the projected impact by the State should be possible. This information can then be taken into account as the Council considers this item in February.

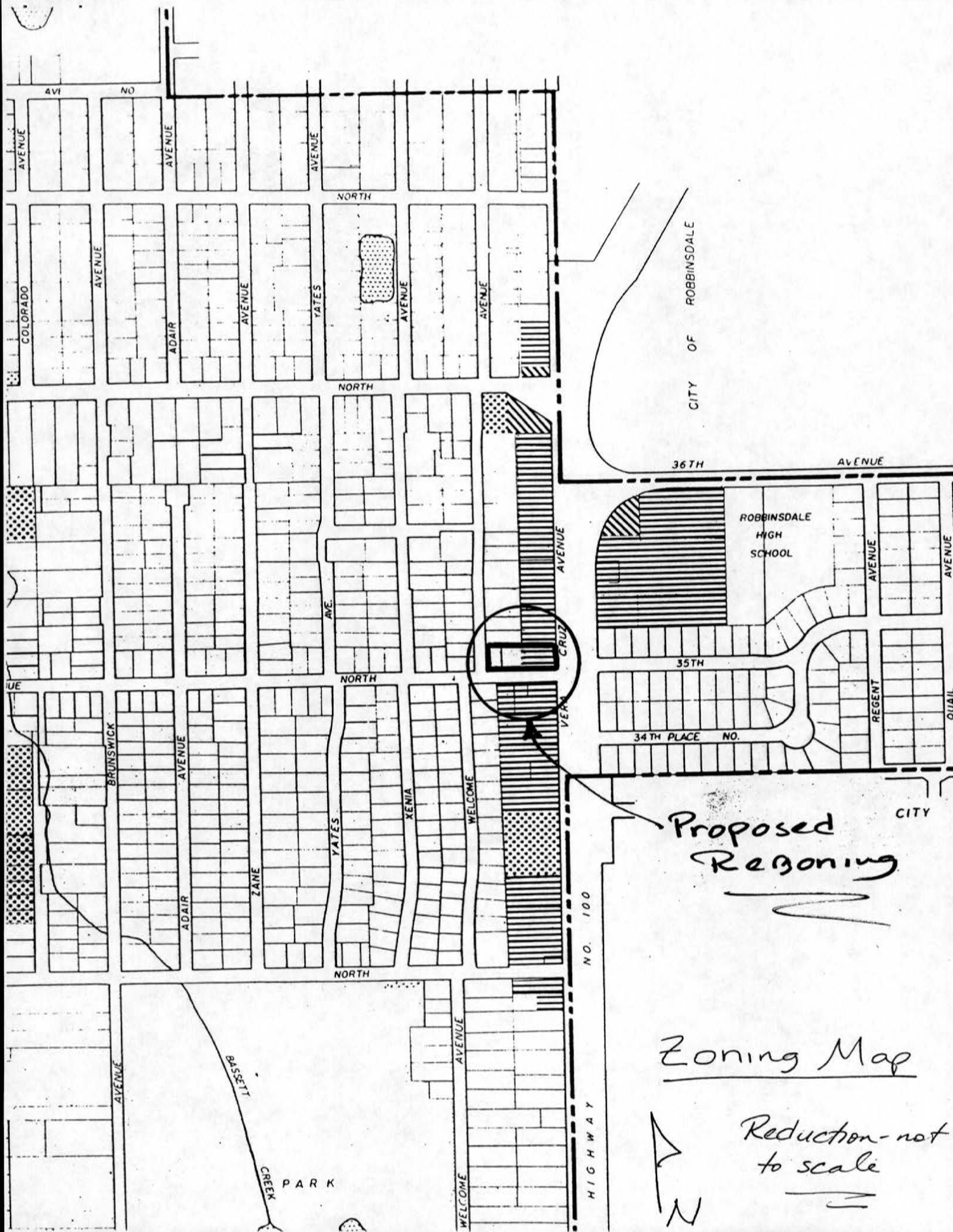

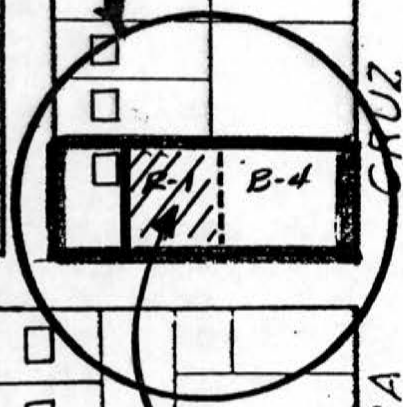

A G R E E M E N T

THIS AGREEMENT made by and between the City of Crystal, a municipal corporation in the State of Minnesota, hereinafter called the City, the first party, and \_\_\_\_\_, hereinafter called the second party,

WHEREAS, second party has requested that the City Council rezone that part of Lot 12 lying east of the west 80', Block 1, Rosedale Acres.

WHEREAS, as a prerequisite to the approval of said rezoning, the City Council requires the construction of certain improvements for the orderly development of the property at 3401 Vera Cruz Ave.

NOW THEREFORE, in consideration of the granting of said rezoning, said second party agrees and covenants as follows:

- Prepare and record plat of property.
- Construct B618 concrete curb & gutter adjacent to site and repair street.
- Construct concrete driveway apron across boulevard.
- Construct 3 curb openings at driveway and repair street adjacent.
- Close 3 driveway openings in curb and repair street adjacent.
- Construct V6 (minimum section) cast-in-place concrete barrier curb.
- Construct 1-1/2" bituminous overlay on parking area.
- Stripe parking stalls with white paint.
- Erect handicap parking stall sign.
- Construct storm sewer and appurtenances to collect and dispose of all surface water on the site.
- Prepare and submit "as built" utility plans.
- Designate and sign fire lanes.
- Note how area lighting if proposed will conform to Section 515.07, Subd. 10, of the Crystal City Code.
- Landscape all open and disturbed areas.
- Provide all lot irons in place and to grade at the time of final acceptance.

That the second party warrants and guarantees all work done under the agreement against any defect in workmanship, materials, or otherwise that may occur within one year from the date of final acceptance by the City of all said work and other requirements.

That construction work be completed not later than one year from issuance of rezoning.

To hold the City harmless from any and all claims which may arise from third parties for any loss or damage sustained resulting from pursuance of the above-described work.

That all just claims incurred in the completion of aforementioned work requirements shall be paid in full by said

second party to all persons doing work or furnishing skill, tools, machinery, services, materials, equipment, supplies or insurance.

All work pursuant hereto shall be in compliance with existing laws, ordinances, pertinent regulations, standards, specifications of the City of Crystal, and subject to approval of the City Engineer.

In the event that said second party has not completed any or all of the aforementioned work and requirements on the completion date as set forth herein, then in that event said second party shall be considered in default. Should said second party be in default, then said second party authorizes said City, its officers, its employees or its authorized agents to enter upon said second party's property and to complete any or all such uncompleted or improperly performed work or other requirements in conformity with this agreement.

As noted in the attached letters, the City has been requested to consider 24-hour on-street parking on Florida adjacent to the Douglas Court Apartments between 27th and 29th Avenues. Such parking is currently prohibited 3 to 6 a.m. by City ordinance.

In considering this request, I believe it is important to review the original justifications for establishing the early morning parking restrictions which are clearly outlined in a memo from Bill Sherburne written to the Council in December of 1983:

The prohibition of overnight parking on all City streets has many advantages. The hours of overnight prohibition are relatively immaterial be they from 2 a.m. to 6 a.m. or 3 a.m. to 6 a.m., or any combination; the main impact is to change parking habits by causing drivers to locate alternate acceptable parking spots.

The elimination of overnight parking will leave the streets open for casual and visitor parking, while eliminating the cumulative problems of "permanent" parking.

A ban on overnight parking readily pinpoints abandoned and stolen vehicles; identifies and eliminates "junkers" on the street; reduces accidents (studies show 10% of all accidents involve a parked vehicle, usually hit & run); improve snowplowing efficiency by enabling a better job to be done in less time at reduced cost; improves street sweeping operations and general cleanliness; minimizes oil dripping on pavement, which is a bane to pavement strength and maintenance; provides a safer street environment by allowing more open traffic movement, fewer shadows, and better street light distribution.

An overnight parking ban will facilitate City operations while allowing daytime parking. Robbinsdale, New Hope, Golden Valley and Brooklyn Center currently prohibit overnight parking.

In approving and enforcing this parking ordinance the Council has been made aware of numerous instances whereby residents have experienced inconvenience or hardship. However, the Council has always upheld the ordinance citing the general City benefit and the problems with enforcement if a selected site approach is enacted. This office recommends the City continue its support of the on-street parking restrictions as currently in effect.

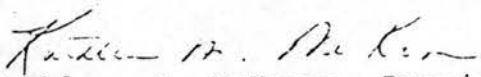

The items listed below are in response to your letter of October 26 regarding parking and street lighting adjacent to the Douglas Court Apartments:

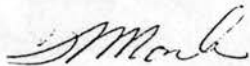
- The City of Crystal operates the street light system in conformance with an approved layout plan. The plan does denote a light at the corner of 27th and Florida Avenues as well as a mid-block fixture on Florida Avenue between 27th and 29th Avenues. Based on your request these lights will be installed as arrangements can be finalized with NSP. The City would interpret a request for any additional lighting as the obligation of property owners to be contracted on a private basis.
- In terms of 24-hour parking on Florida Avenue, the City spent considerable time and effort in formulating its current ordinance which does not allow on-street parking between 3 to 6 a.m. Such a parking policy allows for safer use of the streets by vehicular traffic and improved maintenance operations in terms of snow removal. Crystal believes the street section can and should be used in providing for short term parking in both residential and commercial districts but not as a long term parking alternative.

During my tenure with the City, the lighting and parking policies stated above have not been modified by the Council. A recommendation to modify those policies would not be made by this office in this situation. Should you wish to pursue

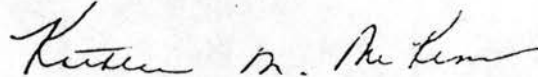

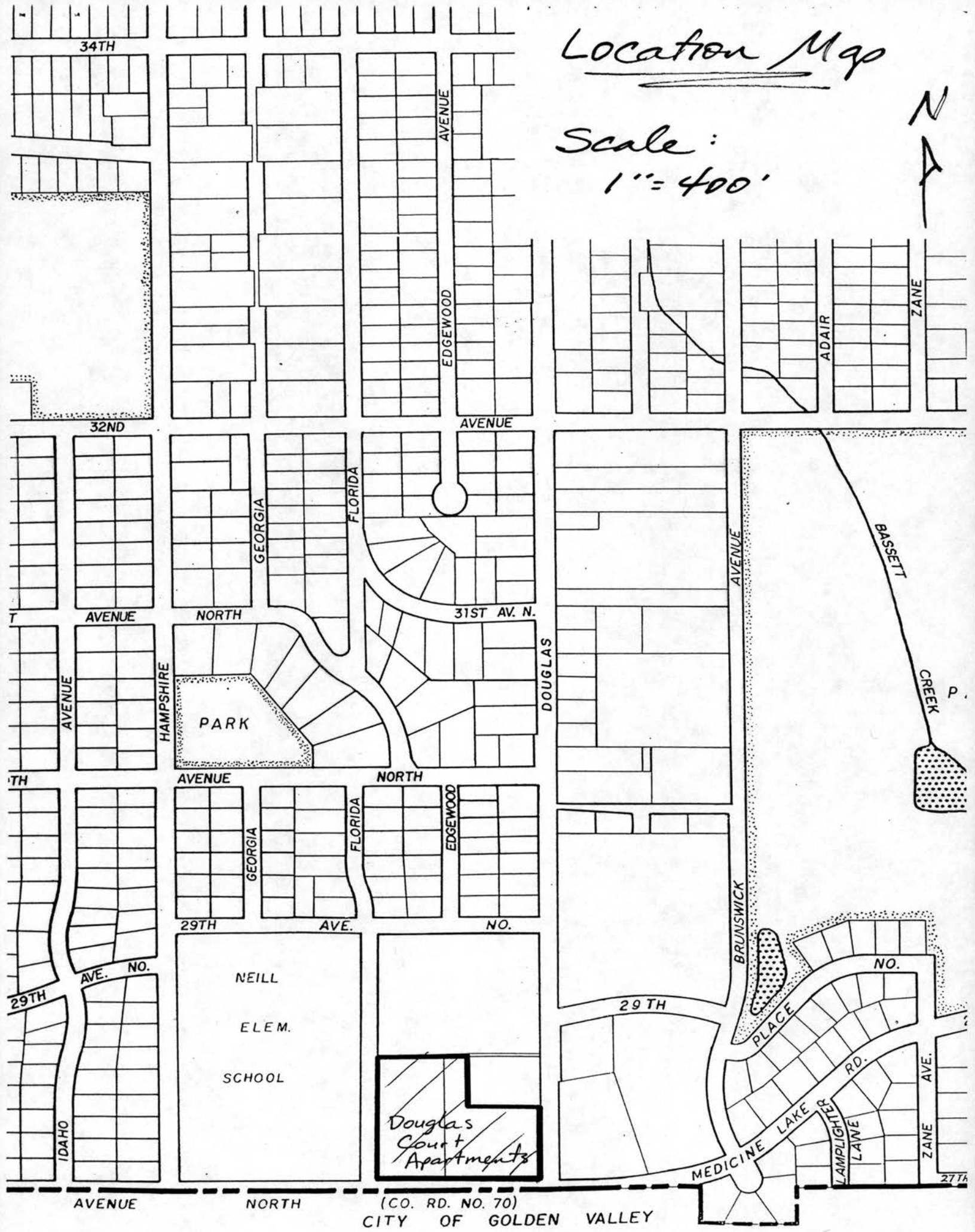

Attached is a summary of costs for insurance renewal for the City of Crystal 1988-1989 policy year. I have been working with our agent, Cary Shaich, the Towle Agency, and have obtained proposals for renewal through our current carrier, League of Minnesota Insurance Trust Program. Insurance renewal figures are for property, general liability, bonds, public officials (errors and omissions), automobile, boiler and workers' compensation coverages. Also for your review, I have attached a summary of past years' premiums paid, workers' compensation experience modification and past insurance carriers.

As you can see, the premium for workers' compensation has a maximum dollar amount of \$144,656. Management has opted to work with the League on a discounted premium for workers' compensation for the City of Crystal. This means that if we have no claims (very unlikely) the minimum premium for workers' compensation would be \$38,177. If we have workers' compensation losses averaging \$30,000 (reasonable assumption - this amount has been based on a 5-year average of City of Crystal workers' comp. claims) our premium would be approximately \$75,000. To reach the maximum amount of workers' compensation premium of \$144,656 we would have to have approximately \$95,000 in workers' compensation claims for the year 1988-1989.

Again, if we continue on with our average of approximately \$30,000 worth of workers' compensation claims our premium will be approximately \$75,000 as compared to a standard premium (without a discount option - no risk) of \$109,077.

Finally, we will be paying our insurance agent a straight commission fee of \$8,650 as compared to plus \$21,000 if a straight commission fee was being charged.

I recommend that the City Council approve package policy, auto policy, workers' compensation policy, and public official policy through LMCIT with limits to \$600,000 for policy year March 1988 to March 1989.

Numerous complaints continue to be received at City Hall concerning problems encountered with parking on both sides of 32nd Avenue between Douglas Drive and Edgewood Avenue. As described in the attached letters, the parking situation is being caused by the operation of the abutting used car sales lot.

While some on-street parking is inherent in the operation of this type of business, it is evident the area must be defined. For that reason, this office recommends parking be prohibited on the south side of 32nd Avenue between Douglas Drive and Edgewood Avenue. Also, restrictions in this same one block section on the north side within fifty (50) feet of Edgewood Avenue and fifty (50) feet of Douglas Drive should be enacted. Such restrictions will allow for safe two-way traffic on 32nd Avenue at all times.

At the same time, this office will work with the City Attorney on the interpretation of our ordinances concerning parking merchandise (cars for sale) within public right-of-way for extended periods of time and the requirement to provide five (5) on-site parking stalls for a used car business. These situations are also contributing to the problem and should be resolved.

As a final item for future consideration, many individuals have questioned why the City ever approved a used car sales lot on this site in the first place. After explaining that used car sales is an allowable use within a B-3 zoning district, their next question is whether such a business could be handled as a conditional use consistent with provisions for a car wash. The Council may wish to consider referring consideration of such an ordinance amendment (Section 515.35) to the Planning Commission.

Again, at this time approval of the specific parking restrictions noted above for 32nd Avenue is recommended.

This letter is to inform you that numerous complaints have been received from residents in the area of Melissa Motors concerning the street-side parking on 32nd Avenue between Edgewood and Douglas Drive. The complainants state that customers and employees as well as an overflow of vehicles for sale are being parked along both sides of the street making two-way traffic on 32nd Avenue impossible. In confirming the accuracy of the complaints, I have found the situation particularly unsafe during late afternoon and early evening business hours.

Strict interpretation of the City's zoning code prohibits merchandise for sale to be displayed within public right-of-way. Additionally, used car lots are required to provide at least five (5) spaces on premises for customer parking. The City allows these spaces to be provided in the aisles as a means of minimizing the impact on adjacent streets while allowing a business to maximize use of their property.

The present situation on 32nd Avenue is unacceptable from a safety standpoint and must be resolved. If you cannot reduce your inventory to provide more space on-site or find an alternate solution, the City will undoubtedly become actively involved within the near future. Such involvement would probably include establishment of parking restrictions along all or part of the street segment in question.

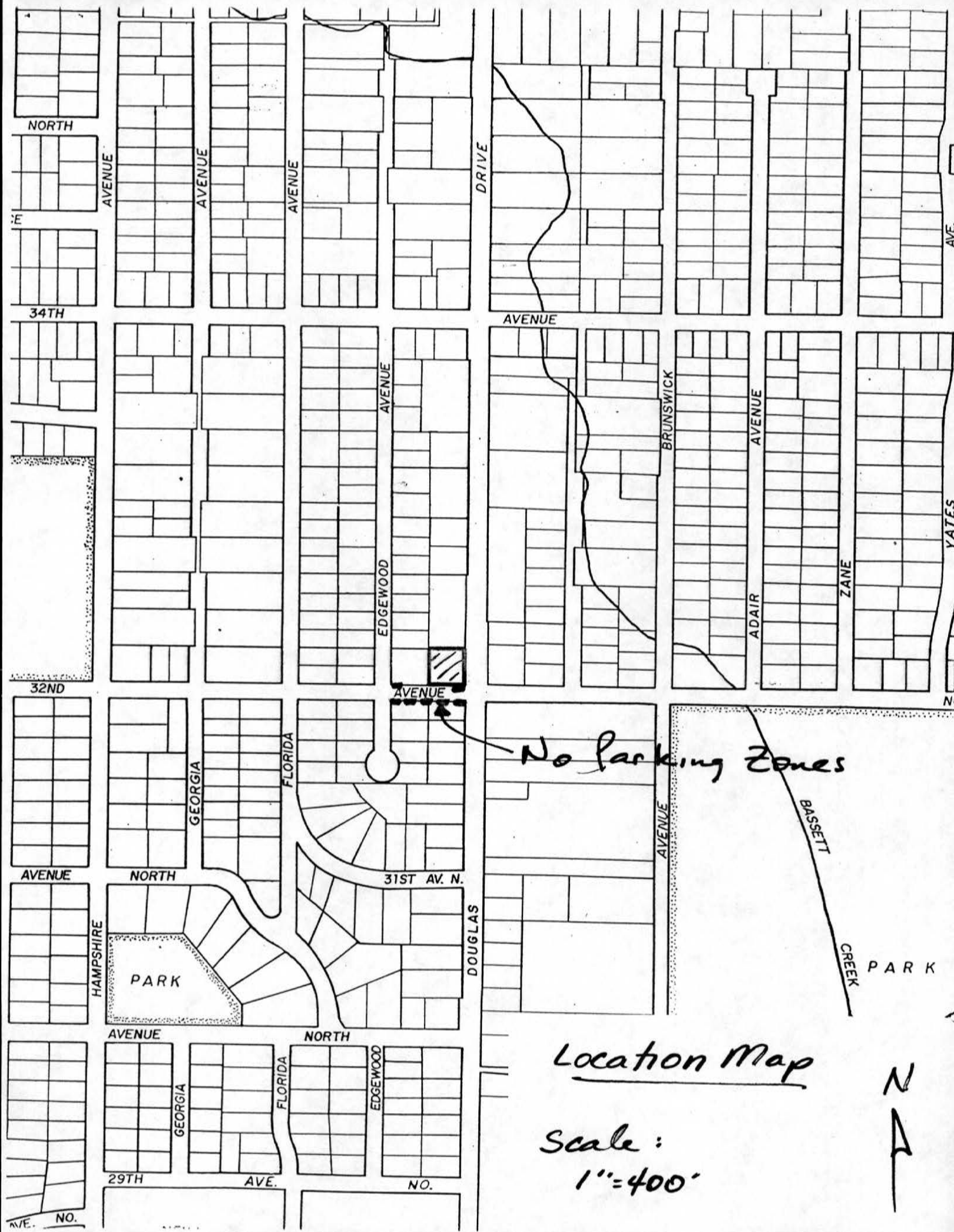

Consideration of stop sign requests is a springtime ritual for every municipality and 1988 is not to be an exception in Crystal. The only difference this year is the way this first group is being presented for Council review.

The stop sign requests described below deal with restricted sight distance, offset intersections or conflicting traffic movements. In reviewing the intersections, this office had no problem with any of the proposed sign locations and therefore petitions were not requested of the area residents. It is proposed that this simplified process be used with future requests. If staff questions or opposes a specific stop sign request, the previously employed petition process would be initiated and brought before the Council after proper resident notification.

Installation of stop signs at the locations described below is recommended:

- Northbound traffic on Jersey Avenue stops at 46th Avenue. The other three legs of the intersection are uncontrolled and this creates a dangerous situation. A stop sign is needed on Jersey Avenue to control southbound traffic and create a standard two-way stop situation.
- Sight distance limitations affect traffic approaching the intersection of 34th and Adair Avenue which was recently the site of a minor traffic accident. It is proposed to install stop signs on Adair Avenue and minimize the impact of said sight limitations.
- The location of a wooden fence at the intersection of 46th Place and Jersey Avenue significantly obstructs sight lines. The operation of a day care at the nearby church also introduces additional traffic into the area. It is proposed to install stop signs on 46th Place which would have a minimal impact on thru traffic movements.
- Postal drivers have experienced a problem at the severely offset intersection of Cloverdale and Hampshire Avenues. Due to the offset situation, it is proposed to place stop signs on Cloverdale Avenue.

- A stand of large pines obstructs view at the intersection of Scott and 53rd Avenues just north of a sharp curve on Scott. It is proposed to place stop signs on Scott Avenue to eliminate the impact of the sight obstruction.
- The development of Rolling Green has significantly increased a conflict situation involving north/south and east/west traffic at the intersection of Quail and Wilshire Avenues. It is proposed to place stop signs on Quail Avenue to establish control for the conflicting movements.

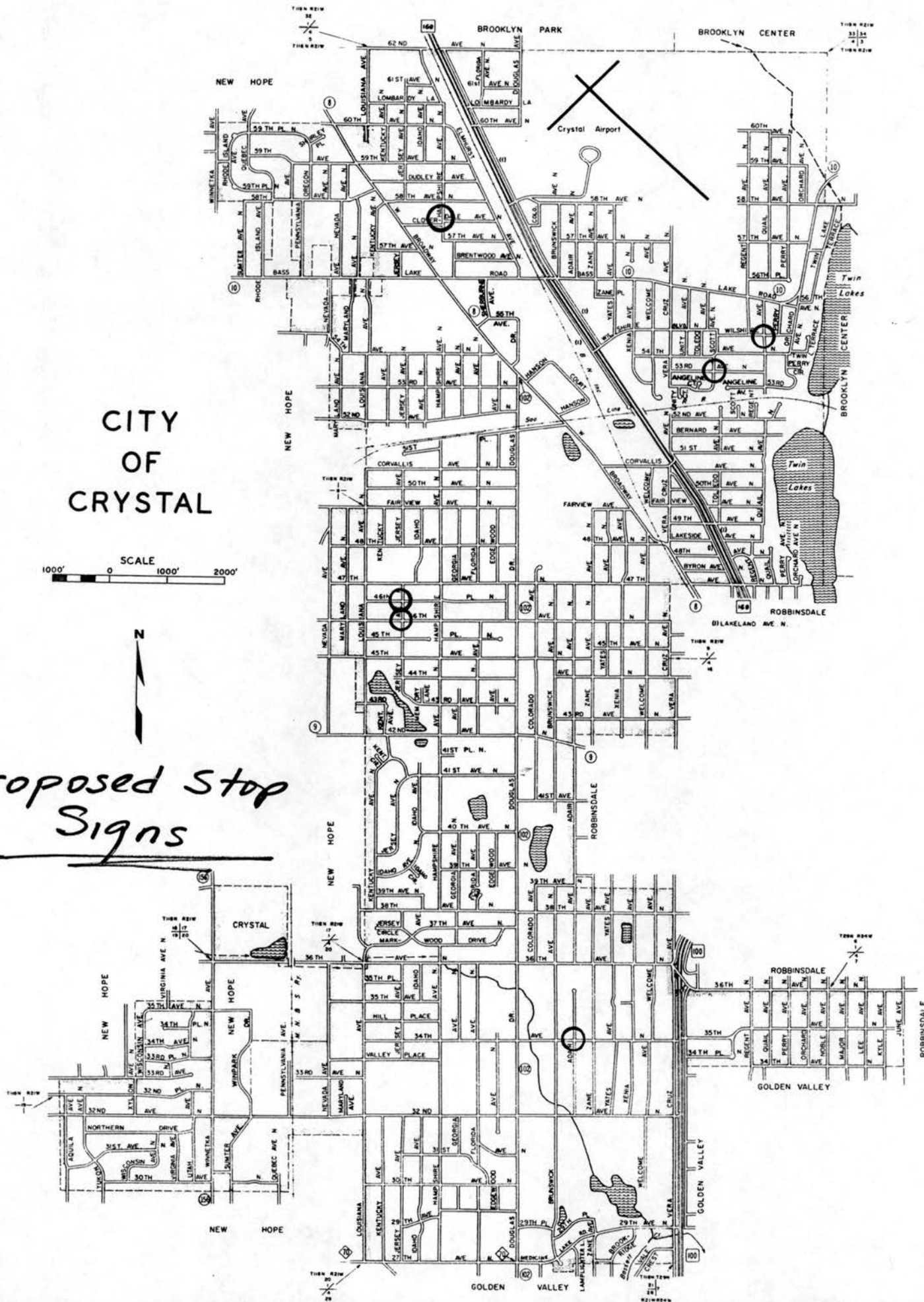

RE: Back Flow Valve Program

Residential property within the four areas of Crystal noted on the attached map experienced some degree of sanitary sewer back-up during the last July's super storm. While the back-ups were not related to system failure, severe in-flow/infiltration and system capacity limitations in these areas did contribute to the problem. For that reason, it is proposed that a back flow valve reimbursement program be initiated.

Such a program would involve the City establishing a minimum valve specification (see attached) and reimbursing home owners for the cost of the valve following inspection of the installation. The entire procedure would be handled by the home owner with the City only involved in the reimbursement process which would be limited to a \$500 maximum. Based on our conversation with plumbing contractors, it is estimated that the cost for valve and installation would total \$1,000.

It is estimated that as many as fifty (50) homes could be eligible for involvement in a back flow valve program although it is not anticipated that all would choose to participate. At present, funds to cover the City's cost for this program are available in the Utility Department budget.

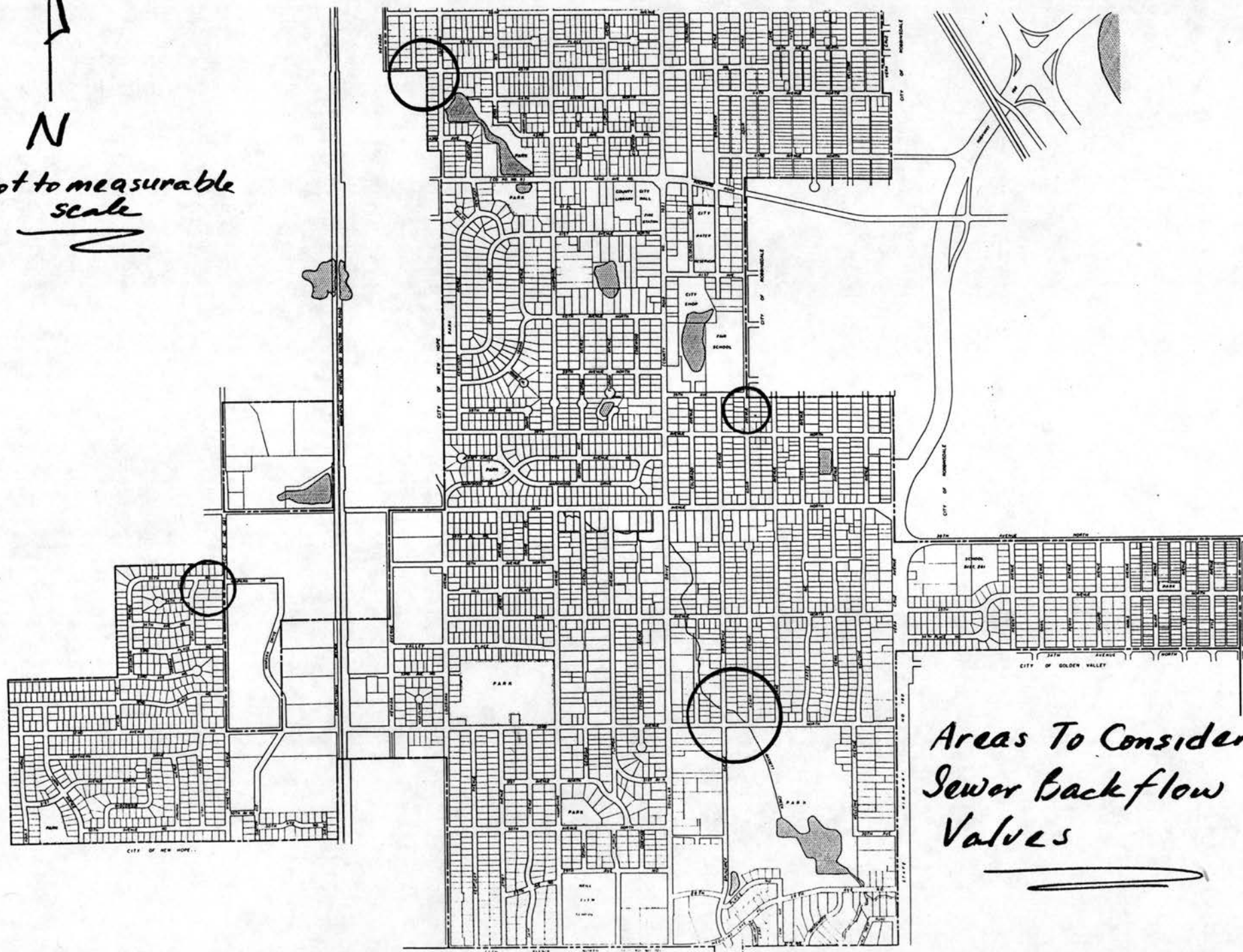
It is recommended the Council establish a back flow valve reimbursement program as outlined above within the four targeted areas. Affected residents would then be contacted concerning the specifics of the program, including minimum specifications, need for permit and inspection, maximum reimbursement and time frame.

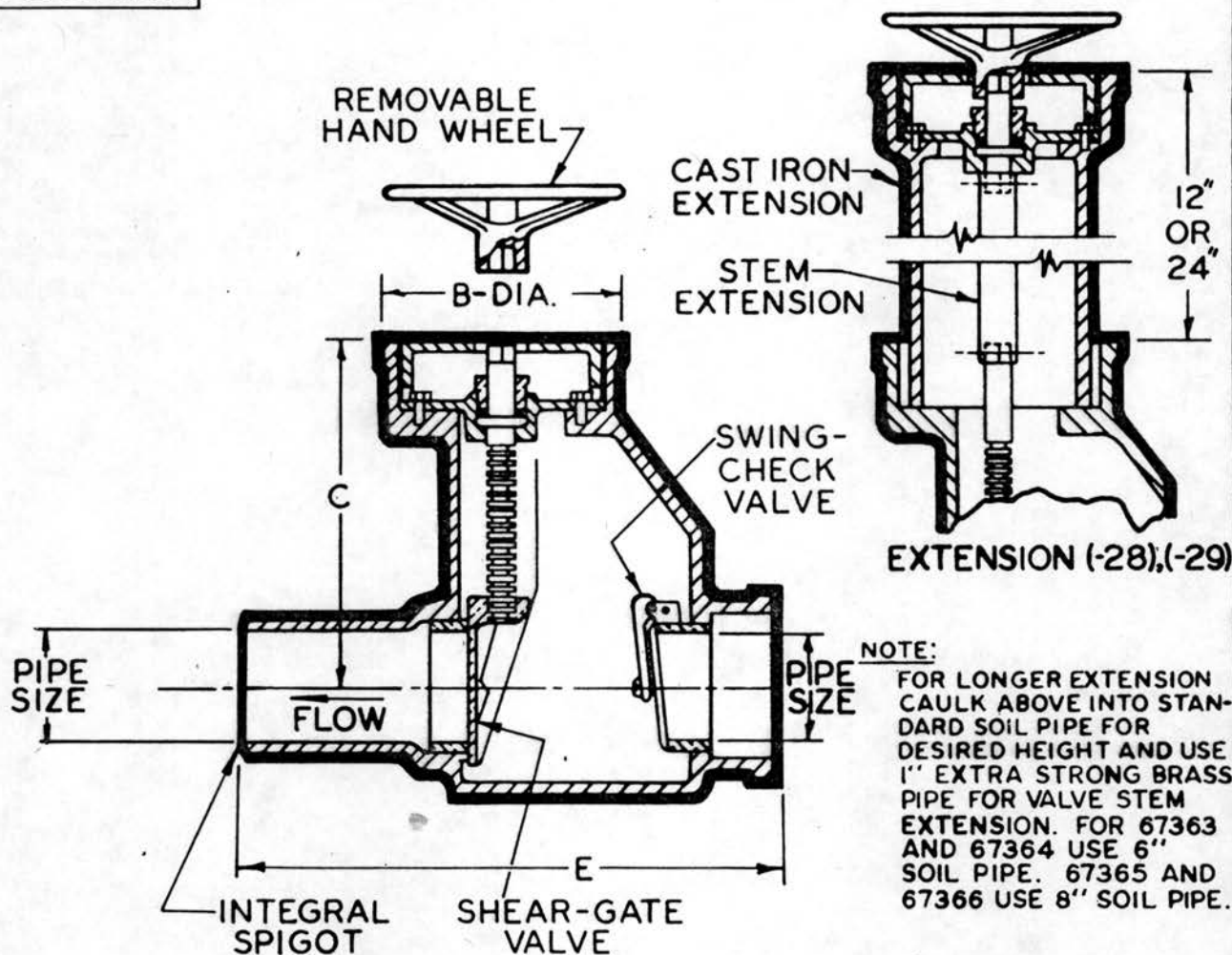

FEASIBILITY REPORT FOR  
1988 SEAL COATING PROGRAM

Project 88-1

In an effort to prolong the usable life of Crystal streets, a seal coating program has been continually performed for many years. The seal coating is set up on a district basis so that each street is improved on a six to eight-year rotating schedule. This year the northeast section of Crystal, bounded by TH 169 and 47th Avenue, is scheduled for seal coating. The work area is noted on the attached map.

The streets in the northeast quadrant of the City are still in relatively good condition. To protect their structural integrity and prolong their useful life, the use of granite chips on all City streets, instead of buckshot on some, is being recommended again in 1988. This surface type represents a good investment when reconstruction costs are reviewed as was done by the Council in establishing an infrastructure fund during the 1987 budget process.

The City has long assessed seal coating costs on a front foot basis. The criteria used in determining the length of that frontage is as follows:

Lots zoned residential or multiple are assessed on the basis of their actual front footage abutting the improvement. For corner lots, the full frontage along the short side is always assessed while the long side is assessed for one-third of the first 135 feet and full measure on the balance. For lots abutting a street on both the front and rear lines, assessment along the rear footage shall be handled as the long side of a corner lot. Lots zoned commercial and industrial are assessed for full frontage abutting the improvement. Assessments for seal coating are levied for a two-year term.

The footage noted does include park land and other City property of general use to the public.

While no change in the calculation of front footage is recommended in 1988, it is proposed that the assessment of residential property be redefined on a unit basis. An average assessment for each residential unit would be calculated by dividing the total front footage (for residential property only) by the number of residential equivalent units deriving benefit. By using a unit or average assessment approach, assessments would be closely linked to usage which is a more accurate indicator of benefit than frontage.

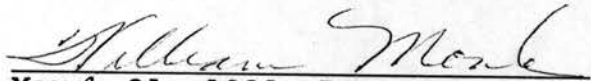
Using the above-noted assessment approach and surface treatment for all 14.7 miles of street in the 1988 Seal Coating Program, the project breakdown is as follows:

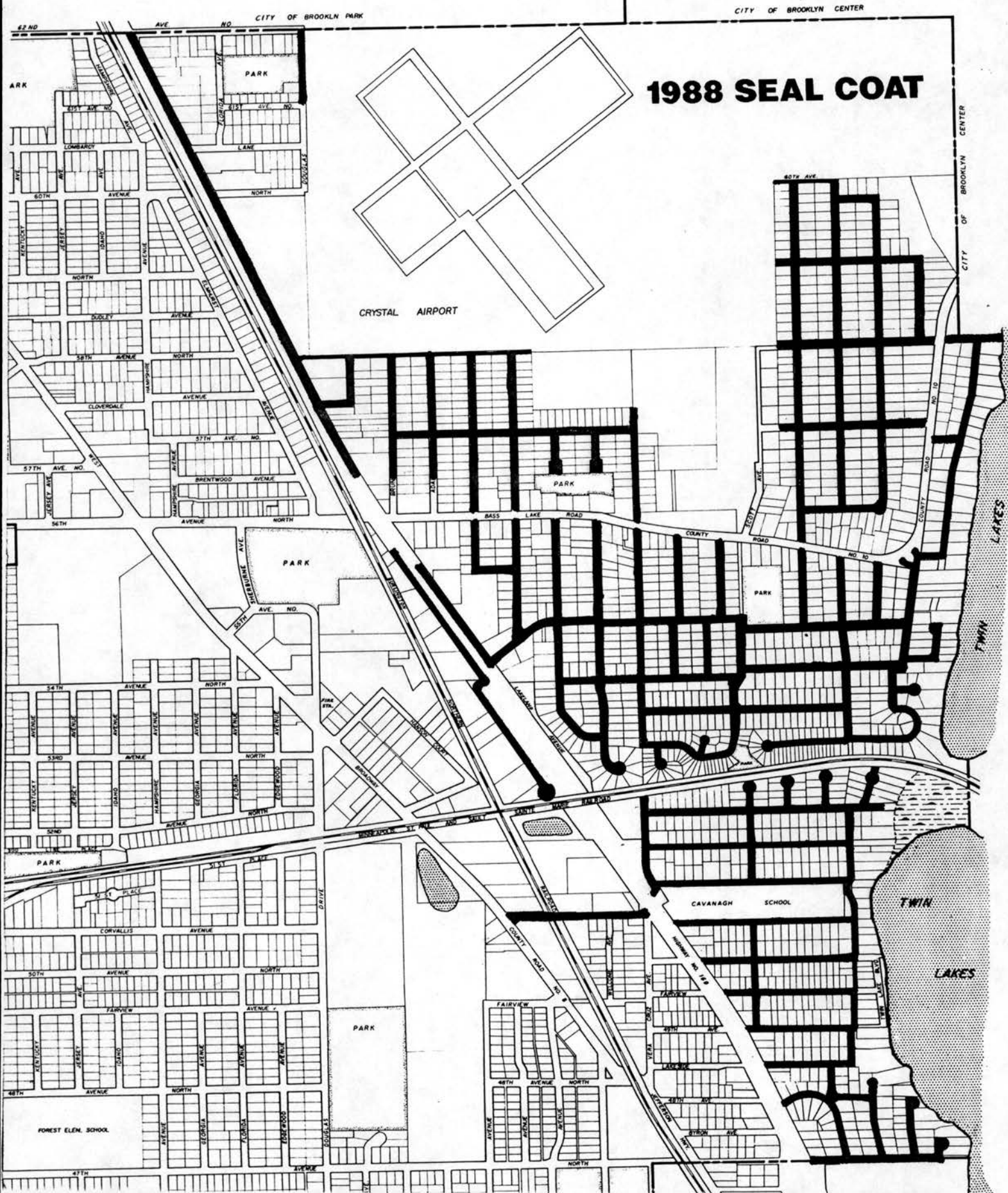
The rate assessed in 1987 was \$1.95 per front foot. This low assessment rate was achieved because of very low oil costs which are not anticipated to be repeated in 1988.

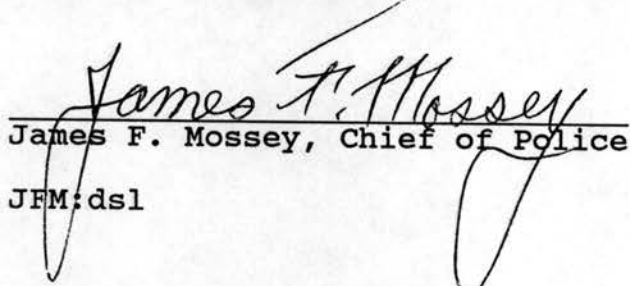

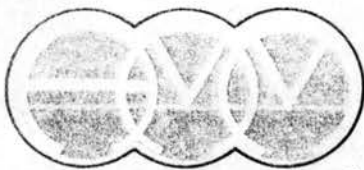

RE: LEGISLATIVE UPDATE - ANNUAL MEETING INFORMATION

1. AMM ANNUAL MEETING WEDNESDAY, MAY 18, 1988.

The 1988 AMM Annual Meeting has been scheduled for Wednesday evening May 18, 1988. Many of the meeting details have not been finalized as yet but it will be a dinner meeting beginning with a social hour starting at about 5:30 P.M. Please mark your calendars now for this important and fun event! A notice detailing the the specific arrangements will be mailed in late April.

2. NOMINATING COMMITTEE APPOINTED BY BOARD OF DIRECTORS:

A seven member Nominating Committee was appointed by the Board of Directors on March 5th. Members are: Chair Mary Anderson, Golden Valley Mayor; Duke Addicks, Minneapolis Legislative Liaison; Betty McCollum, North St. Paul Councilmember; Carl Meissner, Cottage Grove Administrator; Bill Saed, Inver Grove Heights Mayor; Dennis Schneider, Fridley Councilmember; and Gloria Vierling, Shakopee Councilmember.

The offices of President, Vice-President and eight directors are up for election. We are asking for your help in putting forth candidates for Board of Directors and Officers. If you know of a city official who would be considered for nomination; please give his or her name and a brief written resume of qualifications to Vern Peterson or to a member of the Nominating Committee by no later than April 8, 1988.

3. LEGISLATIVE STATUS:

It is that time of the Legislative Session when the status and content of major pieces of Legislation change on a daily basis or even more frequently. Eventhough the status and situation will have probably changed by the time you receive this bulletin, we did want to provide a brief update on some of the key items we have discussed with you in previous bulletins.



**A. COMPREHENSIVE PLANNING AND ZONING (HF 1888/SF 1759).**

This bill which combines and standardizes county, municipal and town planning authority into a single statute has been held over for interim study as requested by the AMM Board. We will have to do our 'homework' on this issue prior to the start of the next session.

**B. TAX INCREMENT FINANCING RESTRICTIONS (HF 1871/SF 1659).**

HF 1871 which has several bad features was passed by a House Tax Subcommittee on Friday March 12th. and will be considered by the full House Tax Committee this week. This bill will likely become a part of the House Omnibus Tax Bill and as such will have a new House File number which we think will be HF 2590. The House version has several troublesome features including the basic elimination of the soil and terrain test for a redevelopment district, street improvements adjacent to a parcel no longer eligible to meet the four year breakdown and an original mill rate certification provision which might drastically reduce the amount of increment captured for the TIF District.

SF 1659 was amended into SF 2370 and was passed out of the Economic Development and Housing Subcommittee of the Senate Tax Committee on March 21st. This bill was substantially amended in subcommittee and its most objectionable features were modified or eliminated. Some small problems still remain (mostly technical) such as the school district referendum levy and we will continue to work on them. In view of the House action, it is likely that SF 2370 will end up in the Senate Omnibus Tax Bill for which we do not have a Senate File number.

**C. PROPERTY TAX REFORM.**

Three proposals are now on the table with Senator Johnson's expected this week. The Outstate/Minneapolis/St. Paul coalition bill has had a hearing in Senate Property Tax Subcommittee without any testimony and House Full Tax Committee with testimony. It is not nor will it be included in either Omnibus Tax bill unless amended in during committee discussion or floor action. The Governors reform package similarly has had hearings in both houses and also is not included in either Omnibus Tax Bill.

The House Omnibus bill at this time contains no LGA increase but does increase Homestead Credit to 53% of the first \$80,000 value with no dollar limit. This is good for the metro area. There are also provisions for C/I relief which impact well for outstate areas. It includes a 'truth in taxation' provision

which is currently unwieldy but may be reasonable with some change. Finally, it returns to the pre 1988 levy limit base using the implicit price deflator or 5% whichever is less as the increase factor.

**D. FISCAL DISPARITIES.**

The Fiscal Disparities bill HF 1126 (Rep. Rest) is still hung up in House Metropolitan Affairs Committee by its Chair Tom Osthoff, a St. Paul legislator. The Senate companion SF 1134 (Sen. Reichgott) has passed a Tax Subcommittee and is awaiting a hearing in Senate Tax Committee. Given the problems in the House it is probable that it will not pass this year.

**E. TRANSPORTATION FUNDING.**

The House passed HF 1749 which includes a 3 cent gas tax and an additional 30 percent Motor Vehicle Excise Tax (MVET) for a total of 35 percent. This position was the recommendation of the Legislative Transportation Funding Commission and is supported by the AMM as a realistic compromise providing necessary Highway and Transit funding. The Senate Finance Committee changed the 30% MVET transfer to an equal one time appropriation with 25% for transit and the other 75% directly to MNDOT. This eliminates MVET distribution to counties and cities and leaves Transportation funding undecided for future years. Senate Tax after making several changes, voted the bill to the floor on a close vote. It now includes gas tax indexing and increased vehicle license fees.

**F. SOLID WASTE.**

The House version (HF 2069) of the Comprehensive Waste Reduction and Recycling act was passed out of the House Environment Committee minus the beverage container deposit legislation but still containing the container packaging tax and the ban on certain plastic containers. The bill now rests in the House Appropriations Committee and still contains the mandate for mandatory curbside recycling by 1990 for all cities over 5,000 population in the metro area.

The Senate companion, SF 1902, was stripped of both the beverage container deposit section and the packaging tax by a subcommittee of the Environment and National Resources Committee and then was passed to full committee. The bill was not heard in full committee prior to the Committee deadlines because there were no provisions left in the bill to pay for the mandatory curbside recycling activities. It is uncertain as to what this bill's ultimate fate may be in the last few weeks remaining.

Now is the time to sign up for legislative committees

Would you like to help shape the League's legislative policies and priorities? The involvement of local officials is a key component of the League's legislative success. Local officials contribute to this success by identifying issues, studying and recommending solutions, voting on legislative policies at the Legislative Policy Adoption Conference, and through personal contact with their legislators. LMC legislative policies have high credibility with legislators because they know that the policies are determined through the involvement of many local officials.

The League encourages elected and appointed officials from throughout the state to sign up for a committee. There are six legislative committees dealing with different subjects. The committees are:

GENERAL LEGISLATION AND PERSONNEL discusses tort liability and insurance, purchasing authority, open meetings, mandates, charitable gambling, licensing of contractors, competitive bidding issues, personnel, PERA, emergency medical services, veterans' preference, and military leave issues.

LAND USE, ENERGY, ENVIRONMENT, AND TRANSPORTATION covers wastewater treatment, solid and hazardous waste, ground and surface water management, land use (planning, annexation, eminent domain, and adverse possession), energy conservation, and transportation issues.

REVENUE SOURCES deals with municipal finance, property tax law, local government aid, and audits and financial reporting issues.

DEVELOPMENT STRATEGIES discusses general development issues including tax increment finance, industrial development bonds, redevelopment, economic development authorities, and housing.



ELECTIONS AND ETHICS deals with election and ethical issues, such as voter participation and a uniform election day policies for example.

FEDERAL LEGISLATIVE handles issues in conjunction with the development of the National League of Cities national municipal policy. Policy areas are fiscal, development, environment, and transportation.

In May, 1988, the League's president will appoint new legislative committee members. The committee appointments are for a two-year period (1988/89) that coincides with the state's biennium. Everyone requesting to serve on a legislative committee will definitely be placed on a committee. The League strives to achieve balanced representation on each committee so we can't guarantee you will be placed on the committee of your first choice, but every effort will be made to do so.

RE: Grill at VFW, 5222 56th Avenue North  
DATE: March 22, 1988

On November 29, 1987, Mary Fandrey inspected a pancake breakfast at the VFW, 5222 56th Avenue North, which was sponsored by the Crystal Lions. She noticed they were using a gas grill which was not under a ventilation hood.

On December 30, 1987, she discussed the matter with me and asked about the requirements for ventilation over gas grills. The Code requires that the grill should have a hood to collect incompletely combusted gases, carbon monoxide and greasy vapors. That same day Mary spoke with Mary Knaeble, President of the VFW Ladies Auxiliary, regarding a steak fry scheduled for December 5, 1987, at the VFW and sponsored by the auxiliary. She inquired about the grill. Ms. Knaeble stated it was indeed a gas grill and it was used. She was informed that they should not use the grill since it did not have proper ventilation.

On February 14, 1988, Mrs. Fandrey inspected a senior appreciation dinner and again advised them not to use the grill for the same reason. The chef was cooperative and discontinued using the grill.

On March 13, 1988, the Lions held a pancake breakfast at the VFW. During the inspection, it was noted that they were using the grill. It was recommended they not use it for the aforementioned reasons. We stated that we would not forbid them to use the equipment but that if they use it, they were doing so against our recommendation and it would be noted on the inspection form.

I know that both groups are aware of the Health Department's position on this.

We are concerned that our efforts be consistent and that groups in the community feel that all are being treated fairly. It is our intention to warn groups of hazards and note them on our inspection forms. It is not our intention, now or in the future, to take further enforcement action with community groups.



The requirement for use of a ventilation hood on a gas appliance rests in the Ventilating Code. (See the attached, highlighted excerpts of the State Mechanical Code.)

#### 1345.0450 GAS VENTS AND FLUES, TYPES AND USE.

Subpart 1. Venting systems. All gas appliances required to be vented except sealed combustion system appliances shall be connected to a venting system that shall be engineered and constructed so as to develop a positive flow adequate to remove flue gases to the outside atmosphere. When venting systems serve appliances requiring draft for proper operation they shall be designed and installed to develop adequate draft so as to satisfy the draft requirements of the appliance with the manufacturer's instructions.

#### Subp. 2. Type B gas vents. Type B gas vents:

A. application: not to be used with recessed heaters, incinerators, and appliances listed for use with chimneys only;

B. shall be round in physical shape except as approved for BW vents in the following; and

C. shall be installed in accordance with this chapter and the manufacturer's specifications.

Subp. 3. Type BW gas vents. The venting of recessed or surface-mounted wall heaters or furnaces shall be such that a section of type BW vent material shall extend through the plate directly above the heater. Immediately above the highest plate there shall be a transition fitting from the oval class BW vent to round class B vent material. This shall extend a minimum of total height of 12 feet above the floor on which the heater sits.

Wall heaters or furnaces which have been designed by their manufacturer for a horizontal vent takeoff and have been so tested and approved shall have their horizontal vent connector as short as possible. The maximum length of the horizontal run shall be six feet.

Subp. 4. Single-wall vent pipe. The material and installation of single-wall vents shall comply with the requirements as specified in part 1345.0500.

Subp. 5. Gas vent; termination. Gas vents may be terminated not less than 12 inches above the highest point where they pass through a roof. Each gas vent shall extend above the roof surface and through its flashing. The outlet opening of any vent shall be not less than 12 inches from any portion of the building or structure, nor less than four feet from any of that portion of the building or structure which extends at an angle of more than 45 degrees upward from the horizontal. (See Figure 6 at the end of this chapter.) Vent caps shall be as specified in parts 1345.0420 to 1345.0440.

Type B gas vents shall not terminate less than five feet in vertical height above the highest connected appliance draft hood outlet or flue collar.

Type BW gas vents serving a vented wall furnace shall not terminate less than 12 feet in vertical height above the bottom of the heater.

Subp. 6. Size of gas vents. The size of the common vent

provisions of draft hoods do not apply to listed appliances having sealed combustion systems constructed and installed so that all air for combustion is derived from the outside atmosphere and flue gases are discharged to the outside atmosphere. Such appliances, having integral venting, shall be considered as being properly vented when they are installed in accordance with their listing and the manufacturer's instructions.

Vent terminals of sealed combustion system appliances shall be located not less than nine inches from any opening through which combustion products could enter the building. A sealed combustion system appliance may be installed in a building opening, such as a window. The bottom of the vent terminal and the air intake shall be located at least 12 inches above grade.

**Subp. 2. Mechanical draft systems.** Venting system exhausters may be used in lieu of natural draft vents for any gas appliance except incinerators. When exhausters are used with gas appliances, requiring venting, provisions shall be made to prevent the flow of gas to the main burner in the event of failure of the exhaust system. The interlock shall prove actual air flow.

Vent connectors serving gas appliances vented by natural draft shall not be connected into the discharge side of the power exhausters.

The exit terminals of exhauster-equipped gas-venting systems shall be located not less than nine inches from any building opening nor less than two feet from an adjacent building and not less than seven feet above grade when located adjacent to public walkways.

Forced draft systems and all portions of induced draft systems under positive pressure during operation shall be designed and installed so as to be gas tight or as to prevent leakage of combustion products in a building.

**Subp. 3. Ventilating hoods and exhaust systems.** Ventilating hoods and exhaust systems may be used to vent gas burning appliances installed in commercial applications, when approved by the administrative authority.

**Subp. 4. Dampers.** Manually operated dampers shall not be placed in the vent connectors from gas appliances except that manually operated dampers may be installed in the vent connector of listed gas incinerators when recommended by the manufacturer. Such a damper or draft regulator shall be installed in accordance with the instructions accompanying the incinerator. Fixed baffles, such as baffles ahead of draft hoods, are not classified as dampers.

**Subp. 5. Use of thimbles.** When passing through combustible walls or partitions vent connectors built of listed type B gas vent material shall be installed so that the clearances required by the listing are maintained.

Vent connectors made of single-wall metal pipe shall not pass through any combustible walls unless they are guarded at the point of passage by ventilated metal thimbles not smaller than the following:

A. for listed appliances, except incinerators, four inches larger in diameter than the vent connector unless there is a run of not less than six feet of vent connector in the open, between the draft hood outlet and the thimble, in which case the thimble may be two inches larger in diameter than the vent connector;

B. for unlisted appliances having draft hoods, six inches larger in diameter than the vent connector;

## City Voters to Use New Voting Equipment

A new voting system is being implemented in the City of Crystal. The voting process remains the same as in the past, except for the actual use of paper ballots and optical scan vote tabulators.

The system is very easy for the voter to use. The voter will mark his or her election choices on a paper ballot and then feed the ballot into an optical scan vote tabulator. The machine will record the vote in much the same way the price code on groceries is read at the check out counter.

The voter will mark the ballot by completing the arrow pointing to the candidate of his or her choice.

Instructions on the ballot will tell the voter how many candidates to vote for in each office. After having completed marking the ballot the voter will insert it into the front of the optical scan vote tabulator. (See photos on page 4 for more instruction.)

The vote tabulator will read the ballot. If an error has been made such as voting

for more candidates than allowed, or voting for candidates of more than one political party in a primary election, the tabulator will return the ballot to the voter and not count it. The voter will receive a new ballot if the ballot is returned by the tabulator.

Election judges will be available on election day to help voters with the new process.

Benefits of the new voting system are three-fold; simplicity and ease of voting to the voter, reduced election costs and earlier precinct vote totals to the City, and reduced election costs and earlier county-wide vote totals to the County.

An Optical Scan machine will be available for demonstration at City Hall for 6 weeks immediately prior to the election.

Brochures are available at information counters throughout City Hall. If you come in to do City business, be sure to pick one up and read through it, or stop by specifically to get one.

Video tapes demonstrating the voting process at the polls on election day will also be aired on the local Cable TV channels periodically.

## Bass Lake Road Intersection Construction to be Started

The final phase of construction on Bass Lake Road is scheduled to be completed this year and involves the reconstruction of the Highway 169/County Road 10 intersection.

This is a cooperative project between the City, Hennepin County, the MN Department of Transportation and the Burlington/Northern Railroad.

This project, which will be performed by C.S. McCrossan, Inc. in three phases, is scheduled to start in April and be

completed by November. Work items include relocation of frontage roads, roadway widening, channelization and median improvements, sidewalk installation and railroad crossing reconstruction.

While Hennepin County will act as the lead agency on this \$3 million project, all parties involved are financially responsible for specific work items.

Crystal has been actively pursuing land acquisition necessary as right-of-way for some time. The only actual construction item for which the City is liable involves

the demolition or removal of six buildings acquired to facilitate frontage road relocation.

As construction progresses through the summer, traffic delays and possibly even a short-term detour will inconvenience and frustrate area motorists.

Such occurrences can and will be minimized but not totally avoided. However, upon completion of this project, Crystal will realize substantial safety and traffic flow benefits that will last for many years.

# Three Cities to Organize Refuse Collection, Recycling

A Joint Powers Agreement has been established between the Cities of Brooklyn Center, New Hope, and Crystal for the purposes of establishing organized refuse and curbside recycling services.

The Agreement establishes the Hennepin Recycling Group, which includes one representative from each city. This group plans to negotiate a recycling/refuse

collection contract with the present refuse haulers.

An informational meeting on recycling and organized collection will be held for the public at Crystal City Hall at 7:30 p.m. Tuesday, April 26. All citizens are encouraged to attend so that you may be informed of the changes that will be occurring in the city's refuse collection system.

If your proposed building or addition were to encroach in one or more of the required setbacks, the ordinance does provide for a legal procedure (variance) whereby you petition the City Council to vary the strict application of the Ordinance.

This procedure is time consuming (usually 4 to 6 weeks) so it's suggested that you get your preliminary plans submitted as early as possible.

Normally the building permit process will take from one to three days after submittal of application, site plan and two (2) sets of building plans.

## Rabies Clinic May 21

The City of Crystal will conduct its 16th Annual Rabies Vaccination Clinic on Saturday, May 21, 1988, from 12:30 p.m. to 3:30 p.m. at the Crystal Municipal Garage, 6125 41st Avenue North.

The clinic will be conducted by a qualified veterinarian and is open to all Crystal residents who wish to bring their pets for vaccination. The cost is \$7 per injection.

Cat owners are also encouraged to bring their pets for the rabies vaccination. All animals must be leashed. It is suggested that cats be brought in a box or similar enclosure.

Dog licenses are also on sale, but residents are reminded that if they are coming just to purchase a license, proof of rabies vaccination is required. Dog licenses are \$5 for spayed or neutered pets, bring proof of certificate; and \$6.50 for unaltered pets.

## Haulers to Pick Up Spring Yard Waste

As you work on cleaning your yard and garden this spring, please keep in mind that your bagged yardwaste will be collected for composting at the Hennepin County Compost Site in Maple Grove. This material must be free of trash and brush. Most residential garbage haulers in the City of Crystal will be collecting yardwaste separately from trash during the peak spring clean-up season. The garbage haulers ask that residents place bagged yardwaste a few feet away from regular trash on your regular trash pickup day.

Free compost is available at the Hennepin County Maple Grove Compost Site Monday-Saturday 8 a.m.-5 p.m. as of April 1. To get to the site take County Road 18 North to County Road 109 (85th Avenue North) west to Zachary Lane. Head north 1/2 mile on Zachary Lane. Site is on west side of Zachary Lane.

When roots and other debris clog the main line it affects more than just one property and could cause problems for your neighbors and yourself. This problem could be eliminated if the City is notified as soon as you clean your sewer line.



# Juveniles Can Be Charged With Various Status Offenses

Status offense laws were written primarily to protect children (because of their "status" as minors), and to help them become responsible adults. The following are "status offense" laws:

**CURFEW:** Curfew laws are set by City Ordinance. In Crystal, persons under the age of 15 must be off public streets, park or other public places or business establishments, between the hours of 10 p.m. and 5 a.m. The time is 12:00 midnight to 5:00 a.m. for those who are between 15 and 18 years of age.

Children out past curfew could be cited by police officers. This means that a referral is made to juvenile court. A common consequence for a first time curfew violator is a \$25 fine.

In 1987, twelve juveniles were picked up by Crystal Police for curfew violations. Only two of the twelve were referred to juvenile court.

The curfew code in Crystal also says that parents may set an earlier curfew time than set by City Ordinance and that shall have the effect of the law for their child.

Curfew laws are enforced to protect children who could get themselves in dangerous situations when alone at night, and to keep children from committing other more serious law violations.

**TRUANCY:** Any child under the age of 16 who skips seven class periods on seven different days or misses seven days of school without an excuse, is considered truant from school.

When school personnel wish to refer a child to court for missing school, they contact their local police juvenile officer who issues a citation requiring that the child and his or her parents appear in juvenile court.

For a first offense, a child will likely be ordered to participate in four hours of unpaid community service work. They will also be ordered to attend school.

If the child continues to truant and is referred back to court a second time, the judge may consider more serious consequences.

Because education is so important for children today, there has been talk at the legislature of raising the mandatory attendance age to 18 or high school graduation, whichever is first.

However, as the law now stands, children are required to attend school until the age of 16. Parents have responsibility to see that their child attends.

**RUNAWAY:** It is against the law for a child to absent him or herself from home without parental permission. If a parent suspects that their child may have run away from home, they may file a report with police.

The child's name will be listed as a runaway child in the national computer system. If found by police, the child will be picked up and returned to parents or to a shelter care facility.

If the child is gone for more than 24 hours and parents wish to have the child sent to court, police may issue a citation that will require a court appearance for the child and his or her parents.

Some children run from home because they don't want to follow the house rules set by parents. They want to be independent and live on their own.

However, as the law currently stands, there is no way a child under the age of 18 can be emancipated. A bill that is currently before the legislature could lower that age to 16 in some cases. But presently, children must be accountable to parents and parents are responsible for the support of children until the age of 18.

Other children run from home because they are being abused by family members. In these situations, it is preferable for the child to contact police and tell them of the problems at home.

Another option is for the child to go to the Bridge for Runaway Youth, a shelter care facility at 2200 Emerson Avenue South in Minneapolis (377-8800). Bridge staff will contact parents to let them know their child is safe.

The child will not be in trouble with police for running if they go to the Bridge because of an abusive or neglectful situation at home.

Crystal had 97 reports of runaway youth in 1987, 23 of which were referred to juvenile court. Court is used as a last resort when other attempts to solve the problem have failed. Parents are usually referred to family counseling or the child may be referred to a program such as the Northwest YMCA Detached Workers first.

A juvenile who is found guilty in court of being a runaway child may be court ordered to attend counseling. They most certainly will be court ordered to stay at home and not run again. A child cannot be detained in a locked facility or jail for running from home.

**SMOKING:** A child must be 18 years of age to purchase or smoke cigarettes. Those caught in possession of or smoking cigarettes can be cited by police. For a first offense, the child will most likely receive a \$25 fine. Crystal Police cited six juveniles for smoking violations in 1987.

It is illegal for a store owner to sell cigarettes to anyone under the age of 18.

**INCORRIGIBILITY:** The law says that children must obey the reasonable rules that parents set for them. A child who repeatedly disobeys house rules may be deemed to be "incorrigible" or beyond parental control.

In 1987, Crystal Police had eight reports of "incorrigible" juveniles, five of which were referred to juvenile court. A youth found guilty in court for failure to follow house rules will most likely receive an order to return home and follow the rules set by parents. In addition, counseling services may be set up for the family.

A bill currently before the legislature (H.F. 1251) would eliminate the category of "incorrigible" or "wayward" child from the law.

**ALCOHOL:** A person must have reached the age of 21 to purchase, consume, or possess alcohol. Alcohol offenders age 18 to 21 are referred to municipal adult court. Those under the age of 18 may be either warned and released or sent to juvenile court.

In Crystal, often times when juveniles are found intoxicated, they are taken to a detox center for their own safety.

It is difficult for officers to know what or how much the child has consumed. Consequently, police want them in a safe place where medical help is readily available and where the child can be watched until no longer "high" or intoxicated.

Detox centers can also assist parents in assessing the seriousness of the drug or alcohol problem so an early intervention can be done for those in need.

Drugs other than alcohol are illegal to possess, consume, or sell for everyone regardless of age unless prescribed by a physician. Drug paraphernalia is illegal to possess if it contains residue of a controlled substance.

The Crystal Police are involved in many "undercover" narcotics projects in an attempt to fight the illicit drug problem.

# News Notes

## SENIOR HOUSING

- Brutger Companies has begun construction of a 79-unit senior housing complex. This three-story structure is located south of Becker Park at the corner of Douglas Drive and 55th Avenue.

## SEAL COATING

- Crystal's annual seal coating and curb replacement program for 1988 will cover the area north of 47th Avenue and east of TH-169. Work includes crack sealing, bituminous leveling, curb replacement and chip seal placement. Work will be performed between the months of April and September.

## FLOOD PLANNING

- In response to flood problems encountered during last July's storm, dredging and outlet improvements will be performed in Memory Lane Pond adjacent to 42nd Avenue just west of Hampshire Avenue. Ponding improvements will also be reviewed soon within Yunkers Park in southwestern Crystal. These improvements are intended to maximize available water storage and offset the impacts of major rainfall events.

## THORSON CENTER

- The City will be vacating Thorson Community Center this summer due to escalating maintenance and operating costs. City programs, such as those for seniors, are being relocated to interim sites while the City Council considers space needs related to all municipal functions and programs.

## 36TH AVENUE

- The City Council has initiated a review of alternatives available in the reconstruction of 36th Avenue between Welcome and Louisiana Avenues. Major items of interest include street width (number of lanes), funding sources and truck traffic routing. With resolution of these items, it is anticipated that construction work may commence late this year or early in 1989.

## WARNING SIRENS

- In the event you hear the civil defense warning sirens, be sure to get official information from a local television or radio station.

Warning sirens are not only sounded for weather emergencies, but are used to warn of other natural disasters or man-made disasters (hazardous material spills or explosions).

**DON'T** call the police/fire department for information. This ties up telephone lines, possibly preventing someone with a true emergency from reaching the police/fire dispatcher.

## Home Improvement Loans

- There are still some funds available through The Crystal Bank's low-interest home improvement loan programs. Interest rates range from 3-9%, depending on applicants' income. Contact a consumer loan officer for details at 533-1511 or 533-1737.

## Highway 100, 36th Avenue To see Changes

The Minnesota Department of Transportation has received Federal funding to improve Highway 100 between 29th and 39th Avenues.

The improvements will include highway widening, frontage road relocation and overpass at 36th Avenue with the diamond interchange, and removal of the intersection at 39th Avenue.

As detailed preliminary design work by the State is completed this summer, the City will be contacting impacted residents and businesses to comment on the lay-out proposals.

Construction of the highway improvements is scheduled for early 1990's.

As the highway lay-outs are being planned, the Crystal HRA is conducting a market analysis to test the potential for redevelopment of the Anthony Shopping Center area and whether such redevelopment, if feasible, should include Mielke Field.

Work on this planning phase is scheduled to be completed this fall and residents and businesses will be contacted during the process.

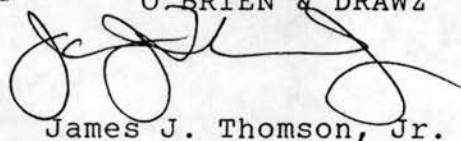

## SYLLABUS

Absent a showing of duress or coercion on the part of the municipality, a dedication requirement may not be challenged after the plat is approved and filed.

Affirmed.

Heard, considered and decided by Nierengarten, Presiding Judge, Sedgwick, Judge, and Forsberg, Judge.

## OPINION

NIERENGARTEN, Judge

Crystal Green partnership (Crystal Green) appeals from summary judgment against it in its inverse condemnation action against the City of Crystal (City). We affirm.



## FACTS

In October 1983, Crystal Green purchased 15.6 acres of undeveloped land adjacent to Highway 169 in Crystal for the purposes of developing a subdivision. In 1984, Crystal Green met with the city engineer to discuss the proposed subdivision. Crystal Green was advised to contact the Minnesota Department of Transportation (MnDOT) because MnDot planned to build a frontage road. The city engineer advised Crystal Green that the City would require it to dedicate the right-of-way as a condition of plat approval.

At plat approval hearings Crystal Green objected to the dedication requirement as an unconstitutional taking of the property without compensation but agreed to dedicate the land "under protest" and received final plat approval. Crystal Green's president testified that he did not challenge the dedication prior to plat approval because the seller, under the 1983 purchase agreement, would not wait, and he would be unable to obtain financing without final plat approval. Before contacting the City concerning its requirements Crystal Green paid \$5,000 in earnest money. The partnership incurred an additional \$20,000 in development costs with full knowledge of the required dedication.

The final plat was filed with the Hennepin County Registrar of Titles on January 7, 1985. Crystal Green sold all 49 lots to a construction company at a profit, but alleges that the dedication cost it five or six lots at approximately \$18,000 per lot, or \$90,000 to \$108,000.

Crystal Green applied for a writ of mandamus requiring the City to institute condemnation proceedings for the taking of Crystal Green's property. Summary judgment was granted to the City and Crystal Green appeals.

#### ISSUE

May a developer who consented to a dedication requirement by filing a plat containing the dedication, challenge the dedication requirement after the plat has been approved and filed?

#### ANALYSIS

Acting pursuant to statutory authority,<sup>1</sup> the City required Crystal Green to dedicate a portion of the proposed subdivision for future use as a frontage road in order to gain plat approval. The municipality is limited to a "reasonable portion." Collis v. City of Bloomington, 310 Minn. 5, 17, 246 N.W.2d 19, 26 (1976). Crystal Green could have challenged the reasonableness of the City's dedication requirement prior to the filing of the final plat through various remedies including mandamus, certiorari, injunction and the declaratory judgment action. See Minn. Stat. § 462.361, subd. 1 (1984); Honn v. City of Coon Rapids, 313 N.W.2d 409, 413 (Minn. 1981). Either mandamus or a declaratory judgment action would have been appropriate remedies in this case.

---

1. "[R]egulations may require that a reasonable portion of any proposed subdivision be dedicated to the public or preserved for public use as streets, roads, sewers, electric, gas, and water facilities, storm water drainage and holding areas or ponds and similar utilities and improvements." Minn. Stat. § 462.358, subd. 2b (1984).

There is no material fact issue. Simply put, the legal issue is whether Crystal Green may challenge the reasonableness of the required dedication after it filed a plat including the dedication. See Minn. R. Civ. P. 56.03; Betlach v. Wayzata Condominium, 281 N.W.2d 328, 330 (Minn. 1979) (on appeal, appellate courts must determine if there are issues of material fact and whether the trial court erred in applying the law.)

Crystal Green argues that it was not economically feasible to litigate the issue and wait to begin its project. However, Crystal Green did not consult the City about possible dedication requirements prior to payment of the \$5,000 earnest money and all the development expenses were incurred after Crystal Green had knowledge of the dedication requirement. Thus, there is no showing Crystal Green acted under duress or was coerced by the City into complying with the dedication. See Sorensen v. Coast-to-Coast Stores, Inc., 353 N.W.2d 666, 670 (Minn. Ct. App. 1984), pet. for rev. denied (Minn. Nov. 7, 1984) (duress caused by economic coercion may show absence of intent to release claims). Any financial duress was of Crystal Green's own making.

[T]he limitation of alternatives imposed by one's own financial problems does not constitute duress.

Bond v. Charlson, 374 N.W.2d 423, 428 (Minn. 1985).

If the dedication requirement were found unreasonable, the City would have the option of removing or modifying its requirement. On the other hand, if Crystal Green is permitted

to comply "under protest" and then ask for payment and the requirement is determined to be unreasonable, the City has no alternative but to pay since the dedication is irrevocable. See Bartlett v. Stalker Lake Sportsmen's Club, 283 Minn. 393, 397, 168 N.W.2d 356, 359 (1969).

Developers must challenge dedications prior to final plat approval and registration in order to assure finality of dedication, give municipalities an opportunity to change their requirements if the requirements are unreasonable, and prevent municipalities from being sued by developers when the only remedy available to a losing municipality is payment.

#### D E C I S I O N

The record does not show the developer was coerced by the municipality or that it acted under duress created by the municipality. The developer may not challenge the dedication requirement after the plat was approved and filed.

Affirmed.
