They will not show tog • Yesterday we presented 5 minutes clip about the first piece, which is the Absent Narrative of the District del Sol that will air later. In addition, 5 minutes clip about the interviews of Minnesotan-Latino successful business people, that is a work in progress with SPNN and it will air later too at TPT channel. • Mario wanted to know if they would all air all at the same time.
