Jo Vos - Share information	Jo Voss, Project Manager for the Office of the Legislative Auditors, presented a brief		
about purpose and	overview of the legislative Auditor's Office. Non-Partisan independent research arm		
evaluation of the audit,	of the Legislature with the Financial Audit Division and the Program Evaluation		
research methods, timeline,	Division. They are having a limited review of all the four councils of color in their		
and financial audit	evaluation including financial audit to see if they need to do a full audit. The		
	Program Evaluation Division looks at State programs that were either created or		
	receive funds from the Legislature to see whether or not they are effective in their		
	program and results. The Legislative Audit Commission suggests ideas and OLA		
	creates a survey. Among the 15 topics generated from the survey this year, the		
	Councils of Color received the most votes from Legislators; they were most interested		
	in this evaluation. The Legislators wanted to know how the Councils are working,		
	how they use the Dept of Admin's SMART program for administrative things. How		
	the Boards operate, the composition of the boards and appointment process, do they		
	operate in full capacity, how they carry out they statutory responsibility.		
	Acknowledge and will be sensitive to the fact that all councils are very different and		
	separate entities. They will be looking through statues, reports, interviewing staff,		
	board members, chairs in every board, and constituents.		
	They will give a report out in time for the next Legislative session in January. The

	ED García comments that if they are looking to improve the efficiency of the councils that the councils become better connected to the system. It is very difficult for us to convey the information and to engage the community if we ourselves are marginalized by the system and have opportunity to have ideas. Ms. Vos will address that and aware of it.		
	BM Jesús Villaseñor expressed concern that some people may have had different experiences with CLAC in the past that may have been pleasant or not, but that now we are trying to be more involve with the community. Our statue is so limited that we sometimes can not do what we want.

Treasurer's Report	ED García presented the Financial Report since BM Francisco Gonzalez was not present The total budget is \$289,327.45 with \$67,544.29 encumbered or already assigned budget items. The unobligated amount of \$22,399.10 added to the encumbered will give you the \$89,943.39 that is unexpended. ED García mentioned that we had received the amount for the redesign of the website for \$5,000 from Lydia Hinojosa. If the Board approves, ED García and Chairwoman Krystell Escobar can sign the contract and Jim Boyle's contract for PR campaign.

Executive Director's Report	ED García discussed that one of the key items in his report is the strategy that we are		
_	following. We have a limited amount of funds available to us, a historic impediment		
	for the Council, and that our community has not approached to the disparities in a		
	strategic way. Without the disparities, the councils would be totally superfluous. The		
	strategy that we have been following is to establish strategic alliances with groups		
	and individuals that do have resources.		
	CLAC is also establishing a relationship with the Jewish community (30, 000 Jews in		
	Minnesota) and are successful in promoting their interests. The Latino corporate		
	executives could be very important but people that succeed start drifting away from

	the community; this is destructive to the interest of the community. They are the models, mentors, who can provide the resource that the community does not have. Campaign with MPR so we can speak for ourselves. He comments that it is very important for us to be in the decision making tables. The more of us that are present, the more our opinion will count.		
	ED García commented that he and Rebeca Sedarski have been working in Rochester for the last 1-1/2 years meeting with the leadership to make Rochester a model community for the rest of the state. He has also attended very important meetings with the Violent Crime Coordinating Council where the Sheriffs, Chiefs of Police, Prosecutors, Dept. Of Corrections are present.		
	In terms of Education, from 3 meeting sessions in 2011, MHC hired HACER with the Legacy Fund Grant. They identified the Elements of Success that have made programs like TORCH at Northfield High school very successful. Now we are trying to implement those elements of success in two high schools: Humboldt High Schools and Northfield High School. This culminates with the presentation of Tor Dahl and Associates to the Legislators and funders by connecting the possibility of success with the economic impact that it could have in the state for the future. Faith institutions are of great importance to Latinos. They are the main source of trust.		
2013 Legislative Session	S. Goodspeed gave legislative updates. She stated that the legislative session is near the end and there are not very many changes we can do so this is a review. SF 1589-Omnibus State Government Committee meeting is today and ED García is going to testify. We are hoping to an increase in our budget. The SF-1236-Omnibus Higher Education bill has been slowly developing but will be working all weekend. The Dream Act was passed by both chambers. Also successful was Banned the Box legislation where job application do not require job applicants to list if they have criminal history until they get to a more advance stage in their application to prevent discrimination.		
	Board members had comments about the fact that Driver's License legislation did not move, lacking support from the Governor.
