IMPORTANT NOTICE

Election boards are required to serve at the delegate election held on the second Tuesday in March from twelve noon to nine P. M. and must enter the names of all persons voting at such election, together with the party ballot voted, on this register. However, such entering of names does not constitute registration for general election. The day of the delegate election is not a day of registration. In order to separate the names of the persons voting at the delegate election from those which may be subsequently entered as registered for general election, *the judges at the close of the delegate election should draw a red line after the last name appearing on each page of this register.* This is important. County auditors should examine the registers after the delegate election and should insert any red lines which have been improperly omitted. At the first meeting of the board of registration, to-wit: primary election day, the board should proceed in the same manner as though no names appeared on this register, that is, the name of a person entered on this list on delegate election day should be again entered either on primary election day or on one of the subsequent registration days in order to qualify such person to vote at the general election.
