MINNESOTA STATE BOARD OF PHARMACY

TWO HUNDRED NINETY-SIXTH MEETING

January 10, 1944. The Board met at the College of Pharmacy, University of Minnesota, at 9:00 o'clock A.M. Members present: Vice President J. N. French, E. A. Deterling, J. G. Pasternacki, John Nelson, and Victor E. Feit, the new member appointed by Governor Edward J. Thye on December 21, 1943 to a full term of five years. Mr. Feit succeeds Fred G. Kustermann, whose term as member expired January 3.

The following named persons had filed applications and were eligible to take the entire examination and were present to take the practical work:

The giving of the practical work occupied the Board the entire morning.

After the class had been called in and put to work, the Board considered the matter of passing a resolution to allow for credit toward the one year minimum drug store experience required for eligibility to take the examination, drug store experience obtained during Easter and Christmas vacations while in attendance in a school or college of pharmacy. Up to January, 1943 no such experience had been accepted for credit, only the summer vacation period.

The following motion, which was made by Mr. Deterling and seconded by Mr. Pasternacki, was passed:

~~THAT DURING THE WAR EMERGENCY AND WHILE THE SCHOOLS AND COLLEGES OF PHARMACY ARE ON THE ACCELERATED PLAN, DRUG STORE EXPERIENCE WHICH HAS BEEN OBTAINED DURING THE EASTER AND CHRISTMAS VACATIONS WILL BE ACCEPTED FOR CREDIT TOWARDS THE ONE YEAR MINIMUM DRUG STORE EXPERIENCE REQUIRED TO BE ELIGIBLE FOR EXAMINATION, AND THE SAME TO BE RETROACTIVE TO MARCH 1, 1943.~~

At 2:00 o'clock P.M. the Board met to give the identification and oral examinations. There were 22 applicants.

The following had made application for the written and identification examinations as they had not had the required one year of practical experience:

One applicant, Stanley C. Gerber, had the required one year of practical experience but was not 21 years old, hence could take only the written and identification examinations.

Mrs. Arlene G. Mornik could not appear for identification examination as she was ill, but did appear for written the next day.

January 11, 1944. The Board spent the day giving the written work. There were 23 applicants.

January 12, 1944. The Board spent the morning marking the written work. At 2:30 o'clock P.M. the Board met at the Nicollet Hotel to consider applications filed for reciprocal registration. Applications had been received from the following:

The above named, with the exception of Mr. Blomster, appeared in person and were interviewed by the Board and their applications checked. They were given the written examination in Jurisprudence required of reciprocal applicants.

S. H. Nicholson, registered in South Dakota, appeared before the Board also, in regard to reciprocating from South Dakota, but he had not filed the official reciprocity blank properly filled out as he had not received same from the National Board office, so the Board had no way of determining his eligibility for reciprocal registration. However, he was given the examination in Jurisprudence pending the filing of his application and other data substantiating his claims relative to his qualifications.

Upon checking the application of Mr. Blomster it was found that he was not 21 years of age when he took the examination in Iowa and was registered as a pharmacist; neither had he had the required amount of drug store experience to qualify for the examination in Minnesota at the time he took the examination in Iowa; nor had he had any college of pharmacy work prior to examination. He did not meet the requirements for reciprocity, and the fee of \$25 which he sent with his application will be returned.

Casmer A. Sathre, who operates a drug store at 1825 E. Lake Street, Minneapolis, Minnesota, a registered pharmacist, had been asked to appear before the Board at this time relative to his conviction of the sale of Barbitol.

Mr. Sathre stated he had been convicted of refilling a prescription for Barbitol for a patient without consent of the physician; that he had refilled this prescription without consent of the physician on two or three occasions. Several months later the patient had taken her life by an overdose of Barbitals. Mr. Sathre admitted filling prescription without consent of physician, and that he was convicted in court and fined \$200. Mr. Sathre felt the death was not caused because of the prescription he had filled, but that the patient had obtained barbitol elsewhere, and that he was a victim of circumstances. Mr. Sathre was excused and after discussion by the Board, the following motion was passed:

It was moved by Mr. Deterling, seconded by Mr. Pasternacki, that Casmer A. Sathre be placed on probation for one year from date of notice. Motion carried.

Harold W. Smetana, ~~was recalled before the Board because~~ a registered pharmacist, owning and operating a drug store at 27 Fifteenth Avenue S.E., Minneapolis, Minnesota, had been asked to appear before the Board in regard to conduct unbecoming that of a pharmacist, more specifically, to-wit: 1) Unlawful sale of certain instruments or articles to be used for the purpose of causing a miscarriage; 2) Conviction in District Court of the State of Minnesota, County of Hennepin, Fourth Judicial District, on July 14, 1943, of a gross misdemeanor, to-wit: Practicing Healing Without a Certificate of Registration in Basic Sciences, and having been sentenced to pay a fine of \$500 or be confined in the workhouse for one year.

After some discussion of the matter, Mr. Smetana told the Board he was making every effort to dispose of the store and made the solemn promise he would make some arrangement for final sale of the store within the next few weeks. Action of the Board was deferred until the meeting of the Board on January 14, 1944.

January 13, 1944. The Board spent the morning marking papers.

At 2:00 o'clock P.M. the Board met in Parlor H, Nicollet Hotel, for a hearing in the case of Bernice L. Murdock who had been cited to appear to show cause, if any, why her license to practice pharmacy should not be revoked, cancelled and set aside on the ground that on or about October 20, 1943 she sold unlawfully to one Gust C. Lange a narcotic drug, namely opium in paregoric, without a prescription having been issued therefore in the manner provided by law, and on the further ground that on the 5th day of November, 1943 she was convicted in the district court of the State of Minnesota in and for the County of Hennepin in the Fourth Judicial District of a felony, to-wit: the unlawful sale of a narcotic drug.

All of the members of the Board, the secretary, and the Board inspector L. J. Cleary, were present; also Mr. Crisler, district supervisor of the Bureau of Narcotics.

George Sjoselius, assistant attorney general, was the Board's legal counsel; and Edgar T. Buckley appeared with Miss Murdock as her attorney.

The date set in the citation for the hearing was January 21, 1944, but Miss Murdock and her attorney had consented to the advancement of the time of hearing in this matter from the 21st day of January, 1944 to January 13, 1944.

A certified copy of the conviction in the district court, marked by the reporter as State's exhibit "A", was offered in evidence. There was no objection by Mr. Buckley.

Mr. Buckley then spoke for the defendant and stated that the record would speak for itself, and that he believed the sentence the court imposed would give some idea of the status of the case as far as the court was concerned, and that in his opinion it was a reasonable fine.

Mr. Sjoselius pointed out that under the law the court could have given Miss Murdock a sentence to the state penitentiary for not more than five years and a fine not exceeding \$1,000.

Mr. Buckley stated that he realized it was within the power of the Board, under the law, to decide upon the future of the defendant; that she had transgressed; that she had made a mistake; and that she is, no doubt, subject to reprimand and censure. Having observed her attitude and her mind since this thing occurred, he stated he felt she was quite remorseful; that this matter had agitated her to the extent that she was indeed penitent; that he felt it had caused her many hours of loss of sleep and peace of mind worrying about the outcome of this matter.

Mr. Buckley felt that Miss Murdock was imposed upon in the sale of this drug; that all of us at times do something we should not do, not intentionally, but just because of immediate circumstances. He further stated that the Board in its official capacity must keep members of the pharmacy profession within proper bounds, the same as the lawyers and the doctors have to do, and that discipline must be maintained for the protection of pharmacy for that of the public.

In his plea for the defendant, Mr. Buckley stated he believed some sort of reprimand, such as a continuation of the case for a period of time to show defendant's good faith in the conduct of her business, would be ample, instead of taking away her means of livelihood. He further stated she had suffered; she appeared before the court and that before the court she was really contrite; that he did not think she would ever violate the law again; that he knew if she were given a chance, she would conduct herself as an honorable member of the pharmacy profession. Mr. Buckley wished that the Board would take into consideration that defendant had suffered much already and therefore is entitled to consideration in this case. Mr. Buckley asked Miss Murdock how she felt about that, and whether she felt that she had made a mistake. Miss Murdock answered "I know that I have". Mr. Buckley asked defendant whether charges made against her were true. Miss Murdock stated they were true and that she would not lie about that.

Miss Murdock was asked if she were given another opportunity, if she would conduct herself in such a manner that she would reflect credit upon herself and her organization? She stated she would like to be given that chance.

Mr. Sjoselius stated to Miss Murdock that there had been other complaints than those which were being discussed today; that so far as he knew none of them had been made since the date of the conviction. He further stated that indiscretions outside the sale of narcotics are just as serious as the sale of narcotics; that if she is guilty of any conduct unbecoming a pharmacist, it can be grounds for revocation of her license--the sale of liquor or any other illegal act on her part.

This ended the hearing and Miss Murdock and Mr. Buckley were excused.

It was moved by Mr. Feit, seconded by Mr. Deterling, that the license to practice pharmacy issued to Bernice L. Murdock be and is hereby suspended for a period of thirty (30) days from date of notice of suspension sent to Miss Murdock. Motion carried.

January 14, 1944. The Board met at its rooms at the Nicollet Hotel, 10:00 o'clock A.M.

Vice President French called the meeting to order.

The minutes of the August meeting were read and approved.

Copies of the financial statement for the year ending December 31, 1943 were distributed to each Board member.

The secretary gave his annual report covering the activities of the Board during the past year.

Moved by Mr. Deterling, seconded by Mr. Feit, that the secretary's report be adopted. Motion carried.

Moved Mr. Nelson, seconded Mr. Feit, that the following named persons having obtained an average of 75 per cent or better but not below 60 per cent in any one subject be granted registration as pharmacists. Motion carried.

Moved by Mr. Pasternaacki, seconded by Mr. Feit, that the following named persons be granted registration as pharmacists through the medium of reciprocity. Motion carried.

It was moved and seconded that ~~St. H.~~ Nicholson be granted registration as pharmacist on his South Dakota registration provided he is eligible for such registration when all the information required on the application has been completed and application filed with the secretary. Motion carried.

The thirteen applicants who were eligible to take the written and identification examinations only were successful in receiving passing marks.

Moved by Mr. Feit, seconded by Mr. Pasternaacki, that the Board of Pharmacy request an opinion from the attorney general in regard to restricting the sale of vitamins in Minnesota to drug stores. Motion carried.

It was moved and seconded that the bond premiums for the secretary and the assistant secretary be paid by the Board. Motion carried.

Moved by Mr. Nelson, seconded by Mr. Deterling, that Dr. Chas. O. Wilson, Associate Professor of Pharmaceutical Chemistry in the College of Pharmacy, be appointed as Chief Consulting Chemist for the State Board of Pharmacy, without compensation. Motion carried.

Moved Mr. Deterling, seconded Mr. Nelson, that the membership fees of \$25 to the National Ass'n Boards of Pharmacy, \$10 to the Conference of Pharmaceutical Law Enforcement Officials, \$15 to the 5th Dist. Boards and Colleges of Pharmacy, and \$2.50 to the Ass'n of Food and Drug Officials of the United States, be authorized to be paid. Motion carried.

Moved Mr. Deterling, seconded Mr. Pasternacki, that \$1,000 be turned over to the Minnesota State Pharmaceutical Ass'n for the advancement of the Science and Art in Pharmacy, when the required number of pharmacist and assistant pharmacist renewal registration fees for 1944 have been paid in. Motion carried.

It was moved and seconded that the pharmacist registration renewal fee for 1944 be fixed at \$5; the assistant pharmacist registration renewal fee at \$3; and for those pharmacists and assistant pharmacists in the armed forces, the fee to be \$1; and the 1944-45 drug store permit fee at \$3. Motion carried.

Discussion was held in regard to giving an examination in March or April, and the possibility of giving the practical work only. This would take care of those who, since taking the written and identification examinations, have completed their one year of drug store experience and have only the practical work to take. No action was taken as to dates, but it was left to the secretary to check into the matter and advise as to the best dates for this meeting.

Moved by Mr. Nelson, seconded by Mr. Feit, that the secretary be authorized to issue a citation for Harold W. Smetana, a registered pharmacist, to appear before the Board of Pharmacy for a hearing in the matter of conduct unbecoming a pharmacist. Motion carried.

In further discussing the case of Bernice L. Murdock, it was moved by Mr. Feit, seconded by Mr. Deterling, that the motion passed on January 13 be re-considered. Motion carried. (Mr. Feit withdrew his motion, and Mr. Deterling withdrew his second to the motion passed on January 13.)

It was moved by Mr. Deterling, seconded by Mr. Nelson, that

Whereas, the State Board of Pharmacy has duly considered the evidence adduced at the hearing upon the charges preferred against Bernice L. Murdock, and the arguments of her counsel, therefore

Be it Resolved by the State Board of Pharmacy this 14th day of January, 1944, that said Bernice L. Murdock be and hereby is found guilty of immoral, dishonorable, and unprofessional conduct, and that as punishment therefor her license to practice pharmacy be suspended for a period of ninety (90) days from the date of the service of such suspension upon her. Motion carried.

Moved by Mr. Feit, seconded by Mr. Deterling, that the members of the Board and the secretary be sent as delegates to the meeting of the 5th District of Boards and Colleges of Pharmacy to be held in Aberdeen, South Dakota, May 8 and 9, 1944. Motion carried.

Moved by Mr. Pasternacki, seconded by Mr. Deterling, that the secretary be sent as delegate to the meeting of the Ass'n of Food and Drug Officials of the United States to be held in St. Louis. Motion carried.

It was moved and seconded that the motion passed by mail ballot October 21, 1943 be ratified. Motion carried.

Motion is as follows: Moved by Mr. Nelson, seconded by Mr. French,

The secretary informed the Board that the State Weights and Measures Department were continuing the inspection of prescription scales and weights in drug stores; that up to this time 360 scales and 11,343 weights had been checked.

Both the secretary and Mr. Cleary, the chief inspector, talked at some length in regard to the sale of dangerous drugs by certain drug stores in the Twin City area. Some of these drugs, barbitals in particular, are being sold over-the-counter to addicts and transients who frequent certain areas. Purchases of these barbitals could not be made by regular shoppers, it was found, so arrangements were made to have an informer make such buys. Quite a number of buys have been made, both from registered pharmacists and unregistered clerks. The Board felt action should be taken against those druggists where these violations were flagrant, and that they should be brought into court and prosecuted.

This being the annual meeting of the Board, election of officers for the year beginning February 1, was next in order.

Mr. Feit was asked to take the chair.

Moved by Mr. Deterling, seconded by Mr. Pasternacki, that J. N. French be elected president. Motion carried.

Moved by Mr. Nelson, seconded by Mr. Pasternacki, that B. A. Deterling be elected as vice president. Motion carried.

Moved by Mr. French, seconded by Mr. Pasternacki, that Frank W. Moudry be re-elected secretary. Motion carried.

Moved by Mr. Deterling, seconded by Mr. Pasternacki, that Effie M. Swanson be elected assistant secretary. Motion carried.


Moved Mr. Nelson, seconded by Mr. Pasternacki, that L. J. Cleary be retained as chief inspector. Motion carried.

At 2:00 P.M. the Board met in Parlor C of the Nicollet Hotel. All members of the Board and the secretary were present. The meeting was called to order by President French.

First order of business was hearing of the case against Edward Langer, a registered pharmacist, owner of the Lincoln Drug Company, 401 Nicollet Avenue, Minneapolis, Minnesota, who had been cited to appear to show cause, if any, why his license to practice pharmacy should not be revoked, cancelled and set aside for immoral, dishonorable and unprofessional conduct, more particularly that on or about January 11, 1944 he did unlawfully sell and dispense to one Gust C. Lange a barbitol drug without a prescription as required by law, and on the further ground that on March 21, 1944 he was convicted in district court of the State of Minnesota, County of Hennepin, Fourth Judicial District, of a gross misdemeanor, to-wit: the unlawful selling of barbitol without a prescription having been issued therefore in the manner provided by law and was sentenced to pay a fine of \$500 or a term of not to exceed six months in the City Workhouse.

April, 1944

Mr. George Sjoselius, assistant attorney general, was the legal counsel for the Board and he opened the case against Mr. Langer.

Mr. Langer was not represented by legal counsel and when asked by Mr. Sjoselius if he admitted the charge, he replied that he did. After the hearing was completed, Mr. Langer left the room and the Board then proceeded to discuss the matter.

It was moved by Mr. Feit, seconded by Mr. Deterling, that final disposition of the case be held up until Friday, April 21. Motion carried.

At 2:50 o'clock P.M. the case against Harold W. Smetana was opened, he having been cited to appear before the Board to show cause, if any, why his license to practice pharmacy should not be revoked, cancelled and set aside and he be debarred from practicing pharmacy in the State of Minnesota, for immoral, dishonorable and unprofessional conduct as follows: 1) That on or about April 9, 1943, he did unlawfully sell or furnish to one Lorraine Dorothy Erickson Granaas certain instruments or articles to be used for the purpose of causing a miscarriage; 2) That on the 14th day of July, 1943, he was convicted in the District Court of the State of Minnesota in and for the county of Hennepin, Fourth Judicial District, of a gross misdemeanor, to-wit: Practicing Healing Without a Certificate of Registration in Basic Sciences.

Mr. Sjoselius opened the case against Mr. Smetana and read the complaint. Mr. Smetana denied the first charge, but admitted the second charge. Mr. Smetana was then excused from the room, whereupon the Board discussed the charges against him.

It was moved by Mr. Feit, seconded by Mr. Deterling, that the first charge be dismissed and that the Board proceed on the second charge. Motion carried.

Mr. Smetana was recalled and questioned at length and upon completion of the hearing, he was excused.

It was moved by Mr. Feit, seconded by Mr. Deterling, that final disposition of the case be withheld to Friday, April 21. Motion carried.

The Board adjourned to meet again Friday morning at the College of Pharmacy to give the examination in identification.

All of the above appeared in person before the Board and were interviewed and their applications checked. They were given the written examination in Jurisprudence required of reciprocal applicants.

Axel Olson appeared before the Board applying for re-admittance as a pharmacist, he having been dropped as of March 4, 1943 for non-payment of fees for renewal of his registration. The records showed he was in arrears for years 1941, 1942, 1943, 1944, total \$20. There is a re-admittance fee of \$25 in addition if granted re-registration.

Friday afternoon. The Board met in Parlor B, Nicollet Hotel, 2 P.M. All members of the Board were present, also secretary Moudry and inspector Cleary.

The following named pharmacists had been asked to appear before the Board in regard to the conduct of their stores and the sale of dangerous drugs over the counter to an informer, Gust C. Lange, under the direction of inspector Cleary. Purchase made in each case was that of Sodium Phenobarbital in yellow capsules called "yellow jackets", a name used by those in the habit of buying this particular drug.

These so-called "yellow jackets" had been analyzed by Dr. Charles O. Wilson, consulting chemist for the Board of Pharmacy, and were found to be Sodium Phenobarbital.

These registered pharmacists admitted they had sold this drug over the counter to our informer, Gust C. Lange, without have a prescription for same.

President French reprimanded these men severely for their conduct as pharmacists in selling dangerous drugs to the public without prescriptions for same, which was in violation of the Barbitol Law and the Board regulation. He told them they were bringing disrespect upon the profession of pharmacy and that if they were again called before the Board for a similar sale of dangerous drugs, the Board would deal severely with them and that it might mean revocation of their licenses.

April, 1944

In each case they admitted they were wrong and assured the Board it would never happen again, and that they would take the full responsibility of seeing that other employees in the stores of which they are in charge, did not make sales of drugs over the counter which are restricted by law or regulation to be sold only on prescription.

Fred Kersch, registered pharmacist and owner of the Nico-Lake Drug, 2 E. Lake Street, Minneapolis, appeared before the Board. He was charged with the sale of Nembutal in his store by one of his pharmacists. Mr. Kersch admitted that his pharmacist had occasionally sold these dangerous drugs without a prescription and without his knowledge or authority; that he personally had made no sales. He also informed the Board that the pharmacist who had made the sale is not with him, that he is now out of the State. He assured the Board he would co-operate and see that no sales of these dangerous drugs would be made over the counter by anyone in his employ.

President French warned Mr. Kersch that the sale of these drugs was a serious violation and that if he was called before the Board again on a similar charge, the Board would take severe action, which would possibly mean revocation of his pharmacist license.

It was moved by Mr. Deterling, seconded by Mr. Pasternacki, that

WHEREAS, the State Board of Pharmacy has duly considered the evidence presented at the hearing upon the charges preferred against Harold W. Smetana, therefore

BE IT RESOLVED by the State Board of Pharmacy this 21st day of April, 1944, that said Harold W. Smetana be and hereby is found guilty of immoral, dishonorable and unprofessional conduct, having been convicted of a gross misdemeanor, to-wit: Practicing Healing Without a Certificate of Registration in Basic Sciences, and that as punishment therefor his license to practice pharmacy be suspended for a period of six (6) months from April 21, 1944. Motion carried.

On further discussion of the hearing of the case against Edward Langer, which was held on the previous day, it was felt inasmuch as Mr. Langer had been fined \$500 for the unlawful sale of barbital without a prescription having been issued therefor; and further, this being his first offense,

It was moved by Mr. Nelson, seconded by Mr. Feit, that no further action be taken by the Board against Mr. Langer in this matter. Motion carried.

April 22, 1944. The Board met at its rooms at the Nicollet Hotel, 10:00 o'clock A.M.

Meeting called to order by President French.

The minutes of the January meeting were read and approved.

It was moved and seconded that the following named persons having obtained an average of 75 per cent or better but not below 60 per cent in any one subject be granted registration as pharmacists. Motion carried.

Moved by Mr. Pasternaacki, seconded by Mr. Feit, that Axel H. Olson be re-admitted as a pharmacist. Motion carried. (Dues in arrears for years 1941, 1942, 1943, 1944, \$20, and re-admittance fee of \$25 paid)

Moved by Mr. Nelson, seconded by Mr. Pasternaacki, that the application of Roderick Q. Johnson for registration as a pharmacist on the basis of his registration in Wisconsin be tabled as it appears from his application he is not eligible if date of his registration as a pharmacist in Wisconsin prior to graduation from the College of Pharmacy, University of Wisconsin, is correct. Motion carried. The secretary was instructed to get further information in regard to this matter.

Moved by Mr. Pasternaacki, seconded by Mr. Deterling, that the application of S. H. Nicholson for registration on his South Dakota certificate be denied as he did not meet with the requirements for examination in Minnesota at the time he was examined and registered in South Dakota. Motion carried.

(Mr. Nicholson appeared before the Board at the January meeting but had not been able to get his application and other material completed to present to the Board at that time, hence these were filed with the secretary at a later date and it was then found he was not eligible for reciprocity in that he had not successfully completed two years of college of pharmacy work, which was required if no drug store experience had been obtained prior to April 23, 1919.)

Moved by Mr. Pasternaacki, seconded by Mr. Nelson, that two delegates be sent to the convention of the National Association Boards of Pharmacy, and the Conference of Pharmaceutical Law Enforcement Officials, to be held in Cleveland, September 7-10; and one delegate to be sent to the convention of the National Association Retail Druggists, date as yet not set. Motion carried.

Moved by Mr. Deterling, seconded Mr. Feit, that the secretary get the dates of the next graduating class at the College of Pharmacy and then set the dates for the next examination to be given by the Board. Motion carried.

April, 1944

The secretary brought up the matter of moneys turned over to the Minnesota State Pharmaceutical Association in 1943, stating \$2,000 had been sent, but that a total of 2218 pharmacists and assistant pharmacists had renewed their registrations during that year. He also stated that the law provides that the Board may in each year turn over to the Minnesota State Pharmaceutical Association for the advancement of the science and art of pharmacy, out of the annual fees collected by it, such sum as it may deem advisable, not to exceed one dollar for each pharmacist and assistant pharmacist who shall have paid his renewal fee during such year.

The secretary also read a motion passed by the State Association in regard to this matter which said in part it was hoped the Board would continue to turn over to the State Association the full \$1 for each renewal fee. The financial statement of the State Association for year ending January 31, 1944 was also presented.

Moved by Mr. Feit, seconded by Mr. Pasternaoki, that \$218 be turned over to the Minnesota State Pharmaceutical Association out of the funds of the Board of Pharmacy, which is balance due for 1943. Motion carried.


The secretary read a letter from Mrs. O. B. Sjurseth, Lakota, No. Dak., in regard to her husband who died January 4, 1944 and who had been registered by reciprocity August 26, 1943. Mrs. Sjurseth made the request that the \$25 reciprocity fee be refunded, if possible, as Mr. Sjurseth had not practiced in Minnesota since registration, which was but a few months prior to his death, as she was badly in need of funds.

Moved by Mr. Nelson, seconded by Mr. Pasternaoki, that the \$25 reciprocity fee paid by O. B. Sjurseth (now deceased) be refunded to Mrs. Sjurseth, provided this is within the rights of the provision of law. Motion carried.

The secretary was instructed to ascertain this fact from the attorney general before proceeding to carry out the directive of the above motion.

Nothing further coming before the Board, on motion adjourned.

August 30, 1944. The Board met at 9:30 A.M. at the Nicollet Hotel to consider the applications filed for reciprocal registration. Applications had been received from the following:

All of these applicants had been notified to appear before the Board and they appeared at the appointed time.

Each applicant was interviewed by the Board and application and other data checked, after which he was given the examination in jurisprudence required of reciprocal applicants.

One applicant, Elizabeth Borovsky, appeared before the Board in the matter of being readmitted as a pharmacist, she having been dropped as a pharmacist because of non-payment of dues for renewal of her registration.

The secretary advised that the records showed Miss Borovsky had been registered as a pharmacist on March 11, 1932, certificate No. 8126; that the last year she had renewed her registration was for 1936; that she had been dropped as of March 4, 1939. The amount of dues in arrears for years 1937-1944 inclusive is \$40, readmittance fee \$25, or a total due of \$65.

Miss Borovsky also was given the written examination in jurisprudence.

The Board adjourned for lunch.

At 2:30 o'clock P.M. the Board met in Parlor J-K, Nicolllet Hotel, for a hearing in the case of Edwin H. Whittaker of Duluth, Minnesota, who had been cited to appear on September 17, 1944 to show cause, if any, why his license to practice pharmacy should not be revoked, cancelled and set aside, and he be debarred from practicing pharmacy in the State of Minnesota for immoral, dishonorable and unprofessional conduct on the ground that on the first day of April, 1944 he was convicted in the District Court of the United States, District of Minnesota, Fifth Division, of a felony, to-wit: combining, conspiring, confederating and agreeing to violate the provisions of the Harrison Narcotic Law of December 17, 1914, as amended, and to violate the provisions of the laws of the United States relating to the making, forging, counterfeiting or altering bonds, bids or public records.

Mr. Whittaker waived the right of the twenty days' notice to which he was entitled, which was the reason he appeared on this date. He was represented by counsel, Royal G. Bouschor.

All of the members of the Board, the secretary, and the Board inspector L. J. Cleary, were present; also Mr. Crisler, district supervisor of the Bureau of Narcotics.

George Sjoselius, deputy attorney general, was the legal counsel for the Board and he opened the case against Mr. Whittaker.

To the question put by Mr. Sjoselius as to what plea he wished to make, Mr. Bouschor made the following statement: "There is only one thing to make, I believe, is guilty, and that there are extenuating circumstances, because the record itself shows a conviction there and a plea of guilty."

Upon completion of the hearing, Mr. Whittaker was excused.

It was moved and seconded that action on this matter be deferred until the meeting of the Board in January, 1945. Motion carried.

August 31, 1944. The Board met at its rooms at the Nicolllet Hotel, 10:00 o'clock A.M., president French presiding.

The minutes of the April meeting were read and approved.

It was moved and seconded that the following named persons having obtained

It was moved and seconded that Elizabeth Borovsky be re-admitted as a pharmacist. Motion carried. (Dues in arrears for years 1937-1944 inclusive \$40, and re-admittance fee of \$25 paid)

In the matter of the application for reciprocal registration filed by Roderick Q. Johnson, which was tabled from the last meeting, the secretary read a letter received from the secretary of the Wisconsin Board which indicated no adjustment in this case could be made relative to dating his registration in Wisconsin after having graduated from the Wisconsin University College of Pharmacy. Mr. Johnson took the examination in Wisconsin before he was a graduate of a college of pharmacy and his registration was dated as of that date also, hence he was not eligible to take the examination in Minnesota when he took examination in Wisconsin.

It was moved and seconded that the application be continued on the table. Motion carried.

The secretary took up the matter of the readmittance of Frank E. McKnight as a registered pharmacist in Minnesota, he having been registered by examination on April 30, 1919, certificate No. 4533, and dropped from the records as of March 4, 1927 due to non-payment of renewal fees. The last year for which he had renewed his registration was 1924.

Mr. McKnight was advised by letter that he would be required to appear in person before the Board, pay up all dues in arrears, plus a readmittance fee of \$25, and also write an examination on the pharmacy laws and other laws pertaining to the practice of pharmacy in Minnesota. In reply Mr. McKnight wrote that in view of the shortage of pharmacists in the pharmacy in Fulton, N. Y. where he was employed, the restrictions and conditions governing travel at this time due to the war, it would be impossible for him to meet with the Board to make his application in person for readmittance.

With his letter Mr. McKnight submitted two affidavits, one from a doctor in Fulton, N. Y., Dr. Anthony J. Cincotta, who certified he had known Mr.

McKnight for the past 15 years; that said Frank E. McKnight had been employed by the Buell Pharmacy and the Wayne Pharmacy in Fulton, N. Y. during that time; that Mr. McKnight was ethical, capable, qualified and safe to practice pharmacy.

The other affidavit was from John A. Buell, a duly licensed pharmacist in the State of New York, that during the past 15 years he had practiced pharmacy in Fulton, N. Y.; that during that time said Frank E. McKnight had assisted him in the practice of pharmacy and had been found to be honest, ethical, capable, qualified and safe to practice pharmacy.

It was moved by Mr. Pasternaacki, seconded by Mr. Deterling, that the requirement of personal appearance be waived in the case of Mr. McKnight, and that he be readmitted as a pharmacist in Minnesota upon payment of dues in arrears and the readmittance fee of \$25; and that further, upon his coming into Minnesota to practice pharmacy, he be required to take the written examination in jurisprudence. Motion carried.

It was moved by Mr. Deterling, seconded by Mr. Pasternaacki, that the following regulation passed July 16, 1938, be RESCINDED. Motion carried.

"That a pharmacy or drug store permit marked 'Limited Permit' be granted to such places of business selling drugs and having a registered pharmacist in charge, but no prescription department, hence no prescription equipment."

Moved by Mr. Pasternaacki, seconded by Mr. Deterling, that the secretary be authorized to expend moneys out of the funds of the Board, if necessary, in sustaining the regulations passed by the Board dealing with the issuance of drug store permits. Motion carried.

Moved by Mr. Feit, seconded by Mr. Deterling, that the secretary be instructed to consult with the attorney general in regard to the regulation pertaining to ownership of drug stores by the widow of the deceased pharmacist owner, amending the same to read "surviving spouse", etc., instead of "widow". Motion carried.

Moved by Mr. Pasternaacki, seconded by Mr. Deterling, that the secretary make application to the Civil Service Commission for a change in the classification rating of Effie M. Swanson, assistant secretary, from Clerk-Stenographer III to Executive I; and that she be granted an increase of \$10 per month effective October 1, 1944. Motion carried.

Moved by Mr. Nelson, seconded by Mr. Deterling, that the following named delinquent pharmacists, owing dues for 1942 and 1943, be dropped from the records of the Board and their registrations cancelled. Motion carried.





TWO HUNDRED NINETY-NINTH MEETING

MINNESOTA STATE BOARD OF PHARMACY

A special meeting of the Board of Pharmacy was held on October 6 and 7, 1944. This meeting had been called by President French for the purpose of studying and making plans for setting up a new procedure in the giving of examinations for licensure, and any other business that the Board felt it necessary to act upon.

President French called the meeting to order at 10:00 o'clock A.M. All members of the Board and the secretary were present.

On motion made, seconded, and carried, the reading of the minutes of the last meeting was dispensed with.

P. H. Costello, secretary of the National Association Boards of Pharmacy, Chicago, had been extended an invitation to sit in with the Board at this meeting.

President French called upon Mr. Costello to say a few words in regard to the over-all picture of examinations given by the various states, and also to comment upon the results obtained by any of the states who had tried the examination proposed by Dr. Robert L. Swain.

Mr. Costello pointed out that the only requirement the National Board had was that a mark be given the candidate in each of the following subjects: Chemistry, Materia Medica, Pharmacy, Practical, Pharmaceutical and Chemical Mathematics.

There was no specified time that the National Board required for the written and practical examinations, but the thoughts of those who were attempting to improve the examinations given, was that greater stress should be given to the practical, with the possibility of cutting down the time allotted for the written, and restricting the written to questions that were more practical.

After much discussion by the various members of the Board as to their ideas of what would be an improvement to their examinations, it was finally agreed that the following plan should be considered:

WRITTEN EXAMINATION

That a written examination be given in the following subjects:

Chemistry
Pharmacy
Materia Medica
Pharmaceutical & Chemical Mathematics
Jurisprudence

That the written examination should occupy one full day, ~~two subjects~~
to be given

PRACTICAL EXAMINATION

That one full day of practical work be given each candidate.

The practical examination to be given shall be prescriptions and/or preparations to be prepared by each candidate.

That each Board Member shall prepare prescriptions and/or preparations to be made by the candidate, not to exceed three per member for the first or trial examination, which number can be increased for later examinations if thought advisable.

Each Board Member shall supervise no more than five candidates in the dispensing laboratory at one time.

The prescriptions or preparations shall cover the following branches:

1. Those which fall in the chemical group and which will bring out or deal with the chemistry of the preparations, such as incompatibilities, chemical reactions, etc.
2. Internal preparations, prepared to bring out and deal with pharmacognosy, pharmacology, etc.
3. Lotions and ointments dealing with dermatology.
4. Eye, ear, nose and throat, oral antiseptics, and percentage solutions.
5. Dry preparations, powders, suppositories, pills.

SCORING OF PRACTICAL WORK

Cards will be used for each candidate covering the preparations to be dispensed. The candidate will be scored as to

Neatness	5 points
Technique	5 points
Method	15 points
Correct Weights & Measures	15 points
Labels - Directions	5 points
Dosage	5 points
Finished Product	<u>50 points</u>
Total	100 points

GRADING OF PRACTICAL WORK

The method used for grading the completed practical work shall be as follows:

1. Each candidate shall be given a total rating earned for each prescription and/or preparation prepared that is given by each examiner.
2. Marks received for each preparation given by the examiner shall be totaled and then divided by the number of preparations given by the examiner to get the average mark for each candidate.

3. The final average for the candidate's practical work shall be determined by adding up the marks given by each examiner for the work given the candidate, and this total shall be divided by five (this being the number of examiners giving the practical examination), and the result will be the candidate's final mark to be recorded for the practical examination.

ORAL EXAMINATION

That an oral examination shall be given by each member of the Board to each candidate.

That each Board Member shall prepare in advance approximately 50 questions, part of them dealing with the practical examination given, and the balance to be questions that are of a practical nature dealing with that particular subject or class of preparations.

That at least ten minutes' time be allotted each candidate per Board Member for the oral examination.

GRADING OF ORAL EXAMINATION

The method for grading the oral examination shall be as follows:

1. Each examiner shall give a mark in the oral examination for each candidate.
2. The oral marks received by the candidate from the five examiners shall be totaled and divided by five, the result being the candidate's mark to be recorded for the oral examination.

TOTAL GRADE AND GENERAL AVERAGE

The total grade of the candidate shall be based upon the mark received in practical work, mark received in oral, and marks received in each of the written subjects, which shall be totaled and divided by the number of subjects (seven) to arrive at the general average.

PASSING MARK

The passing mark shall be not less than 75 per cent, with not less than 75 per cent in the practical examination, and not less than 60 per cent in any other subject, to be eligible for registration as a pharmacist.

Board adjourned to meet again October 7, 1944.

October 7, 1944. Meeting called to order by President French.

The secretary reviewed the plan or model of the new type examination which had been worked out the previous day.

It was moved and seconded that this new type of examination as outlined, together with method of grading, be approved, and to be the type of examination to be given next January. Motion carried.

It was moved and seconded that the assignment of subjects be as follows: Motion carried.

Practical examination:

1. Prescriptions and/or preparations falling
in the chemistry group - - - - - John Nelson
2. Prescriptions and/or preparations for internal use
dealing with pharmacognosy, pharmacology, etc. - - - B. A. Deterling
3. Lotions and ointments dealing with dermatology - - - J. N. French
4. Prescriptions and/or preparations for eye, ear,
nose, and throat; oral antiseptics;
and percentage solutions - - - - - J. G. Pasternacki
5. Dry preparations, powders, suppositories, pills - - - Victor E. Feit

Written examination:

1. Chemistry - - - - - John Nelson
2. Materia Medica - - - - - B. A. Deterling
3. Pharmacy - - - - - J. N. French
4. Pharmaceutical and Chemical Mathematics - - - J. G. Pasternacki
5. Jurisprudence - - - - - Victor E. Feit

It was agreed that during the practical and written examinations, talking by the candidates and Board Members should be restricted to that which pertains to the examinations only so as to have as little distraction in the room as possible.

It was agreed that each candidate taking the examination be given a number for identification purposes instead of using his name on the examination papers. ✓

The following resolution, signed by each member of the Board, was read by Mr. French and presented to Mr. Moudry:

Be it hereby resolved by the Minnesota State Board of Pharmacy as follows:

Whereas, our Secretary, Frank W. Moudry, has long and faithfully served as secretary of this Board, and given unstintingly and untiringly of his time and services to it, an expression of sincere appreciation be given him by this Board at this time.

Be it further resolved that the Minnesota State Board of Pharmacy recognize and congratulate our secretary, Frank W. Moudry, on the outstanding study he has accomplished on vitamin therapy, and that the paper he delivered on this subject at the meeting of the National Association Boards of Pharmacy at Cleveland, Ohio, on September 8, 1944, was one of which we all are proud. Let it be further recorded that this paper was an outstanding summary of his understanding and study of his subject and was most favorably received by all.

Furthermore, be it resolved that this resolution be duly recorded and spread in the minutes of this meeting of the Minnesota State Board of Pharmacy as of this date.





Mr. Johnson is now a graduate of a recognized college of pharmacy and consequently is eligible for examination, hence the ruling that reciprocity privilege could be considered.

Nothing further coming before the Board, on motion adjourned.

THREE HUNDREDTH MEETING

January 8, 1945. The Board met at the College of Pharmacy, University of Minnesota, 9:00 o'clock A.M. for the purpose of giving the practical examination to the applicants having filed for same. The members present were President J. N. French, B. A. Deterling, John Nelson, J. G. Pasternacki and Victor E. Feit. Mr. French had been reappointed January 4 by Governor Edward J. Thye for another term of five years.

The following applicants had filed applications to take the entire examination:

The following named persons had made application to take the practical examination only as they had now completed the one year of practical experience required. At a previous examination they had taken the written work.

This was the first time the Board gave the new type of examination, and the practical took the entire day. Each candidate was given 15 prescriptions to compound, six in the morning and nine in the afternoon.

January 9, 1945. At 9:00 o'clock A.M. the Board met to give the Oral examination to all of the candidates.

At 1:15 P.M. the written examination in the subjects of Pharmacy, Jurisprudence, Pharmaceutical and Chemical Mathematics was given. This took the entire afternoon.

January 10, 1945. The Board met at 9:00 o'clock A.M. to give the balance of the written examination: the subjects Chemistry and Materia Medica. When this was completed the Board adjourned to its rooms at the Nicollet Hotel.

In the afternoon the Board met with its legal counsel, George Sjoselius, and many matters were discussed with him in regard to law enforcement, including action to be taken on violations of the Pure Drug Act as reported by our chemist after analyses have been made of drugs purchased from druggists, manufacturers and wholesalers.

At 4:00 o'clock P.M. the Board met to take action in the matter of the case of Edward H. Whittaker, which was tabled from the August meeting. The meeting took place in Room 806, Nicollet Hotel, Minneapolis, Minnesota, and all members of the Board were present, also George Sjoselius of the attorney general's office.

Mr. Whittaker appeared without legal counsel.

Mr. Whittaker was questioned in regard to what disposition he had made of his narcotic license, and he informed the Board that he had turned in the license and the permit within a week from the hearing, which was held August 30, 1944; that he had sent it to the Collector of Internal Revenue.

Upon being asked what disposition he had made of his stock of narcotics on hand, he advised they were all locked up tight; that he had a very small stock.

Mr. Moudry told Mr. Whittaker he should make an inventory of the narcotics on hand and send same to the Federal Narcotic Bureau, Mr. Crisler, Minneapolis; that possibly he might be able to dispose of the stock to some local druggist. Mr. Whittaker said he would inventory the narcotics and send to the Narcotic Bureau; that whatever the Board wished, he would do.

Mr. Whittaker was advised his case would be tabled until the July meeting of the Board, and pending his good conduct in the drug store, final disposition will be made at that time; that he was free to operate his store.

Mr. Sjoselius stated no doubt Mr. Whittaker understood from the hearing held in August relative to the attitude of the Board in regard to his engaging in any narcotic business. Mr. Whittaker replied "I am sure I will not apply. I will do as you suggested, make an inventory of the stock and dispose of it the best I can."

Mr. Whittaker was then excused.

The matter of the sale of vitamins came up for discussion, and Mr. Sjoselius informed the Board that the contemplated action being brought against the Board for restricting the sale of vitamins to drug stores only had been withheld waiting the outcome of a case in New York which the grocers have brought against the New York Board of Pharmacy on a similar opinion from the New York Attorney General restricting the sale of vitamins to drug stores.

The Board discussed the advisability of waiting for the results of that case, or whether action should be brought here in Minnesota to determine the validity of the Attorney General's opinion.

It was moved by Mr. Deterling, seconded by Mr. Nelson, that Attorney General Burnquist be requested to begin preparation of legal proceedings to prevent the illegal sale of vitamins. Motion carried.

It was moved and seconded that travel and subsistence expense to New York and elsewhere in preparation of the vitamin case be paid out of the funds of the State Board of Pharmacy. Motion carried.

January 11, 1945. The Board met at its rooms at the Nicollet Hotel, 10:00 O'clock A.M. to consider the reciprocal applications filed for registration as pharmacists. Applications had been received from the following:

These men appeared before the Board and were interviewed and their credentials checked. They were given the written examination in jurisprudence required of reciprocal applicants.

Ayao George Tanbara, registered by examination as a pharmacist in Idaho, appeared before the Board in regard to reciprocating, but he did not have the official reciprocity application, only the preliminary blank to present to the Board. He stated he had wired the Idaho Board for confirmation of his registration, his grades, and dates of practical experience prior to his registration, but this had not been received up to the time he appeared before the Board.

He was questioned in detail as to his qualifications, drug store experience, college of pharmacy graduation, etc. Mr. Tanbara advised he would immediately send the preliminary blank to the secretary of the National Association Boards of Pharmacy and as soon as he had been able to get same completely filled out, it would be sent to the Board office. Mr. Tanbara was informed that he would be required to write an examination in jurisprudence if, upon receipt of his application, he was found to be eligible for reciprocity.

Edward J. King appeared before the Board in regard to being re-admitted as an assistant pharmacist, he having allowed his registration to lapse in 1931 for non-payment of renewal fees. The Board questioned Mr. King as to whether he had been engaged in any work connected with pharmacy during this period of years, and he stated that for almost three years now he had been employed in the Heinz Drug Store at Hastings and felt that he was capable of assuming the duties of an assistant pharmacist, if he was reinstated. Also that it was his desire to continue to be actively engaged in pharmacy.

The following persons appeared in person in regard to their applications for opening new drug stores:

George Rogentine (new store in Owatonna)
Vincent Kenjoski (new store in Osseo)
Argyll W. Peterson (new store in Melrose)

The Board advised each one that it did not look with favor upon the opening up of new drug stores during the war emergency, particularly in areas that were now adequately served by pharmacies; that the shortage of pharmacists was becoming acute as there were not enough pharmacists at this time to take care of the requirements of the present pharmacies now in operation; and further, that it was difficult for the Pharmacy Advisory Committee to Selective Service to continue to ask deferment of pharmacists on the grounds that they were essential to the public health needs if more and more permits were granted to open new stores.

Mr. Peterson stated he would be glad to co-operate with the Board in its efforts to curb the opening of more new stores and withdrew his application for a permit to open a new store in Melrose.

The Board expressed its appreciation to Mr. Peterson for his willingness to co-operate in this matter and stated his application would be held in abeyance and would be the first to be acted upon should any other application be received for a permit to open a new store in Melrose.

Mr. Kenjoski was advised to secure further information in regard to his draft status which might make it necessary for him to alter his plans in regard to opening of a store. He stated he would do this and that he would not go ahead with any further plans until he had made further inquiry into his draft status.

Mr. Rogentine did not feel inclined to withdraw his application, stating he and A. G. Wolbert, both registered pharmacists, had severed their connections with Lederle Laboratories and had made arrangements for a location, in fact were already operating as a lunch and confectionery; that Owatonna had always had four drug stores, hence they were desirous of opening this new store which would not increase the number of drug stores over the number which had formerly been in operation.

The Board suggested that possibly the present store could be continued to be run as a lunch and confectionery for the time being and that Mr. Rogentine accept a position as a registered pharmacist until such time the war clouds had lifted and the shortage of pharmacists had eased up.

However, Mr. Rogentine seemed determined in his effort to secure a permit to open a new store and hoped the Board would act favorably upon the application.

John Mausbach had been called to appear before the Board for reprimand in view of conduct unbecoming a pharmacist, he having been charged on November 2, 1944 with using abusive language, and was summoned to appear in Municipal Court in Little Falls on the same date, at which time he plead not guilty. The case was continued to November 13, when he plead guilty and was fined \$20 and costs.

The president of the Board read a letter from Charles A. Fortier, City Attorney of Little Falls, setting forth the record of convictions against Mr. Mausbach.

Mr. Mausbach, upon being questioned in regard to what had transpired on November 2, 1944, what he had said, whether it occurred in his store or outside, stated he could not remember. He stated he did not remember whether he was intoxicated, did not think he had been drinking; that he had discontinued the sale of liquor in his store, and did not drink any more, that is he was not a drinking man at this time.

When asked if he was using intoxicating liquor at all, he said "no", but upon being questioned further, he admitted he might take one or two drinks; that ever since the time he was called before the Board a couple of years ago he had been a changed man, that he was not drinking.

However, he made a promise he would quit drinking.

President French told Mr. Mausbach that if any further complaints come in, or if we find his conduct is unbecoming to a pharmacist, it would mean citing him for a hearing before the Board of Pharmacy, which might mean revocation of his license as a pharmacist.

Mr. Mausbach agreed that if he was brought into court any time after this for any reason, or if there was any reason for being called before the Board again, he stated the Board could revoke his license.

The Board adjourned until January 12.

January 12, 1945. The Board met at its rooms at the Nicollet Hotel, 10:00 o'clock A.M., president French presiding.

The minutes of the August meeting and the special meeting held October 6 and 7 were read and approved.

It was moved and seconded that the following named persons having obtained an average of 75 per cent or better, at least 75 per cent in the practical work, and not below 60 per cent in any one subject be granted registration as pharmacists. Motion carried.

Moved Mr. Pasternacki, seconded by Mr. Feit, that Ayao George Tanbara be granted registration as pharmacist on his Idaho certificate, provided his application for reciprocity and other credentials meet with the requirements of the Board upon his filing same with the Secretary. Motion carried.

The secretary took up the matter of the readmittance of Marvin R. Thompson as a registered pharmacist in Minnesota, he having been registered by examination on July 22, 1926, certificate No. 7499, and dropped from the records as of March 4, 1934 due to non-payment of renewal fees. The last year for which he had renewed his registration was 1931.

Moved by Mr. Nelson, seconded by Mr. Pasternacki, that the requirement of personal appearance and examination in jurisprudence be waived in the case of Mr. Thompson, president of Wm. R. Warner & Company, New York, and that he be readmitted as a pharmacist in Minnesota upon payment of dues in arrears and the readmittance fee of \$25. Motion carried. (Dues in arrears 1932-1944 inclusive, total \$65; readmittance fee \$25; total \$90 have been paid.)

The secretary presented the financial report for the year ending December 31, 1944, and each Board Member was given a copy. Receipts for the year totaled \$17,601.90; disbursements were \$20,812.58. Balance on hand \$13,865.54.

F. W. Hogan, Foley, Minnesota, a registered pharmacist, had been requested to appear before the Board as complaint had been received that he had sold Dover's Powder over the counter without a prescription, this coming under the State Narcotic Act. Mr. Hogan appeared and the Board questioned him at length in regard to the sale of narcotics, his knowledge of both the Federal and State Narcotic requirements and his compliance in regard to same. Mr. Hogan advised he had had no intention of violating any law, but that it had been carelessness on his part, that he would not let this happen again. The Board advised him in regard to the requirements of the Narcotic Acts; that it was his duty as a pharmacist to see that these laws were complied with.

It was moved and seconded that the bond premium for the secretary's bond be paid out of the funds of the Board. Motion carried.

It was moved and seconded that the membership fees of \$25 to the National Association Boards of Pharmacy, \$10 to the Conference of Pharmaceutical Law Enforcement Officials, \$15 to the 5th District Boards and Colleges of Pharmacy, and \$2.00 to the Association of Food and Drug Officials of the United States, be authorized to be paid. Motion carried.

It was moved and seconded that \$1,000 be turned over to the Minnesota State Pharmaceutical Association for the advancement of the Science and Art in Pharmacy. Motion carried.

It was moved and seconded that the pharmacist renewal fee for 1945 be fixed at \$5; the assistant pharmacist renewal fee at \$3; and for those pharmacists and assistant pharmacists in the armed forces, the fee to be \$1; and the 1945-46 drug store permit fee at \$3. Motion carried.

Moved by Mr. Pasternacki, seconded by Mr. Nelson, that the secretary be paid travel and subsistence expense, in the event it is necessary for him to make any trips to secure data and information, witnesses, etc., in the preparation of the vitamin case. Motion carried.

Moved by Mr. Nelson, seconded by Mr. Deterling, that John Mausbach be placed on indefinite probation, and his appearance before the Board again for reasons of conduct unbecoming a pharmacist would mean citation before the Board, which could mean revocation of his certificate. Motion carried.

In the matter of Edward J. King's application for readmittance as an assistant pharmacist, it was moved and seconded that the same be tabled. Motion carried.

A report of the analytical work being done and some of the results obtained was given by Dr. Charles O. Wilson, chief consulting chemist for the Board, and under whose supervision the analyses of drug samples is being done. The secretary brought up the matter in regard to repeated violations in the sale of substandard drugs. It was pointed out that some items purchased from druggists a second time have again failed to meet the U.S.P. and N.F. requirements upon being analyzed.

It was moved and seconded that those druggists from whom drug samples purchased were found to be substandard a second time, should be called before the Board for reprimand; and in the cases of manufacturers of substandard drug items, they should be brought into court. Motion carried.

It was moved and seconded that the motion passed January 10, 1944 allowing credit for drug store experience obtained during Easter and Christmas vacations while the college of pharmacy was on the accelerated plan, now be declared void as the college of pharmacy will again be on its regular schedule: September to June, which leaves the period June to September open for students to obtain practical experience. Motion carried. ✓

This means that beginning with the fall term September, 1944, no drug store experience obtained thereafter during Christmas and Easter vacations will be accepted for credit.

As this was the annual meeting of the Board, the election of officers for the ensuing year was in order.

It was moved and seconded that B. A. Deterling be elected president. Motion carried.

It was moved and seconded that John Nelson be elected vice president. Motion carried.

It was moved and seconded that Frank W. Moudry be re-elected secretary. Motion carried.

It was moved and seconded that Effie M. Swanson be re-elected assistant secretary. Motion carried.



It was moved by Mr. Nelson, seconded by Mr. French, that \$1000 be turned over to the Minnesota State Pharmaceutical Association for the advancement of the science and art in pharmacy, the total amount not to exceed \$2000 for the year. Motion carried.

In the matter of the request of Edward J. King, Hastings, Minn., for readmittance as assistant pharmacist, which had been tabled from the January meeting, it was the opinion of the Board that assistant pharmacists who had been dropped from the records could not be readmitted as such under the pharmacy law. The secretary was requested to get legal information from the attorney general in regard to this matter.

The secretary presented a letter from the Bureau of Narcotics, Washington, dated July 19, 1945, and signed by Will S. Wood, Deputy Commissioner of Narcotics, concerning a Minnesota pharmacist, Kermit B. Solheim of Farmington, Minn., who had been reported to the Board of Pharmacy office as having paid a fine of several hundred dollars by reason of his having become involved in narcotics. The Bureau in Washington had no record of Mr. Solheim paying a fine upon conviction in a court of law of any offense. The letter stated, however, that Mr. Solheim had been reported by narcotic officers on June 2, 1944 and charged with certain violations of the Federal narcotic law; that on January 5, 1945, this case was closed by the acceptance of an offer in compromise of \$500 in lieu of prosecution.

The secretary was instructed to place the matter before the attorney general as to procedure and disposition. Mr. Solheim sold his store, the Hospital Pharmacy in Farmington, on March 10, 1945, and at the time of the Board meeting he was not practicing as a pharmacist in Minnesota.

Final action in the/Ed Whittaker of Duluth, was tabled until the January, 1946 meeting, and the secretary was instructed during the next six months to observe his operations.

The secretary called the Board's attention to the findings in the drug analysis work being supervised by Dr. Chas. Ol Wilson; that notices were being sent out to the druggists where drug samples did not meet the official requirements; that in the matter of prescriptions which had been filled and which did not meet the requirements, the druggists were notified by letter to call the Board of Pharmacy office for an appointment to discuss the matter. Those who were notified thus, either called by telephone and discussed the analysis with the secretary, or wrote in regard to same, or came to the office for an interview. A reprimand was necessary in some cases. In each case the pharmacist commended the Board for the work it was doing in maintaining a high standard of pharmaceutical practice, stating that these check-ups on the pharmacist's dispensing will keep him alert to his professional responsibilities.

It was moved by Mr. Feit, seconded by Mr. French, that the secretary discuss with Mr. Cleary, and be authorized to increase city travel expense on Board inspection work. Motion carried.

On motion duly made, seconded and carried, the following resolution was adopted:

WHEREAS there are certain drugs which as a result of action heretofore taken by the State Board of Pharmacy, may be sold in drug stores in Minnesota upon a physician's prescription only, and

WHEREAS as a result of extensive use or research it has become apparent that such drugs may be dispensed safely without a physician's prescription, they having been approved by the

Federal Food and Drug Administration for over-the-counter sale, and





THREE HUNDRED THIRD MEETING

October 20, 1945

A special meeting was called by President Deterling for October 20, 1945 in order to consider reciprocal applications which had been filed since the July meeting, and to discuss other matters with our legal counsel, such as vitamins, drug store ownership and returning veterans.

All members of the Board were present.

The Board met at the Nicolet Hotel in a room assigned on the mezzanine floor, and the meeting was called to order by President Deterling.

The following reciprocal applicants had been notified to appear and were present:

Eugene Forrest - registered in North Dakota
James P. Pompa - registered in Illinois
James Lueders - registered in Ohio

Each application was checked and applicant interviewed, after which he was given the written examination in Jurisprudence.

The secretary brought up the matter of experience gained under supervision of registered pharmacists in Army or Navy hospital pharmacies by those in the service, and after some discussion of the matter, it was thought best to consider each case individually when presented to the Board, interview the applicant, and then determine how much credit could be given the candidate towards his one year of practical experience required for examination.

The secretary brought up the matter of the work being done in analyzing the drug samples being purchased by the inspector, and the supervision of same by Dr. Wilson; also that Dr. Wilson has given extra service in the analysis of several prescriptions filled by druggists and brought into the office by persons for whom the preparation had been compounded, on the complaint that something was wrong, that certain results detrimental to their health and welfare was obtained in the use of the preparation.

At the request of the secretary, Dr. Wilson had personally analyzed a vitamin preparation by name of Vitola; and an over-the-counter sale of 5-grain Quinine, brought into the office.

~~The Board felt that Dr. Wilson should have some remuneration for this extra work he was called upon to do from time to time, and it was moved by Mr. Nelson, seconded by Mr. French, that Dr. Wilson be given a retaining fee of \$25 per month. Motion carried.~~ *Rescinded Nov. 8, 1946*

After discussion on the matter of the Board's regulation on drug store ownership, the secretary's office having been requested to send copies to several attorneys, the Gamble Stores Inc., etc., it was moved and seconded

In the matter of the application of Edward J. King who was registered as an assistant pharmacist on July 26, 1915 but who allowed his registration to lapse and as a consequence was dropped by the Board as of March 4, 1931. The secretary informed the Board of an attorney general's opinion holding it was not within the jurisdiction of the Board to re-register an assistant pharmacist as Chapter 103, Laws 1929, abolished the examination for registration as assistant pharmacist; and further that anyone who has once been

registered and has defaulted in the payment of fees may be reinstated within two years of such default without examination upon payment of arrears.

In view of the attorney general's opinion, it was moved by Mr. Pasternacki, seconded by Mr. Feit, that the application of Edward J. King for readmittance as an assistant pharmacist be denied. Motion carried.


It was moved and seconded that the application of Eugene Forrest for registration as pharmacist on his North Dakota certificate be granted. Motion carried.

MINNESOTA STATE BOARD OF PHARMACY

Three Hundred Fourth Meeting

January 21, 1946. The Board met in a special room, No. 346, Nicollet Hotel, Minneapolis, Minn., 9:30 o'clock A.M.

Members present were President Deterling, John Nelson, Victor E. Feit and J. N. French. Mr. J. G. Pasternacki was absent. Mr. Deterling had been reappointed on December 12, 1945 by Governor Edward J. Thye to serve another term of five years.

The Board spent the day interviewing applicants who had filed applications for reciprocal registration; also applicants who were desirous of taking the examination, having recently been released from active duty in the armed service of our country, but had not had all of the required one year of practical experience in a drug store, but in lieu therefore had had pharmacy work while in the service and wished to use this experience to make up the difference in the amount short of the one year practical experience required for examination.

The following had filed applications for reciprocity:

All of the above persons were present and each one was called before the Board and his application and credentials reviewed.

Before any of the applicants were called in, the secretary cited certain factors found to be predominant insofar as qualifying for reciprocity. These were, 1) many of the applicants had not been able to secure the one year practice of pharmacy subsequent to registration because of entering the service immediately upon becoming registered; 2) having taken the examination given by the Minnesota Board a number of years past but failing to pass.

The following did not have one year of practice of pharmacy after registration due to entering service:

Robert H. Bowles, Kenneth F. Crahan, J. H. Gitelis, Olaf Iverson, Harris M. Sessions, A. F. Wilhelm.

Abe Silver had taken the examination given by the Minnesota Board of Pharmacy in October, 1931 and failed.

It was moved by Mr. Nelson, seconded by Mr. Feit, that the following resolution be passed:

BE IT RESOLVED, that such persons making application for reciprocity into Minnesota some years later and having practiced pharmacy in the State from which he desires to reciprocate the one year required for reciprocity, be declared eligible for reciprocity privilege. Motion carried.

L. A. Swedien appeared before the Board in the matter of becoming readmitted as a registered pharmacist, he having been dropped for non-renewal of his registration as of March 4, 1944. Dues in arrears for years 1942, 1943, 1944, 1945, \$20; readmittance fee \$25; total \$45.

It was moved by Mr. Nelson, seconded by Mr. French, that Mr. Swedien be required to pass the practical examination given by the Board, and also take a written examination in Jurisprudence. Motion carried.

Each applicant for reciprocity was given a written examination in Jurisprudence. Ten in all.

At 1:00 o'clock P.M. Board adjourned for lunch.

The afternoon session was called to order at 2:00 o'clock P.M.

The following ex-servicemen had been notified to appear before the Board in view of the fact that they had not had one full year of practical experience in a drug store or pharmacy while in civilian life, but had obtained certain pharmacy experience while in the service, and wished to present this for acceptance by the Board of Pharmacy so as to be able to take the examination given this week—two for the practical and oral examinations only, and one for the entire examination.

Mr. Baukol appeared and stated he had been in the service since May, 1944, and had been discharged on October 22, 1945; that he had done pharmacy work under a registered pharmacist in the U. S. Naval Receiving Hospital pharmacy in San Francisco, Calif., and under a registered pharmacist in the San Leandro Naval Hospital Pharmacy. He desired to have this experience recognized by the Board so that he could qualify to take the practical examination to be given the following day. He also presented his honorable discharge for verification. The secretary informed the Board that Mr. Baukol had affidavits covering five months and two days in drug stores in Webster, So. Dak., and the amount of experience needed to qualify for the practical was six months and 28 days.

The Board advised that he should make every effort to secure affidavits from the pharmacists under whom he worked in the Naval hospitals.

It was moved by Mr. Nelson, seconded by Mr. French, that the experience obtained by Mr. Baukol in the San Leandro Naval Hospital Pharmacy, and the U. S. Naval Receiving Hospital Pharmacy, be credited towards the one year of practical experience necessary to be eligible to take the practical examination, and that Mr. Baukol be permitted to take the practical examination to be given January 22, 1946. Motion carried.

Edwin G. Kuhlmann appeared before the Board and stated he had been in the service since August, 1941, having been discharged from the Navy on October 16, 1945. He was desirous of taking the practical examination given the following day, having taken the written examination in July, 1941 and passed the same.

He had affidavits covering practical experience obtained in drug stores before entering the service and after discharge, totaling five months and seven days. He had filed affidavit from a pharmacist registered in the State of Virginia certifying that Mr. Kuhlmann had been under his supervision doing pharmacy work in the Norfolk Naval Hospital, Portsmouth, Va., for a period of five months and 16 days; and one from the commanding officer of the Medical Department, Coronado Height Annex, U. S. Naval Air Station, San Diego, Calif., as to doing pharmacy work there and also overseas in Tarawa and Tinian and Samoa, totaling one year and seven months.

Mr. Kuhlmann asked the Board to consider the affidavits covering two years and 16 days of pharmacy work obtained while in the service, with the possibility of allowing six months and 23 days' credit for this work, the amount of practical experience he was short in order to qualify for the practical examination.

Mr. Kuhlmann also asked as to the possibility of waiving the two year period within which an applicant, having taken the written examination and passed, must qualify for the practical examination in order not to have to retake the written, as he was inducted into service immediately following taking the written examination in July, 1941 and was not discharged until October, 1945.

It was moved by Mr. Nelson, seconded by Mr. Feit, that the pharmacy experience obtained while in service be recognized and that he be allowed six months and 23 days for this experience, the amount of practical experience he is short of the required one year to qualify for the practical examination; and further, that the rule of the Board requiring an applicant who takes the written examination only to qualify for the practical examination within two years, be waived in the case of Mr. Kuhlmann, and that he be permitted to take the practical examination to be given January 22, 1946. Motion carried.

Merlin H. Lee appeared before the Board in the matter of pharmacy experience obtained while in service, which was in the form of a letter from Lt. Commander D. E. Guernsey (MC) USN, stating that Mr. Lee was detailed to pharmacy work in the U. S. Naval Hospital, Base #8, under the supervision of George N. Wheeler, Ph.M. 2/c, registered pharmacist in State of Ohio, from July 1, 1944 to July 31, 1944. Mr. Lee stated he had tried to locate Mr. Wheeler through the Ohio State Board of Pharmacy, and was given an address in Ashland, Ky., but mail was returned.

Mr. Lee is desirous of qualifying to take the entire examination beginning January 22, 1946, and is short 14 days of the required practical experience, and is therefore asking that he be allowed credit for the 23 days of pharmacy work in the Naval Hospital above mentioned.

It was moved by Mr. Feit, seconded by Mr. Nelson, that the pharmacy experience obtained while in service be recognized and that he be allowed credit for 23 days, which will enable him to qualify for the entire examination. Motion carried.

Abner Lee, a registered pharmacist, and owner of a drug store at 801-4th Avenue So., Minneapolis, Minn., had been notified in person by L. J. Cleary, chief inspector, to appear before the Board for questioning in regard to the sale by him of Barbiturates in his pharmacy without a prescription.

At 3:45 o'clock P.M. Mr. Lee appeared as requested.

Mr. Cleary related the circumstances in regard to purchases of barbitals and dangerous drugs over-the-counter, which were sold by Mr. Lee in his

pharmacy located at 801-4th Avenue So., Minneapolis, Minn. Mr. Cleary stated he had made numerous calls to the pharmacy with a shopper and on April 2, 1945, May 14, 1945 and August 21, 1945 Nembutal was purchased without a prescription. Later he advised Mr. Lee of the purchases and told him it would be necessary for him to discontinue this practice or action would have to be brought against him. Mr. Cleary further stated that Mr. Lee told him he would sell no more barbitals or dangerous drugs except upon prescription, and that he would get the O.K. of the doctor for refills.

Upon being questioned by the Board as to reasons for his conduct in the sale of these items, Mr. Lee stated it had been carelessness on his part, that he had sold same to accommodate friends; that during the past six months or so he had mended his ways; that he was complying with the regulations and requirements governing the sale of barbital and dangerous drugs.

Mr. Cleary, at this point, informed the Board that he felt Mr. Lee was desirous of complying with the laws and to operate his store in accordance with same.

Mr. Lee was given a good talking to in regard to upholding the professional standards and ethics of pharmacy, and in complying with all of the regulations and laws governing the practice of pharmacy; that he should operate his store according to the highest standards possible so that as a pharmacist he would be a credit to his community.

It was pointed out to him that if any further complaints come in relative to these unethical practices being continued, the Board will of necessity proceed to take action.

Mr. Lee was dismissed with this warning.

Wesley W. Ahrens, a registered pharmacist and owner of a drug store at 3753 Nicollet Ave., Minneapolis, had been notified by L. J. Cleary, chief inspector, to appear before the Board relative to his conviction in municipal court on November 26, 1945 of selling liquor in his store without a license. Mr. Ahrens did not appear as he was out of town.

Nothing further coming before the Board, on motion adjourned to meet Tuesday morning, Jan. 22, 1946, 8:30 A.M., at the College of Pharmacy, University of Minnesota, to begin giving the examinations for registration as pharmacist to candidates appearing for same.

January 22, 1946. The Board met at the College of Pharmacy, University of Minnesota, at 8:30 o'clock A.M. to give the practical examination. All of the members were present.

The following named persons were present to take the practical examination:

The practical examination occupied the entire day - 8:30 A.M. to 5:30 P.M., with one hour for lunch. Each candidate was given 12 prescriptions to compound.

January 23, 1946. The written examination occupied the entire day, from 9:00 o'clock A.M. to 12:30 P.M., and 1:45 P.M. to 5:00 P.M. Chemistry, Pharmacy, and Materia Medica were given in the morning. Jurisprudence, and Pharmaceutical and Chemical Mathematics were given in the afternoon. Eleven took the written as five had taken the written examination only at a previous examination.

January 24, 1946. The Board spent the morning giving the oral examination to all of the 17 candidates.

The Board adjourned to its rooms at the Nicollet Hotel to begin grading of the examination papers.

January 25, 1946. The meeting was held in the Board of Pharmacy rooms at the Nicollet Hotel. Meeting called to order by President Deterling at 9:30 o'clock A.M.

Legal counsel, George Sjoselius, was to be with the Board at 11:00 o'clock A.M. to discuss matters dealing with drug store permits, so pending arrival of Mr. Sjoselius the Board proceeded to review the applications filed for drug store permit, namely: Samuel C. Wakefield, Wayzata, Minn., who is not a registered pharmacist, to purchase controlling interest in the Community Drug Store, Wayzata, Minn.; and Gamble-Skogmo Inc., for opening of a new store at 5300-02 Lyndale Avenue So., Minneapolis, Minn. An open discussion was held on these two applications so as to be in position to dispose of the business after Mr. Sjoselius arrived.

When Mr. Sjoselius arrived he informed the Board that the Board could expect to have papers served on it by the grocer's association relative to the restriction of the sale of vitamins; that he had talked with Mr. Falharber and he informed him papers were being made out.

Mr. Sjoselius then talked on the regulation of the Board dealing with drug store ownership.

The application submitted by Gamble-Skogmo, Inc., for a license to own and operate a drug store at 5300-02 Lyndale Avenue So., Minneapolis, Minn., was considered.

It was moved by Mr. French, seconded by Mr. Pasternacki, that

WHEREAS, it appears from the application of Gamble-Skogmo, Inc., that the ownership and controlling interest is not held by pharmacists registered in the State of Minnesota, therefore

BE IT RESOLVED, that the application for registration of a pharmacy at 5300-02 Lyndale Avenue So., Minneapolis, Minnesota, and the issuance of a license be denied. Motion carried.

In the matter of the application from Samuel C. Wakefield for a license to operate the drug store known as Community Drug Store of Wayzata, Minnesota, it was moved by Mr. French, seconded by Mr. Pasternacki, that

WHEREAS, it appears from the application that the controlling interest in the ownership of the pharmacy is not held by registered pharmacists in the State of Minnesota, therefore

BE IT RESOLVED, that the issuance of a license be denied. Motion carried.

The secretary read letters from J. A. Garland of Northome, Minn., dated January 4 and 15, 1946, relative to his desire to open up a drug store in Northome. Mr. Garland, not being a registered pharmacist in Minnesota, was desirous of opening a store and employing a pharmacist to operate the store. This procedure does not conform with regulation No. 14 of the Board of Pharmacy dealing with ownership of drug stores.

The secretary also read the following petition:

Regulation No. 14 of the Board of Pharmacy provides that in cases of necessity permits may be issued to other than registered pharmacists for the operation of a drug store. It is this proviso that Mr. Garland requests the Board to consider when reviewing his application.

After considerable discussion by the Board and legal counsel, the secretary was instructed to make a thorough investigation of the need of a drug store in this community and to report his findings to the Board.

In the matter of Ed. Whittaker of Duluth, a registered pharmacist, who appeared before the Board on August 30, 1944 and again on January 10, 1945, to show cause why his certificate as a pharmacist in Minnesota should not be revoked in that he had been convicted for violation of the Federal Narcotic Act, final action and disposition of the case having been deferred by the Board pending his complying with stipulations of the Board in regard to his narcotic permit and narcotic drugs on hand, as well as his conduct in the operation of his pharmacy.

The secretary reported that upon investigation it was found that Mr. Whittaker had complied with the Board's request in disposing of his narcotics to the Federal Bureau of Narcotics, Minneapolis Division; that there was no fault to be found in the operation of his store during the period from January 1945 to date.

It was moved by Mr. Feit, seconded by Mr. Pasternacki, that the disciplining of Ed. Whittaker be terminated and that no further action be taken on this violation. Motion carried.

The secretary read his annual report and the financial statement for the year ending December 31, 1945.

The minutes of the May, July and October meetings were read and approved.

It was moved and seconded that the following named persons having received an average of 75 percent or better but not below 60 percent in any one subject, be granted registration as pharmacists. Motion carried.

It was moved and seconded that Joseph M. Nicola be granted registration on his Washington certificate when his official application for reciprocity and other credentials have been properly certified to and filed with the secretary. Motion carried.

Mr. Nicola appeared before the Board on January 24, but at that time he did not have his official reciprocal application entirely completed and certified to as he had not received it until late. However, he met the requirements for reciprocal registration except for incomplete blanks.

It was moved and seconded that the bond premium for the secretary's bond be paid out of the funds of the Board. Motion carried.

It was moved and seconded that the bond premium for the assistant secretary's bond be paid out of the funds of the Board. Motion carried.

It was moved and seconded that the membership dues of \$25 to the National Association Boards of Pharmacy; \$10 to the Conference of Pharmaceutical Law Enforcement Officials; \$15 to the 5th District Boards and Colleges of Pharmacy; and \$2 to the Association of Food and Drug Officials of the United States, be authorized to be paid. Motion carried.

It was moved and seconded that \$1,000 be turned over to the Minnesota State Pharmaceutical Association for the advancement of the Science and Art in Pharmacy. Motion carried.

It was moved and seconded that the pharmacist renewal fee for 1946 be fixed at \$5; the assistant pharmacist renewal fee at \$3; and for those pharmacists and assistant pharmacists in the armed forces, the fee to be \$1; and the 1946-47 drug store license fee be fixed at \$5. Motion carried.

It was moved and seconded that the secretary check the calendar and determine the most satisfactory dates in July for the next examination. Motion carried.

In the matter of a report as to a narcotic violation by a Minnesota Pharmacist, Kermit B. Solheim, while operating a pharmacy in Farmington, Minnesota, and which was brought to the attention of the Board at its July meeting, the secretary advised at this time that Mr. Solheim was operating a store at Dennison, Iowa.

The secretary also reported that a blank titled "Census of Pharmacists" had been mailed out to all pharmacists in Ramsey county in order to secure a survey as to educational qualifications, status of employment, store hours, workweek hours, wages, re-employment of pharmacists, etc., for the Council on Pharmaceutical Education. This was done to determine the replacement requirement of pharmacists in the future.

The secretary brought up the matter of restricting the sale of Penicillin to pharmacists.

The secretary brought up the question whether Amino Acids should be classified as drugs and the sale restricted to prescription.

It was moved and seconded that the members of the Board and the secretary be sent as delegates to the 5th District Meeting of Boards and Colleges of Pharmacy to be held in Detroit Lakes, Minn., June 24 and 25, 1946. Motion carried.

The question "Shall the Board offer to the pharmacists of the State free analysis of any preparations they may compound to determine their standard" was discussed at length, and it was agreed that this service be given free.

It was moved and seconded that beginning June 1, 1946, the Board of Pharmacy will establish a new service in that druggists making up U.S.P. and N.F. preparations in their pharmacies may send a sample of same to the office of the secretary, who will turn the sample over to Dr. Wilson, chief consulting chemist, to be analyzed so as to determine whether the compounded product meets the official standards. No fee will be charged for this analysis. Results of the analysis are to be mailed out as soon as received. Motion carried.

This being the annual meeting of the Board, election of officers for the year beginning February 1, was in order.

Moved by Mr. Feit, seconded by Mr. Pasternacki, that John Nelson be elected president. Motion carried.

Moved by Mr. Feit, seconded by Mr. Nelson, that J. G. Pasternacki be elected vice president. Motion carried.





May 6, 1946. Special meeting of the Board of Pharmacy called by President Nelson at the request of legal counsel, George B. Sjoselius, relative to the Board regulation on drug store ownership.

Meeting was called to order at 4:00 o'clock P.M. at the St. Paul Hotel, St. Paul, Minn. All the members of the Board were present—President John Nelson, B. A. Deterling, J. G. Pasternacki, J. N. French, Victor E. Feit .

Mr. Sjoselius reported that after considerable study and research relative to the Board's drug store ownership regulation, it was his opinion that the chances for it being upheld by the courts were doubtful, and if the Board desired to test the regulation the attorney general's office would not defend the case; that it would be necessary for the Board to secure outside legal counsel; and further, that the Board's funds could not be used for such service.

He then reported that he had heard from Dr. Robert L. Swain, who had sent him information in regard to cases dealing with pharmacists "in charge", which he had studied. Mr. Sjoselius stated he felt there was some possibility of curbing the ownership of drug stores by non-pharmacists under provisions of our law.

After considerable discussion on the whole subject, it was thought best by the Board to give this further study.

On motion made, seconded and carried, meeting was adjourned until the following day.

May 7, 1946. Meeting called to order by President Nelson at 4:00 o'clock P.M. All members of the Board were present, including the secretary and George Sjoselius, legal counsel for the Board.

The matter of the drug store ownership regulation was further discussed, and it was moved by Mr. French, seconded by Mr. Deterling, that the Board proceed along the lines suggested by Mr. Sjoselius in the matter of the provision of our law dealing with registered pharmacists in charge. Motion carried.

July 15, 1946. The Board met at the College of Pharmacy, University of Minnesota, Minneapolis, at 8:30 o'clock A.M. to give the written examination to those eligible to take same.

The secretary informed the Board that he had written the Minneapolis office of the U. S. Bureau of Narcotics and had requested information as to whether any of these applicants had violated any of the narcotic laws according to their records, and was advised by A. M. Bangs, District Supervisor, that they had no information on any of the individuals.

July 16, 1946. The practical examination occupied the Board the entire day. The morning session from 8:30 A.M. to 12:30 P.M., and the afternoon session from 1:15 P.M. to 5:00 P.M. Each candidate was given 15 prescriptions to compound, nine in the morning and six in the afternoon.

written examination when they had not had the one year of drug store experience required to be eligible for the entire examination.

Joseph L. Martin, the applicant for re-admittance, was present to take the practical examination. He had been informed when he appeared before the Board the previous day that he would be required to pass a practical examination. The preparations that he compounded during the morning did not meet the requirements; and he admitted that some of them he could not compound. The members of the Board interviewed him but his knowledge of pharmacy was not up-to-date, he having been in another line of work for many years. He was discouraged to continue the practical examination in the afternoon session as he had made such a poor showing in the morning's work.

July 17, 1946. The Board gave the oral examination in the morning. When this was completed, Board adjourned for lunch and then to meet later at the Nicollet Hotel.

At 2:00 P.M. the Board met at its rooms in the Nicollet Hotel. Several pharmacists had been notified to appear in the matter of violations of laws and reports of using intoxicating liquor in excess.

At 2:30 P.M. Wesley W. Ahrens, a registered pharmacist operating a pharmacy at 3753 Nicollet Ave., Minneapolis, Minn., appeared as notified. The secretary reported he had checked the records of the court as to Mr. Ahrens' conviction of the unlawful sale of liquor in his store, and found the following:

Nov. 28, 1945 - plead guilty, sentenced to 90 days in workhouse.
Stay of execution to Dec. 26, 1945.
Dec. 26, 1945 - Stay of execution to Jan. 14, 1946.
Jan. 14, 1946 - Stay of execution to Jan. 21, 1946.
Jan. 21, 1946 - Defendant committed.
Feb. 15, 1946 - Filed order to be released.
Defendant on parole to Feb. 7, 1947.

Mr. Ahrens admitted he had been involved, plead guilty, and convicted for the sale of liquor without a license. He was asked questions by President Nelson and members of the Board relative to the length of time he was selling liquor. He was severely reprimanded for his conduct, and the Board pointed out that it places a stigma not only on himself but on the profession of pharmacy as a whole. He assured the Board he had discontinued the sale of liquor for all time, and that his conduct in the future would be such that there would be no occasion for him to be called before the Board again on this charge; and further, that he would always conduct himself in a manner that would be of credit to pharmacy. The Board informed him if he was again called before the Board on a same charge, more drastic action would be taken.

Walter Johnson, registered pharmacist operating a pharmacy in Elk River, Minn., appeared at 3:00 P.M. The secretary reported that he had on several occasions had complaints in regard to Mr. Johnson being under the influence of liquor while in his store; and lastly, the State Board inspector on two recent visits to his store, both times found him in an intoxicated condition. Mr. Johnson had been warned in regard to this matter as the secretary had talked to him personally about it when visiting his store.

Mr. Johnson stated that he at times had taken a drink on the job but did not feel at any time he was under the influence of liquor to extent he could not carry on his duties as a pharmacist. President Nelson and members of the Board reprimanded him for his conduct, and told him if it was necessary for him to be again called before the Board on this matter, that more drastic action would be taken, probably suspension or revocation of his pharmacist license. Mr. Johnson informed the Board his conduct would be such he would never be called again.

Casper C. Hanson, a registered pharmacist operating a pharmacy in Herman, Minn., appeared before the Board at 3:30 P.M. to answer complaints received in regard to his use of intoxicating liquors to excess. The secretary reported to the Board that the doctor in Herman had reported to Mr. Deterling that Mr. Hanson was under the influence of liquor a good deal of the time and at times unable to fulfill his duties as a pharmacist. Under date of July 3, the secretary's office received a letter from Dr. C. E. Baker, Herman, Minn., in regard to Mr. Hanson being called before the Board. He made the statement that Mr. Hanson has snapped out of it and has been fine since, and further that he would like to see him continue on in Herman as long as he tends to business.

Mr. Hanson stated that he was under the influence of liquor at one time when a buddy of his from the war had visited him, but it was not a habit with him. President Nelson informed him that reports had come to our office that he had been under the influence of liquor on several occasions. Mr. Hanson told the Board he realized what he had done was wrong; was not in the best interest of pharmacy; was not good for his business; and assured the Board he appreciated the advice given him, and that there never would be an occasion for the Board to call him before them again on this charge. Mr. Hanson was informed that if he was again called before the Board on this charge, more drastic action would be taken, which would necessitate suspension or revocation of his pharmacist license.

Blair Vickerman appeared before the Board in regard to his application for reciprocal registration on basis of his registration as a pharmacist in Ohio, which he had just been able to get completed. The Board checked his papers and found them in order, and he was given the written examination in Jurisprudence.

The secretary presented several letters received from Sylvester Weiss of Pierz, Minn., who was desirous of purchasing the drug store now owned by Mrs. R. M. Duncan. Mr. Weiss is not a pharmacist and was advised that he was not eligible to own and operate a pharmacy in Minnesota. There were also letters from the Hon. Harold Knutson, Minnesota representative in the Congress of the United States, in his behalf.

The Board adjourned to mark the written work of the candidates.

July 18, 1946. The Board met in its rooms at the Nicollet Hotel. President Nelson called the meeting to order at 9:30 A.M.

FINDINGS OF FACT, CONCLUSIONS
OF LAW, AND ORDER

This matter came regularly on for hearing before the Minnesota State Board of Pharmacy on June 17, 1946, at 10 o'clock a.m. in Parlor H of the Nicollet Hotel, Minneapolis, Minnesota, on the application of Gamble-Skogmo, Inc. for a license to conduct a pharmacy at 5300 Lyndale Avenue South, Minneapolis, Minnesota. William P. Berghuis appeared for the applicant. J.A.A. Burnquist, Attorney General, and Geo. B. Sjoselius, Deputy Attorney General, appeared for the state.

Upon all the files and records herein, including the evidence adduced at the hearing, and being fully advised in the premises, the Minnesota State Board of Pharmacy makes the following findings of fact, conclusions of law, and order.

As findings of fact, the board finds:

1. That Orton N. Swenson is a registered Pharmacist.
2. That Orton N. Swenson does not have authority to -
 - (a) Prescribe general policies for the conduct of the pharmacy,
 - (b) Establish the accounting system and controls for the pharmacy,
 - (c) Select the bank for deposit of the pharmacy's cash receipts or to determine who may withdraw the money therefrom,
 - (d) Establish the hours during which the pharmacy will be open for business,
 - (e) Pay employees for services rendered,
 - (f) Pay state and federal taxes,
 - (g) Keep more than a record of daily receipts and disbursements,
 - (h) Determine the general policy of advertising for the pharmacy;
 - (i) Determine the policy on donations for the pharmacy,
 - (j) Purchase merchandise such as sick room supplies, drug sundries or other merchandise which are not drugs,
 - (k) Fix sale prices of merchandise such as drug sundries or other merchandise which are not drugs.
3. (a) That the height of the ceiling in the large store in which space is set aside for the pharmacy is 14 feet,
 - (b) That the height of the fixtures which serve as partitions of the space for the drug store is seven feet,
 - (c) That the height of the partitions setting off the space within the pharmacy in which prescriptions will be compounded and the drugs used therein will be kept is seven feet and the height of the ceiling over such space is 14 feet.

As conclusions of law, the board finds:

1. That Orton N. Swenson will not be in charge of the pharmacy as required by the Pharmacy Act of 1937.

2. That the keeping of drugs will not be properly safeguarded in the pharmacy.
3. That the method of operation of the pharmacy is not in the public interest or for the protection of the public health.

IT IS HEREBY ORDERED that the application of Gamble-Skogmo, Inc. for a license to conduct a pharmacy at 5300 Lyndale Avenue South, Minneapolis, Minnesota, is hereby denied.

The Board met in a special meeting to consider applications filed for reciprocal registration; to discuss progress of case filed against the Board in the matter of restriction of the sale of vitamins to pharmacies; applications filed for the opening of new drug stores; and other business that might come before it.

The Board met at the Nicollet Hotel, Minneapolis. All members of the Board were present: President John Nelson, J. G. Pasternacki, B. A. Deterling, J. N. French, and Victor E. Feit.

The president called the meeting to order at 2:00 o'clock P.M.

The secretary reported that three applications for reciprocal registration had been filed, although there had been a number who had been sent the preliminary information blank, and they had been informed that if they could get their blanks completed and filed shortly before date of this meeting, applications could be acted on then. Apparently the others were unable to get their blanks in order for consideration.

The persons having filed applications were as follows:

Sister Anne Josephine Meracle	-- from North Dakota
Kermit Jensen	-- from Iowa
George H. Bentson	-- from South Dakota

These applicants had been notified to appear in person and had been advised they would be required to take a written examination in Jurisprudence.

Sister Anne Josephine and Mr. Jensen appeared before the Board and their applications and other material filed were checked and found to comply with the Minnesota requirements regarding reciprocity.

They were given the examination in jurisprudence.

After having been notified when to appear, Mr. Bentson was called out of town and the secretary reported that he had received a letter in regard to this in which Mr. Bentson was concerned because he was unable to appear and asked if his application and fee could be laid over to the January Board meeting.

It was moved and seconded that the application of Geo. H. Bentson for reciprocal registration on the basis of his South Dakota license be held over to the January meeting. Motion carried.

The minutes of the July meeting were read, and upon motion made, seconded and carried, they were approved.

The secretary read a letter from Roy Sanford of Enid, Okla., in regard to readmittance of a former licentiate of Minnesota, Vernon A. Pendleton, who had been dropped for non-payment of renewal fees. Mr. Pendleton was dropped as of March 4, 1944, being in arrears for years 1942 and 1943. Mr. Pendleton was desirous of again becoming registered in Minnesota.

The secretary was instructed to secure further information from Mr. Pendleton in regard to where he had been employed and as to his activities in the matter of practicing pharmacy during the years 1942 to 1946 inclusive.

Letters from I. D. Chenoweth, registered in Missouri as a pharmacist, was brought to the attention of the Board. Mr. Chenoweth is a graduate of the Kansas City College of Pharmacy, June 1928, but as this school was not a recognized school at that time, he was advised he was not eligible for reciprocity. In summer of 1944 this school was consolidated with the University of Kansas City and was accredited by the American Council on Pharmaceutical Education in December, 1944, and as Mr. Chenoweth is now considered a graduate of the University of Kansas City School of Pharmacy, which is now a recognized school, he feels he is eligible for reciprocal registration in Minnesota.

(No action was taken by the Board)

The secretary brought up the matter of applications filed for opening of new drug stores, as follows:

L. E. Manecke, registered pharmacist, for opening a new store in Kiester, Minn.

Donald Sweeney, registered pharmacist, for opening a new store in Madelia, Minn.

Donald H. Scholten, registered pharmacist, for opening a new store at 84 S. 9th St., Minneapolis, Minn.

Keith K. Keller, registered pharmacist, for opening a new store at 3948 W. 50th St., Minneapolis, Minn.

Tracy L. Hafner and C. L. Bartholomew, registered pharmacists, for opening a new store in Slayton, Minn.

The secretary brought up the matter of issuing a household drug license to Mrs. O. A. Strom, Jeffers, Minn., who was operating a drug store formerly in charge of O. A. Strom, pharmacist, (now deceased), as the secretary had advised her she would have to secure a pharmacist to be in charge if she wished to continue operating it as a pharmacy. The other alternative was to remove all drug signs from the building and also all drugs and medicines which are not permitted to be sold under the household drug license, as she was eligible to such license as there was no other drug store in the town.

It was moved and seconded that she be issued a household drug license, and upon issuance of same, discontinue the operation of a drug store and the compliance with the pharmacy laws. Motion carried.

The secretary brought up the matter of issuance of household drug license to L. S. Eggen of Kelliher, who operates the Kelliher Home and Auto Supply. Mr. Eggen had been advised that there were four permits already in Kelliher, which should adequately take care of the household drug needs of the community. Mr. Eggen then replied that Tina Eggen of Kelliher, who had 1946-47 license No. 4460, had agreed to relinquish same

in favor of one issued to Mr. Eggen, so therefore there would be no more than four.

It was the opinion of the Board that there were enough permits in Kelliher for the sale of drugs and medicines without issuing a new license, and for that matter three were enough, and the secretary was advised not to issue any additional license.

The following motion passed on October 20, 1945 was rescinded and it was moved and seconded that same be stricken from the records. Motion carried.

MOTION PASSED OCTOBER 20, 1945 RESCINDED, TO-WIT:

"The Board felt that Dr. Wilson should have some remuneration for this extra work he was called upon to do from time to time, and it was moved by Mr. Nelson, seconded by Mr. French, that Dr. Wilson be given a retaining fee of \$25 per month. Motion carried."

The secretary advised the Board of the operation of the drug store at Argyle by Mrs. Anna Peterson, widow of the late Thomas H. Peterson, she having secured a pharmacist by the name of E. H. Yoho to be in charge of the store. Information had come to the office that Mr. Yoho was not very reliable, that he either was using intoxicating liquor or narcotics so as to unfit him to practice as a pharmacist.

The Board instructed the Secretary to write Mr. Yoho to come in to the office to discuss some of these practices and to ascertain what steps have been taken to discontinue certain practices.

George Sjoselius, deputy attorney general, met with the Board to discuss matters pertaining to the vitamin case. He stated that he had not filed an answer as yet, but that he had talked with the attorney for the grocers, Richard S. Felhaber, and that possibly the case might come up in court sometime in January. However, this was not definite as yet.

The secretary asked Mr. Sjoselius in regard to continuing the pharmacy license issued to the Bannon Mercantile Company, St. Paul, now that this company had been purchased by the Gamble, Skogmo Company, Minneapolis, and therefore was operating under new ownership. Mr. Sjoselius was of the opinion that since Bannon's had been in operation and selling drugs and medicines under the supervision of a pharmacist prior to the passage of the pharmacy law in 1937, and had at that time been issued a license to operate a pharmacy in its store, it would be well not to apply the drug store ownership regulation passed in June, 1941 as covering the new owner.

It was moved and seconded that Sister Anne Josephine be granted registration as a pharmacist on the basis of her pharmacist registration in North Dakota. Motion carried.

It was moved and seconded that Kermit Jensen be granted registration as a pharmacist on the basis of his pharmacist registration in Iowa. Motion carried.

It was moved and seconded meeting be adjourned. Motion carried.

THREE HUNDRED TENTH MEETING

MINNESOTA STATE BOARD OF PHARMACY

January 20, 1947. The Board met at the College of Pharmacy, University of Minnesota, at 9:00 o'clock A.M. All members were present: President John Nelson, J. G. Pasternacki, Victor E. Feit, B. A. Deterling, J. N. French.

The following had filed applications to take the entire examination and had been notified to appear as per schedule sent them:

The above named six applicants appeared at 9:00 o'clock and were given the written examination in Chemistry, Materia Medica, and Jurisprudence. In the afternoon they were given the written examination in Pharmacy, and Pharmaceutical and Chemical Mathematics.

Also in the morning the Board interviewed applicants desiring registration in Minnesota by reciprocity. Their applications, which had been filed previously with the Secretary, were checked, whereupon they were given the written examination in Jurisprudence required of such applicants.

The following had filed applications for reciprocal registration and appeared in person before the Board.

In checking the application filed by Warren W. Naegeli, the secretary pointed out that from the drug store experience obtained by him as listed on the application, it appeared that some of it was part time while attending school. When this was pointed out to Mr. Naegeli he informed the Board he had had additional drug store experience but had not furnished the North Dakota Board with same as it was not needed. He was told to furnish affidavits covering this additional drug store experience to supplement information and data contained in the application.

Joseph L. Martin of Green Isle appeared before the Board again, he having appeared in July, 1946 and had been denied readmittance as a pharmacist. Mr. Martin had been dropped as of March 4, 1933 because of non-payment of renewal fees covering his registration as a pharmacist; and during these past years he has been engaged in work other than pharmacy,

having been employed by the Federal Government in the capacity of rural mail carrier. In view of the poor showing he made in the practical work at the July, 1946 examination, the Board advised him that it would be necessary for him to study and brush up on pharmacy so as to make himself a safe man to be put into the practice of pharmacy as a pharmacist. In view of his having been out of the practice of pharmacy for these many years, the Board felt it was justified to deny readmittance until he could prove to their satisfaction he was competent and safe to again enter the practice of pharmacy.

Neal Schwartau, who had taken the written examination only in March, 1943 because he did not have the required one year of practical experience, appeared before the Board in regard to being short seven days of the required one year drug store experience, and asked whether the Board would permit him to take the practical work, which was the part left to take as he passed the written examination taken in March, 1943, and if successful in passing same, if he would be granted registration as a pharmacist.

The Board felt that inasmuch as he was only short one week, and further, that he was an ex-serviceman and entitled to some consideration in that his gaining the required one year of practical experience had been interrupted by service in the armed forces, that he be permitted to take the practical examination and that he would be eligible for licensure.

Lee A. Cushman appeared before the Board in regard to his being short one month of the required one year of practical experience to be eligible to take the practical examination, and stated in addition to drug store experience obtained as per affidavits furnished with his application, he had done pharmacy work while on board an LCT vessel; that he was in charge of procuring and dispensing medicine for a period of 16 months while overseas. He substantiated this by submitting an affidavit from Lt. M. S. Hemphill, who was the commander of the ship.

The Board allowed one month credit for the experience obtained as above, which gave Mr. Cushman one year of practical experience and so made him eligible to take the entire examination.

January 21, 1947. The Board met at the College of Pharmacy, University of Minnesota, 8:30 o'clock A.M., to give the practical work to those eligible to take same.

The following were present to take same:

Nine prescriptions were given in the morning and six were given in the afternoon to each candidate to compound.

January 22, 1947. The Board spent the morning giving the oral examination to the ten candidates. When this was finished, the Board adjourned to its rooms in the Nicollet Hotel.

In the afternoon Dean Charles H. Rogers of the College of Pharmacy, University of Minnesota, and some of the members of his faculty met with the Board.

The Board of Pharmacy examinations were discussed as some of the Board Members had submitted copies of examination questions for review.

The curriculum at the College of Pharmacy was discussed, and the Board asked for an outline from the faculty of the classes being taught. It was then suggested that the Board purchase textbooks and that the instructors mark the contents according to their importance, that is A, B, and C.

The Board Members suggested to the Dean that the faculty meet at the end of each quarter and discuss the grades of the students who were having difficulty, and to assist them, either by making it possible for them to do better work, or, if in their opinion a student was not capable of carrying the work, that they recommend he discontinue in school.

The enrollment at the College of Pharmacy was discussed; the number of pharmacists for future need in Minnesota; the prospects of meeting that demand; and the possibility of a surplus of pharmacists in the not too distant future if some system of screening is not used.

January 23, 1947. At 10:00 o'clock A.M., Eugene Yohe, a registered pharmacist in Minnesota, appeared before the Board, as per notification sent him, for an interview in regard to his conduct in the practice of pharmacy. Mr. Yohe is about 67 years old and recently was employed in the Argyle Pharmacy by Mrs. Anna Peterson, Argyle, Minn. Complaint was received from Mrs. Peterson that Mr. Yohe was unreliable; that he seemed to have periods when he did not know what he was doing; that he had made several errors in labeling of prescriptions.

After questioning Mr. Yohe relative to these complaints, some of which he did not seem to be very clear on, he was excused.

In discussing his case, the Board asked that Mr. Cleary check with Mr. Yohe's sister, with whom he was living, to get more information in regard to his habits, health, etc. The Board felt that no action should be taken against Mr. Yohe, and that if it was not necessary for him to work, he should be discouraged from accepting employment.

At 11:00 o'clock A.M. Lloyd A. James and Charles F. Falk, pharmacists operating drug stores in Two Harbors, Minnesota, appeared before the Board to discuss the situation in their City relative to the local hospital which operates on a prepaid hospital and medical care plan. It was pointed out by Mr. James and Mr. Falk that the members of the plan were entitled to medical care and drugs from the hospital. They were interested in having the Board investigate the conditions, and if it was under the Board's jurisdiction, to have the drugs supplied by the drug stores on physician's prescriptions to those members of the plan who were not hospitalized.

The Board suggested that the secretary contact Mr. Sjoselius, deputy attorney general, to determine just what the Board could do in this case, and if possible, to make every effort to remedy the situation.

Mr. P. H. Costello, secretary of the National Association Boards of Pharmacy, Chicago, Illinois, met with the Board during the day, discussing the policies of the Board; legislation that is being proposed to permit registration of servicemen with lesser qualifications than are required under the present pharmacy laws of the various states; and other matters of interest to the members of the Board pertaining to licensure, either by examination or reciprocity.

The secretary reported to the Board that one Kay Todd, attorney in St. Paul, came to see him at his store in December, 1946. Mr. Todd informed the secretary that he was representing A. J. McGree, a registered pharmacist in Nevada, for whom he was interested in securing reciprocal registration in Minnesota. He gave detailed brief on Mr. McGree's background from the time he began working in a drug store, his schooling in Colorado, and his becoming registered in Nevada. ✓

Mr. Todd was informed by the secretary that Mr. McGree was not eligible for reciprocity as he did not meet the Minnesota requirements for examination at the time he qualified for examination in Nevada, which is the basic rule for reciprocity. Mr. Todd stated he had checked the law carefully and he felt that the Board had sufficient discretionary power under the law to permit Mr. McGree to receive reciprocal registration in Minnesota. He also stated that if the Board could not see fit to grant reciprocity registration they would introduce a bill in the coming session of the Legislature forcing the Board to give Mr. McGree registration.

Mr. Todd asked that he have the privilege of meeting with the Board at its next meeting, the week of January 19, 1947, and the secretary informed the Board that he had made an appointment for Mr. Todd to appear before the Board at its rooms at the Nicollet Hotel, on Friday, January 24, 1947, 2:00 o'clock P.M.

Mr. Sam Campbell, assistant attorney general substituting for Mr. Sjoselius, who was ill in the hospital, sat in at this session of the Board. Mr. Campbell pointed out the discretionary powers the Board had, under the law, relative to Section 12 of the Pharmacy Act pertaining to registration by reciprocity.

January 24, 1947. The meeting was held in the Board of Pharmacy rooms in the Nicollet Hotel, Minneapolis. President Nelson called the meeting to order at 10:00 o'clock A.M.

The minutes of the November special meeting were read and approved.

The secretary announced he had copies of the financial statement for each member and distributed one to each.

It was moved and seconded that reading the financial statement be dispensed with. Motion carried.

The secretary read a report on examination, reciprocity, drug store statistics; drug samples purchased and analyzed; cost of laboratory technician and temporary inspectors; number granted licenses during the year to practice pharmacy; number of pharmacists having died; number having been dropped, etc.

It was moved and seconded that report be adopted. Motion carried.

It was moved and seconded that the following persons having received a general average of at least 75%, at least 75% in practical, and not below 60% in any one subject, be granted registration as pharmacists. Motion carried.

Schwartau, Neal W.

Lee A. Cushman received a general average of 76.1 per cent but fell below 60% in Chemistry and therefore was not eligible for registration. Under a regulation of the Board he may take this subject over again in order to raise his mark.

It was moved and seconded that George H. Bentson be granted registration as a pharmacist on the basis of his registration as such in South Dakota. Motion carried.

It was moved and seconded that Allen E. Collins be granted registration as a pharmacist on the basis of his registration as such in Mississippi. Motion carried.

It was moved and seconded that Wm. A. Johnson be granted registration as a pharmacist on the basis of his registration as such in North Dakota. Motion carried.

It was moved and seconded that Donald J. Ness be granted registration as a pharmacist on the basis of his registration as such in North Dakota. Motion carried.

It was moved and seconded that Bernard H. Trygstad be granted registration as a pharmacist on the basis of his registration as such in North Dakota. Motion carried.

It was moved and seconded that Peter De Boer be granted registration as a pharmacist on the basis of his registration as such in North Dakota. Motion carried.

It was moved and seconded that Warren W. Naegeli be granted registration as a pharmacist on the basis of his registration as such in North Dakota pending his furnishing the Board of Pharmacy with affidavits supporting additional drug store experience prior to his examination in North Dakota, and that it be left to the judgment of the secretary as to his having complied with all of our requirements in that respect. Motion carried.

It was moved and seconded that Theo. A. Samuelson be granted registration as a pharmacist on the basis of his registration as such in North Dakota as he had now complied with the Board's stipulation that he secure six months' practice of pharmacy in a drug store under a registered pharmacist. Motion carried.

Mr. Samuelson submitted his application for reciprocity and appeared before the Board at the July 1946 meeting. Final action on same was deferred until he had complied with Board's stipulation of obtaining at least six months' practice of pharmacy. The secretary reported Mr. Samuelson had filed an affidavit covering the period from July 1946 to January 1947.

It was moved and seconded that the bond premium covering the secretary's bond be paid out of the funds of the Board. Motion carried.

It was moved and seconded that the membership dues of \$25 to the National Ass'n Boards of Pharmacy, \$15 to the 5th District Boards and Colleges of Pharmacy, \$10 to the Conference of Pharmaceutical Law Enforcement Officials, and \$2 to the Association of Food and Drug Officials of the United States, be paid out of funds of the Board. Motion carried.

It was moved and seconded that \$2,000 for 1947 be turned over to the Minnesota State Pharmaceutical Ass'n for the advancement of the Science and Art in Pharmacy, to be paid in two installments of \$1,000 each. Motion carried.

It was moved and seconded that the fee for renewal of pharmacist license be fixed at \$5 for 1947; the fee for assistant pharmacist license renewal at \$3; and the 1947-48 drug store license at \$5. Motion carried.

It was moved and seconded that the date for the July examination be set for the week beginning Monday, July 21, if there were no conflicts. Motion carried.

It was moved and seconded that the secretary be authorized to expend \$300 to equip and set up laboratory for this year's analyses of drugs, and the making of reports, etc. Motion carried.

It was moved and seconded that to be eligible for registration as pharmacist, applicant must obtain a general average of 75 percent or better, a minimum of 75 percent in his practical work, and not below 60 percent in any other subject. Motion carried. X

It was moved and seconded that Vernon A. Pendleton be readmitted as a pharmacist by payment of dues in arrears, and readmittance fee of \$25. Motion carried.

Mr. Pendleton was dropped as of March 4, 1944 for non-payment of renewal fee for years 1942 and 1943. Therefore he is in arrears at this time for years 1942, 1943, 1944, 1945, 1946, five years at \$5 each, total \$25. Total amount to be paid, \$50.

It was moved and seconded that the five members of the Board and the secretary be sent as delegates to the 5th District Meeting of the Boards and Colleges of Pharmacy to be held in Omaha, Nebraska, April 21 and 22, 1947. Motion carried.

It was moved and seconded that Bannons, St. Paul, Minnesota, under the new ownership of Founders Incorporated, be granted a drug store or pharmacy license. Motion carried.

At 2:10 P.M. the following persons appeared before the Board in behalf of Mr. A. J. McGree who is registered as a pharmacist in Nevada: Kay Todd, attorney in St. Paul, and Edw. W. O'Shaughnessy, attorney associated with Mr. Todd; and Kenneth Eddy, a Minnesota pharmacist and drug store owner in Hastings, Minn., and by whom and in said store Mr. McGree was employed. ✓

Mr. McGree also appeared with the above gentlemen to be heard in the matter of granting reciprocal registration to him on the basis of his registration as a pharmacist in Nevada.

Mr. Todd presented his case to the Board; Mr. McGree spoke for his registration, stating his background and service connection in the Navy; Mr. Eddy spoke in behalf of Mr. McGree, stating his qualifications and his ability to fill prescriptions.

After considerable questioning by the members of the Board, the delegation was told the Board had discussed the matter with legal counsel and that the Board felt under the law it did not have the discretionary power to meet their request. Mr. Todd stated he was sorry the Board felt that way and that they would plan to introduce a bill which would force the Board to grant registration to Mr. McGree.

After the delegation was dismissed, the Board discussed the matter further and it was the unanimous opinion of the Board that we would have to oppose this and any type of legislation that might be introduced in the Legislature which might have any bearing on the lowering of the standards for licensure examination or reciprocity.

It was moved and seconded that the following pharmacists being in arrears for 1944, 1945 and 1946 in renewing their licenses as registered pharmacists in Minnesota, be dropped from the records of the Board and their registrations cancelled. Motion carried.

It was moved by Mr. French, seconded by Mr. Pasternacki, that the Board of Pharmacy adopt the following "Minimum Standards for Evaluating Practical Experience". Motion carried.

MINIMUM STANDARDS FOR EVALUATING PRACTICAL EXPERIENCE

1. The term "Year" as used to designate the quantitative standard for practical experience shall mean fifty-two average work weeks of apprenticeship training acquired under the supervision of a registered pharmacist.

2. To assure a well rounded practical experience, not more than six months of credit per year shall be given for practical experience obtained in a hospital pharmacy and not more than six months credit per year shall be given for practical experience obtained in a

pharmacy or drug store compounding less than 1,000 prescriptions annually or devoting less than fifty percent of its activity to the sale of drugs and medicines and supplying pharmaceutical service.

3. The pharmacy owner or registered pharmacists supervising the practical experience of an applicant for registration must notify the Board of Pharmacy whenever an applicant for registration begins employment under their supervision and whenever an applicant leaves their employ.

4. Persons working under the supervision of registered pharmacists and expecting to qualify for the registered pharmacist examination must notify the Board of Pharmacy of the beginning and end of their employment under the supervision of a registered pharmacist within five days of the beginning or ending of such employment.

5. Boards of Pharmacy shall not allow credit for claims of practical experience required under the pharmacy law unless such claims can be corroborated by records on file in the Board office showing the beginning and ending of the practical experience claimed as supplied by the applicant during his training period and by the pharmacist who supervised the practical experience during the training period.

6. Practical experience shall be credited only when it has been obtained in a pharmacy acceptable to the Board of Pharmacy for that purpose.

7. The term "supervision" as used in connection with the practical experience requirement shall mean that the registered pharmacist or registered pharmacists owning, managing or conducting the pharmacy in which the practical experience is obtained are in personal contact with and actually giving instruction to the person obtaining the practical experience, and during the entire period of such experience, and the registered pharmacist ~~owning or managing the pharmacy shall have been a registered pharmacist for at least five years.~~

8. A pharmacy acceptable to the Board of Pharmacy as a proper place to obtain practical experience shall conform to the best traditions of pharmacy in the State. It shall have available all necessary equipment for professional service, necessary reference works, in addition to the official standards, and current professional journals, and shall meet the following minimum standards:

(a) It must be a pharmacy operating under a permit from the Board of Pharmacy in states where annual permits are required. In states where there is no permit law, the pharmacy must be operated at all times under the supervision of a registered pharmacist and must have signified its willingness to train apprentices or to employ persons desiring to obtain practical experience in accordance with the state pharmacy laws.

(b) Not more than one person acquiring practical experience under the pharmacy law may be employed under the supervision of one registered pharmacist at one time. There shall be no objection to the employment of more than one person for acquiring practical experience in any pharmacy but in every case there must be at least one registered pharmacist employee for each unregistered person acquiring practical experience under the law. *deleted*

(c) A pharmacy acceptable to the Board for practical experience must have a clear record with respect to the observance of Federal, State and Municipal laws and ordinances governing any phase of activity in which it is engaged. *he*

(d) The pharmacy owner and the registered pharmacists supervising the practical experience of applicants for registration must subscribe to the Code of Ethics of the American Pharmaceutical Association. *changed*

9. The individual obtaining practical experience shall keep a notebook properly certified to by the pharmacist supervising the practical experience covering the details of his practical training, and this notebook shall be submitted as part of the application for the Board examination.

It was moved by Mr. Deterling, seconded by Mr. Feit, that the Minimum Standards for Evaluating Practical Experience become effective October 1, 1947. Motion carried. *X*

This being the annual meeting of the Board, election of officers for the ensuing year, beginning February 1, was next in order.

Moved by Mr. Deterling, seconded by Mr. Feit, that J. G. Pasternacki be elected president. Motion carried.

Moved by Mr. Deterling, seconded by Mr. French, that Victor E. Feit be elected vice president. Motion carried.

Moved by Mr. Feit, seconded by Mr. French, that Frank W. Moudry be re-elected secretary. Motion carried.



S. Treasury Department official order form for the purchase of narcotic drugs; and having unlawfully purchased narcotic drugs for purposes other than the conduct of lawful business.

Upon termination of the hearing, the following resolution was passed. Moved by Mr. French and seconded by Mr. Deterling.

RESOLVED By the State Board of Pharmacy, duly convened at Suite 762, Nicollet Hotel, Minneapolis, Minnesota, on the 24th day of July, 1947, that the license of Fred De Roos to practice pharmacy in the State of Minnesota, be, and hereby is, revoked. Such revocation shall become effective immediately upon revocation by the United States District Court for the District of Minnesota of the probation upon which said Fred De Roos is now placed in the proceeding in said court entitled, "United States of America v. Fred De Roos," or upon the commission by said Fred De Roos of any act which is ground for the revocation of the license to practice pharmacy in the State of Minnesota.

BE IT FURTHER RESOLVED That the President and Secretary of the State Board of Pharmacy sign an order embodying the above decision.

THREE HUNDRED TWELFTH MEETING

November 7, 1947. The Board met at the Nicollet Hotel, Minneapolis, Minnesota. Members present, Victor E. Feit, Harry W. Carlsen, J. N. French. Due to illness J. G. Pasternacki and B. A. Deterling were unable to be present.

Vice-president Victor E. Feit called meeting to order at 10:30 o'clock A.M.

Five applications for reciprocal registration had been filed in the office of the Board since the July meeting, and the applicants had been notified to appear in person at this meeting in order that their applications might be considered.

The following appeared and their applications checked and each was interviewed by the Board:

Kyle Taylor, registered pharmacist in Nebraska and former member of the Nebraska Board of Pharmacy, also appeared before the Board. He was desirous of becoming registered in Minnesota by reciprocity but had been unable to get the official reciprocal application completed in time to have the same before the Board for consideration. Mr. Taylor was advised that action on his application would have to be deferred until the next meeting of the Board, and in the meantime he could get his application completed and file it with the secretary.

The above persons were given the examination in Jurisprudence.

Four applicants for the position of inspector, a vacancy existing due to the death of inspector L. J. Cleary, September 8, 1947, had been notified to appear before the Board for interview.

After the applicant had been interviewed he was advised that the secretary would inform him at a later date as to the decision of the Board.

The secretary informed the Board he had heard rumors that Walter Johnson, registered pharmacist and drug store owner in Elk River, Minnesota, was using intoxicant liquors so as to be unsafe to practice pharmacy. Walter Fields, temporary inspector, was sent to Elk River to investigate. He reported he interviewed local doctors, sheriff and deputy sheriff, three businessmen, and cashier of First National Bank. Some of these people were of opinion Mr. Johnson used intoxicants but that most of rumors circulated around were hearsay. Mr. Fields called on Mr. Johnson on two different days, and each time he was on duty, his store in order, and he was perfectly sober. Mr. Johnson had been in an accident last spring, fracturing a limb, and the information received was that he had been much better since that time.

Mr. Johnson had been called before the Board on July 17, 1946 for this same reason and he had been advised at that time that it could mean suspension or revocation of his license if he had to be called before the Board again.

The secretary also read a letter from the Bureau of Narcotics, Washington, D. C., relative to some irregularity in the matter of narcotics pertaining to one Bruce Idziorek, a registered pharmacist in Minnesota. The secretary reported he had called Mr. Idziorek into office to get further information in this matter, that he had warned him in regard to the use of narcotics, and that if we had further complaints, the Board would have to take other action.

November 8, 1947. Vice-president Feit called meeting to order.

It was moved and seconded that Hugo R. Glissman be granted registration as a pharmacist on the basis of his registration as such in Iowa. Motion carried.

Dr. Hedin of Red Wing was also present, as was Mr. Richelman.

After the interview was over these people left and the Board then discussed the matter at length, coming to the conclusion that the brief presented by Mr. Brist, the excerpts of the laws for the various years covering qualifications for examination, and correspondence received from Mr. Richelman, be given to George Sjoselius, the Board's legal counsel for further study and advice as to what action the Board must take.

At 3:30 George Sjoselius sat in on the meeting, and Mr. Brist reported to the Board the action taken by the Council of the Minnesota State Medical Association in the Estrem Clinic matter. He stated the Council voted unanimously against physicians operating pharmacies, and that he was authorized to call on the Estrem Clinic in person to notify them of the Council's action. In his opinion Pharmacy had made progress in the action taken by the Council.

January 30, 1948. The Board met in its rooms at the Nicollet Hotel at 10:00 o'clock A.M. The meeting was called to order by the president, J. G. Pasternacki.

STANDARDS FOR EVALUATING PRACTICAL EXPERIENCE

1. The term "year" as used to designate the quantitative standard for practical experience shall mean fifty-two average work weeks of apprenticeship training acquired under the supervision of a registered pharmacist.
2. The pharmacy owner or registered pharmacists supervising the practical experience of an applicant for registration must notify the Board of Pharmacy whenever an applicant for registration begins employment under their supervision and whenever an applicant leaves their employ.
3. Persons working under the supervision of registered pharmacists and expecting to qualify for the registered pharmacist examination must notify the Board of Pharmacy of the beginning and end of their employment under the supervision of a registered pharmacist within five days of the beginning or ending of such employment.
4. Boards of Pharmacy shall not allow credit for claims of practical experience required under the pharmacy laws unless such claims can be corroborated by records on file in the Board office showing the beginning and ending of the practical experience claimed as supplied by the applicant during his training period and by the pharmacist who supervised the practical experience during the training period.
5. Practical experience shall be credited only when it has been obtained in a pharmacy acceptable to the Board of Pharmacy for that purpose.
6. The term "supervision" as used in connection with the practical experience requirement shall mean that in the pharmacy where practical experience is being obtained a registered pharmacist supervising practical experience shall be in personal contact with and actually giving instruction to the person obtaining practical experience during the entire period of such experience.
7. A pharmacy acceptable to the Board of Pharmacy as a proper place to obtain practical experience shall conform to the best traditions of pharmacy in the state. It shall have available all necessary equipment for professional service, current professional journals, and shall meet the following minimum standards:
 - (a) It must be a pharmacy operating under a permit from the Board of Pharmacy in states where annual permits are required. In states where there is no permit law, the pharmacy must be operated at all times under the supervision of a registered pharmacist and must have signified its willingness to train apprentices or to employ persons desiring to obtain practical experience in accordance with the state pharmacy laws.
 - (b) A pharmacy acceptable to the Board for practical experience must have a clear record with respect to the observance of Federal, State, and municipal laws and ordinances governing any phase of activity in which it is engaged.
 - (c) The pharmacy owner and the registered pharmacists supervising the practical experience of applicants for registration must agree to abide by the Code of Ethics of the American Pharmaceutical Association.
8. The individual obtaining practical experience shall keep a notebook properly certified to by the pharmacist supervising the practical experience covering the details of his practical training and this notebook shall be submitted as part of the application for the Board examination.

The date for the July examination and meeting was set tentatively for the week beginning Monday, July 12.

It was moved and seconded that analysis of drug samples be continued during the ensuing year. Motion carried.

There was considerable discussion in the matter of the cost of analysis during the past year, in view of the number of samples analyzed, and the general opinion was that the cost should be held down. The secretary was instructed to contact Dr. Wilson in regard to this.

It was moved by Mr. Deterling, seconded by Mr. French, that approximately \$600 be set aside for drug sample analysis for 1948. Motion carried.

It was moved and seconded that all the members of the Board and the secretary be sent as delegates to the 5th District Boards and Colleges meeting in Des Moines, May 20 and 21, 1948. Motion carried.

It was moved and seconded that the lease for office space at 3965 Minnehaha Ave., Minneapolis, Minnesota, be renewed for a period of five years

Moved Mr. French, Seconded by Mr. Feit, that the minimum standards for practical experience be amended so that they are comparable to those of the National Association Boards of Pharmacy which were amended and approved at the convention in Milwaukee in August, 1947. Motion carried.

Moved Mr. Feit, seconded by Mr. French, that the following resolution be adopted. Motion carried.

WHEREAS, The Board of Pharmacy recognizing this honor bestowed upon a Minnesota pharmacist and secretary of the Board of Pharmacy, be it

RESOLVED, That this resolution be spread on the minutes of the Board.

The secretary reported he had received a letter from F. Manley Brist, St. Paul, attorney for the State Board of Medical Examiners, relative to Jacob S. Balzer, a registered pharmacist in Minnesota, working as such in a pharmacy in Mountain Lake, who on November 11, 1947 entered a plea of guilty in the District Court of Cottonwood County to an information charging him with the crime of abortion. Mr. Balzer was sentenced by Judge Charles A. Flinn to a term of not to exceed 18 months in the State Prison at Stillwater.

The purpose of the letter from Mr. Brist was to advise the Board of the above fact, and also that Mr. Milton F. Juhnke, County Attorney at Windom, had expressed the opinion that Mr. Balzer is being sufficiently punished for his crime by being imprisoned at Stillwater for 18 months.

A letter from Dr. P. J. Pankratz, Mountain Lake, was also read which had been addressed to Norman French, Lakefield, in which he advised him that Mr. Balzer was serving an 18 month sentence at Stillwater for abortion, and asking the question "Could his license be revoked?". Mr. French sent this letter to the secretary and he replied to same.

After some discussion by the Board in regard to this matter, it was agreed that as per recommendation of legal counsel, George Sjoselius, the secretary should write the Warden of the State Prison at Stillwater asking that he be notified when Mr. Balzer is to be released and other pertinent facts relating to Mr. Balzer.

A letter from the Armstrong Cork Company, Lancaster, Pa., had been received by the secretary relative to the subject "Plain vs. Graduated Prescription Bottles". The letter was signed by George M. Scattergood. The letter called attention to the fact that since 1941 the Armstrong Company had exercised their influence toward the abandonment of graduated bottles for prescription use as the use of such graduations made for inaccuracy in the prescription compounded, stating "Pharmacy, in general, will, through the exclusive use of plain bottles for prescriptions, gain added respect of the medical profession whose members have looked upon users of graduated bottles as lacking all of the adequate tools for accurate prescription compounding".

Attention was also called to the fact that the State Board of Pharmacy of New York has ruled that graduated bottles shall not be used; and the Commonwealth of Kentucky, by regulation of the State Board of Health, prohibits the use of graduated prescription bottles by pharmacist in filling prescriptions.

The Board recommended that this matter be referred to the coming meeting of the 5th District Boards and Colleges of Pharmacy, to be held in Des Moines, May 20 and 21.

The secretary read a letter from J. H. Mueller of Robbinsdale conveying his thanks to the members of the Board for the most able way in which the examination was presented, and that at no time during the entire examination did he feel the questions were anything but those of value to the men in the profession of pharmacy. He hoped he would always be a credit to his profession.

The secretary reported on a letter he had received from Robert T. Walker, secretary of the Tennessee Board of Pharmacy, relative to the exchange of courtesy pharmacist certificates for Board members of Tennessee and Minnesota. The secretary replied that Minnesota had never exchanged courtesy certificates, and that the Board was of the opinion there was no way it could be done.

This being the annual meeting, the election of officers was in order.

It was moved by Mr. French, seconded by Mr. Carlsen, that Victor E. Feit be elected president for the ensuing year. Motion carried.

It was moved by Mr. Feit, seconded by Mr. Carlsen, that J. N. French be elected vice president for the ensuing year. Motion carried.





MEMORIAL DESTROYED AFTER NEW

Lenin Plaque R

BROOKSVILLE, FLA. —(AP)— A memorial to Nikolai Lenin, promoter of world communism, has been removed from a U. S. department of agriculture experiment station here.

Calvin Burns, superintendent of the station, was not available for comment but his wife said he destroyed the memorial Friday. For more than three years the plaque had been located on federal property near this west central Florida community.





It was decided to defer any action in the matter until after Mr. Balzer had appeared.

The secretary submitted a certified copy of the conviction of Arnold Blaustone, an assistant registered pharmacist, for the sale of intoxicant liquors, without a license, at the drug store located at 1041 Olson Blvd., Minneapolis, Minn., owned and operated by Abraham Strimling. After some discussion the Board asked the secretary to contact Mr. Blaustone, stating that the Board would like to meet with him the next day, Friday, January 28, at 4:00 o'clock P.M.

The Board then took under consideration the contemplated regulation drafted by Deputy Attorney General George Sjoselius and which had been sent to all members prior to this meeting. The regulation dealt with minimum space requirements for a pharmacy.

It was moved by Mr. Deterling, seconded by Mr. French, that the following resolution be adopted. Motion carried.

Resolved by the Minnesota State Board of Pharmacy duly convened at Minneapolis, Minnesota, on this 27th day of January, 1949, that the following regulation be and hereby is adopted:

REGULATION NO. 17

NO PHARMACY SHALL BE LICENSED HEREAFTER UNLESS (1) THE SPACE WHICH IT OCCUPIES HAS AN ENTRANCE WHICH AFFORDS THE PUBLIC DIRECT ACCESS FROM THE STREET, (2) THE SPACE WHICH IT OCCUPIES IS SEPARATED FROM THE REMAINDER OF THE BUILDING IN WHICH IT IS LOCATED BY WALLS EXTENDED FROM THE FLOOR TO THE CEILING, WHICH WALLS MAY CONTAIN DOORS TO THE INTERIOR OF THE BUILDING WHICH MAY BE CLOSED AND LOCKED WHEN THE PHARMACY IS NOT IN CHARGE OF A REGISTERED PHARMACIST, AND (3) THE SPACE WHICH IT OCCUPIES CONTAINS NOT LESS THAN 400 SQUARE FEET.

IF THE BOARD DETERMINES UNDER EXCEPTIONAL CONDITIONS THAT IT IS IN THE PUBLIC INTEREST, IT MAY WAIVE ONE OR MORE OF THE FOREGOING REQUIREMENTS.

THIS REGULATION SHALL NOT APPLY TO ANY PHARMACY WHICH HAS BEEN GRANTED A LICENSE PRIOR TO THE EFFECTIVE DATE HEREOF.

Mr. Sjoselius then discussed the vitamin case stating that he is preparing his brief to be submitted to the court, and that he would have it completed shortly.

Mr. Sjoselius brought up the letter from the Red Owl Grocery Stores which the Board had turned over to him. This letter asked for information on a list of medicines that they would like to sell in their stores in Minnesota. After considerable discussion by the Board, Mr. Sjoselius drafted a reply, which the Board approved, and the same was to be mailed to the Red Owl Stores, Inc.

January 28, 1949. The Board met at its rooms at the Nicollet Hotel and at 10:00 o'clock A.M. President Feit called meeting to order.

The minutes of the July and October meetings were read and approved.

A statistical report was read by the secretary giving information as to the number of pharmacists and assistant pharmacists on record January 1; the number of drug stores; the number of persons registered by examination and reciprocity; the number of pharmacists and assistant pharmacists who had died during the past year, and the number that had been dropped from the records.

A copy of the financial statement for the year ending December 31, 1948 was given to each Board member.

It was moved and seconded that Milton E. Doe be granted registration on the basis of his registration in Montana subject to completion of his application and other data. Motion carried.

It was moved and seconded that the application of Samuel A. Johnson for registration on the basis of his Wisconsin license be tabled inasmuch as he had not been practicing pharmacy for a number of years and Mr. Johnson had been advised, when he appeared before the Board on January 26, 1949 to take employment in a drug store and brush up on pharmacy and then appear before the Board. Motion carried.

It was moved and seconded that the fee for pharmacist renewal for 1949 be fixed at \$5; the fee for assistant pharmacist be fixed at \$3; and the fee for drug store license be fixed at \$5. Motion carried.

It was moved and seconded that the membership dues to the National Association Boards of Pharmacy, \$25; the 5th District Boards and Colleges of Pharmacy, \$15; the Association of Food and Drug Officials of the United States, \$3; and the Conference of Pharmaceutical Law Enforcement Officials, \$10, be paid out of the funds of the Board. Motion carried.

The secretary reported that the Notary Commission of the assistant Secretary, Effie M. Swanson, had expired, and it was moved and seconded that the same should be renewed and the cost of same to be paid out of the funds of the Board. Motion carried.

It was moved and seconded that \$2,000 be turned over to the Minnesota State Pharmaceutical Association for the advancement of the Science and Art in Pharmacy as provided by law. Motion carried.

It was moved and seconded that all the members and the secretary be sent as delegates to the meeting of the 5th District Boards and Colleges of Pharmacy to be held in Rapid City, S. D. Motion carried.

It was moved and seconded that two delegates be sent to the meeting of the National Association Boards of Pharmacy, and the conference of the Law Enforcement Officials of the United States, to be held in Jacksonville, Florida, April 25-27, 1949. Motion carried.

It was moved and seconded that the bond premium for the secretary be paid out of the funds of the Board. Motion carried.

This being the annual meeting of the Board, election of officers was in order.

It was moved by Mr. Carlsen, seconded by Mr. Deterling, that J. N. French be elected president for the ensuing year, beginning February 1. Motion carried.

It was moved by Mr. French, seconded by Mr. Carlsen, that B. A. Deterling be elected vice president for the ensuing year, beginning February 1. Motion carried.

It was moved by Mr. French, seconded by Mr. Carlsen, that Frank W. Moudry be re-elected secretary for the ensuing year. Motion carried.

It was moved and seconded that Effie M. Swanson be re-elected assistant secretary. Motion carried.

It was moved and seconded that the employment of Earl J. Schlekau as Chief Inspector be approved. Motion carried.

At 3:30 o'clock P.M. Mr. Sjoselius met with the Board and Mr. Balzer appeared for questioning. After considerable questioning by the Board and by ~~the~~ Mr. Sjoselius, Mr. Balzer was excused.

It was moved by Mr. Deterling, seconded by Mr. French, that in the matter of the citation of Mr. Balzer to show cause why his registration as a pharmacist should not be revoked, that Mr. Balzer should be permitted to continue as a registered pharmacist in the State of Minnesota. Motion carried.

When Mr. Balzer was again called in and advised of the action of the Board he promised to conduct himself in such a manner that it would be a credit to pharmacy.

Mr. Arnold Blaustone appeared and stated he would be willing to answer any questions relative to his conviction in Municipal Court for the sale of liquor without a license. Mr. Blaustone stated that it was the first and only time he had sold liquor at the drug store located at 1041 Olson Blvd., Minneapolis, Minn.; that he had been employed in that store on a part time basis, working three evenings a week. He stated further that the sale was made at closing time and he was anxious to get away from the store, and he weakened and made the sale of a bottle of liquor to an officer of the police department. Mr. Blaustone stated that this was the first time and would be the last.

Mr. Strimling telephone the president of the Board, and also the secretary in behalf of Mr. Blaustone.

It was the opinion of some of the members of the Board that Mr. Strimling, the proprietor of the store, was possibly more guilty than Mr. Blaustone.

Nothing further coming before the Board, on motion duly made and seconded and carried, Board adjourned.

Samuel A. Johnson again appeared before the Board in the matter of his application for reciprocal registration from Wisconsin, his application having been tabled since the January meeting. Mr. Johnson reported that he had been employed in the Berg drug store at St. Charles, Minn. and working under the supervision of Theo. Frisch, registered pharmacist, so as to familiarize himself with the practice

of pharmacy at the present time, as the Board advised him to do when he appeared before it at the January meeting. Mr. Johnson presented an affidavit from Mr. Frisch substantiating his statement to this effect showing employment from February 1, 1949 to July 2, 1949.

The matter of the application of M. J. Livingston for reciprocal registration on the basis of his Iowa certificate, which was considered by the Board at the January meeting, was again brought up. Mr. Livingston re-appeared before the Board at this time. The Board advised Mr. Livingston that additional information received showed that he was not a graduate of the Highland Park College of Pharmacy, nor had he successfully completed the work of two years at the Highland Park College of Pharmacy, which was a requirement for registration as pharmacist in Minnesota in 1927 if applicant had not obtained drug store experience prior to April 23, 1919. The application submitted by Mr. Livingston showed drug store experience obtained beginning January, 1922. Hence he would not have been eligible for examination in Minnesota when he took the examination in Iowa, which is the basic requirement for reciprocity.

When the consideration of the reciprocal applications and the checking of same was finished, the Board met with George Sjoselius, its legal counsel, and after some discussion relative to violations of the Barbiturate Law, the Board went into executive session, President French presiding.

Mr. Moudry presented a copy of the conviction of Virgil J. Dols, a registered pharmacist in Minnesota, who owns and operates a drug store at 130 S. Third St., Minneapolis, Minn., which conviction was for the illegal sale of liquor in his drug store. Plead guilty in Municipal Court, City of Minneapolis, Judge Rolf Fossean. Paid a fine of \$100 on June 6, 1949.

It was moved by Mr. Deterling, seconded by Mr. Carlsen that Virgil J. Dols be asked to appear before the Board relative to his conviction of a liquor violation. Motion carried.

Whereupon the secretary telephoned Mr. Dols and asked him to appear before the Board.

Mr. Dols presented himself and told the Board the details of the liquor violation and conviction. Mr. Dols lost his liquor license and is now out of the liquor business. No further action was taken by the Board against Mr. Dols.

This case was checked by the Food and Drug Administration and also by the Board of Pharmacy but found no evidence of recent refill nor could the prescription be found, the pharmacist stating that the file had been destroyed about a year ago due to an accident of sulphuric acid spilling over it. Mr. Judge stated that the prescription, No. 83877, dated April 26, 1940, for Gust Wiener, had not been refilled for Mr. Wiener.

The secretary also stated that information had been received that barbiturates had been sold over the counter in the Chicago Avenue Pharmacy, 2504 Chicago Avenue, Minneapolis, Minn., owned by Bert F. Supplee, a registered pharmacist. The secretary read the report of the police department on the case of Mrs. Beverly Julian, living at 4452 Colfax Avenue N., Minneapolis, Minn., attempt suicide. Police department made thorough investigation and no action was brought against Mr. Supplee because of insufficient evidence.

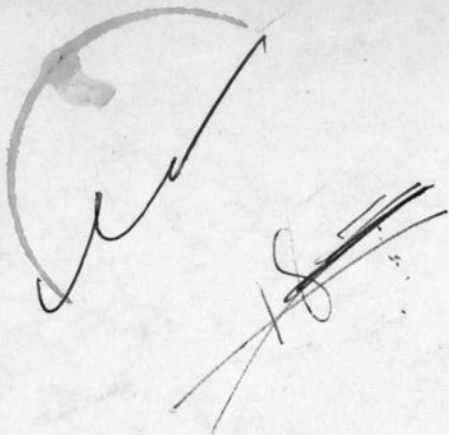



THREE HUNDRED EIGHTEENTH MEETING

October 27, 1949. The Board met at the Nicollet Hotel, Minneapolis, Minn., for a special meeting for the purpose of conducting hearings, and considering reciprocal applications which had been filed with the secretary.

1. That on the 13th day of July, 1949, in the City of Minneapolis, Hennepin County and State of Minnesota, you, the said Irving Earl Kaplan, did assist in procuring a miscarriage of a woman, to-wit: one Joy Vickerman.

President French asked Mr. Lebow to stand up, whereupon he read the citation, to-wit: "You are hereby cited before the Minnesota State Board of Pharmacy to make such answer to the charges herein contained as you may be advised or deem expedient and to show cause, if any you have, why the license to practice pharmacy heretofore granted you by the Minnesota State Board of Pharmacy as a pharmacist should not be suspended or revoked upon the following grounds: unprofessional conduct as follows: that you, the said Harry Lebow, conducted yourself in a manner unbecoming a person licensed to practice pharmacy in the State of Minnesota and in a manner detrimental to the

3:45 P.M. In the matter of the Citation of Richard W. Falk and Albert Skarpness, registered pharmacists in the State of Minnesota, residing at respectively, 522 Ridgewood Ave., Apt. 3, Minneapolis, Minn., and 2310 Roosevelt N.E., Minneapolis, Minn.

Hearing was conducted by George Sjoselius, attorney for the Board, in Room 662, Nicollet Hotel, Minneapolis, Minn.

All of the members of the Board were present, also Mr. Moudry, secretary of the Board; Mr. Falk and Mr. Skarpness.

President French read the citation as follows: (Re: Mr. Falk)

"You have been cited to appear before the Minnesota State Board of Pharmacy to make such answer to the charges herein contained as you may be advised or deem expedient and to show cause, if any you have, why the license to practice pharmacy heretofore granted to you by the Minnesota State Board of Pharmacy as a pharmacist should not be suspended or revoked upon the following ground: unprofessional conduct as follows: that you, the Said Richard W. "Mr. Skarpness, you have been cited to appear before the Minnesota State Board of Pharmacy to make such answer to the charges herein contained as you may be advised or deem expedient and to show cause, if any you have, why the license to practice pharmacy heretofore granted to you by the Minnesota State Board of Pharmacy as a pharmacist should not be suspended or revoked upon the following ground: unprofessional conduct as follows: that you, the said Albert Skarpness, conducted yourself in a manner unbecoming a person licensed to practice pharmacy in the State of Minnesota and in a manner endangering the public health, more particularly as follows: that on the 18th day of May, 1949, while you were acting as a pharmacist in charge of the Danielson Drug Company at 2339 Central Avenue, Minneapolis, Minnesota, you did authorize and approve the filling by Richard W. Falk, a registered pharmacist, of a prescription issued for Mrs. Margaret Bjurstrom with barbital without the written or verbal consent of the prescriber of such prescription as required by law."

IT IS HEREBY ORDERED that as punishment for the unprofessional conduct therein alleged the said Richard W. Falk shall be admonished and reprimanded by the Secretary of the Board. Motion carried.

Moved by Mr. Carlsen, seconded Mr. Deterling:

RESOLVED by the Minnesota State Board of Pharmacy, duly convened in the City of Minneapolis, Minnesota, on the 27th day of October, 1949, as follows:

That Albert Skarpness, having appeared at the meeting of the Minnesota State Board of Pharmacy held in Room 662 Nicollet Hotel, Minneapolis, Minnesota, in response to the citation duly served upon him, and having admitted the charges therein made against him,

IT IS HEREBY ORDERED that as punishment for the unprofessional conduct therein alleged the said Albert Skarpness shall be admonished and reprimanded by the Secretary of the Board. Motion carried.

In reprimanding Mr. Falk and Mr. Skarpness, Mr. Moudry stressed the importance of complying with all laws and regulations dealing with the practice of their profession. Mr. Falk and Mr. Skarpness promised the Board that in the future they will comply with all laws and regulations pertaining to the practice of pharmacy.

After 4:00 P.M. In the matter of the Citation of Edwin Shirley, a registered pharmacist in the State of Minnesota, residing at 4341 Colfax Avenue S., Minneapolis, Minn.

Hearing was conducted by George Sjoselius, attorney for the Board, in Room 662, Nicollet Hotel, Minneapolis, Minn.

All of the members of the Board were present, also Mr. Moudry, secretary of the Board; and Mr. Shirley.

President French read the citation as follows:

"You have been cited to appear before the Minnesota State Board of Pharmacy to make such answer to the charges herein contained as you may be advised or deem expedient, and to show cause, if any you have, why the license to practice pharmacy heretofore granted to you by the Minnesota State Board of Pharmacy as a pharmacist should not be suspended or revoked upon the following ground: unprofessional conduct as follows: that you, the said Edwin Shirley, conducted yourself in a manner unbecoming a person licensed to practice pharmacy in the State of Minnesota and in a manner endangering the public health, more particularly as follows: that while employed as a pharmacist by the Lowry Hill Pharmacy, 1824 Lyndale Avenue South, Minneapolis, Minnesota, you, the said Edwin Shirley, did refill a prescription for barbiturates for C. A. Marshall several times without obtaining the written or oral consent of the prescriber as required by law; that while employed by the Haeny Pharmacy, 5601 Chicago Avenue, Minneapolis, and by Clark's Drug Store, 3469 Minnehaha Avenue, Minneapolis, you, the said Edwin Shirley, did on at least five occasions sell barbiturates as required by law; that on July 26, 1949, you sent by registered mail to C. A. Marshall, Northeast Maryland, a package containing about 60 pentabarbital sodium tablets; that you sold said tablets to C. A. Marshall without a prescription therefor as required by law.

After the hearing the following action was taken:

Moved by Mr. Carlsen, seconded by Mr. Deterling:

RESOLVED by the Minnesota State Board of Pharmacy, duly convened in the City of Minneapolis, Minnesota, on the 27th day of October, 1949, as follows:

X Edwin Shirley, having been duly cited to appear before the Minnesota State Board of Pharmacy on October 27, 1949, at 4:00 P.M., to make such answer to the charges herein contained as he may be advised or deem expedient and show cause, if any he has, why the license to practice pharmacy heretofore granted to him by the Minnesota State Board of Pharmacy as a pharmacist should not be suspended or revoked upon the following grounds:

1. That while employed as a pharmacist by the Lowry Hill Pharmacy, 1824 Lyndale Avenue South, Minneapolis, Minnesota, you, the said Edwin Shirley, did refill a prescription for barbiturates for C. A. Marshall several times without obtaining the written or oral consent of the prescriber of the prescription, as required by law.

2. That while employed by the Haeny Pharmacy, 5601 Chicago Avenue, Minneapolis, Minnesota, and by Clark's Drug Store, 3469 Minnehaha Avenue, Minneapolis, Minnesota, you, the said Edwin Shirley did on at least five occasions sell barbiturates to

C. A. Marshall without a prescription for such barbiturates, as required by law.

3. That on July 26, 1949, you sent, by registered mail, to C. A. Marshall, North East, Maryland, a package containing about sixty (60) Pentobarbital Sodium tablets. That you sold said tablets to C. A. Marshall without a prescription therefor, as required by law,

and the said Edwin Shirley, having at the time and place therein specified appeared before the Minnesota State Board of Pharmacy and denied the allegations contained in the second paragraph and admitted the allegations contained in the first and third paragraphs, the Board, having duly considered the evidence adduced and the statement of said Edwin Shirley,

IT IS HEREBY ORDERED that a final disposition of the charges against said Edwin Shirley is hereby continued until the meeting of the Minnesota State Board of Pharmacy to be held in the fall of 1950 and that the secretary, at least twenty (20) days prior to said meeting, notify said Edwin Shirley of the time and place thereof.

X Motion carried.

The Board adjourned to meet again at 2:00 o'clock P.M., October 28, 1949.

October 28, 1949. The Board met in its rooms at the Nicollet Hotel, Minneapolis, Minn., 2:00 P.M.

President French called meeting to order. (All Members of the Board were present.)

The following persons had filed applications for reciprocal registration and had been notified to appear before the Board.

Ahern, Wm. R.	registered in South Dakota
Mellon, Russell R.	registered in Montana
Mulholland, Kenneth W.	registered in Iowa

All of the above appeared and their applications were gone over and each applicant was interviewed by the Board. All were given the written examination in Jurisprudence.

The secretary reported that M. J. Livingston, whose application for reciprocal registration on the basis of his registration as a pharmacist in Iowa had been denied at the meeting of the Board in July, 1949 because he was not eligible, had filed additional affidavits certifying to drug store experience having been obtained from June, 1918 to August, 1919, which was drug store experience gained while attending high school, and between the ages of 15 and 16.

Moved by Mr. Pasternacki, seconded by Mr. Deterling, that action taken by the Board on July 19, 1949 in the matter of reciprocal registration of M. J. Livingston, be reconsidered and held over to the January, 1950 meeting so that the new affidavits submitted by Mr. Livingston could be checked to determine if he now would be eligible. (3 ayes, 1 no.)

At the request of the Board the secretary asked Bert Supplee to appear before the Board at 3:30 P.M., October 28, 1949, to discuss the matter of the sale of barbiturates over the counter. At the July meeting the Board had reviewed evidence against Mr. Supplee together with our legal counsel, George Sjoselius, and at that time we were advised that the Board did not have sufficient evidence to cite him, but it was of sufficient importance that he should be called before the Board to discuss the matter.

At 3:30 P.M. Mr. Supplee appeared, and the Board listened to his detailed story of the whole case. He also informed the Board that he had been cited before the Federal Food and Drug Administration at its office in Minneapolis for charges of violation of the Federal Food, Drug and Cosmetic Act, which included the sale of barbiturates over the counter. At that time the Food and Drug Administration informed him that his case would be sent to Washington for determination of what action would be taken.

The Board reprimanded Mr. Supplee for carelessness in the practice of his profession, pointing out that as a pharmacist he is required to comply with all the laws of the State and Federal government dealing with the practice of pharmacy, and the keeping of such records as are necessary to comply with the law and for his protection.

Mr. Supplee stated that he had never sold any barbiturates over the counter, and that the charges brought by the Food and Drug Administration were for substitution on the filling of a prescription, and he showed the Board affidavits from the physician that he had authorized Mr. Supplee to dispense the drug that was used in the filling of the prescription.

Mr. Supplee promised the Board that in the future he would comply in all matters pertaining to the laws and regulations of the Board, State and Federal, and that he would keep records and prescription files according to the laws and regulations.

The Board informed Mr. Supplee that if repetition of these practices were made and if they were called to the attention of the Board, it would be grounds for citation for the revocation or suspension of his pharmacist registration.

Marvin Anderson, a registered pharmacist in the State of Minnesota, appeared before the Board at the invitation of the secretary to discuss the matter of refilling a barbiturate prescription, No. 159349, dated February 9, 1943, for Calcium Ipral, without an O.K. from the physician. ✓

Mr. Anderson is employed by the Snyder's Drug Stores, 409 Robert St., St. Paul, Minn., as a pharmacist, and is in charge of the prescription department there. He stated he had no knowledge of the prescription being refilled, that there was no record of it on the prescription, or on the back of it, indicating that it had been refilled.

John O. Roosen, 2704 Pillsbury Ave., Minneapolis, Minn., complained to the secretary that he had had this prescription filled at the Snyder Drug Store and that to his knowledge the pharmacist did not call the doctor for an O.K. but filled it.

After receiving the complaint, the Board's inspector, Earl J. Schlekau, took the number of the prescription and secured the services of a shopper and attempted to have the prescription refilled at the Snyder Drug Store, 409 Robert St., St. Paul, Minn. The shopper was informed that it was necessary to call the doctor for an O.K. and that it would take about twenty (20) minutes. The shopper returned in about a half hour and was informed the prescription could not be refilled, as when the doctor was contacted he stated it should not be refilled.

Mr. Anderson stated that this is the procedure they follow in the store and just could not understand how Mr. Roosen could have received a refill of that prescription without the doctor's O.K.

The Board impressed upon Mr. Anderson the importance of following the laws and regulations of the State and Federal government dealing with dispensing of drugs and medicines; the necessity of keeping adequate records; proper filing of barbiturate and narcotic prescriptions; and the refusal to sell drugs carrying the prescription legend without a prescription

Mr. Anderson, who is in charge of the prescription department, assured the Board he would instruct all of the pharmacists in the department, and assured the Board that as far as their operation was concerned, they would comply with all of the laws and regulations dealing with the sale and dispensing of drugs.

It was moved and seconded that the following persons be granted registration as pharmacists by reciprocity:


