MINNESOTA STATE BOARD OF PHARMACY

Three Hundred and Sixty-Third Meeting  
-----

January 25, 1960. The Board met at 9:00 o'clock a.m., College of Pharmacy, University of Minnesota, Minneapolis. Members present - President Angus H. Taylor, Vice President Floyd M. Alcott, James M. Gardner, Ivan E. Peterson and Max Bearman. Mr. Angus H. Taylor served as a Board Member at this meeting since Governor Orville L. Freeman had not as yet appointed Mr. Taylor's successor.

The following appeared to take the practical examination as they had passed the written examination at a previous examination given by the Board and at this time they had fulfilled the requirement of at least one year of apprenticeship training:

The Board spent the entire day giving the practical examination. The candidates were given five compounded prescriptions to fill in the morning.

The Board adjourned at 12:00 o'clock noon for lunch and reconvened at 1:00 o'clock p.m.

The candidates were given five count-and-pour prescriptions to fill in the afternoon.

The students completed their prescriptions at approximately 3:00 o'clock p.m. The Board Members continued working until 4:30 o'clock p.m., grading the finished prescriptions.

January 26, 1960. The Board met at Westbrook Hall, University of Minnesota, at 9:00 o'clock a.m., to give the written examination in the following subjects: Pharmacy, Chemistry, Materia Medica, Pharmaceutical and Chemical Mathematics and Jurisprudence.

In addition to giving the written examination to the five candidates who were eligible to take the entire examination, the following candidates appeared but were eligible to take only the written examination as they had not as yet obtained the required one year of apprentice training, and had failed the written examination in July, 1959.

\*Mr. Joseph L. Sing appeared to rewrite the Chemistry examination as he had failed to obtain a grade of 60 in this subject when he took the written examination in July, 1959.

The candidates were given three examinations in the morning and two in the afternoon, each Board Member monitoring his own examination.

Total number of candidates taking the written examination was 7.

January 27, 1960. The Board met in its rooms at the Nicollet Hotel, Minneapolis, and began marking the written work of the candidates.

At 10:00 o'clock A.M., Mr. Earle W. Johnson of the Johnson Drug, 1336 Coon Rapids Blvd., Coon Rapids, appeared in response to a letter sent him by the Secretary on January 13, 1960. President Taylor called the meeting to order. All members of the Board were present, also Secretary Arthur L. Eide and Inspector Earl J. Schlekau. Mr. Johnson was called in because his drug store had been found to be uncovered. After discussing this with Mr. Johnson, the Board members severely reprimanded him and he was then dismissed. The interview lasted for an hour and a half.

The Board members continued to mark the written work of the candidates until 12:30 o'clock and adjourned for lunch.

2:00 o'clock p.m., the Board met with the candidates who had taken the entire examination and those who had previously taken the written examination and passed and took only the practical examination at this meeting. These candidates appeared before the Board Members in groups of five for an oral interview. Fifteen minutes was devoted to each group. The interviews were completed at approximately 3:30 o'clock pm.

After the oral interviews were completed the Board then discussed general problems of the Board. and financial situation was discussed.

January 28, 1960. The Board met in its rooms at the Nicollet Hotel, 9:00 o'clock A.M., to consider applications filed for reciprocity and to interview applicants filing such applications.

President Angus H. Taylor called the meeting to order.

Board recessed for lunch at 12:00 o'clock noon.

Board reconvened at 1:30 o'clock p.m.

The Board continued to interview reciprocal applicants until 3:30 o'clock p.m.

3:30 o'clock p.m. Mr. Arthur O. Tronsdal of Duluth, together with Mr. William Kelly and Mr. A. T. Otis of the Rexall Company, appeared before the Board relative to the application of the Tronsdal Drug Company.

Following a general discussion, Mr. Peterson moved and Mr. Alcott seconded a motion that the Board issue a license to the Tronsdal Drug Company pursuant to discussions held this day and at previous meetings of the Board. Motion carried.

The Board adjourned at 5:00 o'clock p.m.

January 29, 1960. The Board met in its rooms at the Nicollet Hotel = 9:00 o'clock a.m.

The meeting was called to order by President Angus H. Taylor.

The minutes of the July, 1960 and the special meeting in September were read. It was moved by Mr. Bearman and seconded by Mr. Alcott, that the minutes be approved as read. Motion carried.

Each Board Member had been furnished with a copy of the financial statement. It was moved by Mr. Peterson and seconded by Mr. Alcott, that the financial statement be accepted. Motion carried.

10:00 o'clock a.m. Mr. George William Murphy, Jr., appeared before the Board with his wife and his attorney, Mr. Robert A. Gearin. (Mr. Gearin stated he was appearing as a friend rather than Mr. Murphy's attorney).

The Secretary of the Board had previously received a petition from Mr. Gearin regarding the reinstatement of Mr. Murphy's license to practice pharmacy in Minnesota.

Mr. Taylor read an excerpt from the minutes of the Board meeting of January, 1958. Mr. Taylor also stated that Mr. Murphy was required to take the practical examination to show he was safe to handle drugs and passed such examination.

Mr. Murphy has previously sent to the secretary, letters of recommendation. These letters were discussed by the Board Members with Mr. Murphy.

Mr. Murphy stated he would like to get back in his profession and that he had had a long time to think things over and felt he owed it to himself and his family to get back in his profession. He stated he had joined A.A.'s during his confinement in St. Cloud Reformatory and felt he had overcome his problems.

Mr. and Mrs. Murphy and Mr. Gearin were asked to leave the room.

After further discussion Mr. Peterson moved that Mr. Murphy's license be reinstated provided the necessary costs were taken care of. Mr. Alcott seconded the motion. Motion carried.

Mr. Murphy was recalled into the room and was advised of the Board's action.

The Board then continued with the executive meeting.

Moved by Mr. Alcott and seconded by Mr. Peterson, that the bond premium for the secretary for the coming year be paid out of the funds of the Board. Motion carried.

Moved by Mr. Bearman, seconded by Mr. Alcott, that the membership fees for the National Association of Boards of Pharmacy be paid out of the funds of the Board. Motion carried.

Moved by Mr. Peterson that \$2,000 should not be turned over to the Minnesota State Pharmaceutical Association for the advancement of the Arts and Science in Pharmacy as provided by law due to the fact that in 1960 the Board will not have the funds. Seconded by Mr. Bearman. Motion carried.

It was moved<sup>and seconded</sup> and that the January, 1961 meeting be set for the week beginning, Monday, January 23. Motion carried.

It was moved by Mr. Bearman and seconded by Mr. Gardner that the twenty-three candidates who received a general average of 75 percent or better, not below 75 percent in practical, and not below 60 percent in any other subject, be granted registration as pharmacists. Upon receipt of Groves-Kelco's application the Secretary made contact with the President of the Board, other members, and the Board's attorney and it was decided that the matter should be put on the agenda for the regular meeting of the Board in January, 1960. On January 5th, 1960, the following communication was sent to Groves-Kelco, Inc.:

Your letter of January 5, 1960 addressed to Groves-Kelco, Inc. has been referred to me for answering.

Since you have not requested us to appear but have merely extended the opportunity to us to appear if we desire and since in the past there has never been an appearance by Groves Kelco, Inc., or to the best of my knowledge by anyone else in connection with a wholesalers license, we can see no reason for appearing in connection with the present application.

The Secretary further reported after conferring with the Chief Inspector and the Board's Attorney that

1. The Groves Kelco, Inc. duly applied for and were issued wholesaler's licenses for the years 1953-54 and 1954-55.

2. That Groves Kelco, Inc., last license terminated June 13, 1955.
3. That since that time Grove Kelco, Inc., continued to wholesale drugs and medicines without any license to more than 1200 retail outlets in the state. That a greater portion of the 1200 retail outlets were unlicensed retail outlets.
4. That among the drug products distributed at wholesale by Groves-Kelco were drug products which Groves Kelco admitted could not be sold at wholesale or retail without license.
5. That numerous drug products sold by Groves Kelco at wholesale to unlicensed retail outlets were drug products which the chief inspector had repeatedly advised them could not be sold to unlicensed retail outlets.
6. Groves Kelco, Inc., has since 1955 disputed and contested the authority of the Board of Pharmacy, has continuously displayed and conducted their business in a hostile and uncooperative manner and has on various occasions by writing, correspondence and other methods, attempted to induce and persuade numerous retail outlets to disobey the instructions of the inspection division of the Board of Pharmacy.

Thereupon by motion of Mr. Peterson, seconded by Mr. Alcott, the application of Groves Kelco, Inc. for wholesalers license was denied and the motion was carried.

Moved by Mr. Bearman, seconded by Mr. Gardner, that the fee for renewal of pharmacist registration for 1960 be fixed at \$5.00, the assistant pharmacist renewal fee be fixed at \$3.00, and the fees for drug store license at \$10.00, and household drug license at \$5.00. Motion carried.

Moved by Mr. Peterson, seconded by Mr. Bearman, that the President, Vice President and Secretary be sent as delegates to the National Association of Boards of Pharmacy meeting in Washington, D.C., in August. Motion carried.

Moved by Mr. Peterson that Floyd M. Alcott be nominated for president of the Board for the ensuing year, seconded by Mr. Gardner. A unanimous ballot was cast for Mr. Alcott.

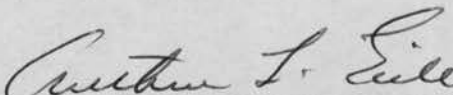
Moved by Mr. Bearman that James M. Gardner be nominated for vice president for the ensuing year. Motion carried.

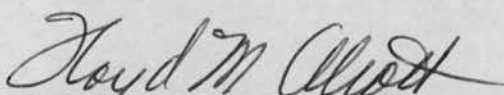

Three Hundred and Sixty-Fourth Meeting  
-----

March 15, 1960. A special meeting was held at the Pick-Nicollet Hotel, Minneapolis, Minnesota. Members present - President Floyd M. Alcott, Vice President James M. Gardner, Ivan E. Peterson, Max Bearman, Oscar A. Olson and Secretary Arthur L. Eide.

The meeting was called to order by President Floyd M. Alcott at 8 o'clock p.m. Mr. Alcott recognized Mr. William Essling, the Board's attorney, and also, Mr. Angus H. Taylor. Mr. Taylor who has been a member of the Board for the past ten years and is the Board's immediate past President, expressed regret at no longer being a member of the Board and extended his congratulations to, and willingness to help Mr. Oscar A. Olson, the Board's newest member.

President Alcott read copies of proposed regulations numbers 20 and 21 to the Board and a lengthy discussion followed.

Mr. William Essling gave a review of the recent court case in Hennepin County District Court in which Judge William Larson rules in favor of the defendants, Red Owl, Inc., and Groves-Kelco Inc. A discussion followed.

Mr. Gardner moved that the Board of Pharmacy, through its attorney, Mr. William Essling, appeal Judge Larson's decision to the Supreme Court, State of Minnesota, and hereby requests that the Board's attorney vigorously handle such appeal. Mr. Peterson seconded the motion and it carried.

A discussion ensued regarding permit stores. Mr. Olson moved and Mr. Bearman seconded that the Board instruct its secretary to make a detailed study of permit stores and report to the Board at its next regular meeting. Motion carried.

Upon motion made and seconded meeting was adjourned.

March 16, 1960 (Wednesday). Board reconvened at 9:30 o'clock a.m., at the Pick-Nicollet Hotel, Minneapolis, Minnesota.

Meeting was called to order at 9:30 o'clock a.m., by President Alcott.

Proposed regulations Nos. 20 and 21 were discussed at length.

At 11:30 o'clock a.m., the Board recessed to attend a meeting of the President's Advisory Council of the Minnesota State Pharmaceutical Association at the Normandy Hotel, Minneapolis.

At 4 o'clock p.m., the Board reconvened at the Pick-Nicollet Hotel and proposed regulations Nos. 20 and 21 were discussed.

Mr. Peterson moved and Mr. Gardner seconded that the following regulation be adopted by the Board:

WHEREAS the first obligation of the Board of Pharmacy of the State of Minnesota is to protect the public health as it may be affected by the preparation, sale and distribution of drugs and

WHEREAS the sale and distribution of drugs by prescription is best safeguarded by direct, constant and professional contact between the physician, patient and pharmacist and

WHEREAS the solicited mail order sale and distribution of drugs by prescription tends to impair the necessary direct, constant and professional contact between physician, patient and pharmacist and

WHEREAS the solicited mail order sale and distribution of drugs by prescription tends to lead to falsification, forgery and fraudulent presentation of prescriptions

NOW THEREFORE, BE IT RESOLVED by the Board of Pharmacy of the State of Minnesota, duly convened in Minneapolis, Minnesota this 16th day of March, 1960, that the regulation hereinafter set forth be hereby promulgated and adopted to be immediately effective:

NO. 20. Hereafter no pharmacist or pharmacy shall solicit by advertising of any kind the sale or distribution of drugs by prescription by any mail order plan of any form. The mail order sale of drugs by prescription is prohibited whenever such sale has been solicited by advertising of any kind by any person or persons.

Motion carried unanimously.

Mr. Olson moved and Mr. Bearman seconded that the following regulation be adopted by the Board:

WHEREAS the first obligation of the Board of Pharmacy of the State of Minnesota is to protect the public health as it may be affected by the preparation, sale and distribution of drugs and

WHEREAS the advertising of prices, percentiles of prices or discounts of prescriptions or drugs requiring a prescription can be misleading to the public and

WHEREAS advertising prescriptions as being sold at a discount, lower price or percentile of a price is conducive to the use of substandard pharmaceuticals

NOW THEREFORE, BE IT RESOLVED by the Board of Pharmacy of the State of Minnesota, duly convened in Minneapolis, Minnesota this 16th day of March, 1960, that the regulation hereinafter set forth be hereby promulgated and adopted to be immediately effective:

NO. 21. No pharmacist or pharmacy shall advertise in any manner, prices, percentiles of prices or discounts, for prescriptions and drugs requiring a prescription.

Motion carried unanimously.

The Board then held a general discussion and adjourned late in the evening.

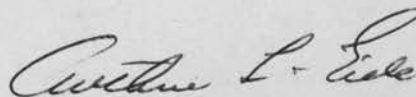

- 3) The fee for examination as a registered pharmacist in this state shall be raised from \$20.00 to an amount to be set by the Board not to exceed \$50.00.
- 4) The per diem to the Board members for their actual services as such, be changed from the present mandatory amount of \$20.00 to an amount to be set by the Board but not to exceed \$35.00 per day.
- 5) The fee for registration of pharmacists in this state by reciprocity from another state be raised from \$25.00 to an amount to be set by the Board not to exceed \$50.00.
- 6) The fee for annual pharmacist license renewal be raised from \$5.00 to an amount to be set by the Board not to exceed \$15.00.
- 7) The fee for the annual renewal/licenses of pharmacy be raised from \$10.00 to an amount not to exceed \$20.00.

Following a discussion Mr. Olson moved and Mr. Gardner seconded that the Secretary take the necessary steps for the introduction and passage of such legislation. Motion carried.

Mr. Gardner moved and Mr. Bearman seconded that the Secretary be instructed to make the following changes in licensing and examination fees as soon as practicable if the proposed legislation is passed by the legislature:

Pharmacist renewal to be set at \$10.00 per year.  
Pharmacy license renewal to be set at \$20.00 per year.  
Wholesaler's license to be set at \$50.00 per year.  
Manufacturer's license to be set at \$50.00 per year.  
Assistant pharmacist license renewal remain at \$3.00.  
Household drug license remain at \$5.00 per year.

Fee for examination as a pharmacist remain at \$20.00 through July, 1961 Board meeting and be further discussed at that meeting. Motion carried.

Mr. Gardner moved and Mr. Bearman seconded that the Board recognize the U.S.P. XVI and N.F. XI as official and that all licensed pharmacies be required to have copies of these official books on hand. Motion carried.

Mr. Olson moved and Mr. Peterson seconded that action on pocket identification cards for licensed pharmacists in this state be tabled until the July meeting. Motion carried.

Mr. Olson moved and Mr. Gardner seconded that the Board take official notice of the apparent infraction of laws by registered pharmacist Ronald Lavine and that the Secretary conduct an investigation of the case and take the necessary action in the matter. Motion carried.

Mr. Olson moved and Mr. Bearman seconded that James H. Gardner be nominated for president for the ensuing year. Motion carried. It was moved and seconded that nominations be closed. Motion carried.

Mr. Bearman moved and Mr. Olson seconded that Mr. Ivan E. Peterson be nominated for vice-president for the ensuing year. Motion carried. It was moved and seconded that nominations be closed. Motion carried.

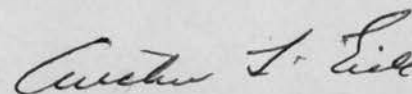

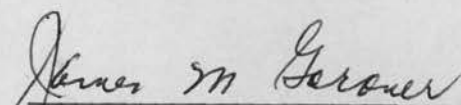

Mr. Appel moved and Mr. Telander seconded that the fee for reciprocity to this state, on the basis of registration in another state, be raised from the \$25 fee of the present to the \$50 fee allowable by law beginning with the January 1962 meeting of the Board. Motion carried.

Mr. Appel moved and Mr. Bearman seconded, that the fee for renewal of registration as a pharmacist in this state be raised from the present \$5 to \$10, beginning with the pharmacists renewals due March 4, 1962.

A discussion ensued involving the issuing of pocket identification cards to each registered pharmacist at each time his license renewal is paid. It was decided that this idea had merit and following a thorough discussion, Mr. Appel moved and Mr. Telander seconded that the Board's secretary issue appropriate pocket cards at the time of the next license renewal. Motion carried.

The possibility of the need for additional file cabinets at the Board office was discussed next. The secretary informed the Board members of the existing need for additional filing space. After a thorough discussion Mr. Telander moved and Mr. Appel seconded that the secretary determine the needs of the office and be authorized to purchase the necessary number of file cabinets. Motion carried.

A discussion involving the purchase of a new Diebold cardineer filing wheel for the office began. The secretary pointed out the fact that the present wheel was no longer adequate in capacity. He also pointed out that the cards being used at the present time were due to be replaced and that for these two reasons a new, larger wheel would be in order. Catalogues showing the desired type of wheel and its price were presented to the Board members for study. Mr. Peterson moved and Mr. Appel seconded that the secretary purchase from Diebold, Inc., one Model #10816-16 rotary file for the office paying the quoted price from Diebold less the amount allowed for tradein on the former wheel. Motion carried.

The purchase of a new more efficient Pitney-Bowes postal meter was discussed and action on this matter was laid over to a future meeting.

The Board's president, Mr. Gardner, asked for a motion that the secretary's salary be increased from \$8400 per year to \$9,000 per year effective immediately. He also asked that this motion include provisions for a two-week paid vacation to be allowed during a calendar year, January 1 through December 31. This motion was so made by Mr. Peterson and seconded by Mr. Bearman and carried unanimously.

Minnesota State Board of Pharmacy - 370th Meeting - July, 1961

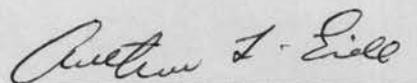
At previous meetings of the Board the possibility of changing the narcotic status of Paregoric had been discussed. After a thorough discussion the Board instructed its secretary to approach the State Board of Health to present to them the following proposal: "That the prescription status of Camphorated Opium Tincture (paregoric) in Minnesota be changed from Class A narcotic, requiring a written prescription to Class B narcotic, allowing either written or oral prescriptions for the product". It was the consensus of the Board that this move would further facilitate the practice of medicine and pharmacy by allowing oral prescriptions. It was noted by the Board that according to Federal Rules regarding Narcotics, Paregoric is an exempt preparation.

President Gardner had informed the Board of his intention to resign his appointment for reasons of ill health. Mr. Peterson, Mr. Bearman, Mr. Telander and Mr. Appel then requested that the Minutes of the Board reflect the following:

Mr. Peterson, Mr. Bearman, Mr. Telander and Mr. Appel, learn with regret of President Gardner's intention to resign. The members of the Board will miss his sage advice and devotion to duty. Mr. Gardner gave freely of his time and energy to the improvement of the public health as it is affected by the practice of the profession of pharmacy and his presence as a member of this Board will be missed. His services have been deeply appreciated.

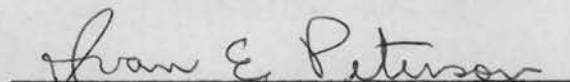

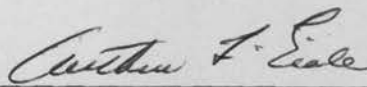

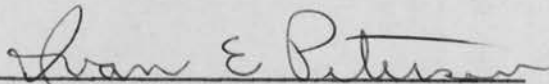

The Board took official notice of the resignation of President James M. Gardner and the appointment of John H. Nelson of Redwood Falls, by Governor Elmer L. Andersen on September 18, 1961.

9:30 o'clock A.M., Mr. Gerald J. Schauff of Schauff Pharmacy, 3359 - 36th Avenue South, Minneapolis, appeared in response to a letter from the Secretary which further required that he bring his exempt narcotic records covering the past two years. The Board Members reviewed Mr. Schauff's exempt narcotic register and noted excessive sale of certain exempt preparations. After a thorough discussion with Mr. Schauff regarding this apparent infraction of the narcotic laws, the Board issued a severe reprimand to Mr. Schauff and extracted the promise from him that this situation would be cleared up and all laws dealing with exempt narcotics and all other drugs would be faithfully observed at the Schauff Pharmacy.

10:30 o'clock A.M., the Board considered the application of the Groves Kelco Company of Minneapolis, Minnesota, for a Drug Wholesale License.

Mr. Arnold Royce, an officer of the Groves Kelco Company, and Mr. Theodor Herman, Attorney of Minneapolis, appeared for the applicant.

A record of the proceedings was made by Phyllis R. Farquharson, Court Reporter.

After inquiry of those persons representing the applicant and considering the Board's files and records, the following motion was made:

Moved by William F. Appel and seconded by Norman W. Telander, that the application of Groves Kelco Company for a Drug Wholesale License be denied for the following reasons:

1. Drug wholesale licenses are to be granted for the selling at wholesale of drugs, medicines, chemicals, or poisons, for medicinal purposes and not for the wholesale selling of baby foods and toiletries.

2. The Groves Kelco Company has a very unsatisfactory record of past violations of the Pharmacy Act and Board Regulations, and advised the Board that it would not follow Board regulations with which it did not agree.

During a recent inspection by Inspector Earl J. Schlekau, it was noted that the Korner Kut Rate Drug Store was open for the transaction of business without a pharmacist in charge.

After a thorough discussion with Mr. Timmons the Board issued a severe reprimand and warned Mr. Timmons that any further infractions of this type would be dealt with in the most severe manner possible.

2:30 o'clock P.M., Mr. Hoyt H. Haycock, Pine City Drug, Pine City, Minnesota, appeared in response to a letter from the Secretary regarding the operation of this store. During a recent inspection by Inspector Earl J. Schlekau, it was noted that the Pine City Drug Store was open for the transaction of business without a pharmacist in charge.

After a thorough discussion with Mr. Haycock, the Board issued a severe reprimand and warned Mr. Haycock that any further infractions of this type would be dealt with in the most severe manner possible.

3:30 o'clock P.M., Mr. Douglas Stark, one of the owners of the Thrifty Drug, Brainerd, Minnesota, appeared in response to a letter from the Secretary regarding the operation of this drug store. During a recent inspection the store was found to not be properly covered by a pharmacist while open for business.

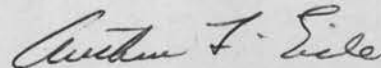
No pharmacist, or pharmacy, shall accept or fill a prescription which has been received by mail and that has been written by a practitioner not licensed to practice his profession in this state.

The mail order sale of drugs by prescription is prohibited whenever such sale has been solicited by advertising of any kind by any person or persons. No pharmacist or pharmacy shall accept or fill a prescription which has been received by mail and that has been written by a practitioner not licensed to practice his profession in this state.

Mr. Nelson moved that the meeting be adjourned. Mr. Telander seconded this motion. Motion carried.

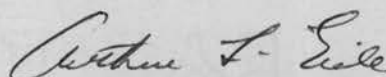

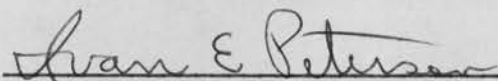

Mr. Telander moved and Mr. Appel seconded that the license to practice pharmacy previously issued by this Board to Marvin M. Friedman be suspended for a period of sixty (60) days beginning at midnight Wednesday, February 14, 1962 and lasting until midnight Sunday, April 15, 1962, and that Mr. Friedman pay all costs of the proceedings and in addition thereto, pay the reinstatement fee of \$25 and further that the Secretary notify Mr. Friedman of this suspension and collect the necessary fees. Motion carried.

Mr. Nelson moved and Mr. Bearman seconded that the license to practice pharmacy previously issued by this Board to Clemence Barich be suspended for a period of five (5) days beginning at midnight Thursday, February 2, 1962 and lasting until midnight Tuesday, February 6, 1962, and that Mr. Barich pay all costs of the proceedings and in addition thereto, pay the reinstatement fee of \$25 and further, that the Secretary notify Mr. Barich of this suspension and collect the necessary fees. Motion carried.

Mr. Nelson moved and Mr. Appel seconded that the license to practice pharmacy previously issued by this Board to Robert W. Jones be suspended for a period of five (5) days beginning at midnight Thursday, February 2, 1962 and lasting until midnight Tuesday, February 6, 1962, and that Mr. Jones pay all costs of the proceedings and in addition thereto, pay the reinstatement fee of \$25 and further, that the Secretary notify Mr. Jones of this suspension and collect the necessary fees. Motion carried.

At 7:15 o'clock P.M., and on motion duly made and carried the Board adjourned for the day.

January 27, 1962. (Saturday) The Board met in its rooms at the Nicollet Hotel at 8:30 o'clock A.M. President Peterson called the meeting to order.

At 9:00 o'clock A.M., Mr. Frank L. Toonen appeared before the Board in a continuation hearing of a citation served upon him on January 5, 1961. This hearing had been delayed from the regular July meeting due to the death of Mr. Toonen's wife. After a thorough discussion of Mr. Toonen's professional practice, Mr. Bearman moved and Mr. Telander seconded that the citation and actions thereon be dismissed. Motion carried.

Mr. Shiffman was requested to appear before the Board to explain why the Grand Central Pharmacy, which is owned by Mr. Shiffman, was not utilizing the separate outside entrance which it contains. After a thorough discussion of the situation, agreement was reached and Mr. Shiffman departed.

At 12:00 o'clock noon the Board recessed for lunch and reconvened at 1:30 o'clock P.M.

At 2:00 o'clock P.M., Mr. Sam Lavine of Minneapolis appeared before the Board in response to a letter regarding the Radisson Ramp Pharmacy which he owns and was found to be uncovered. After a thorough discussion Mr. Lavine stated that the store would be covered at all times and the Board informed Mr. Lavine that any further infractions would involve more stringent action on the part of the Board.

At 2:30 o'clock P.M., President Peterson ordered the Board into executive session and called the meeting to order.

Minutes of the July meeting, the special meeting of August 31st, the special meeting of October 6th and the special meeting of November 29th were read. The following errors or omissions were noted and the Secretary was directed to change the minutes as follows:

Mr. Nelson moved and Mr. Appel seconded that the 22 candidates who received a general average of 75% or better, not below 75% in practical, and not below 60% in any other subject, be granted registration as pharmacists. List of names as follows:

April 11, 1962. At 8:30 o'clock A.M., the Board met in its rooms at the Nicollet Hotel. Members present were: President Ivan E. Peterson, Vice President Max Bearman, Mr. Norman W. Telander, Mr. William F. Appel and Mr. John H. Nelson. Also present were the Board's Secretary, Arthur L. Eide and the Board's Attorney, Robert W. Mattson. The Board's Inspector, Earl J. Schlekau was also present.

At 9:00 o'clock A.M., (Wednesday) Mr. John H. Mueller, appeared before the Board in answer to a letter written to him in regard to the Board's Inspector finding his pharmacy open for business without a pharmacist in charge. Mr. Mueller brought his attorney, a Mr. Fallon, with him. A discussion ensued regarding this infraction of the Pharmacy Act. Mr. Mueller presented his facts indicating extenuating circumstances. The Board then severely reprimanded Mr. Mueller and dismissed him.

At 10:00 o'clock A.M., Dr. Dahl, D.V.M. and Dr. Vollmer, D.V.M. met with the Board at their request to discuss the distribution of veterinary medicines in this state. After a thorough discussion it was agreed that the professions of Pharmacy and Veterinary Medicine would work together for the orderly and proper distribution of veterinary medicines in this state.

The Board members then discussed general business requiring their attention and at 12 o'clock noon recessed for lunch.

The Board returned to its rooms at 1:00 o'clock P.M., and again began discussing general business.

At 2:00 o'clock P.M., Mr. Raymond Rybak of Rybak's Pharmacy in Minneapolis appeared before the Board in response to a letter written to him by the Secretary. Mr. Rybak had been dispensing excessive quantities of certain exempt narcotic preparations. Mr. Rybak's exempt narcotic register, which he had been requested to bring along, was studied thoroughly by the Board members. A discussion followed during which Mr. Rybak was reprimanded for past actions and warned to thoroughly scrutinize each transaction involving exempt narcotics and on the basis of his professional knowledge, restrict sale of this type of preparation when necessary. Mr. Rybak was then dismissed.

A general discussion followed relative to other Board business. A proposed regulation prohibiting the distribution of drugs by vending machines was discussed thoroughly. The Board instructed

its Secretary and Attorney to investigate thoroughly the legal aspects of such type of regulation and report their findings at the July meeting.

At 5:00 o'clock P.M., on motion duly made, seconded and carried the meeting adjourned.

April 12, 1962 (Thursday) At 8:30 o'clock P.M., the Board met in its rooms at the Nicollet Hotel. Members present were President Ivan E. Peterson, Vice President Max Bearman, Mr. Norman W. Telander, Mr. William F. Appel and Mr. John H. Nelson.

At 9:00 o'clock A.M., Mr. Alan Stein of Shopper's City Pharmacy appeared before the Board in response to a letter from the Secretary. Mr. Schlekau, the Board's inspector had discovered a gross violation of Regulation No. 19 involving the display of drugs at Mr. Stein's Pharmacy. After a thorough discussion the Board severely reprimanded Mr. Stein and extracted from him the statement that his present method of displaying drugs would be brought into conformity with Regulation No. 19 and would remain that way.

At 10:00 o'clock A.M., Mr. Paul Stratton, President of Osco Drug, Inc., and Mr. Street, professional service department manager of Osco Drug, Inc., appeared before the Board in regard to applications for licenses to operate a pharmacy in behalf of Osco. A lengthy discussion ensued and at 11:30 o'clock A.M., Mr. Stratton and Mr. Street departed.

At 12:00 o'clock noon the Board recessed for lunch.

At 1:00 o'clock P.M., the Board reconvened in its rooms at the Nicollet Hotel.

The Secretary reported on recent meetings with the State Board of Health relative to the possibility of changing the narcotic status of camphorated tincture of Opium (Paregoric) in this state. According to the Harrison Narcotic Act, Paregoric is classified as an exempt narcotic federally. In Minnesota it has been, and is classified as an "A" class narcotic which requires a written prescription. In order to facilitate the practice of medicine and pharmacy in Minnesota the Board had instructed its secretary to contact the State Board of Health regarding the possibility of changing the status of Paregoric from Class "A" to Class "B", thereby allowing oral or telephoned prescriptions to be accepted by pharmacists from practitioners legally qualified to prescribe it. The secretary informed the Board that the State Board of Health could not, under the present law, change the status of Paregoric from "A" to "B" but that they could change its status from "A" to exempt and would do so provided the Board of Pharmacy

would limit its dispensing to written or oral prescription only.

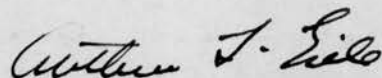
A lengthy and thorough discussion followed after which Mr. Telander moved and Mr. Appel seconded that:

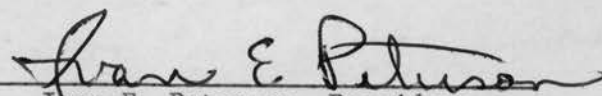
Commensurate with the action of the State Board of Health in declaring Camphorated Tincture of Opium (Paregoric) an exempt preparation in Minnesota, the State Board of Pharmacy does hereby declare, under the power vested in it under Minnesota Statutes Chapter 151.06, Subd. 2, that the compounding, dispensing, vending or selling of Camphorated Tincture of Opium (Paregoric) be accomplished only on a prescription, written or oral, of a practitioner lawfully entitled to prescribe the same in this state.

Motion carried unanimously.

A discussion ensued relative to the possibility of moving the Board office from its present location (3965 Minnehaha Avenue, Minneapolis) to more suitable quarters. The Secretary pointed out to the Board that the present quarters did not adequately allow for proper hearings and that it (the present quarters) was not adequate for present office and administration requirements. The Secretary reported that he had investigated several possible locations and reported the areas and rents for such areas. The Board instructed the Secretary to seek out adequate quarters for the Board and in so doing to work closely with Mr. Max Bearman and Mr. William Appel as an informal committee to determine the necessary action. The Board, as a whole, indicated a desire to remove its offices from the present quarters and furnish any new office spaces with furniture in kind so as to enhance its present position regarding hearings and administrative demands. Discussions of furnishings required in adequate office spaces revolved around a conference table and chairs in the event that suitable office spaces were acquired. The Board then instructed the Secretary to work with Mr. Max Bearman and Mr. William Appel in selecting suitable furniture for any office spaces that may be chosen by them.

Members present were: Ivan E. Peterson, President, Max Bearman, Vice President, Norman W. Telander, William F. Appel and John H. Nelson. Also present were Arthur L. Eide, Secretary, Earl J. Schlekau, Inspector and Robert W. Mattson, Attorney.

The matter of the application by Snyder's Drug Stores, Inc., for pharmacy licenses for 21 stores located in Minnesota was considered.

2:00 o'clock P.M., Mr. Lloyd D. Berkus and Mr. William H. Smith, officers of Snyder's Drug Stores, Inc., appeared for the applicants.

A record of the proceedings was made by Phyllis Farquharson, court reporter.

After considering the applications, exhibits, the Board's files and records, and hearing the testimony of those persons representing the applicants and the testimony of Mr. Earl J. Schlekau, the following motion was made: Moved by Norman W. Telander and seconded by William F. Appel that the following findings of fact be adopted and the application by Snyder's Drug Stores, Inc., for pharmacy licenses for 21 stores be denied.

The State Board of Pharmacy hereby finds that:

1. All of the outstanding capital stock of Snyder's Drug Stores, Inc., consists of 5,000 shares of common stock and that all 5,000 shares of stock are issued to and held by Red Owl Stores, Inc.
2. Snyder's Drug Stores, Inc., is a wholly owned and controlled subsidiary of Red Owl Stores, Inc.
3. The applications for pharmacy licenses are in fact those of Red Owl Stores, Inc., acting by and through its wholly owned subsidiary, Snyder's Drug Stores, Inc.
4. The Red Owl Stores, Inc., through their retail grocery outlets have been for some time, and were as of the date of this hearing, selling drug items in violation of the state law.

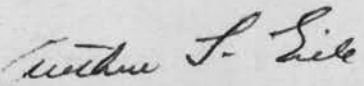
5. No evidence or testimony was presented at such hearing to indicate that Red Owl Stores, Inc., intended to discontinue such illegal sales.

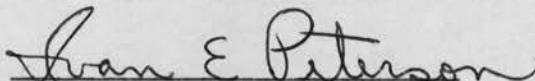
It is therefore ordered that the applications for pharmacy licenses for the 21 stores submitted by Snyder's Drug Stores, Inc., under date of April 19, 1962, be denied. The reason for such denial is based upon the conclusions that:

1. Snyder Drug Stores, Inc., is a wholly owned and controlled subsidiary of Red Owl Stores, Inc.
2. Red Owl Stores, Inc., has a past history of violations of the state pharmacy law.
3. Red Owl Stores, Inc., is presently violating the state pharmacy law.
4. The applicants did not submit any evidence or indication that Red Owl Stores, Inc., will discontinue such violations of the state law in the future.
5. Mr. Berkus appearing for the applicants admitted that they did not represent nor could they speak for Red Owl Stores, Inc., and therefore any statements which they made regarding the Snyder Drug Stores, Inc., were meaningless and without effect since Snyder Drugs, Inc., is wholly owned and controlled by Red Owl Stores, Inc.

Motion carried unanimously.

July 19, 1962. The Board met at its offices at 1965 Ford Parkway, St. Paul, at 8:30 o'clock A.M. At 9:00 o'clock A.M., Pharmacist Sidney Shom appeared before the Board at his own request. The purpose of his appearance was to discuss generally the practice of the profession in Nursing Homes. The Board listened to Mr. Shom's views and a discussion ensued. Having had an audience with the Board, Mr. Shom departed at approximately 9:45 o'clock A.M.

At 10:00 o'clock A.M., Mr. Douglas Stark appeared before the Board in answer to a letter sent to him by the secretary on July 9th, 1962. Mr. Stark appeared to answer questions put to him by the Board regarding certain advertising which appeared on behalf of Thrifty Drug in the Little Falls Daily Transcript of June 6, 1962, which in the Board's opinion, was in violation of Regulation No. 21. A discussion ensued followed by a reprimand to Mr. Stark and an understanding that the advertising in question would cease.

At approximately 11:30 o'clock A.M., the Board departed its office and proceeded to the Nicollet Hotel for a meeting with the Executive Committee of the Minnesota State Pharmaceutical Association. After a thorough discussion relative to the proper distribution of drugs and the operation at Mr. Jolink's pharmacy in Edgerton, he was excused at approximately 11:00 o'clock A.M.

July 20, 1962. At 11:00 o'clock A.M., the Board continued its meeting at its offices at 1965 Ford Parkway, St. Paul, Minnesota, members continuing in attendance were: Ivan E. Peterson, President, Max Bearman, Vice President, Norman W. Telander, William F. Appel and John H. Nelson. Also present were Arthur L. Eide, Secretary, Earl J. Schlekau, Inspector and Robert W. Mattson, the Board's Attorney.

The matter of the application by Snyder's Drug Stores, Inc., for pharmacy licenses for 21 stores located in Minnesota, was considered.

Mr. Lloyd D. Berkus and Mr. William H. Smith, officers of Snyder's Drug Stores, Inc., and Mr. Charles S. Bellows, Attorney, appeared for the applicants.

A record of the proceedings was made by Phyllis Farquharson, court reporter.

The hearing was concluded at 12:25 o'clock P.M., and at 12:45 o'clock P.M., the Board recessed for lunch.

The Board returned to its offices at 1:45 o'clock P.M., and continued its deliberations.

After considering the applications, exhibits, the Board's files and records, and hearing the testimony of those persons representing the applicants and the testimony of Mr. Earl J. Schlekau, the following motion was made: It was moved by Mr. William F. Appel and seconded by Mr. Norman W. Telander that the following findings of fact be adopted and the application by Snyder's Drug Stores, Inc., for pharmacy licenses for 21 stores be denied.

The Board of Pharmacy hereby finds that:

1. All of the outstanding capital stock of Snyder's Drug Stores, Inc., consists of 5,000 shares of common stock and that all 5,000 shares of stock are issued to and held by Red Owl Stores, Inc.
2. Snyder's Drug Stores, Inc., is a wholly owned and controlled subsidiary of Red Owl Stores, Inc.
3. The applications for pharmacy licenses are in fact those of Red Owl Stores, Inc., acting by and through its wholly owned subsidiary, Snyder's Drug Stores, Inc.
4. The Red Owl Stores, Inc., through their retail grocery outlets have been for some time, and were as of the date of this hearing, selling drug items in violation of the state law.

5. No evidence or testimony was presented at such hearing to indicate that Red Owl Stores, Inc., intended to discontinue such illegal drug sales.

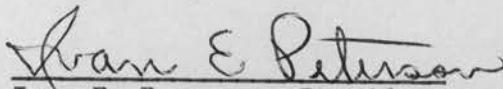
6. Red Owl Stores, Inc., has, within recent months, been charged with and convicted of violations of the Federal Food and Drug Act.

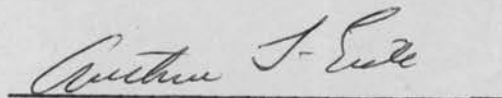

WHEREAS certain licenses are required and are issued to persons and firms qualified to dispense and distribute drugs in this state and

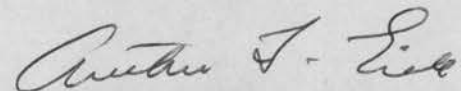
WHEREAS the public health, safety and welfare are best protected when acquiring drugs by contact with a properly licensed person or firm and

WHEREAS irresponsible persons and minors may obtain drugs from vending machines without contact with a qualified person or firm and thereby possibly do harm to themselves or others:

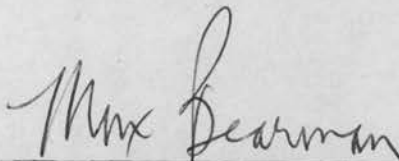
NOW THEREFORE, BE IT RESOLVED by the Board of Pharmacy of the State of Minnesota, that it does adopt the following regulation to be effective immediately:

No. 22. It shall be deemed unlawful to distribute, dispense or vend any drug by automatic or vending machine.

November 13, 1962 (Tuesday). The Board met in its rooms at the Nicollet Hotel. Members present were: President Ivan E. Peterson, Maurice C. Hillestad, William F. Appel and John H. Nelson. Secretary Arthur L. Eide and Board's legal counsel, Mr. Robert Mattson were also present. Mr. Raymond J. Dauphinais, Chief Legal Counsel for the American Pharmaceutical Association, also attended the meeting.

The Board discussed various parts and aspects of the proposed new pharmacy law. Wording of certain sections was discussed in detail. The methods of presenting the proposed act to the Presidents' Advisory Council of the Minnesota State Pharmaceutical Association were discussed. The meeting lasted well into the evening on this one subject alone.

November 14, 1962 (Wednesday). The Board met in its rooms at the Nicollet Hotel at 9:00 o'clock A.M. Members present were: President Ivan E. Peterson, Max Bearman, Maurice C. Hillestad, William F. Appel and John H. Nelson. Secretary Arthur L. Eide and Board's legal counsel were also present.

At 10:00 o'clock A.M., Mr. Peterson ordered the meeting to another room to join members of the Presidents' Advisory Committee of the Minnesota State Pharmaceutical Association. The purpose of this meeting was to discuss in general terms and in detail where necessary, the provisions of the proposed new pharmacy act. This meeting lasted through the lunch hour and into the afternoon. Following this gathering President Peterson ordered the Board to continue its meeting in its own rooms where further discussions regarding legislation were held.

At approximately 5:00 o'clock P.M., on motion duly made, seconded and carried the meeting adjourned.

November 15, 1962 (Thursday). The Board met in its offices at 1965 Ford Parkway at 8:30 o'clock A.M. The first order of business considered was an application by Pix Pack Food Market for a license to sell Ordinary Household Drugs, Medicines and Chemicals.

Mr. Appel moved and Mr. Nelson seconded that the application be denied because of the close proximity of already established adequate pharmaceutical service. Motion carried.

At 9:00 o'clock A.M., Mr. William Smith, Vice President of Snyder's Drugs, Inc., appeared on behalf of Mr. Lloyd Berkus, President of Snyder's Drugs, Inc. Mr. Berkus had been sent a letter to appear before the Board in regard to the apparent coverage of Snyder's Drug Store in the suburb of New Hope by a person not a licensed pharmacist. Mr. Smith explained the difficulty in scheduling confronting Snyder's. He admitted that this alleged discrepancy could have occurred and vowed that it would not occur in the future. At approximately 9:30 o'clock A.M., Mr. Smith departed.

At 10:00 o'clock A.M., Mr. Earl A. Halvorson of the Powers Dry Goods Company, accompanied by their legal counsel, Mr. John Benson, arrived in response to a citation issued to Powers Dry Goods Company to show cause why the license previously issued to Powers should be renewed even though Powers had allegedly been operating their pharmacy department at certain times without a pharmacist in charge. An informal conference was held between legal counsel for the Board and Mr. Benson. Following this a conference between the Board and its legal counsel was held. Legal counsel pointed out that there were certain investigational and procedural discrepancies in the Board's actions and, therefore, suggested that the matters contained in the citation involved be continued until the January meeting of the Board. The Board so agreed and Mr. Halvorson and Mr. Benson were informed and so departed.

You are hereby cited to appear before the Minnesota State Board of Pharmacy at a meeting to be held at the office of the Minnesota State Board of Pharmacy, 1965 Ford Parkway, in the City of St. Paul, County of Ramsey and the State of Minnesota, on the 19th day of March, 1963, at 10:00 o'clock A.M., to make such answer to the charges herein contained as you may be advised or deem expedient, and to show cause, if any you have, why the license to practice pharmacy, heretofore granted to you by the Minnesota State Board of Pharmacy as a pharmacist, should not be revoked or suspended and you be debarred from practicing pharmacy in the State of Minnesota for unprofessional conduct or conduct endangering public health as follows:

1. That you did on November 22, 1962, dispense and sell at retail without benefit of prescription, to one Kenneth Burton, four ounces of Cosanyl and did on November 23, 1962, dispense and sell at retail without benefit of prescription, to the same person, four ounces of Cosanyl,

said second sale being contrary to the law and not within the exemptions contained in Minnesota Statutes 1961, Sec. 618.08.

2. That you did on December 3, 1962, dispense and sell at retail, without benefit of prescription, to one Robert Chatham, four ounces of Cosanyl and did on December 4, 1962, dispense and sell at retail, without benefit of prescription, to the same person, four ounces of Cosanyl, said second sale being contrary to the law and not within the exemptions contained in Minnesota Statutes 1961, Sec. 618.08.

3. That during the period from January 1, 1962 to December 31, 1962, you did not keep proper records of the sale of exempt narcotic drug preparations as required by Minnesota Statutes 1961, Sec. 618.09.

4. That you did allow, permit and assist clerks and pharmacists employed by you to dispense and sell at retail, without benefit of prescription, narcotic drug preparations contrary to law and not within the exemption contained in Minnesota Statutes 1961, Sec. 618.08

5. That during the period from January 18, 1962 to January 15, 1963, you did purchase for resale 640 ounces of a drug preparation known as Phenergan Expectorant ~~and~~ Codeine and that your records disclose the dispensing and sale of 398 ounces resulting in a shortage, not accounted

for, of approximately 242 ounces.

1. That you did on October 12, 1962, dispense and sell at retail, without benefit of prescription, to one Patrick Neary, four ounces of Cheracol and did on the same date dispense and sell at retail, without benefit of prescription, to the same person, four additional ounces of Cheracol, said second sale being contrary to law and not being within the exemptions contained in Minnesota Statutes 1961, Sec. 618.08.

2. That you did on December 15, 1962, dispense and sell at retail, without benefit of prescription, to one Patrick Neary, four ounces of Cheracol and did on December 16, 1962, dispense and sell at retail, without benefit of prescription, to the same person, four ounces of Cheracol and did on the latter date, dispense and sell an additional four ounces of Cheracol at retail, without benefit of prescription, said second and third sales being contrary to law and not within the exemptions contained in Minnesota Statutes 1961, Sec. 618.08.

3. That you did on October 12, 1962, dispense and sell at retail, without benefit of prescription, to one Pat Olson, four ounces of Tricodene and did on the same date dispense and sell at retail, without benefit of prescription, to the same person, six ounces of Terpin Hydrate and Codeine and did on October 13, 1962, dispense and sell at retail, without benefit of prescription, to the same person, six ounces of Terpin Hydrate and Codeine, said second and third sales being contrary to law and not within the exemptions contained in Minnesota Statutes 1961, Sec. 618.08.

4. That you did on October 12, 1962, dispense and sell at retail, without benefit of prescription, to one Bob Smith, four ounces of Tricodene and did on the same date, dispense and sell at retail, without benefit of prescription, to the same person, four ounces of Terpin Hydrate and Codeine and did on October 13, 1962, dispense and sell at retail without benefit of prescription, to the same person, four

ounces of Cheracol; said second and third sales are contrary to law and not within the exemptions contained in Minnesota Statutes 1961, Sec. 618.08

5. That during the period from January 1, 1962 to January 18, 1963, you did purchase for resale 5,436 ounces of a drug preparation known as Robitussin A-C and that your records disclose the dispensing and sale during that time of 630 ounces and the inventory is as of January 18, 1963, 32 ounces, resulting in a shortage not accounted for, of approximately 4,774 ounces.
