The Department Commander then delivered the following address which was well received and listened to with much interest by all the members of the Encampment.

**Address of Department Commander.**

**HEADQUARTERS DEPARTMENT OF OREGON,  
GRAND ARMY OF THE REPUBLIC,  
PORTLAND, OREGON, February 26, 1889.**

COMRADES: Another year of peace and prosperity has joined the procession. Another mile-stone in our life's journey has been passed. No more will the three 8's of the calendar remind us of their similarity to the sign of "Our Uncle" and thereby cause us to reflect that our lives are in pawn. We learned that chapter, I hope, permanently, twenty-five years ago.

**DEPARTMENT REPORTS.**

Reports in detail from department officers indicate that the Grand Army in Oregon has been prosperous during the past year, and that numerically and financially a steady growth has been maintained.

The year was commenced with a total membership in the Department of 35 Posts and 1228 members.

We have now 41 Posts in good standing, and 1431 members, a net gain of 203 besides 30 members out on transfer cards.

There has been a gain of five new Posts, and one Post reorganized, Burnside No. 23 at Ashland, which is now in a flourishing condition. Efforts to resuscitate Morton Post No. 31 at La Grande, have not succeeded, though there are good hopes of an ultimate return to life and usefulness.

Preliminary steps have been taken toward establishing Posts at Alba in Umatilla Co., at Burns in Harney Lake Valley, and at Newburg, in Yamhill Co.

Posts at Toledo, Lexington and Linkville, with an aggregate membership of 30, have disbanded and transfer cards granted the members.

The immigration of the year has brought more than the usual number of old soldiers, and there is a good field for recruiting in every locality where there is a Post already established. It will take but little combined effort, comrades—a little more "pushing of things," to double our membership and the representation in this Encampment.

The financial statement of the A. Q. M. G. shows that we commenced the year 1888 with a balance of cash on hand of \$464.31. We now have on hand cash, with all bills paid, \$645.82, showing a gain of \$181.51.

**WOMAN'S RELIEF CORPS.**

The organization of this auxiliary of the Grand Army has been in able hands during the past year, and if comrades will aid the ladies in localities where the Corps is yet to be, and give the Corps a start, they will find no lack of zeal, in good works. Mrs. Sarah E. Miller, Department President, reports for the year relief given to the amount of \$271.60; 90 soldiers and their families assisted; 367 members of the Corps, and a cash balance on hand of \$334.32—every dollar of which, in the hands of the ladies, will go as far toward active relief as two dollars would if granted by Posts or members. Comrades, assist the Relief Corps and it will assist you.

**SONS OF VETERANS.**

Efforts have been made to establish and maintain one or more Camps of the Sons of Veterans. No permanent success has been reported during the year. For the future we have hopes.



## MEMORIAL DAY.

Memorial Day was observed with more than usual care and impressiveness in most of the localities in the State, and comrades should carefully foster the memorial sentiment, that the observance of the day does not degenerate into a day of festivity and merry-making, instead of a day of fasting and prayer—of memorializing the deeds of our country's brave defenders—our comrades, who fell in defense of the Nation's life.

## NATIONAL ENCAMPMENT.

Oregon was represented in the National Encampment at Columbus, Ohio, in September, by a few comrades who were well repaid for their time and the expense incurred, by the grand reunion participated in.

The excursion train starting from Southern California and travelling northward and eastward via Sacramento, Portland, Tacoma, Helena, St. Paul and Chicago, made up of comrades and friends of the G. A. R. from California, Oregon, Washington and Montana, made a memorable trip across the continent and arrived in Columbus the afternoon of the 11th of September in good time for the parade on the following day.

If there ever was a thought in the minds of any of the Union war veterans that the patriotic heart of the Nation was growing lukewarm, or if there was a doubt harbored that their days and nights on the tented field amid privations and pain were spent in vain, those thoughts and doubts must have been scattered to the winds like the Willamette mists before the summer sun, when they viewed the pageant and participated in the kingly welcome that was so open-heartedly and enthusiastically tendered the gathered thousands of veterans in that beautiful capitol of Ohio. No former Encampment has equaled it in point of numbers, and it will probably never be exceeded in that respect or in the hospitality bestowed.

Well may Ohio veterans be proud of having served from such a State this grand Nation, which their valor has helped to save. A city of 80,000 souls was called upon to provide for a quarter of a million of visitors, and royally they did it; no one was hungry or bedless from necessity.

It was estimated that there were 60,000 veterans in line on the day of parade.

To the few members from this State it was especially a day long to be remembered—as the day of an eventful battle when called up, (from the hid away leaves of the past) stands before one clear cut and minute in detail, from the intensity of feeling then had, so this day of parade at Columbus it seems, must ever remain in the minds of every participant a well remembered, impressive day.

The central thought is, the people of this Nation have not forgotten her defenders and never will.

The legislation at the Encampment was stirring and important. A detailed report thereof is now at disposition of the members of this Encampment in the printed proceedings. General orders from National and Department headquarters have heretofore mentioned those of most importance.

Oregon was represented in the Encampment by five votes, as follows: A. E. Borthwick, O. Summers, Z. T. Wright, A. T. Harris and D. L. Crossen. The last two having been elected representatives at a meeting of the Council of Administration on resignation of the comrades elected at the last meeting of this Encampment. I would suggest that no comrade be elected representative to the National Encampment who will not go or furnish a substitute.

## DUES.

The question of dues is a serious one in our Order, especially on this coast.

Adj. Gen. Fish says that about one-tenth of the comrades are on the suspended list, mostly for non-payment of dues. In some Posts the dues amount to but a dollar a year. Many Posts in this Department charge \$6 per year.



It seems to me if the relief committees of the Posts were given instructions to look into the financial condition of comrades and report with recommendations that dues be remitted in worthy cases, the Order would be strengthened by keeping in good members, and that too at little actual cost.

#### DECISIONS.

But few questions of importance have been presented to me for decision during the year. Local questions have arisen in a few instances and have been answered, I hope, to the satisfaction of all comrades.

#### DEATHS—CEMETERIES.

We have been signally blessed in not having a long roll of honor to read for the year past. To those who have answered the last roll call we say, God-speed you and farewell. Many may the years be yet to come in which the roll of the living will out number that of the dead. While on this subject I wish to say that the comrades of this city are moving toward having a G. A. R. Cemetery, worthy the last resting place of the best.

They have bought a tract in a sightly, high and beautiful location near the city, laid it out in lots and are nearly ready to dispose of the same. Purchasers being restricted to comrades or their families. The example is a worthy one for comrades in other places to follow.

#### LEGISLATION.

The seventh Encampment appointed a committee to draft a bill for relief of indigent soldiers and sailors of the late war. A bill was prepared and introduced by Comrade H. H. Northup, member of committee, and also representative from this county at the session of the Legislature just closed. The bill has become a law and will be given in full in the printed proceedings of this Encampment.

#### CONCLUSION.

When, one year ago, comrades, you honored me with the highest office in your gift, I confess I accepted it with many misgivings. You in your hearts know whether I have realized your hopes. In the weighing I hope the measure has not been altogether light.

To my official staff my gratitude is due for intelligent, patient labor for the good of the Order.

Asst. Adj. Gen. R. A. Frame and A. Q. M. Gen. H. C. Allen, both busy men, have been particularly zealous in the discharge of their duties, which has required almost constant daily attendance. Henry Fry, Department Inspector, and F. O. McCown, Judge Advocate, have always responded to my calls with carefulness, and to my entire satisfaction.

Chief Mustering Officer J. L. Carroll, living at Pendleton, has not been called upon to organize any Posts in his locality. Those instituted have been located nearer some other Department Officer. To one and all, officers and members, my thanks are tendered for kindly consideration and courteous attention.

The Order in this State, in my opinion, is in better condition than ever before. The gain in most of the Posts is steadily increasing and the Order will continue to grow for years to come.

A few days ago I received from the War Department some 23 marble headstones for old soldiers, not members of Posts; these stones, in addition to the numbers received by Commanders of neighboring Posts, now mark the last resting place of a union veteran of the war, whose place of burial would have soon become unknown.

Collectively, the soldier of the late war needs no gaudy chaplet or "enduring marble" to commemorate his brave deeds. His record forms some of the brightest pages of our Nation's history, inseparably connected therewith, and as enduring as time.

Individually, the old soldier, living or dead, deserves the protection and care of his fellows. We are growing gray in the service comrades—the silver lining is showing a little wider every year. Muster-out rolls and final descriptive lists are in constant demand.

Let us be enjoined then, comrades, in this parting thought, that of whatever race, tongue or creed, we may be in the world at large, in our relations with each other, we are bound together by that mystic trio—the greatest of which is Charity.

The above statement is not a complete showing, as many Posts do not report amounts expended, and the figures are taken from the Adjutant's reports made quarterly to this office. As will be seen, the losses by suspension during the year have been large and while every reasonable effort has been made to prevent this but little good has resulted, and in some few cases the whole membership of Posts has been suspended for want of quarterly reports.

While the majority of the quarterly reports from Posts are made out and forwarded within the time specified by law, my reports to National Headquarters have been delayed long beyond the prescribed limit simply by the failure of many Posts to send in their reports at the proper time. This has occurred every quarter during the past year, notwithstanding repeated efforts upon the part of our Department Commander through general orders and personal correspondence to induce Posts to respond within the proper time. There have been issued during your administration 7 General Orders and 1 Special Order.

The Council of Administration has been called together one time during the year for the transaction of such business as came within its province.

While the increase in membership has not been large, I think the Department is *to-day* in good healthy working order with fair prospects for the future.

As you are aware, many of the Posts are weak, numerically, their members widely scattered, many going miles on foot over roads rough and almost impassable, to attend a meeting. Such Posts are made of material which was tried and not found wanting way back when father Abraham called for 300,000 more.

As I am about to surrender the position with which you have honored me, I cannot refrain from asking all comrades present with whom I have had business relations the past year, to accept my acknowledgments for their uniform courtesy and generous treatment during my official term, and I desire in saying official good-bye, to thank you and all members of your staff with



whom I have been associated, for many favors and hearty support and aid in the performance of my duties, and in laying aside the insignia of your A. A. G., I do not forget that my acknowledgments are due to you first for the appointment, which was unsolicited on my part, and lastly for the steadfast support, timely advice and able counsel which have tended very much to lighten my official duties.

COMRADE: I have the honor to make the following annual report, relative to the health and condition of comrades of this Department. Within the last eight months I have received reports from the Surgeons of thirty-five Posts.

There has been but little sickness and very few (if any) comrades in the Department who have not had sufficient means to defray the expenses of sickness.

No deaths have been reported in the Department.

I would recommend that Post Surgeons see and prescribe for all destitute, sick and disabled comrades of their Posts, their widows and orphans, and secure if possible, from the Posts or relief funds, the money necessary to purchase the medicine.

Statements are requested to be made by Post Surgeons to the Medical Director at the end of each quarter (in an informed manner) showing the number of destitute sick soldiers treated by you during the quarter, and the source from which the funds to purchase the medicine or surgical appliances (as the case may be) were obtained.

Names of soldiers treated will not be given, only a mere informal statement setting forth the number.

### Report of Department Inspector.

HEADQUARTERS DEPARTMENT OF OREGON,

COMRADE: I have the honor to submit to you and through you to this Encampment this, my report, as Inspector of this Department.

Reports of inspection were received from 39 of the 41 Posts constituting this Department at the beginning of my term of office.

The 39 Posts report a membership of 1,325 in good standing at the close of the quarter ending March 30th, 1888.

The work of the ritual is committed to memory and properly performed in 9 Posts, 15 report partly, 13 answer in the negative, and one promises that it will be.

Officers and guards are uniformed and equipped in 9 Posts, 2 report members uniformed and equipped and 5 uniformed only.

The officers and members are regular in their attendance in 37 Posts, two report the attendance as fair and all report both officers and members as exhibiting great interest in their work.

But 3 Posts pay regular benefits in sickness; 14 have a separate relief fund amounting to \$2,162.33.

The amount expended in charity during the year ending March 30th, 1888, as reported by 24 Posts is \$884.30.

These figures do not represent the total disbursements for charity in this Department. Assessments and collections have been made in special cases of which no report is made.

In many of the Posts that have no separate fund, the calls for assistance are met by private subscriptions from the members.

The Womans' Relief Corps is working side by side with the comrades of the Grand Army of the Republic and in the noble work of Charity the Department of Oregon will rank second to none.

Two Posts, Shiloh No. 22, of Independence, and General Lyon Post No. 26, of Toledo have surrendered their charters, and Burnside Post No. 23, of Ashland, that had been suspended was re-organized. I have received no reports or official notice of the muster of any new Posts during the year.

69 muskets are owned by the posts, and Farnsworth Post No. 43, has the use of 24 belonging to the State.

7 Posts report their prospects excellent, 24 good and the balance fair.

In order to secure a prompt and thorough inspection of the Posts of this Department, 25 Assistant Inspectors were detailed, and in assigning them to duty I endeavored to so arrange the work that no Post would be inspected by one of its own members; but owing to the location of some of the Posts and the distance the Inspecting Officer would be obliged to travel to reach them I detailed the Inspector in a few instances from the Post he was to inspect.

I visited 16 Posts and inspected 14 of them personally, remaining two days at Ashland where I re-organized Burnside Post No. 23, and installed the officers elect. This Post had been suspended, but starts on its new life with flattering prospects for success.

I then visited Grants Pass, Roseburg, Cottage Grove, Albany, Salem, Oregon City, Portland, East Portland, Albina, North Yamhill, McMinnville, Forest Grove, Corvallis and Newport. Leaving home May 6th and reaching Newport in time to take part with the comrades in the services of Memorial Day. Traveling nearly 800 miles and spending nearly 4 weeks on the road.

I found a great lack of uniformity in the manner of doing Grand Army work, and an earnest desire for drill and instruction on the part of Post officers and comrades who fully realize the importance of having the work uniform and properly preformed.

This inspection was made without expense to the Department. Each Inspecting Officer defraying his own expenses or being entertained by the comrades visited. Realizing the importance of a thorough inspection I would recommend that this Encampment provide for the payment of traveling expenses to inspectors in future.

My sincere thanks are due to the Assistant Inspectors for the prompt and efficient manner in which they discharged the duties assigned them.

From their reports and from my own observations I can report our Department to be in a flourishing condition. The comrades earnest and enthusiastic, carrying forward the good work with energy and zeal.

The tide of immigration is bringing to our State hundreds of old soldiers and I would urge the comrades to be prompt and energetic in the work of recruiting and cease not their efforts until every one of these old comrades are mustered into the ranks of the Grand Army of the Republic.

OREGON LEGISLATURE.

FIFTEENTH SESSION.

### HOUSE BILL No. 102.

*Introduced by Mr. NORTHUP and read first time January 21, 1889.*

#### A BILL

For an Act to Provide for the Relief of Indigent Union and Mexican War Soldiers, Sailors, Marines, and Indian War Volunteers, and for the Relief of their Indigent Widows and Minor Children, and to Defray the Funeral Expenses of such Indigent Soldiers, Sailors, Marines and Volunteers.

*Be it enacted by the Legislative Assembly of the State of Oregon :*

SECTION 1. The board of county commissioners of the several counties of this state are hereby authorized to levy, in addition to the taxes now authorized to be levied by law, a tax not exceeding two-tenths of one mill upon the taxable property in their respective counties, to be levied and assessed as now provided by law for the assessment and collection of taxes, to create a fund for the relief of indigent soldiers,

sailors and marines who served in the Union army at any time from April 12, 1861, to April 12, 1865, and who received an honorable discharge therefrom, and who have resided in Oregon for six months, and for the relief of indigent soldiers, sailors and marines who served in the war with Mexico in the United States army, and who received an honorable discharge therefrom, and have resided in Oregon for six months, and for the relief of indigent soldiers and volunteers who served not less than thirty days in any of the Indian wars in Oregon, Washington Territory or Idaho Territory, or who received a permanent disability while in such service, and who have resided in Oregon for six months, and for the relief of the indigent widows and of the minor children of such soldiers, sailors, marines and volunteers, and to defray the funeral expenses of such soldiers, sailors, marines and volunteers.

SECTION 2. Upon the passage of this Act, the commander of any post of the Grand Army of the Republic, or any camp of Indian veterans, proposing to undertake the relief provided for herein, shall file with the county clerk of the county within which said post or camp may be located, the names of the commander or captain and other officers of such post or camp, and the names of any relief committee thereof, and shall also file a notice in writing that such post or camp will undertake the relief of the indigent persons provided for in the first section of this Act, and by the third Monday in January of each year shall file with the county clerk a similar notice, and shall also render and file a detailed statement of the amount of the relief furnished during the preceding year, and the amount thereof, the names of the persons to whom furnished and on whose recommendation, and such other facts and suggestions as may be deemed material. Such commander or captain shall also file a bond with one or more sureties, to be approved by the county court or the judge thereof, in a sum not less than one hundred dollars and not more than one thousand dollars, the amount to be fixed by the county court, or the judge thereof, which said bond shall run to the county judge and his successors in office, conditioned that if said commander or captain shall faithfully apply all the funds that shall come into his hands for that purpose to the relief of the indigent persons named in the first section of this Act, the same shall be void. In case said bond shall be enforced, there shall be recovered from the principal and sureties thereon, three times the amount which shall be found to be misappropriated, which shall become a part of said relief fund. On the approval and filing of said bond, and on the recommendation of the relief committee of any post or camp, orders shall be drawn in favor of the commander or captain of such post or camp, in the same manner as orders are now drawn for the relief of the poor, which said orders shall designate thereon the name of the person or persons for whom the relief is intended, and in like manner, a sum not exceeding thirty dollars may be drawn to pay funeral expenses of any indigent soldier, sailor, marine or volunteer named in the first section of this Act.

SECTION 3. In case there is no post or camp within any county of this State, the county judge thereof shall undertake the relief provided in this Act.

SECTION 4. The county judge in the county within which there is a post of the Grand Army of the Republic, an organization of the Mexican war veterans, or a camp of Indian veterans shall be prohibited from sending any person of the class for whom relief by this Act is provided, to the county poor house, without the consent of the commander or captain of the post or camp or chief officer of such organization first obtained. All such indigent persons shall be provided for so far as practicable at their homes.

Fixing the place of meeting of the next Encampment being in order, Comrade Straight named Eugene City as a very suitable place for its next session.

Past Department Commander N. S. Pierce named Astoria.

Acting S. V. C., F. M. Johnson of Corvallis, in a humorous as well as eloquent speech, favored his own city.

Comrade F. M. Miller suggested a more central place than those named.

Comrade H. H. Northup named Portland.

Comrade Z. M. Parvin favored Eugene City.

Comrade R. T. Chamberlin also favored Eugene City and "brought down the house" with one of his characteristic, witty speeches. Witticism and eloquence seemed to be contagious, and each comrade in speaking of his favorite place of meeting was full to overflowing, Senior Vice Department Commander Johnson being the leader of the occasion.

The Encampment presented a *reddish* hue.

Past Department Commander G. E. Caukin suggested that the delegates from Portland refrain from voting and let those from the outside Posts decide the place of meeting.

A vote being taken, resulted as follows:

Eugene City . . . . .	72 votes.
Astoria . . . . .	(withdrawn.)
Corvallis . . . . .	15 votes.
Portland . . . . .	15 "

Eugene City having a majority of all the votes cast was declared as the place for holding the next Encampment. On motion of Comrade F. M. Miller the vote was made unanimous.

Upon the suggestion of the A. A. G., R. A. Frame, Comrade E. W. Allen moved the Encampment that its next regular meeting be on the 12th day of February, 1890, the anniversary of the birth of Abraham Lincoln, which was unanimously adopted amid much applause.

On motion it was ordered that the A. A. G. notify the Woman's Relief Corps of the time and place of the next meeting of the Encampment, which was done accordingly.

On motion of Comrade O. Summers the Encampment proceeded to the election of officers for the ensuing year.

#### DEPARTMENT COMMANDER.

Nominations being declared in order, Comrade A. Rodgers of Sedgwick Post No. 10, nominated Comrade E. B. McElroy of Sedgwick Post No. 10 for Department Commander, seconded by Comrade A. B. Woodin of McPherson Post No. 5.

Comrade C. P. Holloway of U. S. Grant Post No. 17, nominated B. B. Tuttle of Geo. Wright Post No. 1, seconded by Comrade Will T. Boyd of Farnsworth Post No. 43.

Comrade C. L. Fay of Geo. Wright Post No. 1, nominated



James A. Varney of James W. Nesmith Post No. 12, seconded by Comrade F. M. Miller of J. F. Miller Post No. 42.

Nominations being closed, the Commander appointed as tellers Comrades J. C. Cooper, C. P. Holloway and F. M. Miller.

The vote resulted as follows:

E. B. McElroy having received a majority of all the votes cast was declared elected, and upon motion of Comrade Will T. Boyd the vote was made unanimous.

Comrade D. D. Neer nominated E. Martin of Sumner Post No. 12, East Portland, for S. V. C. Comrade O. Summers seconded the nomination, and upon motion of Comrade F. M. Miller the rules were suspended and the A. A. G. was instructed to cast the vote of the Encampment for Comrade E. Martin for S. V. C. which was accordingly done, and he was declared duly elected.

#### JUNIOR VICE COMMANDER.

Comrade N. S. Pierce nominated J. L. Carroll of Kit Carson Post No. 28, for J. V. C.

Comrade E. A. Mix nominated S. B. Ormsby of Geo. H. Thomas Post No. 11, who declined the nomination. Being no further nominations the rules were suspended upon motion, and the A. A. G. was instructed to cast the vote of the Encampment for Comrade J. L. Carroll for J. V. C. which was done, and he was declared duly elected.

#### MEDICAL DIRECTOR.

Comrade J. C. Cooper nominated J. W. Haines of G. K. Warren Post No. 21 for Medical Director. No other nominations being made, upon motion of Comrade D. D. Neer the rules were suspended and the A. A. G. was directed to cast the vote of the Encampment for J. W. Haines for Medical Director, which was performed and he was declared duly elected.

#### CHAPLAIN.

Comrade R. T. Chamberlin nominated C. L. Fay of Geo. Wright Post No. 1, Portland, for Chaplain. No other nominations made, on motion of Past Department Commander F. H. Comrade R. T. Chamberlin introduced the following resolution:

PORTLAND, OREGON, February 27, 1889.

WHEREAS, It is not only the law of the United States as recorded on the Statutes, but also the wish of the people, as expressed by the platforms of all political parties, that honorably discharged soldiers and sailors, all things being equal, are entitled to preference in appointments to positions in the U. S. service; and

WHEREAS, Many old soldiers have in the past been discharged from the Government service for political and other reasons, in violation of law, as is amply proved by their appointment as specials to fill and perform the duties of the same office from which they were so discharged; therefore, be it

*Resolved*, That this Encampment ask, as our right, that our Representatives in Congress use all endeavors to return to their position all such old soldiers as are capable and efficient; be it further

*Resolved*, That they also ask and endeavor to secure the reappointment of all such old soldiers against whom no well authenticated charges appear, and their promotions which would have occurred to them if they had remained in the service from which they were unlawfully and unjustly removed; be it also

*Resolved*, That a copy of these resolutions be sent to each of our Representatives in Congress, and also furnished the press for publication.

After considerable discussion a substitute was offered by Comrade H. H. Northup and adopted, as follows:

*Resolved*, That this Encampment condemn the removal of any old soldier by any political party for political reasons from any office, and this Encampment ask for the restoration of any such soldier to the office from which he may have been so removed.

Together, with the following amendment, which was adopted:

That copies of the substituted resolution offered by H. H. Northup be sent to our Senators and Representatives in Congress.

On motion it was ordered by the Encampment that Past Commander A. E. Borthwick, Past Assistant Adjutant General R. A. Frame and Department Commander E. B. McElroy be directed and authorized to have printed 2000 copies of the proceedings of this session.

On motion a vote of thanks was extended to the retiring officers of the Encampment.

On motion a vote of thanks was extended to the Southern Pacific R. R. Co., the O. R. & N. Co. and the Oregonian R. R. Co., for transportation of members to this Encampment at reduced rates, and that copies hereof be forwarded to said R. R. Co's.

Also a vote of thanks was tendered the managers of the Cyclorama for admitting at reduced rates members of this Encampment and viewing the beautiful picture of the battle of Gettysburg.

#### Chaplain's Report.

The following letter was received from Department Chaplain R. McLean as his report for the past year which was received soon after the Encampment adjourned and is as follows:

GRANTS PASS, Feb. 25, 1889.

DEAR SIR AND COMRADE:—I regret exceedingly that owing to my recent illness I find myself so crowded with work that it will be impossible for me to meet with you to-morrow. I know it is my duty to send in a report, yet I do not know where I shall find the materials from which to compile one. I am convinced that the majority of the Posts in the Department observed Memorial Day, yet hardly one-third of them have reported its observance.

The only report of deaths comes from Preston Post No. 18, Union: Thomas Culver, Co. D, 151st Ill. Inf., died Jan. 18, 1887, and Capt. Elytle Haynes, Co. B, 1st Ark. Inf., died Oct. 15, 1888.



It is to be regretted that the Post Chaplains have thus failed to report, and have left me in such a condition that I can make no report concerning the condition of the different Posts.

If I were to take advantage of my position as Chaplain to preach the comrades a little sermon, the lesson that I would strive to inculcate would be this: that the permanence and prosperity of an organization will be measured by the adherence of its members to the laws governing that organization; and that submission to discipline is just as necessary for the well being and perpetuity of the Grand Army of the Republic as it was for that grand army that throttled the rebellion. To my mind the great danger that threatens the G. A. R. is that its members will grow more lax in the matter of discipline until the organization will lose all power of cohesion.

I trust that there will be an awakening in this matter, and that the old soldier's spirit may be revived.

### CIRCULAR NO. I.

The Twenty-second National Encampment of the Grand Army of the Republic will meet at Columbus, Ohio, on Wednesday, September 12, 1888. The grand parade will occur on Tuesday, September 11th. It is proposed, and arrangements are being so made, that the delegations from the Pacific Coast Departments, including California, Oregon, Washington, Idaho, Montana and Dakota, may unite in one grand special train, starting from Los Angeles, California, and gathering delegates on the way, proceed northward and eastward via Northern California, Portland, Tacoma, Spokane, Helena, St. Paul and Chicago. From St. Paul the joint delegation to accompany Commander-in-Chief Rea and Staff to Columbus, Ohio.

The Transcontinental Association of Railroads, at a recent meeting passed a resolution, as follows: "That an excursion rate be made on account of the National Encampment of the Grand Army of the Republic in September next, of \$80.00 to Columbus, Ohio, from Pacific Coast common points (good going and returning) by all routes including the Short Line. Tickets to be placed on sale on dates to be hereafter agreed upon; to be limited, east bound, to first day of Encampment and west bound to October 31, 1888." It will be necessary that the purchaser *choose the route for return at the time of purchase of ticket.*

It is anticipated by the General Council that the attendance at the Encampment will far exceed that of any former year, the parade alone will be worth a trip across the continent to see, and the meeting of so many old soldiers and the reunions that will take place after these many years, *and all comrades*, will make it a grand Encampment well worth attending.

Other Coast Departments are preparing printed matter and displays of products from all sections within their borders, and Oregon should be well represented by men and advertising matter.

Post Commanders are requested to make a thorough canvass of their Posts

and report to these Headquarters as soon as received the names of comrades and families and all others who will go to the Encampment from their locality, and state whether they desire Pullman or second-class sleepers to St. Paul, Minn. The payment of \$80.00 secures the use of second-class sleepers free to St. Paul and return.

Such report to be sent as soon as practicable and not later than August 20, that timely arrangements may be made for their comfort. The Special G. A. R. Excursion train consisting of Pullman Sleepers, free second-class sleepers, dining car and day coaches will leave Portland on Tuesday, September 4th, at 8:50 o'clock P. M. Leave Tacoma, September 5th at 8:55 A. M. Leave Pasco Junction same day at 10:40 P. M. Those who join the excursion train at Pasco Junction from points in Eastern Oregon, will come on regular passenger train to Umatilla and make direct connection with regular train to Pasco and join the excursion train at that point.

I.—One more bright star in the military history of our country has answered the summons of the grim monarch who conquers and levels all. It is with profound regret and sorrow that the announcement is made that Comrade PHILIP H. SHERIDAN, General of the United States Army and member of our Order, died on the 5th instant, at Nonquett, Mass. The story of his military career, as a General and a hero, is familiar to every school boy, and will be recorded to the latest epoch of American history; and in the future times the patriotic hearts of all lands will be inspired to emulate his illustrious example. In his death the Nation sustains an irreparable loss; to his comrades of the G. A. R. it comes as an individual bereavement. As a mark of respect the Posts of this Department will cause their flags and charters to be draped in mourning for thirty days.

II.—Comrades of the G. A. R., ladies of the W. R. C. and all others who intend going to the 22d National Encampment, at Columbus, Ohio, should notify these Headquarters *at once*, that proper arrangements may be made for their comfort. The special excursion train bringing the California delegation, will arrive at Ashland, Oregon, on Monday, Sept. 3d, and leave that place at 6 P. M., arriving at Portland at 11 A. M. Sept. 4th, leaving for St. Paul via Tacoma at 8:50 P. M. same day. An agent, authorized to sell tickets to Columbus and return at \$80.00, will go with this special train. Round trip tickets will be on sale at Portland, on Sept. 2d, 3d and 4th. The sale of these tickets is not confined to the G. A. R.

III.—Post Chaplains are requested to comply with General Orders No. 3 from these Headquarters, of date April 25, 1888, and send a report of Memorial Day exercises, participated in, or held by their several Posts, to Department Chaplain Rev. R. McLean, Grant's Pass, Oregon. One report

GENERAL ORDERS }  
No. 5.

I.—Among the important measures passed at the 22d National Encampment, at Columbus, Ohio, in September, was the following majority report of the Committee on Resolutions, which was adopted by a vote of 356 to 22, and is published to illustrate the advancement made by the Grand Army on the question of pensions:

RESOLVED, That it is the sense of this Encampment that the time has come when the soldiers and sailors of the war for the preservation of the Union should receive the substantial and merited recognition of this government by granting them service pensions; and further

RESOLVED, That this Encampment favors the presentation to Congress of a bill which shall give to every soldier and sailor who served in the United States between April, 1861, and July, 1865, for a period of 60 days or more, a service pension of \$8 per month, and to those whose service exceeded 800 days an additional pension of one cent per day per month for service in excess of that period.

Your committee also earnestly recommend the preparation of a bill placing

the widows of Union soldiers, sailors and marines on the pension list without regard to the time of service or the cause of the soldier's death.

Your committee further report that we do not withdraw our support of the bill now before Congress, which was proposed and endorsed by the Pension Committee, known as the disability pension bill.

II.—The following decisions from the report of the Commander-in-Chief to the Encampment are published for information:

No. 1. *Proof of Eligibility.*—The proofs of an applicant's eligibility to membership must be such as are prescribed by the law of evidence.

\* \* The fact of honorable discharge from the service should be shown by the original certificate of discharge, if such was issued to him (which was not always the case), or in the event of its loss or destruction without his privity or procurement, a duplicate certificate from the War Department, or its equivalent from some officer of the State government having adequate records and authority to issue it. It is *not admissible* for a Post to admit a recruit upon *oral or un-official testimony*.

No. 14. *Concerning Muster Three Months after Election.*—The rules and regulations do not in terms require that a recruit should actually be mustered within three months after written notice of his election. He is required to present himself for muster within three months after such notice, but there are no words of exclusion which prohibit his muster after the expiration of that period. Such muster is, therefore, not void for that reason alone.

III.—From the report of the Adjutant General, it appears that the order is still increasing in membership, having gained over 30,000 during the past year, and it must be now fully 400,000 strong.

IV.—The Department Commander congratulates the officers and comrades who have worked so zealously and successfully in building up the order to its present prosperous condition, and he earnestly recommends that they continue the good work and keep on recruiting until every man eligible shall have been mustered into our ranks. Special efforts should be made by Posts to restore to active membership comrades on the suspended list, and keep in the old members as well as recruit new ones. If each Post will appoint a committee on delinquents, it will be a step in the direction of doing good.

V.—Aids de-Camp, in accepting the appointment, are expected to use every effort in building up and strengthening the order in their respective localities, reporting to these Headquarters from time to time, work performed or matters needing attention.

VI.—Especial attention is again urged to the Woman's Relief Corps. There are many reasons in favor of establishing a Corps of this noble auxiliary, wherever there is a Post in this Department. Post Commanders should take the initiative and start the work of organization.

VII.—The following letter from the Commissioner of Pensions was published in General Orders No. 6, National Headquarters, April 3, 1888, and is here reproduced because of its great importance to the Order:

DEPARTMENT OF THE INTERIOR,  
BUREAU OF PENSIONS,

WASHINGTON, D. C., March 7, 1888.

JOHN P. REA, Commander-in-Chief, G. A. R.:

*Sir:*—The records of the Army and Navy Survivors' Division are not yet considered complete. There are many Posts of the G. A. R. that have never forwarded service cards, and returns from these Posts would be valuable additions. It would also be esteemed a favor if the officers of Posts would make quarterly statements to the Pension Bureau of all changes that occur upon their rosters, such as deaths, transfers, names of recruits, etc. This

information would be of material aid in keeping the record verified, and it is hoped that greater attention will in future be paid to such details.

During the past year greater efforts have been made to establish files of miscellaneous organizations, and it would be a further favor if Post Adjutants in making service cards would be careful to note if any of the members served in the Mississippi Marine Brigade, Elliott's Ram Fleet, or U. S. Signal Corps, or were on detached service in Quartermaster's Department, Commissary Department, Ambulance Corps, Pioneer Corps, or at any time during their services acted as pontoniers, orderlies or clerks at Headquarters, nurses or hospital stewards. In giving names of any comrades who served in the navy, the name of each vessel on which they served should be given; also the date of service on each.

In addition to the regular Department cards, which will be forwarded to any Post upon application made for same to Commissioner of Pensions, penalty cards are always on hand to be distributed to comrades who are not members of the G. A. R. These cards bear on the face an official frank, which insures their return through the mails free of postage.

As fast as recruits come in see that a descriptive card is forwarded as above. Cards can be supplied on application to R. A. Frame, Ass't Adj't Gen., Portland, Or., stating number desired.

VIII.—Post Chaplains have duties that should not be overlooked. Reports on Memorial Day services should be sent to Department Chaplain, Rev. R. McLean, Grant's Pass, Or., at once. Also a report of deaths of members, with statement of rank and service in the Army and in the G. A. R., that the memorial page of Encampment proceedings may contain a complete record.

IX.—Adjutants' and Quartermasters' reports are not forwarded to these Headquarters from some of the Posts as promptly as they should be. Reports for the third quarter are due from Posts Nos. 7, 19, 22, 25, 28, 36, 40 42 and 44.

I.—In conformity with the rules and regulations, (see Sec. I, art. VII, chap. II) the annual election of all Post Officers, Delegates and Alternates to the Department Encampment will be held at the first stated meeting in December. II.—The Officers elect and appointed will be installed at the first stated meeting in January, by the Senior Past Post Commander present, Department Aide or other Post Officer, according to rank and seniority, unless a special detail be made hereafter at the request of the Post Commander. Installing Officers will see to it (before proceeding with the duties of installation) that the required official bonds have been duly executed, and that returns of Adjutants and Quartermasters for December have been made.

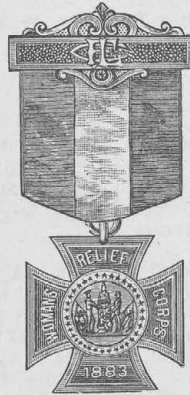
