### REPORTS OF OFFICERS

The Department Commander then read his report, which was referred to Past Commanders A. E. Borthwick, M. L. Pratt and W. J. R. Beach for consideration.

#### REPORT OF DEPARTMENT COMMANDER.

Headquarters of the Grand Army of the Republic of the Department of Oregon.

To the Comrades assembled in the Thirty-second Annual Encampment: Comrades, I herewith return the official honors you were pleased to confer on me one year ago at Salem, Oregon, where we were treated royally by the Comrades and the ladies and citizens; the fine reception we were tendered and the pleasant memories remain with me still.

#### VISITATIONS.

I did not visit as many Posts as I would have liked during 1912, as I thought the Spring of 1913 would bring out better weather, but it did not come, so I kept putting it off until it got too far along in May, and then I could not go as often as I would have liked. I made an official visit to Salem, Oregon City, Forest Grove, and the ten Posts in Multnomah County very often, and the visits were always pleasant and instructive to me. I would have been pleased to have visited all the Posts in the Department and to have grasped the hands of the Comrades and to look into their kindly faces and to hear their kind words: "How are you, Commander?" and to go over the old war times from 1861 to 1865, and each one would have his own remembers the second of the contrades and the good ladies of the Relief Corps will have to take the will for the deed—the heart was willing.

#### MEBMERSHIP.

We have 63 Posts now in good standing in the Department, consisting of 1983 members as shown by the last semi-annual report. Not-withstanding the large death rate the reports show a net gain of 41 members during the year. One new Post has been added to the roll, Corinth No. 35, at Tillamook, on August 24, 1912, mustered by Chief Mustering Officer, William Clemens.

#### THE GETTYSBURG ANNIVERSARY.

This being the fiftieth anniversary of the Battle of Gettysburg the State of Pennsylvania has appropriated \$25,0.00, the U.S. Government \$175,000 for the proper celebration of this Peace Jubilee. Many of the states of the Union have appropriated money for the transportation of all comrades and Confederate soldiers wishing to participate. The State of Oregon appointed two commissioners and appropriated \$5,000 toward the transportation of all soldiers, both Union and Confederate, who were engaged in that battle. It was supposed at this time that the above amount would be sufficient for the expenses of all who were eligible to attend as shown by the registration at Department Headquarters.

After the passage of the bill many applications were received at Headquarters, making the appropriation inadequate for the transportation of all. Through the kindness of the Governor arrangements were made with the railroads to supply the deficiency.

#### FORTY-SIXTH NATIONAL ENCAMPMENT.

The 46th National Encampment was visited at Los Angeles, California, by the Department officers and representatives. Left the Union Depot on the 7th of September, 1912, at 3 p. m. We had ten sleepers and two diners and one baggage car, a special train. We stopped at different points and the Drum Corps would go out and serenade the people and all were pleased to see the Comrades and their wives all so happy at our time of life. We arrived at Los Angeles at 3:35 p. m., on Monday, the 9th day of September, 1912, and went to the Department Headquarters at the Baltimore Hotel, and every evening we had an entertainment, so that we were always going, On Wednesday the parade was a large affair. The streets were crowded with the ladies dressed in white and all carrying flags to wave at us and cheer us along our way. The line was about five miles long and we only made a few stops. The weather was delightful and we had no accidents during the parade. Our Division was in command of the Department Commander of Oregon and the Veteran Drum Corps ahead of it and the ovation the boys received was simply great. Our Drum Corps was the only one that had seen service in the Civil War and the Comrades behaved fine and did splendid work; they seemed never tired and were always cheerful. Every one spoke well of them while we were in and around Los Angeles and the Comrades of our Department received great cheers along the line.

We visited the Soldiers' Home at Santa Monica, Cal., and saw the buildings and grounds, and had lunch at the Committee's expense. Commander-in-Chief Trimble's headquarters were at the Alexandra Hotel, a fine place to go and visit other Comrades from other States. I visited old Massachusetts members and had a happy time talking and lunching with the Comrades and ladies of the Corps of Massachusetts. my old State.

We came back by the const route to San Francisco and visited the towns across the Bay. On the 17th of September I was at Haywards, California, It was the 50th Anniversary of the Battle of Antictam and the schools were in session, so my friend's daughter invited me to address the children at the school, so I talked to the different classes about the battle and particitism, and loyalty to the old flag.

I desire to thank the Posts of our Department for the response to the cry of distress from the Comrades of Ohio. The call was made by me and the Posts subscribed \$368, which our Adjutant General sent to C. W. Blodgett, Department Commander of Ohio, for the families of the Comrades of his Department.

#### OREGON SOLDIERS' HOME.

Is well kept by Comrade Elder and his good wife, and Governor West has been and will be the friend of the Comrades. He told our Committee that the boys could stay there if they received more than \$20.00 per month, so the Comrades felt easy, but the legislature placed the Home under the care of a Board of Control, consisting of the Governor, Secretary of State and State Treasurer, (since the above was written the Board has raised the limit to \$30 per month.)

.

The Home is crowded now, and the Comrades have to have their names on the waiting list; but I am informed that they are going to make an addition so as to accommodate more, and that will be good for the boys.

#### OLD GLORY-FLAG DAY.

The flag of our country must be respected at all times and places as it stands for the Nation that you Comrades so bravely defended, and to have it respected at home and abroad as the emblem of freedom, equal rights and protection to all citizens of America who are willing to obey the laws of the land, and to those who are not, send them to some other country, where they belong, as we have no room for them here. May our flag long wave over you good Comrades and the good neocle of our land.

#### ENCAMPMENT.

Comrades, while we are assembled here this 17th day of June, 1913, we remember that it was on this day, June 17th, that our Revolutionary Soldiers assembled at Bunker Hill and met the British, 137 years ago, for American freedom; and the Army of the Potomae met the Confederate troops at Aldie, Loudon County, Virginia, 59 years ago today in a battle for freedom, and we won that battle with a large loss of life. My regiment alone lost out of 294 members in eight companies, 198 killed, wounded and missing, whose bodies lie buried in the soil of old Virginia, and the day brings sad memories to me every year as it rolls around.

#### WOMEN'S RELIEF CORPS OF OREGON.

The gratitude of the Comrades of the Grand Army of the Republic to this auxiliary is beyond computation. Many of our Posts owe a great deal to the helping hand and encouragement they received from these noble women banded together to give assistance to the families of the Comrades in sickness and in distress; as old age comes on us and our earning capacity decreases, these noble women step to the front and relieve our wants, and may the choicest blessings rest with them and upon them for all time to come.

#### THE LADIES OF THE GRAND ARMY.

While they are not the auxiliary of the Grand Army of the Republic, they are composed as they say of the wives, mothers, sisters and daughters of the soldiers of the Civil War, and a patriotic band who do some good to some Posts, as I have been informed, and our best wishes go out to all loyal women enlisted in behalf of the Civil War Veterans.

#### DEPARTMENT HEADQUARTERS.

Owing to the kindness of the county court of Multnomah County as a commodious room in the new court house has been assigned to the Department for Headquarters, entirely free of cost. The number of the room is 575, and it is hoped that the Comrades will feel themselves at home whenever they can make it convenient to visit Headquarters. The saving to the Department by the change is about \$130 per year.

#### OFFICIAL STAFF.

I wish to tender my thanks to all the members of my official family who have so ably assisted me during my term of office.

My thanks are especially due to the Assistant Adjutant General for his loyal support in the management of the affairs of the Department

Conrades, I shall cherish the hope always that I am remembered with charity by you for my short-comings, and with loyalty for our year's work, and I shall always remember with a grateful heart the kindness shown me by the Comrades and the Ladies of the Relief Corps during my administration.

## REPORT OF JUNIOR VICE-DEPARTMENT COMMANDER.

Oregon City, Oregon, June 15, 1913. To the Commander and Comrades, Department of Oregon, G. A. R.

I have the honor as Junior Vice Commander of this Department to you that I have obeyed all orders sent to me from Headquarters, that I have visited two Posts and found that the Officers and Comrades had forgotten the ritual and were unable to muster in a recruit in due form.

I found an Officer of the Day in one Post of the Department who was not able to instruct a recruit in the unwritten work of the Order. I would earnestly recommend that the Comrades post themselves up for the good of the Order. I have had the honor of serving Meade Post No. 2, three and one-half years as Adjutant and Patriotic Instructor, and during the present year have visited eleven schools and addressed more than three thousand pupils, in which work I was assisted by the Drum Corps, the Relief Corps, the Post Commander and Comrades of Meade Post No. 2.

The Comrades and ladies of the W. R. C. are doing all in their power to teach parifolism to the rising generation. Every school we visited greeted us warmly and nearly all served refreshments, the elegant lunch served by the Oregon City High School having been cooked by the pupils. The interest in this work is growing each year and I would strongly recommend all comrades to visit the public schools wherever possible to do so.

I have assisted in organizing a Veteran Association of Oregon that recognizes all soldiers and sailors of all wars of the United States, in this manner bringing together all who have loved and fought for the old flag—our "Old Gropy."

We have recruited all Comrades of the Civil War whom it was possible to induce to join the G. A. R., so that Meade Post is stronger today than a year ago, although seven comrades have answered the last roll call during the year.

Well, Comrades, let us close up the ranks, touch elbows and do our whole duty to God, our Country and our Comrades.

Yours in F. C. & L., H. S. CLYDE, Junior Vice Department Commander, The next report in order was that of the Medical Director, which was referred, after reading, to the following Comrades: W. N. Morse, H. S. Fargo and S. W. Taylor.

To the Commander and Comrades:

Passing years seem to show increased appreciation of the services, and respect for the survivors of the Civil War. This may be shown to some extent because of the belief, as speakers tell us, that we will soon all be gone, illustrating the truth of the adage, "Blessings brighten as they take their flight." Since the public is disposed to say complimentary things to us, and the scholars of the public schools are taught to look upon us as somewhat interesting relies of a war that they have been compelled to study about in their school bistories, and the nation at large continues prosperous as a result of the preservation of the Union, and commercial exchange between the different national there are inducements offered exchange between the different standing the fact that we have pretty generally reached the three score and ten year milepost in our years of life, and orators continue to tell us we will soon depart and go the way of all the earth.

In view of these and other inducements, and in view of the general desire of the Comrades to spend several more years in noting the progress of events, the medical department feels justified in offer-

ing some suggestions intended to promote longevity.

Recent study into causes of death in old age show that intestinal auto intoxicuation figures largely as a causative factor. This has nothing to do with automobiles, for the intoxication is not necessarily alcoholic, but the term indicates poisoning as a result of the retention and decomposition of undigested matter in the large intestine of the human body. We are apt to eat more than we can digest and assimilate, and are not careful enough to dispose of the surplus by regular and sufficient movements of the bowels, so that from this retained surplus, toxines are formed, and toxines are but another term for poisons. These toxines are auto toxines because formed within the body and not introduced from without. Fermentation and decomposition do take place within our bodies under certain circumstances, and the decomposed products do harm by interfering with the functions of heart, liver, kidney and brain.

Another term used to express a quite frequent cause of death in the aged is Arterio Sclerosis, a hardening of the walls of arteries, weakening them and predisposing to apoplexy which quickly removes its victim from among the living. This hardening of the arterial walls brings death in other ways and is now recognized as a serious em-

barrassment and handicap to length of days.

Now, is there any satisfaction in being told how we might be taken off? An Irishman is reported to have said, "If I knew the place where I was to die in, faith I'd never go there," and a little caution along certain lines might help us to avoid or defer these things

mentioned as causes of death

How shall we avoid making our bodies a receptacle for decomposing matter? By eating less, for one thing; we eat too much too irregularly, as we are often willing to acknowledge. Suppose we have done this, what shall we do next? See that the matter consumed does not remain with us too lone. See to it that every day brings its outgo as well as its intake. Flush our intestines by the liberal use of water, cool, soft water as pure as can be obtained. Begin early in the morn-water acts, principally on the kidneys and does not so greatly assist in emptying the bowel. Cool, but not too cold because of injurious effect upon bodily tissues. Take first drink of water an hour if possible

before breakfast so that the stomach may be somewhat emptied for the meal. Don't drink very much or very strong coffee for breakfast. Drink more water between meals until from two to eight quarts have been taken daily. This will give you more saliva to aid the first digestive process, and more fluid for its different processes, and with this water the intestinal canal is being cleansed and flushed. Possibly for awhile a little laxative salt might be added with profit, but this is not likely to be needed very long for the water will answer without it. Why use soft water? Because hard water contains mineral salts that might be deposited in the walls of arteries and assist in the hardening process mentioned. This liberal use of water acts also to dilute bile salts and promote healthy liver action, keeps the kidneys in better shape and is a general all round good remedy, and when I say all round, it may be understood that outside applications are needed as well as inside use. Baths and abundant internal use of water at so called medicinal springs, might be practiced at home with equal advantage and at much less expense.

Beer is no substitute for water, and alcoholic drinks only do harm, liver pills are generally a delusion, but that which is all about us, pure, cool, soft clean water, boiled when necessary, used freely in connection with good judgment in eating, good use of the free air in circulation, good habits and good disposition will give one a good chance to ward off the grim reaper for many years to come.

We have assembled in our Annual Encampment and it will be a meeting of memories and reminisences. The compensations of age are its memories, and happy the man whose mind is not clouded by putrid memories, but of noble deeds, bravely performed in a glorious cause. While we remember and repeat to each other the sad and amusing things of 1861 to '65, let us remember some things more vital than these

Who among us thought in those days, much beyond the fact that were fighting for the unity of our country and the preservation of our flag. Did it ever occur to you that the flag stands for more

than the liberty of the slave and the integrity of the Union?

I have a higher conception of that flag: I have begun to reverence it as God's flag. It stands for more than any flag that ever floated over the Parliament of Nations. I say it is God's flag, for I verily believe that the principles for which it waves in the breezes are the principles proclaimed from Mt. Shai, recorded in the twentieth chapter of Exodus and preached by the Divine Teacher in his Sermon on the Mount centuries ago. I believe that the nation bearing this flag has been ordained of God to become the schoolmaster of the nations of the earth.

Already the nation that was old when Moses was born, after thousands of years of stagnation, has turned to the folds of this flag and in an almost bloodless revolution has torn the dragon from their flag-staff and hoisted a new banner which embodies all the essential teachings of our "Old Glory," and a pagan ruler has called upon all the nations of the earth to join in prayer for the success of the

nation that was born in a day,

God bless the Chinese Republic. We are their schoolmasters, and how gloriously has almost one-third of the human race learned and put in practice the lessons we have taught under the "Stars and Stripes."

R. C., which will mean that this Post will stay on the Roster until the last man is planted. I refer here to No. 35 of Tillamook. Report of the Legislative Committee read by the Assistant Adjutant General, and on motion same was unanimously adopted by the Encampment.

Newberg, Oregon, June 17, 1913.

General T. B. McDevitt, Commander Department of Oregon, Grand Army of the Republic:

Dear Sir and Comrade: The undersigned Legislative Committee, would respectfully report:

That soon after our appointment a meeting of the full committee was had at the office of the Assistant Adjutant General in Portland, and the proposed measures presented the committee were considered and discussed.

It was unanimously voted to not disturb the present terms of the so-called Northup law, by amendment or otherwise

The passage of the bill drawn by the Hon. Wallace McCament, making Lincoln's birthday a legal holiday was assisted by this committee and by the active work of our Commander among the legislators at Salem, and it is now a law.

A sub-committee was appointed to draft a bill providing free meeting places for Posts of the Grand Army of the Republic and auxiliary and allied organizations, which resulted in the enactment of the

following law, to-wit:

"Be it enacted by the People of the State of Oregon: "Section 1. The State authorities having charge of the Armories erected or to be erected in counties of the State where Posts of the Grand Army of the Republic are organized, or where Women's Relief Corps auxiliary to Posts are organized, or where there are Circles of the Ladies of the Grand Army of the Republic duly organized, or where there are Camps of United States Spanish War Veterans, upon written request of the Commander of such Post or Posts or Camp or the President of the Women's Relief Corps or Circle, shall provide suitable meeting places, including ante rooms in such Armories free of cost to such Posts, Camps, Women's Relief Corps or Circle; providing, that

there is sufficient unoccupied space in such Armory so to do, and that the occupancy thereof by any of the organizations hereinbefore referred to does not materially interfere with the occupancy of such Armory for the purpose or purposes for which it was originally intended.

"Section 2. In counties where there is no Armory belonging to or under the control of State authority, the county courts of such counties, upon written application of the Commander of a Post of the Grand Army of the Republic or Commander of a Camp of the United States Spanish War Veterans, or President of a Woman's Relief Corps or Circle of the Ladies of the Grand Army of the Republic, shall allow such Post, Camp, Relief Corps or Circle, free of cost, to occupy a portion of the court house or any other public building, where such occupancy shall not materially interfere with the occupancy of such building for the original purpose or purposes for which it was intended.

"Filed in the office of the Secretary of State, February 13, 1913." Subsequently it was thought advisable to secure an appropriation to aid veterans who participated in the battle of Gettysburg, now living in Oregon, to attend the Fiftieth Anniversary of that decisive battle in July next. As less than fifty veterans had responded to repeated calls for lists of participants, it was estimated that five thousand dollars would be ample funds to pay each their transportation; and so through the efforts of part of your committee and others the following bill was passed, to-wit:

"Whereas, the State of Pennsylvania has by act of its legislature approved May 13, 1909, created a Commission to arrange for a proper and fitting recognition and observance at Gettysburg of the Fiftieth Anniversary of the Battle of Gettysburg, inviting the co-operation of other States.

"Be it enacted by the People of the State of Oregon:

"Section 1. The Governor of this State shall appoint one or more Commissioners to act with said Pennsylvania Commissioners. Such Commissioners to serve without compensation other than actual traveling expenses. Such Commissioners to be soldiers eligible to attend the celebration under the provisions of section 2 of this act.

"Section 2. All soldiers who as such took part on either side in the Battle of Gettysburg, Pa., on the 1st, 2nd and 3rd days of July, 1863, or any of said days, who shall now be residents of the State of Oregon, shall be entitled to attend the celebration of the Fiftieth Anniversary of said battle on July 1st to 4th, 1913, under the provisions of this act; provided, that only such number shall be entitled to attend under the provisions of this act, as can do so under the appropriation made, and those first applying shall be preferred in the order of their application.

Section 3. The Department Commander of the Grand Army of the Republic of this State shall make enrollment of the persons above designated who may desire to attend said celebration, and make provisions for their necessary traveling expenses in attending the same, under such rules and regulations as he may adopt, with the approval

of the Governor.

"Section 4. For the purpose of carrying out the provisions of this act there is hereby appropriated out of any funds in the treasury not otherwise appropriated the sum of five thousand dollars, or so much thereof as may be necessary. The Secretary of State is hereby authorized and directed to audit all duly approved claims incurred in pursuance of this act, and the foregoing appropriation, and to draw his warrant on the State Treasurer in payment thereof out of the appropriation made by this act.

"Filed in the office of the Secretary of State, February 26, 1913."

In all of this legislative work your committee was very heartily assisted by you, Sir, the Commander of the Department, and by members of the legislature, veterans of the Spanish-American War, notably the Honorables Jay H. Upton, Jas. D. Abbott and Dr. T. L. Perkins, and by many other members of the legislative assembly.

#### REPORT OF COMMITTEE ON SOLDIERS' HOME.

We, the committee on health, condition and management of the Oregon Soldiers' Home at Roseburg, beg to submit the following:

For reasons not easily overcome the committee did not make a personal inspection of the Home as they desired to do, but beg to

state that by correspondence and personal interviews with members as well as by the biennial report of the officers of the Home much information has been gathered.

Pursuant to a call from the Governor, the Commandant of the Home and the Chairman of the Committee met in conference at the Governor's office on January 7th, at which time and place matters tooking towards the comfort of the inmates and betterments of the Home were taken up and discussed. The Commandant estimated the amount of funds necessary for maintenance and betterments of the Home for the years 1913-1914 at \$22,000. This was the amount, i. e., \$12,900 per annum, plus \$5,000 for improvements, appropriated by the report submitted by the treasurer of the Home, has been expended for the purposes intended.

None of the appropriation for the present biennial term, owing to the ninety-day limit before the law became effective, has been available.

The Chairman of the Committee brought up in this conference the matter of rules governing the Home, charactering some of them as being, in his opinion, arbitrary, unwise and with a tendency to work a hardship to the inmates. He specifically called attention to the rule denying the privileges of the Home to those receiving pensions in excess of \$20 per month, that the men applying for admission, in many instances, were without homes and unless taken into the Soldiers in which the laws of the State expressly provide ex-soldiers shall not be placed, and to hamper and harrass these aged defenders of the Nation as not only wrong in principle, but criminal in intent.

To this sentiment both the Governor and the Commandant gave their hearty assent, the Governor saying: "We must recognize the fact that rules governing State institutions are necessary and proper, but whenever they prove detrimental or work a hardship to occupants of the Home, a too literal interpretation should not be placed upon them; in other words, rules, especially those governing the Homes of those men who served their country in its time of need, should be elastic and made to fit the occasion."

This policy, the Commandant stated, had always been his method of dealing with those under his charge. "The rules are not of the making of either the Governor or myself, but were made by those formerly governing the State institutions. I am, myself, an ex-solider and my sympathies naturally would be with my comrades, and to enforce too rigorously rules laid down for my guidance in the management of the Home, is not my purpose and is not practiced. There are cases, however, as the committee must admit, where the strong arm of the law must be resorted to and the Home is no exception. As to the charge of compelling members to leave the Home on account of excess corder to provide room for those on the waiting list whom I felt sure were more deserving of the privileges of the Home."

The committee finds that the Home is taxed to its capacity, with a number always on the waiting list.

#### COTTAGES.

Three of the cottages are occupied at the time this information was received (May 10th). While the law governing the Home does not provide rations for the maintenance of soldiers' wives, the food furnished comrades occupying the cottages is sufficient for himself and wife. In addition, a garden plot has been set apart for each cottage, where vegetables may be grown for their use. This, it seems to the committee, is a wise provision, for it not only furnishes a supply of fresh vegetables, but provides a means of light employment to the Comrades, thereby giving necessary exercise, which conduces in no small degree to their health and contentment.

#### HEALTH OF INMATES.

The health of the occupants of the Home, as reported by Dr. Hoover, head physician, is excellent, and considering the advanced age of the men, the death rate is remarkably low. In a population averaging during the blennial term of 1911-12 of 160, the deaths amounted to but 20.

From the information your committee has been able to gather. they are pleased to say, in recapitulation, that the occupants of the Home and cottages appear to be humanely treated and well cared for As one occupant said, "I have been a member of a number of Homes and will say that the one at Roseburg is by far the most desirable and comes nearer being a home in fact than any other I have been in.'

Your committee feels justified in commending the management of the Home for the sympathetic interest shown our aged comrades. who, by force of circumstances, unfortunate as they are, are placed in a position of dependence upon others for the living they are unable to provide for themselves.

In conclusion, we beg to quote the following, from the report of

Commandant Elder to the Governor:

"My thanks are due to the Grand Army of the Republic for the cordial and pleasant relations existing between the management of the Home and the officers of the various posts throughout the State. Quantities of reading matter have been received from posts and from the Woman's Relief Corps and Ladies of the G. A. R., for which the grateful thanks of the officers and members of the Home are due. It should also be mentioned that a large number of publishers of daily and weekly newspapers throughout the State have thoughtfully supplied the library of the Home with copies of publications, adding in no small way to the enjoyment of the members of the Home. ### REPORT OF SPECIAL COMMITTEE ON "INBODY CASE."

The special committee appointed at the Thirtieth Annual Encampment to consider and report upon the resolutions concerning the reimbursement of bondsmen of Jake Inbody, defaulting Assistant Quartermaster General of the Department, presented the following report:

To the Annual Encampment of the Department of Oregon, G. A. R., at Newberg, June 17-19, 1913;

Comrades: Your committee appointed to make final disposition of the matter of reimbursement of bondsmen of Jake Inbody, late Assistant Quartermaster of the Department, and into whose hands was placed a copy of all the action taken thereon in all preceding emcampments, which your committee has carefully perused, and after due consideration of all the facts in the case, we deem it an act of simple justice that each Comrade whose name appears as bondsman in said case, and who has paid any moneys on account of said defalcation shall be reimbursed, in such amount as may appear set opposite his name

And your committee would further say, that we find from the history of this case, that the low condition of our Department finances

have been the cause of this tardy act of justice, and not a disposition to wrong any Comrade identified with a case we all deplore, Respectfully submitted

On motion to adopt the above report, Comrade H. S. Fargo. of Sumner Post, being recognized spoke as follows:

Department Commander and Comrades: As a member of the committee whose report is now before you I desire to say that this matter covers a period of time beginning in 1894, during which time resolutions have been adopted and reconsidered concerning the repayment of the bondsmen, and this committee recommends the repayment of the sums paid by the said bondsmen. You are all familiar with

the facts in the case.

I desire to say that in view of all that has been done and said in former years and of the further fact that this Encampment expects prompt and definite action in this matter at this time on the part of the committee, I took it upon myself to interview Comrade Northup. as he was the principal beneficiary in the action contemplated by this report, and to learn from his own lips his version of the affair. Judge Northup said to me that this was a closed incident as far as he was concerned, that he held no legal claim against the Department, that he felt that he had discharged his legal obligation only, that many unkind and uncalled for remarks had been made that should have been left unsaid, and if the Encampment cared to consider his wishes in the matter that it should be dropped and considered forever disposed of. And I believe now a motion to indefinitely postpone the whole matter should be sustained

prefer, however, to hear from Comrade Borthwick who may desire to be heard, after which if you feel it to be your duty to thrust into the unwilling hands of these bondsmen money which they do not want and to which they lay no claim we shall be content.

The case is in your hands, and your answer, recorded here will be final, in the settlement of this unhappy controversy.

Comrade A. E. Borthwick here took the floor and confirmed the statement of Comrade Fargo as to the expressed desire of Judge Northup that further action looking to repayment of the money he had paid on the defalcation bond be discontinued, and he further stated that another bondsman, Comrade H. Sutcliffe, who had paid on said bond, had written a note stating that he made no claim for reimbursement, that Comrade Cleveland Rockwell, the only other bondsman who had paid anything on the bond is now deceased and that his heirs had removed to Pennsylvania, that no claim had ever been made in their behalf for reimbursement and he thought under all the circumstances it was right and proper that the matter be indefinitely postponed.

On motion of Comrade Borthwick, seconded by several Comrades, the matter was indefinitely postponed.

On motion of Comrade J. S. Hamilton, a vote of thanks was extended to the Comrades who had paid on said bond and who now relinquish all claim for reimbursement.

#### ROLL OF HONOR.

The roll of the Comrades who have passed away since the last Encampment was read by the Assistant Adjutant General, the Comrades of each Post standing while the names of the dead from their respective Posts were read.

After the reading of the roll, Comrade J. J. Walter, Depart-

ment Chaplain, spoke as follows:

No doubt these departed Comrades passed out with the consciousness of duty well performed, and no doubt that He who is our great Commander has said to them, "Well done, good and faithful servant."

Institutions of learning call the end of school days, "Commencement days," and so they are to the young man and woman who have completed their college life. ## IN MEMORIAM

#### SALMON BELL ORMSBY.

Born October 18, 1825, at Parishville, New York, and received his education in the public schools. On the breaking out of the Civil War he was teaching school in Missouri, and on account of his outspoken loyal sentiments had great difficulty in effecting his escape from rebeldom, and coming north enlisted August 39, 1822, in Company K, 5th Michigan Cavalry, serving in Custer's Brigade in the Army of the Potomac, participating in the Battle of Gettysbury and several other engagements.

He was promoted to First Lieutenant in the 108th U. S. Colored Troops July 3, 1864, and to Captain, August 5, 1865, serving in command of Posts in Kentucky and Mississippi, and in several other important positions, during and after the close of hostilities, and was honorably discharged with his regiment, March 21, 1866.

Comrade Ormsby came to Oregon in 1883, and affiliated with the Grand Army of the Republic through Sedgwick Post No. 10 at Salem; as member of the State legislature in 1892 was influential in securing the passage of the bill establishing the Soldiers' Home at Roseburg.

He was elected Commander of the Department of Oregon in 1849, serving in that capacity with zeal and fidelity, and subsequently removed to Portland, where he died August 22, 1912, in full membership with A. J. Smith Post No. 26, in Sellwood suburb of the city.

Comrade Frank Severance of Tillamook placed that city in nomination, supported by Comrade J. C. Cooper, who presented the formal invitations of various organizations of that place.

A rising vote was taken, resulting in the selection of Tillamook as the location for the Encampment of 1914. On motion the vote was declared to be unanimous, and Comrades R. T. Chamberlain, A. E. Borthwick and G. A. Harding were appointed a committee to notify the Convention of the W. R. C. of the action of the Encampment.

The Comimttee on Resolutions presented the following report, which on motion was unanimously adopted.

Resolved, that we tender our gratitude to the transportation companies of the State for the generous concessions made to us in the matter of rates to our Encampment, and we are specially grateful for the open round trip ticket, and the elimination of the troublesome

and annoying certificate plan.

Whereas, the Commonwealth of Oregon, through its Governor and Legislative Assembly last convened has appropriated the sum of \$5,000,00 in aid of the celebration of the Fiftieth Anniversary of the Battle of Gettysburg, and to furnish transportation for veterans resident in Oregon who participated in said battle, and

Whereas, the said appropriation, owing to a greater registration than was first anticipated has proved insufficient to pay transportation for all entitled to go, and the Governor, in conjunction with the railroad companies, have generously made arrangements whereby all veterans who participated in that historic battle will be enabled to attend the

celebration, therefore,

Be it Resolved, by the Thirty-second Annual Encampment of the Department of Oregon, G. A. R., now in session at the city of Newberg that the thanks of this Encampment are due, and are hereby extended to Hon Oswald West, Governor of Oregon, and to the legislative Assembly, for their generous action in providing financial aid to both Union and Confederate veterans who may wish to attend the said celebration.

Resolved that a copy of these resolutions be forwarded to the Governor and to the press.

Resolved, that the thanks of the Comrades of the Thirty-second Annual Encampment of this Department are hereby tendered to the Department of Oregon Woman's Relief Corps for the generous donation of \$50.00 to the funds of the G. A. R.

## UNOFFICIAL PROCEEDINGS

#### WEDNESDAY, JUNE 18.

On Wednesday morning at 9:30 the annual parade of the Department took place, headed by the Department Drum Corps and the Newberg Band. The Newberg Graphic says: "Wednesday was a great day. The weather was perfect and the streets lined with people in the best of humor. It was an inspiring sight to see the old veterans in line, four deep, followed by the W. R. C. Then came the general parade with decorated autos and floats, which were cheered at every turn. But the parade of Newberg's best crop, the babies, must not be forgotten. It was a great showing and well worth seeing."

At the public school building a flag was presented to the school by the W. R. C. and a picture of Abraham Lincoln by the Ladies of the G. A. R.

The presentation speech in behalf of the W. R. C. was made by Mrs. N. Byers, and was responded to by Professor Stanbrough, who said:

"I remember a similar occasion on these grounds six years ago, when you last visited our city, at which time you presented a flag that was raised above this building. Six years is a short time compared with the age of the Republic, but in the life of a child in school it brings vast changes. Pupils who were finishing the sixth grade at the time of your former visit, have this year completed the high school course, some to continue in institutions of higher education, others to find their places in the business affairs of life.

building at a cost of more than \$45,000. Six years ago we had only a little more than 600 pupils. This year we had 925, an increase of fifty per cent. Newbers has always had a just pride in her schools, recognizing in them one of the most valuable of her community affairs.

"Again on this occasion we see an indication of your interest, not in the schools of Newberg only, but in the great American public school system everywhere. Nor, indeed, do I wonder that you feel such interest; for I realize that the public schools of the country are the best safeguards of national prosperity.

"You who sacrificed so much to preserve our national integrity, on the battlefield, or as the mothers, wives, and daughters left at home, know better than we of a younger generation what it has cost to

preserve our national institutions. We must learn from you, and from the pages of history which you have helped to write, the true value of our heritage.

"As in the truest sense our country consists not in fertile fields, forests, mountains, and rivers, but in crystalized sentiment in the form of certain well defined principals—so patriotism consists not in love for the land as such, but in loyalty to those principles which have made our country what it is.

"The boy who in the morning views with anxious eyes the threatening clouds, and advises us not to raise the flag for the day and thus
expose it to the elements, or who secures his teacher's permission to
leave the room to see that the flag is taken in before an approaching
shower, has learned something of the respect due the national emblem.
But our desire for the boy is that he may have a broader view and
a clearer vision of all that the flag represents in human sacrifice,
human desire and human aspirations; that he may see back of the flag
those principles for which it stands, principles that point unerringly
to the hand of God as directing the destinies of our nation."

The Campfire at the Rink on Wednesday evening was attended by a very large and appreciative audience, presided over by Past Department Commander B. F. Pike.

The program included selections by the Veteran Quartet of Portland, composed of Comrades W. N. Morse, A. W. Mills, Dr. J. E. Hall and Z. M. Parvin. Readings by Mrs. Morse, Mrs. Underwood and Miss Smith, a whistling solo by Mrs. Clarke of Salem, vocal solo by Mrs. T. D. Pollock of McKinley Corps, Portland, and short addresses by Mrs. Reeves, Department President of the Ladies of the G. A. R., Department Chaplain J. J. Walter, Past Department Commander H. V. Gates, President J. C. Pennington of Pacific College, and others.

1. The Department Commander is pleased to announce that the Semi-Annual report of this Department to National Headquarters for the term ending June 30th, shows a very gratifying condition of affairs. Notwithstanding the large death loss, and the entirely too large list of suspensions, the report shows a net gain of 37 members.

There is no good reason why 127 men should remain on the suspended list. Let the Post officers, especially the Quartermasters. put forth every effort to retain every man on the rolls and to reclaim

those who have allowed themselves to be suspended.

Remind those who have dropped out of the ranks that in future years, when the rolls of the Grand Army are searched by those who shall live after us they may not find our names as "suspended," (which means the same thing as "deserted"), in the last days of the Grand Army. Let us keep our records clean, my Comrades

The careful consideration of the Comrades is called to the following quotations from a circular just issued by Chapin Post No. 2, of

the Department of New York.

"What have I done during the last six months that has been of any benefit to the Post? What would become of the Post if every member had done exactly as I have done? How many times have I been absent when I could have been present if I had made an effort to do so?

"Have I visited the sick and spoken a kind word to cheer them in their affliction? Would I be pleased to receive the same consideration

in case of sickness as I have given others?

"If you will attend your Post meetings it will encourage the officers to take more interest in its affairs. Every Post whose meetings are well attended is successful, its business properly conducted and that Post can secure new members.

"Every man who wore the blue in the days of the war, who neglects to affiliate with the G. A. R. is depriving himself of a fraternity and comradeship which, if understood and appreciated, would always be a joyous and happy memory. Comrades should not deprive themselves of the pleasant fellowship and delightful association that are always connected with the meetings of the G. A. R.

There are less than 200,000 Comrades who belong to the Grand Army at the present time, and do you know there are more than 300,000 veterans drawing pensions who do not belong to our Order, who are reaping the benefits of the organized forces of its Comrades, but are showing none of that fraternity that holds them together.

'Every pension law that has been passed for the last 30 years has

had as its starting force the influence of the G. A. R.

"The G. A. R. has always been an influence for good. It has brought about the teaching of patriotism and civics in our public schools. It has caused the flag to be raised and floated over the school houses of the country. It has secured special and selected burial plots in cemeteries for our dead Comrades. It has established Memorial Day, when hundreds of thousands of all classes turn out to pay grateful tribute to the valor of the living and the memory of the dead. It has secured the passage of laws for the distribution of more generous relief for aged and infirm veterans and widows than ever known

"The Grand Army has brought about the establishing of 31 Soldiers' and Sailors' Homes, located in 27 states, and assisted in securing 10 National Homes. Several of these Homes admit the wives, widows and orphans of veterans.

"The G. A. R. has had as members some of the noblest characters of American manhood, as well as some of the grandest heroes the world has ever known. In its ranks have been Grant, Sherman and Sheridan, Thomas, Logan and McPherson, Burnside, Meade and Hancock, Farragut, Porter and McKinley

"The men who carried the musket and stood behind the guns have

equal rights in the G. A. R. with these men of fame."

2. Post Commanders are requested to forward to these Headquarters as soon as possible the names of the Comrades of their respective Posts who participated in the Battle of Gettysburg. This information is desired by the Commission appointed on the Celebration of the Fiftieth Anniversary of that Battle, to be held on July 1-4, 1913,

FIFTHETH ANNIVERSARY OF THE BATTLE OF GETTYSBURG. For the information of Comrades who contemplate attending the celebration of the Flittleth Anniversary of the battle of Gettysburg, which takes place on July 1-4, of the current year, upon the field where the most sanguinary contest of modern history was fought, and where American valor and heroism were displayed to a degree seldom withnessed by man.

The State of Oregon has appropriated the sum of \$5,000, or such part of said sum as may be necessary to pay transportation of old soldiers of the Civil War, who fought on either the Union or Confederate side on any of the three days of the battle, and who reside in

the State of Oregon.

The Government will establish a camp for the occupancy of those who may attend the celebration, with tents, accommodating eight men each, and will furnish cooked rations, blankets and camp conveniences for the four days of the celebration.

Each Comrade will be required to furnish his own soap and towels. Fully equipped hospitals will be established, with corps of doctors and nurses for the proper care of any who may suffer from disease or

accident.

All Comrades who may desire to take advantage of the provisions of the appropriation must first file their name, company, regiment, residence and postoffice address, with the Assistant Adjutant General, C. A. Williams, of the Department of Oregon, G. A. R., 229 Labbe Building, Portland, Oregon, when they will be furnished with a blank affidavit setting forth their actual participation in the battle on one of the three days, which must be filled out in full, properly witnessed and sworn to before a notary or magistrate with authority to administer an oath, and returned to the Assistant Adjutant General as above. Should the amount appropriated be insufficient to pay expenses

of all applicants, those first applying will be preferred.

For the information of those wishing to attend the celebration who did not take part in the battle in 1863, it may be stated that the

railroad rates from Portland to Gettysburg and return are not yet definitely announced beyond Chicago, but will probably be about \$100. From Portland to Chicago and return the fare is \$72.50, tickets good till October 31st, with liberal stop-over privileges west of Chicago on return trip.

The Commissioners feel it their duty to speak a word of warning those who contemplate the journey to Gettysburg and who are not in good physical condition. The journey will be long and tresome, and at a time of year when very high temperature may be expected, and it is earnestly recommended that those proposing to make the trip, take counsel with their physician and be guided by his advice. The veterans are also reminded that the journey will necessarily be attended with considerable expense as the money appropriated by the State can only be used for railroad tickets.

The following have been appointed by the Governor, under the provisions of the act, as Commissioners to represent the State of Oregon in the General Commission for the anniversary celebration:

Comrades: I wish to emphasize paragraph four of General Orders number nine, of our Commander. We deem it wise to give some reasons why this Order is important, and should be strictly compiled with as far as possible.

We are a Christian Nation. We have a Christian President and Scretary of State, and many of the prominent leaders in the affairs of our Government are not only nominal Christians, but active in

the service of our Divine Lord and Master.

It matters little what our private views and beliefs may be on the questions of soteriology. The fact emains that we are reconized as a Christian Nation by all the people and nations of the woods and a Christian. It behooves us then, as loyal subjects and defenders of our national unity and integrity, to be among the first of all civic organization to recognize this great underlying fact of our national life Does not this fact also explain another fact of which we are all so justly proud, and that is, that the Grand Army of the Republic is today everywhere recognized as among the strongest moral forces in our commowealth?

When you heard your country's call for her defense, many of you came from christian homes and during all the dangers and privations of war, were followed by the undying love and daily prayers of christian homes. Yea, more—your Commander-in-Chief in those dark days, spent many sad and anxious hours in prayer that your life might be

spared, that you might succeed in defending the old flag.

When I say that we are a christian nation, I do not mean to say that we are all saints or angels, but I do mean to assert that we have taken the twentieth chapter of Exodus as the foundation upon which we have built our jurispridence and we are trying to square our lives by the Sermon on the Mount in our conduct in life toward our fellowmen.

We consider the Sabbath previous to and May 30th our memorial day, both sacred to the memories of our Civil War, but somewhat different. May 30th we might say is wholly given to memorial services, while the Sabbath preceding May 30th, should inspire us for still higher moral and spiritual attainment.

We note a sad refrain in the report of our previous department chaplain, Smith, and that was that of the forty-three Posts reporting Sunday services only two sermons were preached by vicerans of the Civil War.
