



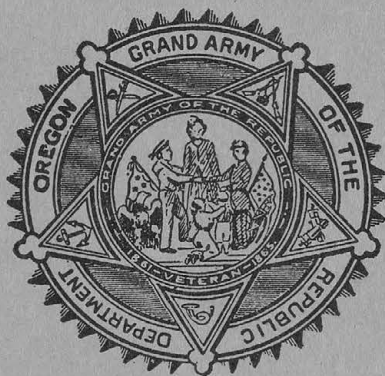

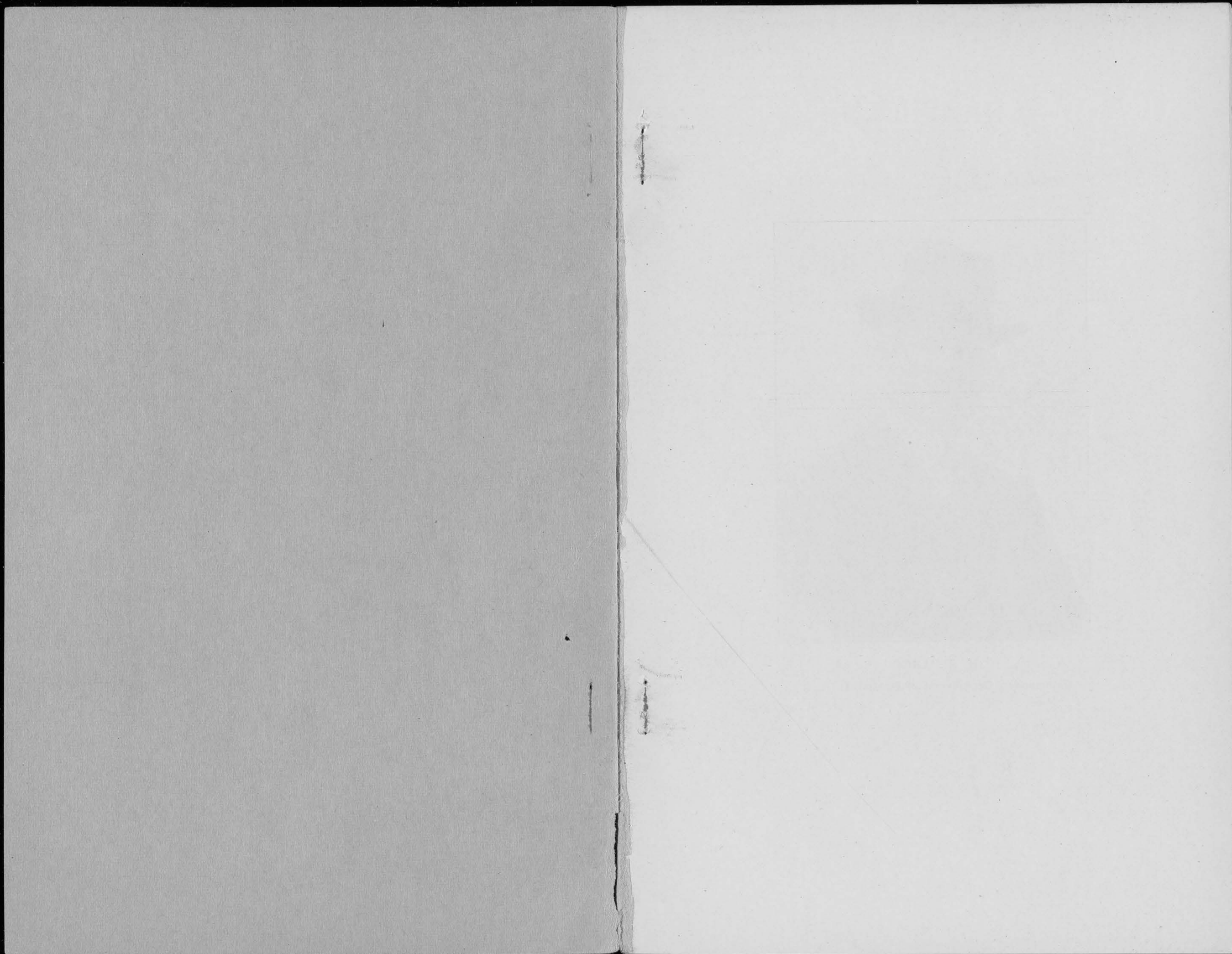

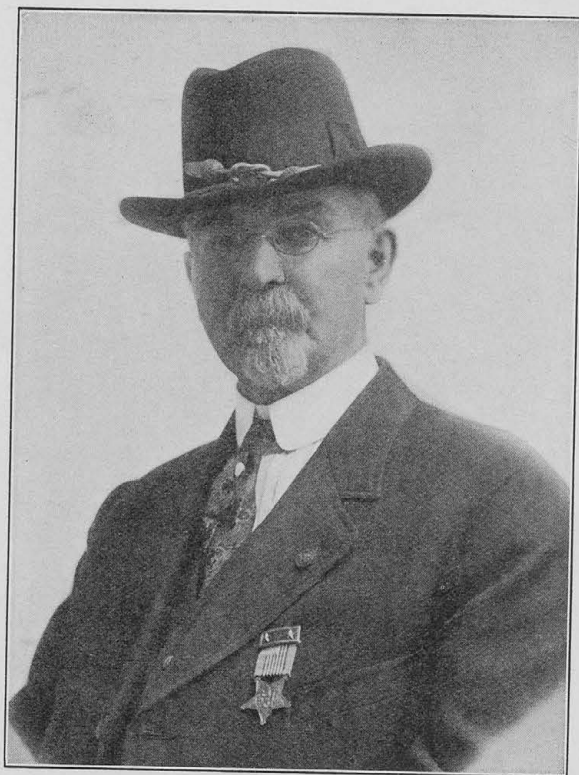

On motion of J. C. Cooper the Encampment ordered the appointment of a committee to wait on the Department Convention of the Woman's Relief Corps to convey the greetings of the comrades and the information that the Encampment was in regular session.

On motion of C. A. Williams a similar committee was ordered to visit the Convention of the Ladies of the G. A. R. and Geo. A. Harding, L. Rossell and W. J. R. Beach were named as members of the committee.

The next order of business being "Reports of Officers," the Department Commander's report was read by the Assistant Adjutant General, and referred to Past Department Commanders S. F. Blythe, W. J. R. Beach and Newton Clark for consideration.

REPORT OF DEPARTMENT COMMANDER

Comrades: The convening of this Encampment marks the closing of another year in the history of this Department of the Grand Army of the Republic.

One year ago you conferred upon me the distinguished honor of an election to the office of Commander of the Department of Oregon. I now return these honors, and place them in your hands with all the grace with which they were then conferred upon me; with the sincere hope that my successor may be accorded the same cordial greeting and warm-hearted comradeship that has been given me everywhere by the Comrades of the Grand Army of the Republic.

There never was a time when the Grand Army of the Republic was held in higher esteem than it is at this time, nor was there ever a more affectionate regard manifested by all the people toward the survivors of the war fought for the preservation of the Union, than today.

The past year has not been especially eventful in our country.

No great calamity has befallen us as a nation; the war clouds that at one time were of portentous threatening along our southwestern border, appear to have subsided.

As Americans, of kin to all the world, we are interested observers of the mighty conflict that is being waged in Europe where the destinies of nations are trembling in the balance. We as a nation are undisturbed within and without, pursuing the honest vocations of life with a greater degree of freedom than was ever before vouchsafed to mankind under any other government in all the history of the world.

Fifty years have past since the great Civil War. The growth and magnificent achievements of our great united country, has become the wonder of the world.

Marvelous indeed is the record of this nation made in the last fifty years. Emerging from the darkness and devastation of four years of frightful war, with undaunted courage she stood before the world a renewed, regenerated and disenthralled democracy.

Purified and rejuvenated by the scourge of civil war, free indeed to breathe the pure air of heaven; and with the flash and vigor of youth, the young manhood of America that had fought her battles in war, came forward, and eagerly seized upon the opportunities that have awaited them, and have proved to the world that the victories of peace are indeed no less renowned than war.

The men who now compose the Grand Army of the Republic were the pioneers in the great work that has been accomplished. They made these things possible, and to their sons and daughters belong the honor of leadership in the mighty activities of the present age.

The seeds of patriotism we have sown along our pathway are bringing forth fruit in the way of patriotism, loyalty and good citizenship.

Our great public school system is the great bulwark of our civilization and in these we have planted the seeds of patriotism, and this year, more than ever before, our public schools have responded handsomely to the call of duty, in taking part in the exercises of Memorial Day.

Such action speaks volumes of praise for the school management of our State, and offers encouragement to the comrades that have worked so long and earnestly to bring about these conditions.

We have great reason to be thankful for the many blessings that we enjoy today; thankful that we still live to enjoy the fruits of our labor; thankful that while other nations are torn with war, we as a nation continue to enjoy the blessings of peace and domestic prosperity under the flag that means so much to us.

During the year your Department Commander has visited, officially, thirty-three of the posts of the Department, with forty-seven additional calls, spoken at fifty-one meetings, attended the National Encampment at Detroit and performed other official functions, traveling about six thousand miles.

I am convinced that the visitation of the several posts of the Department is a matter of great importance, and I respectfully recommend that the several posts take up the matter of dates with the incoming Department administration in order that a more complete system of visitation may be inaugurated.

I also feel it my duty to suggest, that hereafter, in view of the important fact that the Department should be represented at the National Encampment by the Department Commander, and the further

fact that the great distance necessary to be traveled to attend the Encampment, involving considerable expense, that this Encampment provide at least the railroad expenses of the Department Commander in making this journey.

The Department Commander assisted by our Assistant Adjutant General and other comrades organized a new post, viz.: Hancock Post No. 21 at Rainier.

This new post was organized with ten charter members to which substantial increase is assured and it is now being ably assisted by a newly organized Woman's Relief Corps. The comrades of Hancock Post No. 21 are to be congratulated.

Great credit is due to our auxiliary organizations, the Ladies of the Woman's Relief Corps and Ladies of the G. A. R., for their great help and encouragement they have rendered to us during the year.

Their generous hospitality, as well as their financial contributions from time to time; all of which we fully appreciate and for which this Department will ever owe them a debt of gratitude.

It is with a feeling of pride and satisfaction that your Commander acknowledges the splendid courtesy of the Spanish War Veterans in extending to the comrades of the Grand Army of the Republic as individuals, honorary membership in their splendid young organization. I am pleased to report that many of the comrades have accepted this privilege and become honorary members of the order, and find much pleasure in the association with the bright young men who compose this very much alive and progressive organization.

Great credit is due to our Assistant Adjutant General for the able manner in which he has conducted that office, as well as the office of Assistant Quartermaster General of the Department.

His economical management, close attention to the duties of his office, his personal qualifications, capabilities, and efficiency render the services of Comrade Williams almost indispensable. The Department Commander greatly appreciates his assistance during the year.

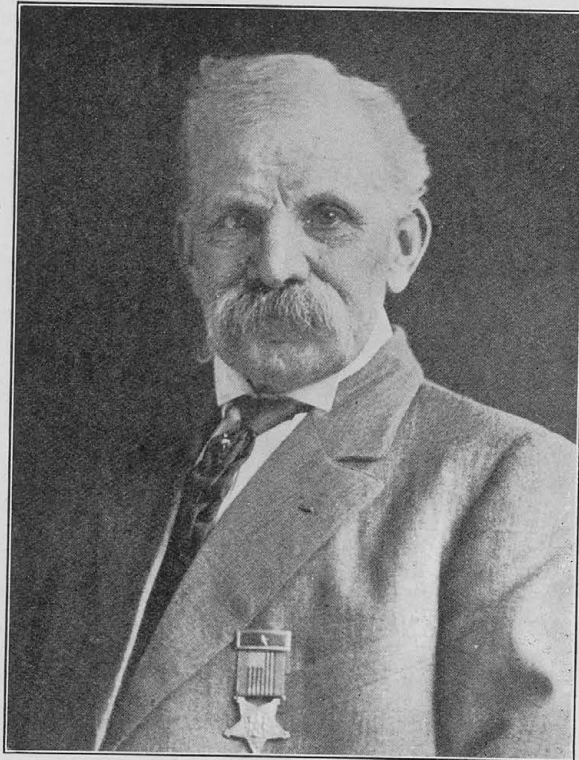

I wish, on this my first opportunity, to tender to my comrades my grateful thanks for the high honor conferred on me by the Thirty-

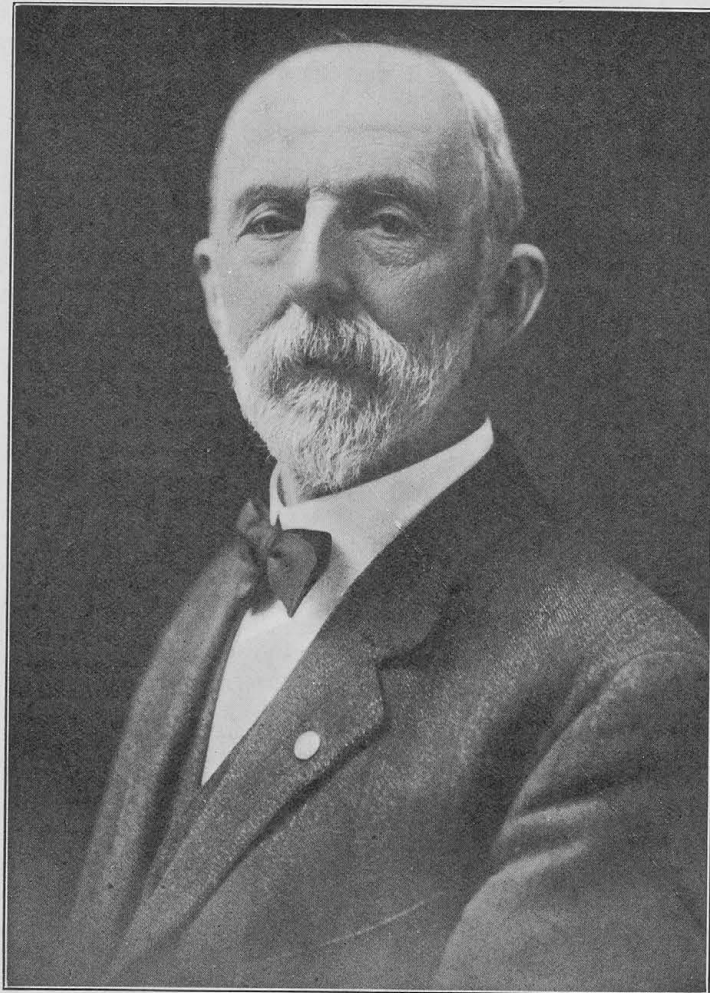

third Annual Encampment at Tillamook, Oregon, in 1914, by electing me Junior Vice-Commander, and I hope that my report will be worthy of the office which I have held for the past year. I had the pleasure of attending the Forty-eighth National Encampment of the Grand Army of the Republic held at Detroit, Michigan, September 3 and 4, 1914, and assure you it was one of the greatest pleasures of my life.

I arrived in Detroit on Sunday, August 31, picked up by one of the boy scouts and hustled off to place of rest and grub, which happened to be a widow woman, and had fine fare. Monday morning started to hunt for Oregon headquarters. Visited National headquarters to find a list of department headquarters, found where Oregon headquarters were located. I arrived at the place but did not find the boys, as they left their luggage and all leaving on that day, and leaving no word, I did not find them until Tuesday evening. As I was still on the hunt for them I ran into Commander Fargo, being the first one of the Oregon boys I had seen since I arrived in Detroit. Wednesday morning we got together and organized for work. I wish to say right here I never saw such a large gathering handled with so much care. Detroit made good all she promised, it is a nice city, and a whole-hearted people. I will not give you a full report what I saw as it would make a load to relate, but a few things I wish to tell you of what the boy scouts are made of and what they did on the day of the parade, and how the boys did all through the days of the encampment. 1,200 boy scouts maintained at Detroit, 400 of them were on duty all the time, their services were waiting on comrades, locating places for them to stay, helping in crossing streets, and when a comrade gave out he was taken to a place of rest by a boy scout, if sick taken to a hospital. These scouts were of the age from 10 to 14 years. On the day of the parade these boys showed their usefulness all along the line of march. They by hundreds were serving the comrades with hot coffee and cold water, and when a comrade fell out of line, gave out, or was sick, he was taken out to a place of ease and when sick taken to a hospital by the boy scouts. I tell you it was grand and these are the boys that are going to protect the country. They will be there when called for in the future.

Of the encampment, I wish to report before I close, of the generous way that Detroit treated the comrades on Tuesday, September 2, 1914. The city gave a naval pageant led by the U. S. Revenue cutter, followed by seven large steamers, loaded down with comrades' wives, and W. R. C. numbering some 6,000 on a ride of 12 miles.

Wednesday was the day of the grand parade and vast crowds lined the streets, windows, and housetops, over 300,000 people. Oregon Department came in for a share of the cheers. I had the pleasure of leading our department, Commander Fargo not being well. Nine of the boys were in line, three not taking part, making a total of twelve

from our department. Comrade France was nominated for National Junior Vice-Commander and then withdrew. I would like to say right here that I should like to see this Department represented in the National Encampment to fill the place of Junior Vice-Commander and I should recommend that the Department select and recommend some good comrade for that place with instructions to the delegates to work to that end.

I have the pleasure to state that in the past year I have visited five posts, two posts I have visited twice, making seven visits in all. I find some in good working order, find three not taking up the countersigns by the officer of the day, vouching for the comrades, now I move that the countersign be taken up from each man at all meetings, and that the officer of the day get his countersign from his commander, so that he will be correct. I would also recommend that the post hold open meetings, assisted by the W. R. C., once every two months, for I believe that nothing will help build up a post or W. R. C. any better.

I have the honor to say that I have visited three schools the past year and can say that my visits have been pleasant and I have been pleased with the interest that the school children take in my visits. Get the children interested and they will not only meet you half way, but will come all the way. I would recommend to visit the schools oftener and not wait from one year to another, the children are hungry for instruction, and comrades it is up to us to see that they get it. Now is the time to do the good work we fought to bring about.

I am proud that I am an American citizen. I am proud that I live in a land where peace and prosperity go hand in hand with all the world. Now we are the only great nation which stands aloof from the universal havoc, our faces are turned towards the light, and high above us flies our Star Spangled Banner.

The Medical Director read his report, as follows, which was received with applause by the comrades and referred to M. L. Pratt, I. McGowan and J. M. Shelley for consideration.

MEDICAL DIRECTOR'S REPORT

McMINNVILLE, OREGON, JUNE 14, 1915.

To the Commander and Comrades, Department of Oregon, G. A. R.

To have lived long enough before the Civil War to have taken a part in it, to have successfully passed through our share in that four years' conflict where not only hostile bullets were fired to cut short our earthly career, but where in addition the germs of malaria, chronic

diarrhoea, typhoid fever, mumps, smallpox, and the dangerous and doubtful articles the sutler used to sell us, were on hands, recognized or unrecognized, to remove us from the land of the living, and to have lived in addition long enough to celebrate a half century of years after the close of the Civil War, gives us reason for congratulation and gratitude, and argues that we must have been built of pretty fair material which possessed excellent resisting powers.

Our physical appearance at this time suggests to one willing to acknowledge that all the good things of life do not belong to the last half century, that in our boyhood the catnip, the sage or the boneset teas administered internally, with the wilted plantain leaves, the cabbage leaves, the flax-seed or bread and milk poultices, the mustard plasters and the fly blisters applied at various places on the outside of our anatomy to bring trouble to the surface or make it so hot outside we would for the time forget we had trouble anywhere else, was for us after all about as safe a proposition as to have been born about 60 years later when any internal bodily ailment seems to require professional investigation by the thrust of a long hollow needle into this human machinery to secure a sample of vital fluid for the microscope on the hunt for dangerous germs, or not content with this, and not content with examination with an x-ray machine, which is supposed to reveal all our physical short-comings, this desire for seeing what is inside would only be satisfied by a chance to look in after having shaved us, rubbed us and scrubbed us with antiseptic fluids and separated our muscles with sterilized knives or scissors, and then proceed with one or more rubber-gloved hands to explore our internal machinery to satisfy the explorers whether our stomachs needed resetting, our gall bladders need repairing, our intestines need replacing, our appendix needs removing, and whether there is anything remaining that could safely be left without a readjusting.

We certainly took dreadful chances in those days before the war in not knowing what was going on inside of us when we had a pain in the region of the stomach, but fortunately for us boneset tea would act as an emetic if we drank enough, and on its return would sometimes bring the cause of the trouble up with it, or if that was not at hand, a hot plate kept on the outside, with draughts of peppermint or spearmint tea inside, had a soothing effect and we got the grateful relief which satisfied us then fully as well as people are now satisfied to tell of their relief by means of surgical operations.

We have reason to remember with gratitude the careful foresight of our mothers and grandmothers who gathered the medicinal herbs in their season, carefully dried them and hung them up in the garret for future use. In time of need they were there generally in liberal quantity, if fortunate enough to get along without them their odor was not unpleasant and sometimes seemed to assist in bring on grateful and refreshing slumber.

Our grandchildren are growing up under different medical and surgical conditions. When we were boys and used to snore at night it was said to be due to a cold in the head, and if the snoring became very decided we were turned on our side to make the tones a little less rasping. Now a snoring boy or girl is reported the victim of adenoids and must have tonsils removed or some guilty membrane inside the nose snared or excised.

We did not have the milk we drank pasteurized, and the bottles from which it came sterilized, but we enjoyed it and as long as it was known that the cow herself was "pasteurized" in a good field and gave plenty of milk, our parents were willing to take the chances on our growing. In those early days we used to be afraid of a hospital and did not know what our temperature was morning and evening, and had no chance to fall in love with a pretty trained nurse whose dainty little headgear and white apron look so attractive, and who so skillfully handles the hospital patients of the present day. No, some of these things were denied us, but we are here, glad that we are living, and hope to carry with us to the tomb, when we cannot live any longer, all the bodily organs internal and external, with which nature endowed us, apologizing however to the many good and useful surgeons whose skill we recognize, whose necessity we acknowledge, and whose services we would call for in a time of need.

REPORT OF DEPARTMENT CHAPLAIN

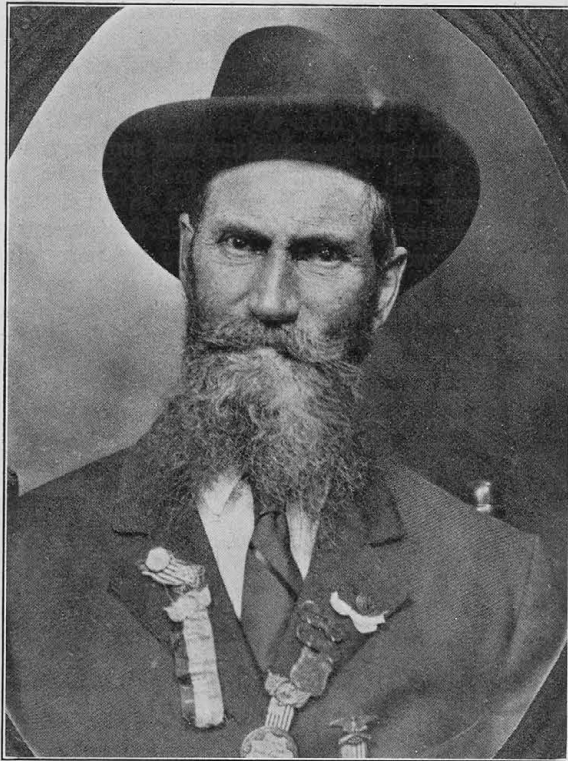
Commander and Comrades of the Grand Army of the Republic.

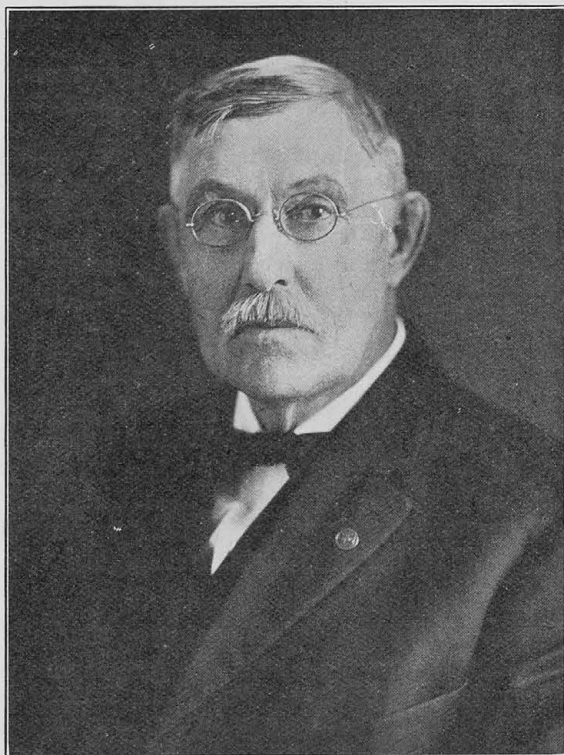

The committee appointed to prepare suitable memorial of our late comrade, Past Department Commander A. J. Goodbrod, presented the following, which was adopted as read:

In Memoriam

ALBERT J. GOODBROD

(Department Commander in 1900)

Comrade Goodbrod was born in Wittenberg, Germany, February 26, 1844. With his parents he came to America in 1852, and lived for many years at Newark, New Jersey.

He enlisted at New York City on the third day of January, 1862, to serve for three years or during the war as private in Capt. Wm. W. Bennett's Company B, 11th New York Cavalry, otherwise known as "Scott's Nine Hundred."

The regiment under Col. Jas. B. Swain left the state May 5, 1862, and served in the Department of Washington and the 22d Corps from May, 1862; in the Department of the Gulf from March, 1864; at La Fourche, La., from May, 1864; at Baton Rouge, La., from June, 1864; in 2d Brigade Cavalry, Department of the Gulf, from August, 1864; in the Department of the Cumberland from March, 1865; and was mustered out at Memphis, Tenn., Sept. 30, 1865.

The regiment or portions of it took part, among others, in the following engagements: Blue Ridge Mts., Va., June 18, 1862; Poolsville, Md., Dec. 14, 1862; near Fairfax Courthouse, Va., June 27, 1863; Boliver Hts., W. Va., June 30, 1863; Harper's Ferry, W. Va., July 7, 1863; Edward's Ferry, Md., Aug. 27, 1863; Leesburg, Va.-Rockville, Md., Sept., 1863; New River, La., May 15, 1864; Bayou Sara, La. and Brookhaven, Miss., Nov., 1864; skirmishes in La. and near Memphis, Tenn., Mar. 12, 1865. At Germantown, Miss., April 18, 1865, one of the last actions of the war, the regiment lost its greatest number—nine killed and twenty-four wounded.

Albert J. Goodbrod received an honorable discharge at Washington, D. C., on the third day of January, 1864, and re-enlisted as veteran, in the same company and regiment, January 4, 1864, to serve three years.

He was wounded at Fairfax Courthouse, Va., June 27, 1863, by a minie ball passing through a lung and lodging in his shoulder. He remained on the battlefield seven days, and was then taken to a hospital in Washington, rejoining his company after five months. He received honorable discharge with his regiment at Memphis, Tenn., Sept. 30, 1865, and re-enlisted on March 1, 1866, at New York City in M Company, 1st U. S. Cavalry, and was mustered out March 1, 1869, at Camp Lyons, Oregon.

Comrade Goodbrod located in Union, Oregon, in 1876, and there served the city and community in numerous capacities; was city marshal for four years; councilman five years, and in the various services was always identified with the best interests of the city and state.

He joined Preston Post No. 18, G. A. R., and was its Quartermaster in 1884, and J. V. Commander in 1885, and Commander in 1887. He transferred his membership to O. P. Morton Post No. 36 at La Grande, Oregon, and became its Commander. In June, 1897, at the Department Encampment at Independence he was elected delegate to the National Encampment, and at The Dalles in May, 1898, was elected J. V. Department Commander; the following year at McMinnville he was again elected delegate to the National Encampment, and in June, 1900, at La Grande, he was unanimously elected Department Commander and served a full term. In 1902 he retransferred his membership to Preston Post No. 18, G. A. R., and remained in it to the end.

Comrade Goodbrod and Louisa Shoemaker were married at Union, Oregon, Dec. 10, 1890, and have two sons, George A. and F. Adrian.

Mrs. Goodbrod is a member and Past President of Preston Corps No. 22, W. R. C.

Comrade Goodbrod was of large stature, commanding presence and was endowed with robust health until late in life. When bodily ills intervened he felt distressed and annoyed, not so much for his own comfort, as that his disabilities deprived him of that usefulness that he wished to give to those deserving his care and assistance.

After a somewhat lingering illness, he passed away at La Grande hospital, August 21, 1914, aged 70½ years.

With his passing we, his comrades, deplore his loss and we commiserate with his family and his many personal friends; a brave patriotic soldier, a good and valued friend and citizen of the Republic has gone to his reward. Of such as he it is said, "They rest from their labors and their works do follow them." God be with you, dear comrade, rest in peace; hail and farewell.

Resolved, That this testimonial be made a part of our permanent record of this Encampment, and copy thereof be sent to the family of our departed comrade.

At this point a committee from the convention of the Woman's Relief Corps was introduced, who tendered the Encampment the greetings of that organization with a free-will offering of \$83.55 in cash, for the use of the Department.

The ladies were received with enthusiasm, and a rising vote of thanks was tendered the Auxiliary for its generous gift.

The following resolution, introduced by Comrade T. E. Hills, was read and unanimously adopted by the Encampment by a rising vote:

Whereas, The Pacific Coast has never been honored by the election of a Commander-in-Chief of the Grand Army of the Republic; and

Whereas, We believe the time has come in the history of our order when we should be so recognized and honored; therefore be it

Resolved, That the Department of Oregon, Grand Army of the Republic, assembled in its Thirty-fourth Annual Encampment endorse our honored and worthy comrade, B. F. Pike, for the position of Commander-in-Chief, whose record in our organization is above reproach, and our confidence in his ability and integrity stands unquestioned.

Resolved, That our representatives to the Forty-ninth National Encampment at Washington are hereby instructed to do all in their power to secure his election.

The following resolution, relating to expenses of Drum Corps at Encampment sessions, was adopted as read:

Whereas, The Oregon G. A. R. Drum Corps is regarded as a necessary adjunct to the success and enthusiasm of our annual encampments; and

The Committee on Resolutions submitted their report to the Encampment which was unanimously adopted.

1. The passing of another annual Department Encampment, demonstrating as it has the friendly interest and tender consideration of the citizens of the charming city of McMinnville, who have done so much to make our stay pleasant, calls for the expression of our sincere thanks and grateful appreciation to all who have in any way assisted in making this one of our most enjoyable sessions. Such kindnesses tend to brighten the evening of our lives, and cannot be forgotten.

2. To the officials of the Southern Pacific Railroad, with special mention of Messrs. Scott and Stinger of Portland, we tender our thanks for courtesies extended us and assure them we will remember their kindness in furnishing a special train for our use from that city.

3. We note with regret the passing from earth of Mrs. Rose Bloch Bauer, whose talented rendering of patriotic songs, especially "The Star-Spangled Banner," has proved a delight and inspiration to many comrades and others who have been privileged to hear her.

4. Past Department Commander J. C. Cooper and comrades of Custer Post No. 9 have won our regards by personal and untiring efforts to give us "the time of our lives," and we will carry away with us most pleasant memories of the graceful movements, the excellent drill and the splendid work of the attractive young ladies whose music and field work has added so materially to our enjoyment.

5. The Drill Team of the George Wright Relief Corps has our approval and endorsement and their marching already shows that its members have the capacity, courage and grace for skilful and efficient movement.

6. We heartily endorse the sentiment of the letter of thanks to the family of the late Dr. O. P. S. Plummer for the valuable contribution to the Department of the volumes of the Official History of the War of the Rebellion.

7. We approve the recommendation of the Department of Kentucky favoring the establishment of permanent National Headquarters and appointment of permanent Adjutant General.

8. We approve the proposition to publish summary of the membership of each post in the Department in future Department Rosters.

UNOFFICIAL PROCEEDINGS

We are indebted mainly to the Telephone-Register of McMinnville for the following report of the unofficial proceedings during the Encampment:

The big special train of nine coaches from Portland Monday noon carried 410 passengers. They were accompanied by General Passenger Agent John M. Scott, who personally looked after the comfort of guests and their proper transportation throughout the entire encampment. The Southern Pacific has never had a passenger agent equally devoted to the needs of the people in transportation matters as is Mr. Scott. The job of assignments was a big one for the reception committee after the arrival of this train, and the general public will never know how hard they worked. The work was accomplished finally, however, and everybody found a place of entertainment.

The parade on Monday was an interesting event. It was led by Marshal W. G. Henderson and James Martin, assisted by several ladies as aides on horseback. The Elks band followed, making superb music. Thirty members of the Oregon National Guard were in line, then came the guard of honor, comprising 32 young ladies in white uniforms armed with swords, and a company of 24 girls of the local campfire dressed in Indian maiden costumes, armed with spears. There were 83 members of the Elks lodge in the parade. These were followed by the drum corps, composed of seven fifers, three snare drums and one bass drum. Accompanying the corps on either side was a line of flower girls—little tots just big enough to keep up with the procession, bearing flowers to be bestowed upon the soldiers. Following them was the body of G. A. R. veterans, 290 in number, and it is understood that at least 100 did not feel like joining in the march and remained outside. Two auto loads followed and behind them were the Ladies of the G. A. R. and W. R. C. In this company were 10 ladies carrying a large flag strewn with roses. Another company of 12 ladies from the George Wright Post of Portland marched under the direction of a leader and were nicely uniformed in white. There were 222 ladies in line. Then followed behind a band from the amusement company's show, and lastly came the Spanish War Veterans. Though few in number, these soldiers of the younger set were enthusiastic and bore a large Cuban flag alongside the national colors. They are members of the Bert J. Clark camp of this city. The parade was reviewed by Governor Withycombe from an automobile near the McMinnville National Bank. The Governor made a brief address at the park following the parade.

The evening program consisted of a nice address of welcome by Mayor Tilbury, who turned over a large key to Department Commander Fargo, who made response in an address of some length.

Mrs. Eva Ruger of Tillamook, president of the W. R. C., also spoke, as did Mrs. C. E. Parker, representing the ladies of the G. A. R. Roy W. Kest spoke as Department Commander of the United Spanish War Veterans.

On Tuesday evening there was a pleasing address by Dr. Loughridge, and vocal selections from two male quartets from Portland. J. D. Stevens of Portland responded to a call and made an address outlining the military possibilities of this country in case of war. There were presentation gifts to retiring Commander H. S. Fargo and Mr. Kellogg, chief of drum corps, by the ladies representing the two auxiliary organizations.

One of the pleasing events of the evening was the presentation to the Department of Oregon, G. A. R., of a check for \$28.75 by the Ladies of the G. A. R.

The Spanish War Veterans took the drum corps in five automobiles Tuesday afternoon on an excursion to Dayton and Lafayette, where they dispensed patriotic airs in a lavish manner. Frank Rogers was one of the party, and he says he had one of the best times of his life. They started with an audience of one in Dayton, and the music was no sooner started than the people came running from all directions until a large crowd had gathered about the band. The experience was repeated in much the same manner at Lafayette. Representative P. P. Olds addressed the visitors, extending thanks for the music and calling for three cheers for the veterans, which was lustily responded to. In the evening the Spanish veterans, took lunch at the Antlers restaurant with members of Harrington Camp, S. W. V., who had come up in autos from Hillsboro. Late the same evening, after all exercises were over, they together visited the bivouac of the drum corps on South E street, where they had a good social time, and had difficulty in restraining the musical veterans from getting out at midnight and disturbing the slumbering hosts of the town. Duncan Harris and Fred Garrison were leaders in this movement, and they had many testimonies from the old soldiers that never before had they been treated so cordially by the younger veterans—in fact, this was about the first time they had enjoyed such an innovation.

The Veterans' quartet of Portland, composed of Messrs. Mills, Morse, Hall and Parvin, delighted the audience on Monday and Tuesday evenings with vocal selections both patriotic and humorous. Prof. Parvin was formerly of Salem, and has been at the head of musical events of the state for years. He has composed much music, and is now at the head of a music school in Portland. The other quartet is known as the Grand Army, and they are also from Portland. They gave three selections Tuesday evening, and were twice enthusiastically called back. All are fine singers, and show that they enjoy the art. The personnel of this quartet is Messrs. Chambers, Hamilton, Varner and Powellsen.

There was a total registration of 728 visitors. Of these 488 were veterans, 165 members of the Relief Corps and 75 Ladies of the Grand Army.

Our visitors were polite and most gracious in their appreciation of the efforts of this city to entertain.

GENERAL ORDERS No. 3, Series 1914-15.

I. The Department of Oregon was represented at the Forty-eighth National Encampment of the Grand Army of the Republic, at Detroit, Mich., August 31 to September 6, by the Department Commander, the Junior Vice-Department Commander, and eight representatives, all of whom were present at the business sessions of the Encampment. The headquarters of the Department were established at Room 107, Ponchartrain Hotel, where an open register was kept for recording the names of all callers. The entire delegation took part in the grand parade on Wednesday, when nearly 10,000 comrades marched a distance of one mile and a half in the presence of 200,000 people who extended to the marching comrades a most cordial greeting. The city was beautifully decorated and special entertainments were provided for each evening of the week, when very interesting programs were presented. The leading features of these gatherings were the eloquent addresses of Commander-in-Chief Washington Gardner and Commander-in-Chief-elect David J. Palmer of Iowa, which were much appreciated by the comrades. The city of Detroit is entitled to great credit for the splendid manner in which she handled this great Encampment.

II. The Department Commander, like his predecessors, desires to remind the comrades, both officers and members of the importance of earnest and continuous effort in recruiting our ranks from the many worthy men who, for some inscrutable reason, still remain outside our order.

The editor of the National Tribune well says: "Every man who has a spark of comradeship in his nature, who is glad that he served in the Union army, should be more than proud to unite with his comrades in the work of caring for his suffering comrades. He should be ashamed that he does not take his proper share of it. When a veteran dies it is the desire of himself and all his relatives that he should be given the honors of a burial by his Post and his grave properly marked and cared for on Memorial Day. How can he expect this if he has not joined with his comrades in paying similar honors to those who have preceded him?"

"Furthermore, membership in the Grand Army of the Republic is a place on the roll of honor which is highly valued by his children and grandchildren. It is a certificate of his honorable service in the army and navy which saved the Union. There are more than 200,000 veterans outside of the Grand Army who are enjoying the fruits of its work in the shape of a liberal pension and who should be in the ranks in gratitude for what has been done for them, and in helping

carry on the magnificent work of charity and honor to all soldiers and sailors who followed the flag in the days of the nation's distress."

The Department Headquarters has many calls for assistance from ex-soldiers of the Civil War, practically all of which are made by men who are not affiliated with the Grand Army, and who really have no valid claim upon us.

It is the policy, however, of this office to render whatever help its limited resources will admit to any old soldier who may be in destitute circumstances.

It is hoped that every post in the Department will at once enter upon an active campaign for recruits, and will bring inside the breastworks those comrades who have so long remained outside.

The commander would also urge upon the post officers the duty of holding their membership. Do not be too ready to suspend or drop from the roll those who, from poverty or even negligence have become in arrears in their dues. While of course it is necessary to have a good financial basis for the post let it be remembered that the great object of organization is not the collection of dues, but the promotion of comradeship. Let no comrade in the Department be dropped from its rolls because of poverty.

III. It is with pleasure that the Commander announces the addition of another post to the working force of the Department. Hancock Post No. 21, at Rainier, Columbia County, was mustered on July 22, 1914, by the Department Commander, assisted by the Assistant Adjutant General, and several comrades from Portland.

The new post starts off with enthusiasm and will no doubt be a useful reinforcement to the ranks of the Department. Steps have already been taken toward the organization of an Auxiliary.

IV. The special attention of Post officers is called once more to the matter of Post records and reports. In too many posts in this Department, as well as in others, the adjutants and quartermasters are remiss in the discharge of their duties and their records are so negligently kept that it is impossible to make an intelligent report from them.

The Descriptive Books of some of the posts, (which should be most carefully kept, as they contain the complete record of membership) are a disgrace to an organization of intelligent men. Officers frequently report to these headquarters that the post records are in such shape that they cannot make a full report of the condition of the post.

The Post Commanders are largely responsible for this neglect, as the Adjutant is appointed by the Commander and it is his duty to see that his subordinate performs his duty.

The Commander is responsible also for the prompt forwarding of reports to Department Headquarters, after he has examined them

and satisfied himself that they are fully and correctly made out. If he finds them imperfect or incorrect he shall cause the necessary corrections to be made before forwarding them.

Post Adjutants are urged to give immediate attention to the reports of deceased comrades to this office as soon as possible after the decease of any comrade of their post. Blanks for such reports will be sent to each post in the near future.

VI. The following information from the Bureau of Pensions is published for the benefit of those who are entitled to increase under the act of May 11, 1912, on account of age, and whose pension certificates were issued before the passage of the act providing for automatic increase:

"Applications for increase of pension under the act of May 11, 1912, on account of age and length of service, are no longer required.

"If a soldier now pensioned under the act of May 11, will simply advise this Bureau of his full name, the company and regiment in which he served, the number of his pension certificate, and the date when he became entitled to a higher rate under said law, such communication will be given consideration, in the order of its receipt, with a view to issuing a certificate for a higher rate, and for any future increases to which he may become entitled by reason of age and length of service."

VII. An inspection of the posts of this Department is hereby ordered and the same will be conducted under the direction of

Comrade L. J. Fish, of Post No. 5, the Department Inspector. The list of Assistant Inspectors will be forwarded to the Post Commanders in the near future, and it is confidently expected that every post in the Department will report its inspection.

McClearn, who was a barber in Portland in 1873, and was last heard from in San Francisco in 1882 or 1883, as he was about leaving that city for Portland, Oregon. This comrade served for a time in the U. S. Navy during the early part of the war, and afterward in the 4th Mass. Cav., being finally discharged on account of wounds. Any information concerning this man will be gladly received at these Headquarters and most gratefully appreciated by his widow.

With sincere regret the Department Commander announces the decease of one of his predecessors, who served the Department as its Commander in 1900.

Comrade A. J. Goodbrod was born in Germany in 1844, coming to this country with his parents at the age of 8 years. He enlisted in Co. B, 11th New York Cav., and served with faithfulness and gallantry to the close of the war.

A brave soldier, a faithful comrade, a good citizen and an honest man has gone to the ranks of the Grand Army beyond.

1: It is forty-seven years since Gen. John A. Logan, of glorious memory, issued his General Order No. 11, designating May 30 as Memorial Day.

The Department Commander directs that this order be read as part of the exercises of Memorial Day.

HEADQUARTERS GRAND ARMY OF THE REPUBLIC.

WASHINGTON, D. C., MAY 5, 1868.

I. The thirtieth day of May is designated for the purpose of strewing with flowers, or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village and hamlet churchyard in the land. In this observance no form of ceremony is prescribed, but posts and comrades will in their own way arrange such fitting services and testimonials of respect as circumstances will permit.

We are organized, comrades, as our regulations tell us, for the purpose, among other things, "of preserving and strengthening those kind and fraternal feelings which have bound together the soldiers, sailors and marines who united to suppress the late rebellion."

What can aid more to assure this result than by cherishing tenderly the memory of our heroic dead, who made their breasts a barricade between our country and its foes?

Their soldier lives were the reveille of freedom to a race in chains, and their deaths the tattoo of rebellious tyranny in arms.

We should guard their graves with sacred vigilance. All that the consecrated wealth and taste of the nation can add to their adornment and security is but a fitting tribute to the memory of her slain defenders.

Let no wanton foot tread rudely on such hallowed grounds. Let pleasant paths invite the coming and going of reverent visitors and fond mourners. Let no vandalism of avarice or neglect, no ravages of time testify to the present or to the coming generations that we have forgotten as a people the cost of a free and undivided republic.

If other eyes grow dull and other hands slack, and other hearts cold in the solemn trust, ours shall keep it well as long as the light and warmth of life remain to us.

Let us, then, at the appointed time, gather about their sacred remains, and garland the passionless mounds above them with the choicest flowers of springtime; let us raise above them the dear old flag they saved from dishonor; let us in this solemn presence renew our pledges to aid and assist those whom they have left among us, a sacred charge upon a nation's gratitude—the soldier's and sailor's widow and orphan.

II. It is the purpose of the Commander-in-Chief to inaugurate this observance with the hope that it will be kept up from year to year while a survivor of the war remains to honor the memory of his departed comrades. He earnestly desires the public press to call attention to this order, and lend its friendly aid in bringing it to the notice of comrades in all parts of the country in time for simultaneous compliance herewith.

III. Department Commanders will use every effort to make this order effective.
