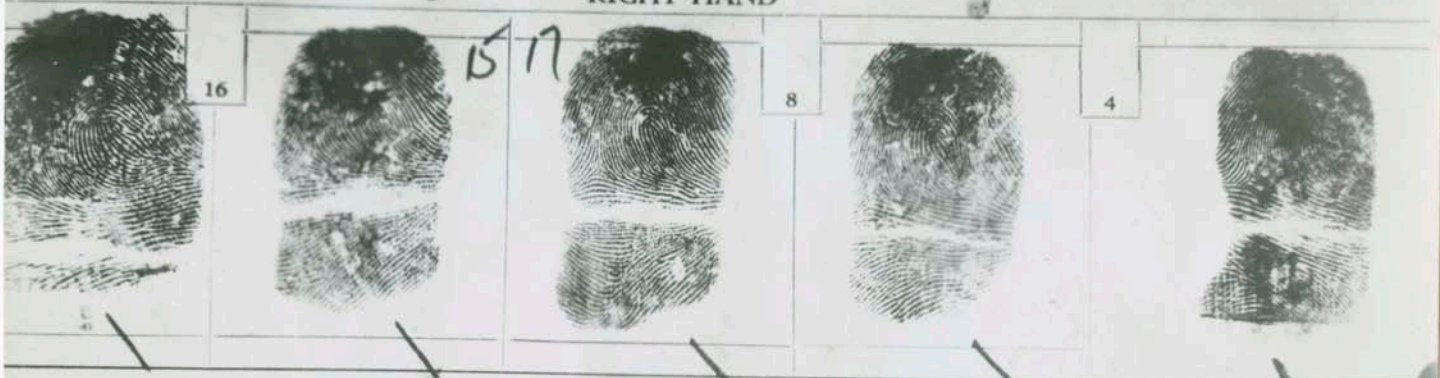

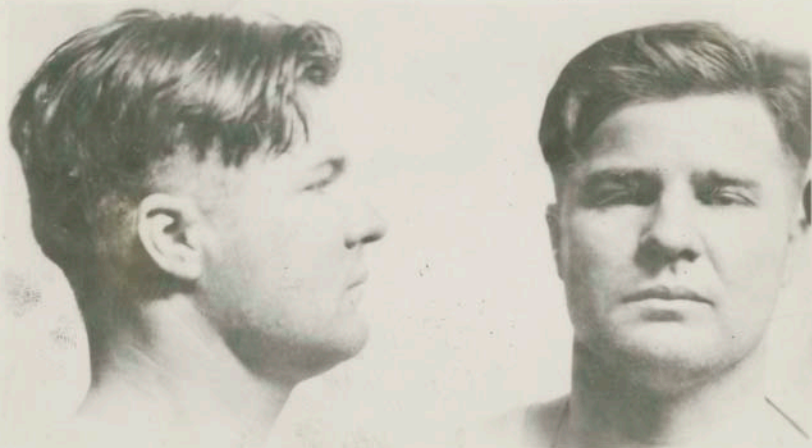

Bankers Rap New Deal at U. S. Session

Speakers Call Roosevelt Unfair, Condemn Recovery Measures.

Washington, Oct. 22.—(P)—Direct and frequently harsh criticism of administration recovery policies dominated the opening sessions of the annual convention of the American Bankers' association.

Speakers at the meeting condemned one of the most significant in the association's history, moreover, were often with a vigorous denial of the often repeated charge that the banks have refused to co-operate with the government and have retarded recovery by unduly restricting loans.

PURVIS LEADS MEN IN AMBUSH ON OHIO FARM

Desperado Goes Down, Gun in Hand, Fleeing Afoot From Hall of Bullets.

Companion Still Held In Jail to Face Kansas City Gang Massacre Charge.

East Liverpool, Ohio, Oct. 22.—(P)—The department of justice caught up with Charles (Pretty Boy) Floyd, violent criminal of the Ozarks, near here Monday, and he was killed in a hail of rifle, pistol and machine gun bullets.

Federal agents and police came upon the No. 1 public enemy at a farm seven miles north of here, fifty or more shots rang out as the officers halted the criminal's flight, and he fell mortally wounded, unable to use either of the two automatics he was carrying.

Fourteen bullets struck him, in the back, and another in the side. Quickly the officers, including four department of justice men and four East Liverpool policemen, rushed to his prostrate form.

Abs About Ribbent.

"Who the hell tipped you?" demanded the dying man as they approached him. Then he inquired, "Where is Eddie?" (apparently he referred to Adam Ribbent, captured Saturday near Wellsville, Ohio, when he and Floyd engaged other officers in a gun battle.) Just before he died, Floyd admitted his identity to Melvin Purvis,

MOTHER PREPARES GRAVE THAT FLOYD PICKED FOR SELF

Akins, Okla., Oct. 22.—(P)—There's a grave near this little village awaiting Charles (Pretty Boy) Floyd, the Oklahoma outlaw who was slain Monday near East Liverpool, Ohio. He picked it himself, and his mother, believing she never would see him alive again, has tended it carefully for more than a year.

"Right here is where you can put me," 35-year-old Mrs. W. F. Floyd said her son told her in May, 1933.

"I expect to go down soon with lead in me—perhaps the sooner the better," Floyd added.

head of the justice department's bureau of investigation in Chicago, Purvis immediately questioned Floyd concerning the machine gun massacre of five men at the Kansas City Union station in June, 1933, but to his dying breath, Floyd refused to admit participation in that crime.

"He wouldn't admit it," Purvis said.

Purvis had a few more words with Floyd, which the federal agent did not reveal.

Floyd died about 15 minutes after he was shot. Officers were carrying him to a nearby road where they had an automobile waiting to take him to a hospital when he passed away.

Ignores Order to Halt.

When the officers came upon Pretty Boy he was talking to S. L. Dyke, a farm hand employed by Mrs. Ellen Conkle, endeavoring to persuade him to take him to Youngstown.

As the officers approached, Floyd hid under a corncrib but changed his mind at the last minute and started running for an automobile. Then he turned and ran across a pasture toward a wooded ridge. Purvis commanded him to halt, but Floyd paid no heed.

The officers fired a volley, Floyd

continued to run, however, until additional bullets felled him.

Witness Tells Story.

Dyke described the shooting as follows:

"I told Floyd I would not take him to Youngstown tonight, but I promised to take him to Clarkson, a nearby village.

"I backed up the car. Floyd was in the rear seat. Mrs. Dykes was in the front seat with me. I saw the two automobile loads of officers before Floyd saw them and wondered who they were. When Floyd saw them his face paled and he ordered me to drive back of the corn crib. First he fell on his face, rolled over on his back, and then on his stomach. He got up on his knees and then fell down again.

Dying, He's Handcuffed.

"When he was about 500 feet away, the officers started shooting. First he fell on his face, rolled over on his back, and then on his stomach. He got up on his knees and then fell down again.

"By that time the officers reached him and put handcuffs on him."

Later Floyd's body was brought to a mortuary here.

The body had hardly arrived before a crowd of 500 gathered, much as another crowd formed a few months ago when Purvis led the raid that ended in the death of John Dillinger at Chicago.

Floyd had only \$120 in his pockets when he died. The magazines of the two automatic pistols he was carrying were fully loaded.

Farmer Calls Federal Men.

Floyd had appeared at the farm Monday afternoon, where he was seen by Arthur Conkle. Previously warned, as were all farmers in that section, to be on the lookout for

'PRETTY BOY' NAMED FOR 'SLICK' HAIR COMB

Oklahoma City, Oct. 22.—(AP)—Here's how Charles Arthur Floyd, came by the sobriquet of "Pretty Boy" as told in his native eastern Oklahoma hills.

After beginning his career of outlawry in St. Louis, Floyd returned to Salisaw, where the hill folk, impressed by his pocket comb and careful pompadour—"slick as axle grease"—dubbed him "Pretty Boy."

strangers, Conkle notified the department of justice men.

They raced to the Conkle farm, followed by the four East Liverpool policemen. The shooting began quickly.

At noon Floyd had asked Mrs. Alma Conkle to cook a dinner for him. She prepared the meal while the desperado questioned her about newspaper stories she had read.

Fire at Short Range.

After the meal Floyd asked Mrs. Conkle if she could arrange to get him an automobile ride to Youngstown. She said he would have to wait for the men to return from work in the fields.

Floyd was only about 200 feet away from the officers when the burst of gunfire brought him down. The first shots that struck him apparently produced a numbness for, although he was hit at least eight times, one of his dying statements was, "You got me twice."

The trail of the outlaw was picked up in Ohio Saturday when a man residing near Wellsville, Ohio,

reported to police there that he saw two suspicious characters in a ravine near his home.

When officers investigated they were greeted with bullets. Police then organized a posse, and a general gunfight ensued in which a posse member and a policeman were wounded.

One of the suspects was arrested and identified as Richetti, but it was not until much later that police learned the other man was Floyd.

Kidnaps Motorist.

While Richetti was being captured, Floyd kidnaped James H. Baum, 65, a florist, and forced him to drive him away in Baum's automobile. The officers, however, overtook Baum's car. Floyd ordered Baum to jump out and then fled to a nearby woods while the officers fired at him. One of the shots wounded Baum.

Floyd was not reported seen again until he appeared at the Conkle farm Monday.

Richetti in his cell refused to believe officers Monday night when they told him Floyd had been killed, until he was shown accounts of the death in a newspaper.

"I don't see why he stuck around so long," Richetti said.

Richetti told officers he would resist any attempt to extradite him to Missouri to face a murder charge in the Kansas City massacre.

"I want a lawyer," he said.

Wellsville officials said the prosecutor of Columbiana county, where Richetti was arrested and, Floyd was killed, would confer with authorities from Kansas City Tuesday to arrange details for returning Richetti to Missouri.

The trail of crime which Floyd blazed across the country started in St. Louis in 1925 when he was given a sentence of five years for highway robbery.

Pal Executed.

In 1930 he showed up in Akron, Ohio, and was arrested for questioning in connection with the killing of a policeman. Bert Walker was arrested with Floyd and went to the electric chair.

Officials could not find sufficient evidence to bring Floyd to trial and turned him over to thesylvania, Ohio, police for bank robbery. After escaping jail and being recaptured, Floyd was sentenced to from 10 to 25 years in the Ohio penitentiary.

He escaped that term by jumping from a window of the train which was taking him to Columbus.

At Bowling Green some time later, officers recognized him, but Floyd shot his way out, killing Patrolman Ralph Castner. Floyd then returned to the familiar Ozarks and in April, 1932, he shot his way out of another police ambush, killing Erv Kelly, a veteran peace officer.

Kills Six Policemen.

At least seven murders were attributed to his gun and six of them were policemen. His favorite hideouts were in the mountains of western Arkansas and eastern Oklahoma and in the Seminole oil fields.

Purvis Monday night issued the following statement:

"The killing of Floyd brings to a close the relentless search on the part of the department of justice.

"The search was directed by J. Edgar Hoover from Washington and I have been in constant contact with him.

"Mr. Hoover and all the special

agents were particularly interested in Floyd because he killed one of our men in the Kansas City massacre of June 17, 1933."

Police Monday night continued to hold Richetti under close guard in the Wellsville town jail, but after refusal all day to turn him over to federal officers, armed with a murder warrant, it was said he would be surrendered to them Tuesday.

With Richetti in jail, the death of Floyd came only a few hours after a federal grand jury in Kansas City began delving into the Union station massacre in which both were accused.

The third man named in the government as having participated in that mass murder of four officers and a convict was Verne C. Miller, who months ago was slain by gangsters near Detroit.

Police said Monday night they had received a wire from Mrs. Walter Floyd, mother of the bandit, in Sallisaw, Okla. The wire said:

"I am the mother of Charles Floyd. If he has been killed, turn the body over to a reliable undertaker and prevent any pictures being taken of him and bar the public. Pass this request to the United States department of justice. Hold body until I arrive."

RICHETTI NAMED IN MURDER WARRANT

Columbia, Mo., Oct. 22.—(P)—Prosecuting Attorney W. H. Sapp Monday issued a first degree murder warrant against Adam Richetti for the slaying here in June, 1933, of Sheriff Roger Wilson and Sergeant Ben Booth of the Missouri state highway patrol.

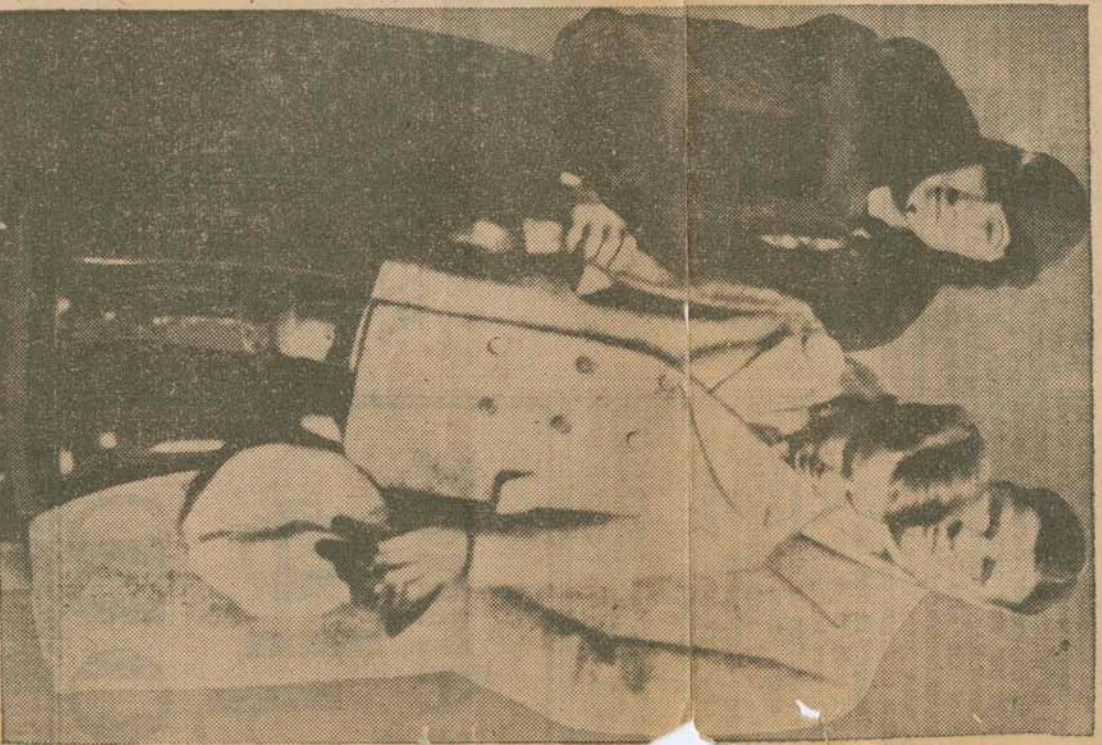
Richetti is under arrest at Wellsville, Ohio, where he was captured Saturday.

Sapp said the warrant had been sworn out on information furnished him by the state highway patrol.

He said an immediate effort would be made to return Richetti here for trial.

Sheriff Wilson and Sergeant Booth were shot down at a highway intersection here as they attempted to stop a car suspected to contain holdup men escaping from a Mexico, Mo., bank robbery.

Floyd's Son, 9, Sheds No Tears at Father's Death.

Bixby, Okla., Oct. 22.—(A)—Waiting for his mother to come from Okmulgee, where she has been attending a sick friend, 9-year-old Jack Dempsey Floyd Monday night worked at a crossword puzzle while his grandparents talked in subdued tones of the death of his father, Charles A. Floyd, slain outlaw.

For six weeks the boy has been a pupil at the Central Consolidated school at Bixby. His teachers reported him exceptionally bright, and making good grades.

Monday night his play was as subdued as the voices of his grandparents, Mr. and Mrs. Ben Hargreaves, tenant farmers, but he had not wept.

The mother, Mrs. Ruby Floyd, divorced wife of the outlaw, took him to the farm home in September after they had appeared in various small vaudeville houses of the southwest, portraying a story based on the life of Floyd and telling the story that "Crime Does Not Pay."

Floyd Killed After a Meal 'Fit for King'

East Liverpool, Ohio, Oct. 22.—(A) —Mrs. Ellen Conkle made Charles (Pretty Boy) Floyd's last hour on earth a little more pleasant with a meal that Floyd himself described as "fit for a king."

Mrs. Conkle lives at the farm home where Floyd made his last stand Monday. She cooked his last meal for him and it consisted of potatoes, spare ribs, rice, pumpkin pie, doughnuts and coffee.

Floyd paid her a dollar for it and said the meal was "well worth it."

His white shirt dirty and open at the neck, his hair mussed, Floyd turned up at the Conkle home at about 3 p. m., about an hour before federal agents and police arrived.

Floyd told Mrs. Conkle he had been hunting squirrels and was lost. Mrs. Conkle said she did not believe him, and asked if he had hunted squirrels Sunday night.

"To tell the truth, lady," Floyd answered. "I was out with my brother and were drunk. My brother left me and I got lost."

"I'd like something to eat. I'm hungry and I'll pay for it."

Floyd washed his hands, sat down and asked for a newspaper. After eating Floyd asked Mrs. Conkle to drive him to a highway several miles away where he expected to find "his brother."

Mrs. Conkle told him to wait until her brother returned from husking corn. Floyd then climbed into the automobile beside the corn crib and waited.

His last remark to Mrs. Conkle was: "I look like a wild man, don't I?"

A few minutes later he was mortally wounded by police and federal agents.

Bankers Breathe Easier as Dillinger, Floyd Fall

Chicago, Oct. 22.—(A) —Bankers of the midwest breathed a lot easier Monday night.

Three months ago this night John Dillinger was slain here. Monday Charles (Pretty Boy) Floyd was a victim of federal guns.

Thus in 90 days bank robbers who roved the midwest fell—their gangs either preceding the leaders in brushes with the law, or dwindling into nothingness.

The death of the Indiana outlaw spelled finis to his band of vicious gunmen, who under their notorious leader looted banks of Ohio, Indiana, Illinois, Wisconsin, Iowa, Minnesota and South Dakota of \$500,000.

And in the interim since Dillinger's demise July 22 bank holdups have been fewer and the loot insignificant.

Melvin Passolt, chief of the Minnesota crime bureau, citing the fact that there had been only four bank raids in his state this year compared with 24 at this time last year, said the dethroning of the Dillinger mob was a big factor in the decrease.

On September 26, 1933, Dillinger engineered the escape of 10 prison

pals from the Indiana prison at Michigan City. They in turn raided the jail at Lima, Ohio, released Dillinger and killed Sheriff Jess Sarber.

Almost at once the gang started robbing and plundering, attacking banks in which there were large sums and shooting anyone who got in the way.

Since Dillinger and several of his chief aids have been slain or executed and the few still at large have gone into hiding, most of the robberies in the states through which the mob formerly roamed have been perpetrated by novices.

Records of the Bankers' Association of Indiana, Dillinger's native state, showed that from June 8, 1933, through June 30, 1934, there were 23 holdups with a total loss of \$125,991. From July 1 to September 20 there were only four holdups with a total loss of \$8,540.

During the Dillinger activity Wisconsin had 12 holdups, two of which, supposedly by his gang, netted the invaders \$39,000 in cash and \$25,000 in securities. Since he was slain there have been nine holdups and burglaries, in each of which only a small amount was taken.

Floyd Termed First Machine Gun Bandit

Oklahoma City, Oct. 22.—(A) —Charles "Pretty Boy" Floyd, Oklahoman slain Monday in Ohio introduced the machine gun to prominence in his bank raids. He was regarded generally as the first outlaw to use the machine gun extensively, and at one time had a machine gun mounted permanently in a speedy automobile.
