

CRIMINAL RECORD

As Harry Sandovich alias Harry J. Porche, #16479, arrested Police Department Minneapolis, Minnesota, September 11, 1918; charge, attempted grand larceny; fined, \$100.00.

As Harry J. Porche, #6463, arrested Police Department, Omaha, Nebraska, January 2, 1920; charge, investigation robbery; turned over to Lincoln, Nebraska.

As Harry Sandlovich, #241, arrested Police Department, Lincoln, Nebraska, May 16, 1920; charge, jumping bond - auto theft; forfeited \$1,000.00 bond.

Notation unsupported by fingerprints:

As Harry Sandlovitch pleaded guilty District Court, Lincoln, Nebraska, April 25, 1915; charge burglary with explosives; paroled from bench, 2 years; dismissed from parole, September 25, 1927.

Harry Sawyer is wanted for the kidnaping of Edward G. Bremer at St. Paul, Minnesota, on January 17, 1934. An indictment was returned by the Federal Grand Jury at St. Paul, Minnesota, January 22, 1935 charging Harry Sawyer and others with the kidnaping.



Sawyer and Weaver Going to Leavenworth

Harry Sawyer, former St. Paul bootlegger, and William Weaver of Little Rock, Ark., ex-convict, both convicted in St. Paul of participation in a conspiracy to kidnap Edward G. Bremer, St. Paul banker, for \$200,000 ransom, will go to Leavenworth penitentiary, it appeared Saturday. S. J. Picha, chief. deputy U. S. marshal, said Leavenworth is used as a "clearing house" from which prisoners are sent to the institutions where they will be permanently confined. At Washington it was said prisoners are never sent directly to Alcatraz penitentiary in San Francisco bay, but are taken there from other institutions.
