## Requirements for Vendors

1. Registered Vendors must sell only what they grow and/or list origin of products with sign and price.
2. Vendors are required to register with the Chamber. The Mosinee Area Chamber of Commerce, Inc., and the Mosinee City & Police Department will regulate this.
3. Vendors must be approved by the Chamber & have a business sign with name & address listed.
4. At the end of each Farmers Market, Vendors must clean the area & remove trash.
5. By signing this registration form, you acknowledge that you are not protected under the liability insurance of the City of Mosinee, or The Mosinee Area Chamber of Commerce, Inc.
6. Vendors selling prepared food items must provide a copy of their license and seller's permit.

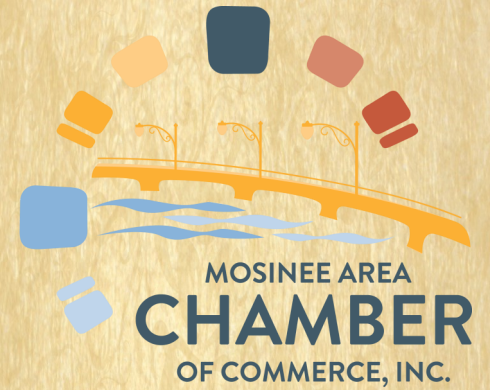
