COMMON NIL RISKS EVERY PARENT SHOULD KNOW

The excitement around NIL can sometimes overshadow potential pitfalls. Being aware of these common risks is your first line of defense in protecting your child's future.

Predatory Contracts and Unfair Deals:

- What it is: These are agreements that look appealing on the surface but contain hidden clauses, vague terms, or disproportionate demands. They might ask for lifetime rights to your child's image, require them to post inappropriate or misaligned content, or include unfavorable revenue splits. Be wary of deals that offer upfront cash without clear expectations or ask for exclusivity without significant compensation.
- Red Flags to Watch For:
 - "We'll just take a percentage of whatever you make." (Often too high, vague on services provided).
 - Demands for exclusive rights to your child's NIL for an extended period.
 - Lack of transparency on payment schedules or deliverables.
 - Promises of large sums of money without clear justification or a detailed proposal.
 - Pressure to sign quickly without allowing for legal review.
- Why it's Dangerous: Such contracts can limit future opportunities, legally bind your child to unfavorable terms, and even expose them to financial or reputational harm.

COMMON NIL RISKS EVERY PARENT SHOULD KNOW

• Eligibility Violations & Compliance Issues:

- What it is: Each state high school athletic association, and the NCAA for college-bound athletes, has specific rules regarding NIL. Violating these rules-knowingly or unknowingly-can lead to severe consequences, such as being banned from school sports, losing athletic scholarships, or even impacting future college eligibility.
- Why it's Dangerous: Even minor infractions can derail an athlete's career and academic future. Rules often cover what activities are allowed, how compensation can be received, and prohibitions on using school logos/uniforms in deals.
- **Example:** Accepting payment for an endorsement that promotes a product banned by your state's high school athletic association, or using your school's mascot in an advertisement without explicit permission.

• Unreported Income & Unexpected Tax Trouble:

- What it is: Any income earned through NIL-no matter how small-is generally taxable. Many parents and young athletes are unaware of this. Failure to report NIL income can lead to penalties, fines, and surprise tax bills from the IRS or state tax authorities.
- Why it's Dangerous: This can create significant financial strain, negatively impact credit, and lead to legal issues down the road. It's crucial to understand that even non-cash compensation (like free products) can be considered taxable income.
- Example: Receiving a free pair of shoes from a brand in exchange for a social media post, which might be considered taxable income if its value exceeds a certain threshold.



COMMON NIL RISKS EVERY PARENT SHOULD KNOW

• Social Media Exploitation & Reputational Damage:

- What it is: The digital world is powerful, but it also carries risks. This includes brands pushing students to post inappropriate, controversial, or misaligned content that could damage their personal brand or violate school values. It also involves "agents" or scouts contacting athletes directly through DMs without verified identities or legitimate intentions.
- Why it's Dangerous: What goes online, stays online. A single misstep can lead to reputational damage that impacts college recruitment, future NIL opportunities, and even career prospects. Predatory individuals can also use social media to gain inappropriate access or exploit young athletes.
- **Example:** Being pressured to post a photo wearing a controversial brand, or engaging with an unknown 'scout' who asks for personal information or inappropriate content.

WHAT PARENTS CAN DO TO PROTECT THEIR ATHLETE

Your active involvement is the single greatest safeguard for your child in the NIL era. Here are key actions you can take:

Start With Your School's NIL Policy and State Rules:

- Action: Contact your Athletic Director to understand [Your School Name]'s specific guidelines regarding NIL. Ask if the school has an NIL Advisory Board or designated resources. WHAT PARENTS CAN DO TO PROTECT THEIR ATHLETE

Ask About Every Deal – Get Everything in Writing:

- Action: If your child is approached about a NIL opportunity, ask questions. Lots of them. Demand to see any and all contracts or agreements in writing. Do not rely on verbal promises. Key questions include: Who is paying? For what specific service or content? How long is the agreement for? How is my child protected? What are the deliverables? Are there termination clauses?
- Benefit: A written contract protects both parties by clarifying expectations, compensation, and legal terms. It is essential for safeguarding your child's rights and ensuring fair treatment.

Understand the "True Cost" of NIL:

- Action: Beyond just the dollar amount, evaluate the hidden costs or impacts of a NIL deal. Will this deal demand too much time, affecting academics, training, or family time? Does it genuinely reflect your child's character and values, or is it just for money? Could it negatively impact their recruiting process if a college dislikes the association? Is this worth it long term for their overall well-being and future?
- **Benefit:** This holistic evaluation ensures that NIL opportunities contribute positively to your child's life and future, rather than becoming a distraction or a detriment.

WHAT PARENTS CAN DO TO PROTECT THEIR ATHLETE

- Get Financial & Legal Guidance Early:
 - Action: Don't wait until a large deal comes along. Connect with trusted professionals for advice. Ask your Athletic Director or coaches if they offer workshops on budgeting, taxes, or entrepreneurship. For any earnings, even seemingly small ones (e.g., over \$600/year), consult a qualified financial advisor and tax professional. For contracts, seek review from a sports or entertainment attorney.
 - Benefit: Professional guidance protects your child from legal and financial missteps, ensures proper tax compliance, and helps them make smart decisions about managing and investing any NIL income for long-term security.

HOW TO BE AN ADVOCATE, NOT JUST AN OBSERVER

Attend School NIL Education Sessions (or Request One):

- Don't Chase NIL Deals. Help Your Child Build Value First:
 - Action: Resist the temptation to aggressively pursue every potential deal. Instead, focus on helping your child excel in their sport, maintain strong academics, develop their character, and build a positive, authentic personal brand.
 - **Benefit:** When your child builds genuine value, influence, and a strong reputation, the meaningful opportunities will come naturally, and they will be better prepared to handle them.

5 QUESTIONS PARENTS SHOULD ASK BEFORE SIGNING ANYTHING

Before your child signs any NIL agreement, take a pause. Discuss these critical questions as a family, and if necessary, with legal counsel.

1. Is this legal under our school and state rules?

Why this matters: High school NIL rules vary by state and can be strict.
 Violating them could impact your child's eligibility for school sports or future college scholarships. Always verify.

2. What exactly is my child being asked to do, and is it appropriate?

 Why this matters: Understand the specific deliverables (e.g., number of posts, appearances, content creation). Ensure the activities align with your child's values, age, and comfort level, and will not negatively impact their reputation or time commitment.

3. Who owns the content being created, and how can it be used?

 Why this matters: Some contracts may seek broad ownership of content, limiting your child's ability to use their own image or likeness in the future. Ensure you understand the terms of usage and duration.

4. Are we being paid fairly - and when?

 Why this matters: Compensation should be clearly defined (e.g., flat fee, per-post, royalties). Understand the payment schedule and what happens if deliverables are not met. Research market rates for similar deals to assess fairness.

5. Do we have this in writing, and have we had it reviewed by a lawyer?

 Why this matters: Verbal agreements are unreliable. A written contract protects everyone. More importantly, have an independent attorney specializing in sports or entertainment law review any contract before signing, to ensure all terms are fair and understood.

BONUS: THE 3 C'S OF NIL PARENTING

These principles will serve as your compass in the NIL journey:

- Clarity: Know what NIL means, what it doesn't mean, and precisely what's allowed (and not allowed) by your school and state athletic association. Seek out clear information.
- Communication: Maintain open and regular dialogue with your child about their NIL goals, online activities, and any opportunities or concerns. Also, communicate openly with your Athletic Director and coaches.
- Consistency: Be the calm, guiding voice amid external hype, pressure, and social media influence. Consistently reinforce your family's values and your child's longterm well-being above short-term gains.
