# Agreements for the Sacred Dream Alchemy Portal

By enrolling in this program, you agree to the following:

#### 1. Process & Energetic Agreements

- You will show up earnestly and share insights and expansion experiences, as well as any struggles and blockages, so we can integrate them into the work.
- Soul-Work is non-negotiable and while not meant to be overwhelming, this means that you agree to engage with the Soul-Work assignments, which will be in your personal shared folder (see your inbox!)
- You will track your dreams and send any that arise between sessions (you will receive a link to the form where to submit your dreams).
- You understand that the truths revealed will challenge your ego. This is expected and welcome it's how we identify where ego protection is operating. *You agree to meet this challenge in partnership with me rather than avoiding it.*

#### 2. Container Structure & Boundaries

- The 6-session container must be completed within 4 months of signing up to maintain momentum and potency.
- Between sessions: You are strongly encouraged to send dreams as they come.
  This helps me connect with their meanings, which we will explore together in the live sessions.

- Cancellations made less than 24 hours before your scheduled session will count as a used session, and may not be rescheduled. This helps maintain the energetic integrity of the container and honors both of our time.
- Single (drop-in) sessions are available only as a preparation for the 3-month container or as check-ins for past clients.

#### 3. Core Modalities of the Journey

- Each cycle includes 2 guided journeys, in sessions 3 and 5.
- Each cycle includes archetype readings for deep guidance and symbolic insight.
- Dreamwork is a continuous thread, guiding and shaping the work.
- There are nervous system expansion processes to be practiced regularly in between sessions — designed to help you hold more emotional and energetic capacity.

#### 4. Payment Terms & Refund Policy

- Payment is non-refundable once the portal is entered, whether in full or through a payment plan. This includes all circumstances (change of mind, scheduling conflicts, etc.).
- If you are on a payment plan, you agree to complete all installments in full. This commitment reflects the energetic container we're co-creating.
- By enrolling, you are committing to the full energetic and financial container.
  Payment plans are not pay-as-you-go; they are a mutual agreement to honor the full journey.
- If some extreme circumstances arise, please communicate with me. I will do my best to work with you within my availability and integrity.

#### 7. Session Rescheduling & Completion

- You may reschedule a session with at least 24 hours' notice.
- All 6 sessions must be completed within 4 months of your start date. Unused sessions after that time are forfeited unless otherwise agreed.
