It is your responsibility to make sure the NAICS codes you are certified in are kept up to date. If you wish to become certified in an additional type of work, submit a [NAICS Expansion Application](#) available on the [Small Business Certification and Contract Management System](#).

Your firm's next Annual Update is due: May 31, 2026.

Your firm's 3-Year Review is due: May 31, 2026.

*****If you are ONLY certified as an Interstate DBE, you do not need to submit a 3-Year Review. Submit an Annual Update every year.***

To notify DSBO of any changes to your firm's legal structure, ownership, management, or control, within thirty (30) days of such change, submit a Material Change Application available on the [Small Business Certification and Contract Management System](#).

It is your responsibility to make sure that you keep your contact information up to date, maintain your certifications, and comply with all applicable rules and regulations.
