The City and County of Denver's Division of Small Business Opportunity (DSBO) has reviewed your Annual Update/3-Year Review and is pleased to inform you that McBride Lighting, Inc. NAICS 238210: LOW VOLTAGE ELECTRICAL WORK

NAICS 238210: SURVEILLANCE SYSTEM, INSTALLATION ONLY

NAICS 238990: SIGN (EXCEPT ON HIGHWAYS, STREETS, BRIDGES AND TUNNELS) ERECTION

It is your responsibility to make sure the NAICS codes you are certified in are kept up to date. If you wish to become certified in an additional type of work, submit a <u>NAICS Expansion Application</u> available on the <u>Small Business Certification and Contract Management System</u>.

Your firm's next Annual Update is due: May 31, 2026.

Your firm's 3-Year Review is due: May 31, 2026.

To notify DSBO of any changes to your firm's legal structure, ownership, management, or control, within thirty (30) days of such change, submit a Material Change Application available on the Small Business Certification and Contract Management System.

If you are also ACDBE/DBE certified through DSBO, you do not need to complete a separate Annual Update or 3-Year Review for your ACDBE/DBE certification.

It is your responsibility to make sure that you keep your contact information up to date, maintain your certifications, and comply with all applicable rules and regulations.
