Elections are conducted transparently and in full compliance with our Articles of Association. In terms of internal management, IAPORTS' structure includes an Executive Director, a Chief Financial Officer (CFO), and a dedicated Membership Experience area, ensuring operational efficiency and a strong focus on serving our members.

#### Our roles

The association aims to:

- (a) Work on strategic agendas to increase the competitiveness of the port sector in the global market.
- (b) Build a reputation for international excellence by participating in prominent events and promoting cooperation with global organizations.
- (c) Support the development of world-class port leaders by offering educational and exchange programs.





# Membership fees

IAPORTS has established a transparent fee structure based on the total number of employees per organization, ensuring fairness and accessibility across our diverse membership base. Membership fees are paid annually and are renewed during the next membership season.

The membership season runs from September of each year until February of the following year, when existing members are invited to renew their participation. Fees listed for this cycle are valid for the 2026 membership year and cover all activities scheduled and confirmed from January 1 to December 31, 2026.

Members who complete payment in advance and join from September 1, 2025 will enjoy full access to all IAPORTS activities still taking place in 2025, allowing them to participate in the remaining events and initiatives of the year as official members.

Payments can be made via wire transfer, deposit or PIX, or credit card—ensuring convenience and flexibility for all members.
