

MyKneeLife Privacy Policy

Introduction

In order to use the MyKneeLife mobile application ("App"), you must first acknowledge and agree to our Privacy Policy. You cannot use the App without first accepting this Privacy Policy.

General

We provide the MyKneeLife Application. We ("Individual," "us," "we," or "our") recognize and understand the importance of your privacy and are committed to protecting the personal information of our users ("User," "you," or "your"). This Privacy Policy describes how we manage, store, and utilize your Personal Data within the MyKneeLife app.

To use our app, you must consent to the collection and processing of your Personal Data as described herein. If you do not agree with the terms of this Privacy Policy, you may not use the app.

We are committed to maintaining a secure, user-controlled environment that protects your personal data.

Personal Data You Provide

Account Credentials

To use the MyKneeLife App, you log in via third-party authentication providers such as Facebook or Google. MyKneeLife stores a hashed version of your account authentication token for verification purposes.

Profile Information

When you create an account, you may provide Personal Data such as your name, email address, and other information necessary to verify your identity.

Photos, Videos, and Audio

If you choose to upload media, the App will request access to your device's camera, microphone, and photo library. This allows you to share photos, videos, and audio clips within the App.

Feedback / Support

When you contact support, we may collect information such as your name, email, IP address, phone model, and any message content to assist in resolving your issue.

Permissions Required

To function properly, the App may request the following permissions:

- INTERNET
 - NOTIFICATIONS
 - CAMERA
 - STORAGE

Log Data

If the App encounters an error, we collect “Log Data” via third-party tools. This may include your device’s IP address, OS version, app configuration, time and date of use, and other diagnostic information.

Your Personal Data (Use)

We use your name and email address solely to manage your account, send transactional emails, and offer app-related updates. We do **not** share or sell your personal information to third parties outside the use cases described here.

Security

We value your trust in providing your Personal Data and use commercially acceptable means to protect it. However, no method of transmission or electronic storage is completely secure, and we cannot guarantee absolute security.

General Data Protection Regulation (GDPR)

We are a Data Controller of your personal data. Our legal bases for processing personal information include:

- Performing our contract with you
- Your consent
- Our legitimate business interests
- Compliance with legal obligations

We retain personal data only as long as necessary to fulfill the purposes outlined in this Privacy Policy or to comply with legal obligations.

If you are a resident of the European Economic Area (EEA), you have the right to:

- **Access** your personal data
- **Rectify** inaccurate or incomplete data
- **Erase** your data in certain circumstances
- **Object** to processing under specific conditions
- **Port** your data in a structured, commonly used, machine-readable format
