- Paid participation at Local/State Levels
- Fees must include official tiara/crown and sash
- No substitutions for official tiara, crown or sash are allowed
- Local/State organizations are considered chapters of the national organization

PLEASE NOTE - Local/State organizations may not use the word PRINCESS in any manner including sashes, marketing, recruiting, printed materials, digital offerings, social media posts, etc. In addition, the locals and states MAY NOT hold a scored competition of any kind with the 'Little Sister' program.

Official logo may only be used on signage, marketing materials, website, or social media for the purposes of advertisement, awareness, and recruiting, and may not be used on any merchandise. The official logo may not be altered in any manner as to color, font, 'surrounding elements', or addition of a crown.







Cover photos may be your choice of graphic or photo. Profile photo should be background of Pink hex code #E2188F with white text in Konnect Bold.

You may use the tiara or crown on your merchandise. Shirt colors should consist of one of the four colors above with logos in either gold, white, pink, or black. States names should be in Konnect Extra Bold, Local names in Konnect Bold, and the chapter title name (EX: Magnolia Belles, etc.) should be in Konnect Light.
