AMENDED ORDER FOR SERVICE BY PUBLICATION

It appearing to the Court from the allegations in the Petition, that ordinary service of process cannot be obtained. The Department has filed a Motion for Service by Publication and the Affidavit of Diligent Search that details personal attempts of service of process. The Department has indicated that the whereabouts of Respondent, Juan Manuel Rodriguez Chavez, father, is unknown and cannot be ascertained by diligent search, and therefore, the ordinary process of law cannot be served upon the Respondent.

It is, therefore, ORDERED that said Respondent be served by publication with the following notice to be inserted in each publication one (1) time per week for four (4) consecutive weeks. Publication shall run in both a physical newspaper of general circulation in the county in which the Respondent was last known to reside and a secondary news Web site in the county in which the notice was published. Publication shall also run in the Country of Mexico.

It is further ORDERED that if the Respondent does not enter an appearance or otherwise answer the Petition, further personal service or service by further publication shall be dispensed with and service of any future notices, motions, orders or other legal documents in this matter may be made upon the Respondent by filing same with the Juvenile Court Clerk of Robertson County, Tennessee.

NOTICE TO RESPONDENT, JUAN MANUEL RODRIGUEZ CHAVEZ

The State of Tennessee, Department of Children's Services, has filed a Petition alleging that the custodian committed acts or failed to take actions that cause the children, KENYA SAMANTHA REYES ANJEL, DOB: 05/22/2014; MAYCON JUNIOR ESCALANTE ANGEL, DOB: 04/21/2010; AITANA CAMILA RODRIGUEZ ANGEL, DOB: 09/06/2019; and ESTEFANIA RODRIGUEZ ANGEL, DOB: 05/25/2022, to be Severely Abused, Abused and Dependent and Neglected as defined by T.C.A.§ 37-1-102 (b)(27), T.C.A.§ 37-1-102 (b)(1), and T.C.A.§ 37-1-102 (b)(12) etc., and that disposition of the minor children should be with a 3rd party and/or State Custody. It appears that ordinary process of law cannot be served upon you because your whereabouts are unknown or you are avoiding service of process. You are hereby ORDERED to appear in the Juvenile Court of Robertson County, 529 South Brown Street, Springfield, TN 37172, within 30 days of this Notice to personally answer the Petition. Failing to appear or filing an answer, without good cause, pursuant to the Rules of Juvenile Procedure and the Rules of Civil Procedure will result in the loss of your right to contest the Petition. This is an order by the Magistrate. A Party may, within ten (10) judicial days of the entry date on which the Magistrate's FINAL Order, file with the Court a written request for a review of the record by the Juvenile Court Judge. The request must include written exceptions to the Magistrate's findings, conclusions or recommendations, and specify the findings to which the party objects, the grounds for the objection and the party's proposed findings, conclusions or recommendations. No review will be granted if the requesting party did not participate in the hearing before the Magistrate in good faith. If no review before the

Judge is requested, or a review is expressly waived by all parties within the specified time period, then the Magistrate's order becomes the final order of the Court. A party may appeal the final order pursuant to T.C.A. § 37-1-159. Any appeal for a de novo hearing to Circuit Court must be filed with the Juvenile Court Clerk's Office within ten (10) days of the entry of the FINAL Order.
