Directions For Use:

In Feed: Administer at a rate of 250 - 500 grams per ton of complete feed

In Water: Administer at a rate of 25 grams per 100 liters of drinking water

Ingredients:

Dried *Lactobacillus acidophilus* fermentation product, dried *Lactobacillus plantarum* fermentation product, dried *Bifidobacterium bifidum* fermentation product, dried *Bacillus subtilis* fermentation extracts, dried *Aspergillus oryzae* fermentation extracts, lactose

Appearance & Odor:

White to off-white, free-flowing powder with little to no odor; readily soluble in water.

Packaging:

500 g pouches, 1 kg pouches, 10 kg boxes, 10 kg pails, 25 kg kraft bags

Safety:

All ingredients are Generally Recognized As Safe by the United States Food and Drug Administration. There are no adverse effect, interactions or contraindications with the product. No withdrawal time is required.

Storage & Shelf Life:
