#### **Directions For Use:**

For poultry: administer at the rate of 0.25 – 0.50 ml/liter of drinking water for five (5) consecutive days. For cattle: administer at the rate of 3 – 5 ml/head/day.

#### **Ingredients:**

Sugercane molassas distillers solubles condensed (MOS), citric acid, phosphoric acid, lactic acid, propionic acid, artichoke extract, dried *Bacillus subtilis* extract, riboflavin supplement, pyridoxine hydrochloride, D-calcium pantothenate, thiamin hydrochloride, proplylene glycol, Dl-methionine, sorbitol, L-carnitine, distilled water

#### **Appearance & Odor:**

Natural colored, translucent liquid with little to no odor.

#### **Packaging:**

1 liter bottles, 6 bottles per case, 114 cases per pallet
