Directions For Use:

For poultry: administer at the rate of 0.25 – 0.50 ml/liter of drinking water for five (5) consecutive days. For cattle: administer at the rate of 3 – 5 ml/head/day.

Ingredients:

Sugercane molassas distillers solubles condensed (MOS), thiamin hydrochloride, riboflavin supplement, pyridoxine hydrochloride, D-calcium pantothenate, phosphoric acid, citric acid, lactic acid, propionic acid, artichoke extract, propylene glycol, distilled water

Appearance & Odor:

Natural colored, translucent liquid with little to no odor.

Packaging:

1 liter bottles, 6 bottles per case, 114 cases per pallet

Safety:
