



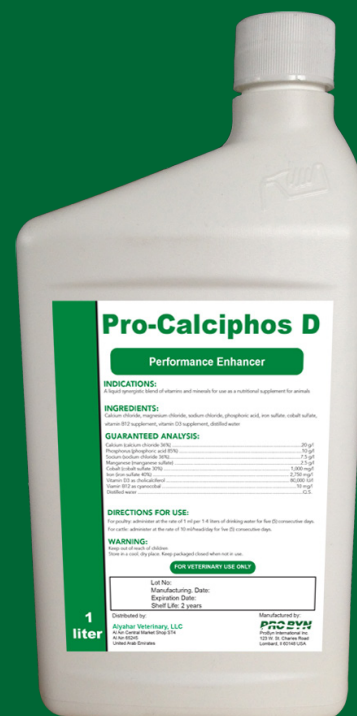

Phosphorus (phosphoric acid 85%)	10	g/l

Manganese (manganese sulfate)	2.5	g/l
Cobalt (cobalt sulfate 30%)	1,000	mg/l
Iron (iron sulfate 40%)	2,750	mg/l

Directions For Use:

For poultry: administer at the rate of 1.0 ml per 2-4 liters of drinking water for five (5) consecutive days. For cattle: administer at the rate of 10 ml/head/day for five (5) consecutive days.

Ingredients:

Calcium chloride, magnesium chloride, sodium chloride, phosphoric acid, iron sulfate, cobalt sulfate, vitamin B₁₂ supplement, vitamin D₃ supplement, distilled water

Appearance & Odor:

Natural colored, translucent liquid with little to no odor.

Packaging:

1 liter bottles, 6 bottles per case, 114 cases per pallet

Safety:

All ingredients are Generally Recognized As Safe by the United States Food and Drug Administration. There are no adverse effect, interactions or contraindications with the product. No withdrawal time is required.

Storage & Shelf Life:

Three (3) years from manufacture date; store in a cool, dry area. Keep container closed when not in use.
