## 1. General Terms

### 1.1 Eligibility:

All GatesFX clients are eligible for one (1) TradeLocker Deposit Bonus Account. Multiple bonus accounts per client are not permitted under any circumstances.

### 1.2 Unlimited Bonus Use:

While traders may only maintain one bonus account, the 100% Deposit Bonus feature is unlimited use.

- If the bonus is removed for any reason (including rule breaches), traders may transfer remaining funds back to their Wallet and then re-transfer into the account to receive a new credit.
- Additional deposits to the bonus account will also receive a 100% credit based on the amount transferred.

### 1.3 Bonus Amount:

The bonus credit will equal 100% of the amount transferred to the account, subject to the maximum credit cap.

#### Examples:

- If you transfer \$100, you receive a \$100 credit (total equity: \$200).
- If you transfer \$1,000, you receive a \$1,000 credit (total equity: \$2,000).

### 1.4 Credit Cap:

The maximum credit per bonus account is \$10,000. Any transferred amount exceeding \$10,000 will not be matched.

### 1.5 Account Type & Conditions:

- The 100% Deposit Bonus is available exclusively on TradeLocker, using ECN Raw conditions:
  - Raw Spreads
  - \$10 static commission per lot (round turn)
  - Execution speed: Ultra-low latency



## 2. Bonus Removal & Breach Rules

### 2.1 Equity Threshold Rule:

The bonus credit will be automatically removed if the account equity at any time falls below 120% of the initial deposit amount. All open positions will be closed upon bonus removal.

#### Example:

- If you deposit \$1,000 (and receive \$1,000 credit for \$2,000 total equity), the equity must remain above \$1,200 (120% of initial deposit).
- If equity drops below \$1,200, the bonus will be removed, and positions will be closed.

### 2.2 Purpose of the Rule:

This rule is in place to protect both the client and GatesFX from complete account loss, ensuring that:

- The trader does not lose their entire balance.
- Bonus funds provided by GatesFX are safeguarded.

#### Important:

The Bonus Account is designed for experienced traders seeking additional capital to scale accounts faster and maintain an edge. It is not intended for traders who disregard risk management, engage in overleveraging, or exhibit “full-port” gambling behavior.

### 2.3 Reapplying the Bonus:

- If the bonus is removed, the trader can reapply by transferring funds back into the account.
- If profits are withdrawn, the bonus will also be removed. Traders can reapply by re-transferring funds to the account.

#### Example:

- A trader deposits \$1,000 and earns profits, then withdraws \$500. The bonus is removed.
- The trader can transfer the remaining balance (or add new funds) back to the account and receive a new 100% credit.

## 3. Restrictions & Abuse Prevention

### 3.1 Prohibited Activities:

Use of HFT bots, arbitrage systems, latency exploitation, reverse hedging, or any other method deemed as abuse of the bonus system is strictly prohibited.

- Detection of such activity may result in immediate removal of the bonus credit without prior notice.
- Repeat violations may result in account suspension.

### 3.2 Bot Trading:

Automated trading systems, including EAs with high-frequency strategies, are not allowed on bonus accounts.

## 4. Bonus Conversion to Balance

### 4.1 Conversion Eligibility:

Traders can convert bonus credit into real balance for withdrawal or continued trading after completing the required lot volume. This can be done an unlimited number of times.

### 4.2 Lots Required Calculation:

$\text{Lots Required} = \text{Credit Received} \div 10$

Examples:

- Deposit \$500 → Receive \$500 credit → Required lots =  $500 \div 10 = 50$  lots.
- Deposit \$1,000 → Receive \$1,000 credit → Required lots =  $1,000 \div 10 = 100$  lots.

### 4.3 Conversion Process:

Once the required lots have been completed, the bonus credit will be converted into balance automatically upon request.
