smartFINANCE Choice Referral Bonus Example






4 Referrals X \$75 = One Time \$300 Bonus

Each time you enroll a new smartFINANCE Choice member, you earn a one time \$75 referral bonus. The example above illustrates how you can enroll 4 smartFINANCE Choice members and generate a one time \$300 bonus which is equal to the price of the smartFINANCE Choice membership.

Rapid Fire Bonus





- The Rapid Fire Bonus is a bonus that pays out \$25 every time your personally enrolled members renew their monthly subscriptions (\$15 for smartFINANCE retail members).
- Example: Jenny personally enrolls 5 new customers on November 17th. All 5 customers renew their monthly subscription on or before December 17th. Jenny will receive a \$25 Rapid Fire Bonus for each renewal for a total of \$125. Jenny will receive the \$125 Rapid Fire Bonus on Friday, 2 weeks after the close of the weekly commission period.

Membership Credit



The Membership Credit is a way you can earn a credit that covers your monthly membership renewal. You can qualify for a membership credit when you have 4 personally enrolled members who pay the same amount (or greater) than you do for their monthly membership renewal.



Example:

Joe is on a smartFINANCE Choice membership (monthly renewal = \$149.99) and has 4 personally enrolled members:

- Tom is on an iGenius Select membership
 - Monthly renewal = \$174.99
- Mary is on a smartFINANCE Elite membership
 - Monthly renewal = \$224.99
- Ben is on a smartFINANCE Choice
 - Monthly renewal = \$149.99
- Jen is on iGenius Premium membership
 - Monthly renewal = \$174.99

Because Tom, Mary, Ben, and Jen all pay \$149.99 or more for their monthly membership renewal, Joe qualifies for the Membership Credit and his Premium membership renewal will be covered.

Pro Status Qualification



If a member qualifies for Pro Status, and their total amount of payable bonuses/commissions earned in the rolling 4 week commission period is less than \$1,000, the difference is paid to the member so the total earnings now equal \$1,000.

An active member may qualify for **Pro Status** by having 6 active personally enrolled members (3 in the binary left leg and 3 in the binary right leg) who are also on a membership with a monthly renewal that is \$149.99 or greater during the rolling 4 week commission period AND by generating 3,000 QEV.




Pro_Status Qualification



Hypothetical example: Sarah is an active member on a smartFINANCE Premium membership who has qualified for the rank of Platinum Executive with 3,250 QEV. Sarah has 6 active personally enrolled members on a membership with a monthly renewal that is \$149.99 or above (3 on her left, 3 on her right), so she has qualified for Pro Status.

In the rolling 4 week commission period Sarah has earned:



Binary Team Commissions






The leg with the lesser amount of binary tree group volume (Jenny) is your pay leg.

You get paid 10%, 12.5%, 15%, 17.5% or 20% based on your rank.



Generational Match Bonus





Members who have achieved the rank of Global Executive and above are eligible to receive the Generational Match Bonus. The Generational Match Bonus pays up to 10% of the Binary Team Commissions of each member in the earning member's eligible generations.


A generation is defined by the Global Executive rank.

Members may earn up to 5 generations of Generational Matching Bonus depending on their rank.

Please refer to Bonus Table.



Generational Match Bonus Example



In this example, Joe's qualified pay rank is Ambassador, so he earns 2 generations of matching for each enrollment tree leg. Joe enrolled Mary, so she is one of his enrollment tree legs.

Joe's 1st generation of this enrollment tree leg includes both Mary and Larry. Larry qualified as Global Executive and by doing so creates Joe's 2nd generation.

Joe's 2nd generation begins with Susan, but is still open, as no one below has reached the rank of Global Executive yet.

Mary and Susan earned \$100 in weekly Binary Team Commissions. Larry, Sharon, and Steve earned \$200 in weekly Binary Team Commissions.

The Generational Match Bonus can pay **up to** 10% of the Binary Team Commissions of each person in the earning member's eligible generations (this examples only assumes a 3% match).

Joe earns \$3 (\$100 X 3%) on both Mary and Susan's earnings and \$6 (\$200 X 3%) on Larry, Sharon, and Steve's earnings for a total of \$24.
