

Privacy Policy

This Privacy Policy ("Policy") applies to LW-SolutionsLLC.com, and LW Solutions LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [insert website here]. The Company's website is a Real Estate Virtual Assistance site. Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

Sharing Information with Third Parties

The Company does not sell, rent, or lease its customer lists to third parties.

Tracking User Behavior

Automatically Collected Information

Security of Your Personal Information

- SSL Protocol

- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which the consumer provided the information.
