

Dynamic Video Solutions Podcasting Services Agreement

This Agreement ("Agreement") is entered into as of the date of acceptance by the Client ("Effective Date"), by and between Dynamic Video Solutions ("Company"), located at 931 E. Southern Avenue, Suite 103, Mesa, AZ 85204, and the Client ("Client"), whose details are provided during the online checkout process.

1. Services Provided

2. Payment Terms

The Client agrees to pay the fees associated with the selected service package. Payments are due monthly, with setup fees due upon agreeing to this agreement. All payments should be made to Dynamic Video Solutions via the payment method provided during the online checkout process.

3. Term and Termination

This Agreement will commence on the Effective Date and will continue for an initial term of three (3) months ("Initial Term"). After the Initial Term, this Agreement will continue on a month-to-month basis until terminated by either party with 30 days' written notice.

Early Termination: If the Client chooses to terminate this Agreement before the end of the Initial Term, the Client agrees to continue making payments for the remainder of the Initial Term. This ensures that the Client receives the full value of the services provided.

4. Client Responsibilities

The Client agrees to:

- Arrive on time for scheduled studio sessions
- Communicate any changes or additional requests in a timely manner

5. Company's Responsibilities

Dynamic Video Solutions agrees to:

- Provide the services outlined in the selected package
- Ensure recordings and edits are completed within the specified timeframes
- Maintain the confidentiality of the Client's content

6. Limitation of Liability

In no event shall the Company be liable for any indirect, incidental, special, consequential, or punitive damages arising out of or related to this Agreement. The total liability of the Company for any claim arising out of or related to this Agreement shall not exceed the amount paid by the Client in the preceding 12 months.

7. Governing Law

This Agreement shall be governed by and construed by the laws of the State of Arizona, without regard to its conflict of law principles.

8. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior or contemporaneous understandings, agreements, representations, and warranties, whether written or oral, regarding the subject matter hereof.
