- 3.3 By providing your phone number, you consent to receive text messages (SMS) from Kingsson Assurance, and you acknowledge that these messages may include important service information, billing notices, policy updates, and promotional offers.
- 3.4 You may opt-out of receiving marketing or promotional text messages by replying "STOP― to any message, or by contacting our customer service team at \[Insert Contact Information].
