


Figure 1: Security Vendor Analysis Dashboard





Expected Benefits: Improved customer experience, reduced phone inquiries, increased online ordering, 24/7 menu availability

2. Enhanced Navigation & Site Structure (Priority: HIGH)

The current header displays SHOP, ABOUT, FAQS, NEWS, and CONTACT sections. However, the site lacks dedicated pages for key user journeys that could significantly improve engagement and SEO performance.

Recommended Additions:

- Dedicated 'Menu / Products' page with comprehensive catalog
- 'Deals & Specials' section to highlight current promotions
- 'Best Sellers' and 'Staff Picks' to guide new customers
- Educational resources and strain guides
- Improved internal linking structure for better SEO

Expected Benefits: Better user navigation, improved SEO rankings, increased time on site, enhanced product discovery

3. Local SEO & Location Optimization (Priority: MEDIUM)

While the site displays address and hours, there are opportunities to strengthen local search presence and make it easier for customers to find your location.

Suggested Enhancements:

- Embedded interactive Google Maps with accurate pin location
- Directions from nearby cities (Buffalo, Rochester, etc.)
- Local landmarks and visitor tips
- Schema markup for local business
- Optimized 'Near Me' search terms

4. Professional Photography & Visual Content (Priority: MEDIUM)

High-quality imagery builds trust and professionalism. The current site uses category images, but expanding visual content can significantly enhance credibility.

Recommended Visual Assets:

- Professional interior shop photography
- Product close-up shots with consistent styling
- Staff and team photos to personalize the brand
- Behind-the-scenes content
- Educational infographics

5. Customer Reviews & Social Proof (Priority: MEDIUM)

Displaying customer testimonials and Google Business reviews directly on the website builds credibility and trust, especially for first-time visitors researching dispensary options.

Implementation Options:

- Google Business reviews widget on homepage
- Testimonials section with customer quotes
- Star ratings display
- Third-party review aggregation (Leafly, Weedmaps)
- User-generated content showcase

6. Educational Content & Expanded FAQs (Priority: LOW-MEDIUM)

While a FAQs section exists, expanding educational content can improve SEO, establish authority, and help customers make informed purchasing decisions.

- Cookie policy and consent management
- Accessibility statement (ADA compliance)
- Return and refund policy
- Cannabis-specific disclaimers

8. Homepage Hero Section Optimization (Priority: HIGH)

The current homepage banner requires clarity improvements to effectively communicate Flo Dispensary's value proposition and drive user action.

Issues Identified:

- Messaging lacks clarity about offerings
- Text contrast may be insufficient against background
- Missing clear value proposition
- Call-to-action button not prominent enough

Recommended Updates:

- Improve text contrast and readability (larger fonts, better colors)
- Add compelling headline: 'Premium Cannabis Products in Basom, NY'
- Include supporting subheading highlighting quality, pricing, or experience

- Make primary CTA highly visible (e.g., 'Shop Our Menu', 'View Today's Specials')
- Consider rotating banners for promotions and announcements
