1. How to read our Profit & Loss statement.
2. In reviewing the P&L, are there trends throughout the year we need to be aware of ? (peaks and troughs of cashflow etc) Can you showt us...
3. How to read our Balance Sheet. What should we be looking for?
4. Is our current company structure right considering our long term plans?

What are the benefits of this arrangement.

In general, are we doing the best for our long term wealth creation and security?

(sole trader versus Pty Ltd etc. Drawing a salary capped by tax brackets versus no salary and pulling dividends. What about superannuation?)

5. In your opinion, how is our business going?
In comparison to other trade companies, how are we going?
6. What do we need to charge out to make money? To breakeven?
7. Can you assist with forward forecasting for the business?

For example, if I wanted to employ a new tradie at \$30 an hour,

can I afford it? What effects will this have on the business? (You personally will need to understand if you need to purchase a vehicle, complete vehicle branding, purchase racking system and stock) and if we were to talk about forward forecasting, is this an additional expense over and above our monthly arrangement?

(this question could be asked face to face)

8. In your opinion, what information (indicators) should I be looking at on a monthly, weekly and/or daily basis to help me understand the financial health of the business?

Do you have an easy spreadsheet that we can follow as a dashboard to monitor our progress?

Eg.

Total invoiced.

Total money owed (30, 60, 90 days) Total in bank?

How long would you suggest we need to meet for?

Are you available on <X date>, <X time>?

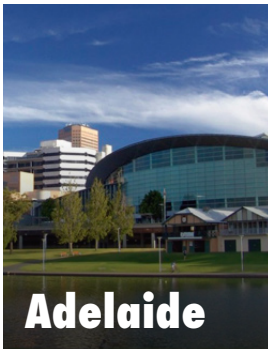

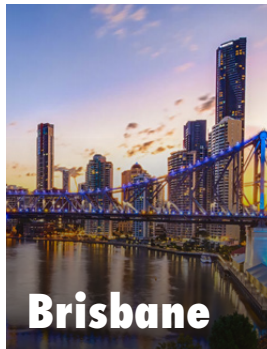

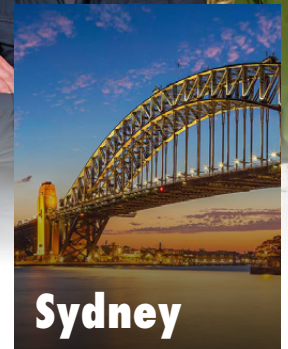
