3. Commission Structure & Payments

4.1 The affiliate's unique link directs potential clients to a **checkout page for all AG Marketing Agency services**. 4.2 Affiliates must instruct their referrals to **select the correct service before completing their purchase**. 4.3 Once a purchase is completed, AG Marketing Agency will receive a payment notification, and the client will receive a confirmation email. 4.4 AG Marketing Agency will contact the client to schedule an onboarding call and complete the service setup, which is typically completed within one week.
