### Information We Collect

We collect personal information that you provide directly, such as your name and email address, when you subscribe, make a purchase, or create an account. Payment details are collected and securely processed through Stripe; we do not store full payment information on our servers.

In addition, we may collect technical information automatically when you visit our site. This can include your IP address, browser type, device data, pages visited, and referring URLs. We use cookies, pixels, tags, and analytics tools to understand how visitors interact with our content, monitor marketing performance, and improve the experience we offer.

### Use of Personal Information

Your personal information is used to deliver the services you've requested, manage your account, communicate with you, and personalize your experience. This may include sending journal downloads, membership updates, or relevant offers. You can unsubscribe from promotional communications at any time by using the link provided in our emails.

We also use information to improve our business operations, track the performance of our marketing efforts, and maintain the functionality and security of our site.

## **Third-Party Services**

We do not sell or rent your personal data. However, we may share your information with trusted third-party service providers who assist with payment processing, email delivery, customer management, website hosting, and analytics. These providers have access only to the data necessary to perform their functions and are required to keep it secure and confidential.

Our platform is built on FEA Create, which includes integrated tools for email, CRM, and member portal access. All services used are selected for their commitment to privacy and data protection.

## **Account Access and Data Security**

To access membership content, you will create an account with login credentials. You are responsible for maintaining the confidentiality of your account information. We implement reasonable administrative, technical, and physical safeguards to protect your personal information from unauthorized access, loss, or misuse. However, no method of data transmission over the internet can be guaranteed as 100% secure.
