Privacy Policy

This Privacy Policy ("Policy") applies to CrystalClearTransactions.com, and Crystal Clear Transactions ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include CrystalClearTransactions.com. The Company's website is a Real Estate Virtual Assistance site. Collection of your Personal Information

- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that
 is compatible with the context in which the consumer provided the
 information.
