SCOPE OF THIS PRIVACY POLICY

- 17. I will use technical and organisational measures to safeguard you Data: -your data is physically stored under 2 locks and keys.

- 19. If any court or competent authority finds that any provision of this privacy policy [or part of any provision] is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.
- 32. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 33. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
