MEMBERSHIP TERMS & CONDITIONS

ENROLMENT & WITHDRAWAL

- Enrolment is presumed for the entirety of 2025
- Fees will continue to be charged until Perth Circus & Dance Academy receives written notification of withdrawal
- To withdraw from classes, two weeks written notice must be provided to admin@perthcircusdanceacademy.com.au from the scheduled class day
- Normal class fees will be charged if less than two weeks notice is given

PAYMENT SCHEDULE

- Membership fees are added to your account and account statements issued on Monday
- Direct Debit payments are processed on Wednesday
- All fees are payable by weekly direct debit
- All clients must enrol in autopay (direct debit) and enter valid payment details via the Parent Portal

PAYMENT OPTIONS

- Weekly direct debit (required)
- Payment in advance via Parent Portal or in studio (acts as pre-payment that weekly fees deduct from)
- Debit / Credit card payments via the Parent Portal incur a 1.81% + 0.30c fee per transaction

MAKE UP CLASSES

- Classes that fall on a Public Holiday or are cancelled by Perth Circus & Dance Academy can attend a make-up class in the following week
- No refunds, make-up classes, or credits will be given for missed classes due to personal reasons

CLASS PARTICIPATION REQUIREMENTS

- Students cannot participate in classes if:
 - Payment details are not on file. To add payment details, login to parent portal > click enrol in autopay and add card details
 - Direct debit payment fails for 2 consecutive weeks
- Students cannot participate in any Perth Circus & Dance Academy events if account has outstanding amounts

DEBT COLLECTION

- Perth Circus & Dance Academy reserves the right to pass outstanding fees to a Debt Collection Agency. This will incur a 35% surcharge on the account balance.

REFUND POLICY

- All class fees, aerials equipment levy and concert performer's fees are non-refundable.

FEE SCHEDULE

- Aerials Equipment Levy fees will be debited on the first week of the school term. I understand that the aerials equipment levy fees are non-refundable. For new enrolments, fees will be added upon enrolment
- Additional Concert Performer's fee of \$100 will be debited according to the payment schedule. This will be charged in two parts: 50% in Week 5 of Term 3 and 50% in Week 1 of Term 4.

HOLIDAY SCHEDULE / PAUSE POLICY

- Classes continue to operate during school holidays as per our normal timetable
- Students wishing to pause tuition must email admin@perthcircusdanceacademy.com.au
- Pause requests must be submitted at least one week before the pause period begins
- Accounts may be paused for up to 4 weeks in a calendar year

DIRECT DEBIT TERMS

As a direct debit customer with Perth Circus & Dance Academy, through our payment partner Stripe Payments Australia Pty Ltd., I agree that:

- I am responsible for entering and updating when necessary my bank account and/or credit card details via the Parent Portal
- I will nominate a default payment method if multiple payment method are entered

Perth Circus & Dance Academy, through Stripe Payments Australia Pty Ltd. has the authority to debit my account or credit card the full balance owing on Wednesday of each week

FAILED PAYMENT POLICY

- A failed payment fee of \$15 will be added to my Perth Circus & Dance Academy account if my direct debit payment fails and / or my account becomes overdue
- Where a direct debit payment fails for 2 consecutive weeks, students will not be able to participate in classes and any Perth Circus & Dance Academy events until all outstanding amounts are paid in full

UNIFORMS

At PCDA we believe that wearing studio uniforms give students a sense of belonging to our team as well as creating an identity for our studio in the greater community. Perth Circus & Dance Academy maintains a dress code to encourage concentration and a sense of inclusiveness. Uniformity in dancewear allows the teachers to assess how well the students are implementing the technique being taught, problems with alignment, and other important aspects of dance training including being able to spot students in skills safely. However, most importantly, it promotes studio pride, inclusiveness and a real sense of belonging.

Uniforms and most dance shoes can be purchased year-round from the studio.

ADDITIONAL COSTS

- Aerials classes will incur an additional \$20 per term equipment levy charged at the beginning of each term (or upon enrolment for mid-term enrolments).
- Other costs may include:
 - PCDA uniform
 - Dance shoes appropriate to the class
 - Non-compulsory studio events
 - Concert Participation Fee (\$100 per child)
 - 50% will be charged via direct debit Week 5 of Term 3
 - Remaining 50% will be charged via direct debit Week 1 of Term 4
