





The Dynamic Aggressive Taxable Composite may invest in Individual Stocks, Exchange-Traded Funds, Open-End Mutual Funds, or Private Investment Strategies. Key material risks include that the composite assets may depreciate, potentially causing the composite to underperform the benchmark. The Dynamic Aggressive Taxable composite is compared against a custom blended benchmark comprised of 7.5% Bloomberg Global Agg Bond & 92.5% MSCI World All Cap (NET). The custom benchmark is calculated by weighting the respective index returns on a monthly basis. The Dynamic Aggressive Taxable composite has a minimum of \$5,000. The Dynamic Aggressive Taxable composite was created in August 2021 and incepted on December 1, 2019.

The currency used to express performance is USD. Gross-of-fee returns are reduced by trading costs. Net-of-fee returns are calculated using a model fee of 1%. The model fee is the highest investment management fee that may be charged for this composite. The annual model management fee is applied on a monthly basis, by deducting 1/12th of the model fee from the monthly gross returns. Composite dispersion is measured by the asset-weighted standard deviation of annual gross returns of those portfolios included in the composite for the full year. The 3-year annualized standard deviation measures the variability of the composite gross returns and benchmark returns over the preceding 36-month period. Bloomberg Global Agg Bond - The Bloomberg Global Aggregate Index is a flagship measure of global investment grade debt from twenty-four local currency markets. This multi-currency benchmark includes treasury, government-related, corporate, and securitized fixed-rate bonds from both developed and emerging markets issuers.

MSCI World All Cap (NET) - The MSCI World All Cap Net Index captures large, mid, small and micro cap representation across 23 Developed Markets (DM) countries. With 11,681 constituents, the index is comprehensive, covering approximately 99% of the free float-adjusted market capitalization in each country.
