

# FenceMas 2025 Giveaway — Official Rules, Terms & Conditions

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

These Official Rules govern the FenceUSA “FenceMas 2025 Giveaway” (“Promotion”). Participation constitutes full and unconditional agreement to these Rules and to all decisions made by FenceUSA LLC and its representative Nick Amechi, which are final and binding.

## 1. Eligibility

The Promotion is open only to:

- Legal residents of **New Jersey, Pennsylvania, or Delaware,**
- Age **18 or older,**
- Who **own and reside** at a residential property located within FenceUSA’s service area.

Entrants must have legal authority to approve fence installation on their property.

The following are **not eligible**:

- Employees, contractors, affiliates, and immediate family or household members of FenceUSA,
- Tenants, non-owner occupants, landlords, or owners of investment or rental properties,
- Corporate entities, trusts, or LLCs.

Void where prohibited or restricted by law.

## 2. Entry Period

Entries open **December 1, 2025 at 12:00 AM EST** and close **December 17, 2025 at 11:59 PM EST**.

Entries submitted before or after this period will not be accepted.

### 3. How to Enter

To enter, participants must complete the official entry form available on FenceUSA's website or linked social media channels during the entry period. Limit **one (1)** entry per person, email address, household, or property address.

Multiple entries or entries submitted using fake names, bots, or automated tools will be disqualified.

**No purchase or payment is necessary to enter or win. A purchase does not improve your odds.**

### 4. Prize Details

One (1) winner will receive a **FenceUSA fence installation valued up to \$10,000 USD**, which includes:

- Standard fencing materials (e.g., vinyl, wood, aluminum),
- Standard labor and installation,
- Layout and design at FenceUSA's discretion.

**The following are not included in the prize value and are the sole responsibility of the winner:**

- Permits, HOA approvals, site clearing, grading, retaining walls, stump/concrete removal, or other pre-work,
- Any project upgrades or customizations not explicitly included in FenceUSA's project scope,
- Any cost exceeding \$10,000.

Prize must be scheduled and installed within **six (6) months** of the winner announcement, weather and scheduling permitting.

Prize is **non-transferable**, holds **no cash value**, and cannot be substituted, sold, or exchanged.

## 5. Winner Selection & Prize Scope Determination

The winner will be selected **solely at the discretion of Nick Amechi, on behalf of FenceUSA LLC**, based on evaluation of the stories submitted in the entry form. FenceUSA may consider factors such as impact, need, sincerity, and alignment with the spirit of the giveaway. All decisions are **final and not subject to appeal**.

In addition, **FenceUSA will determine the exact scope of work** that constitutes the “up to \$10,000” prize value. This includes, but is not limited to:

- The amount of fencing provided,
- The layout and total footage installed,
- Material type, style, and configuration,
- Installation labor and complexity,
- Site accessibility and conditions.

FenceUSA will use **fair and reasonable judgment** in determining what combination of labor and materials equals the \$10,000 value. The winner **does not have the right to demand specific materials, footage, or configurations**, and all scope-related decisions are final.

Any portion of the project that exceeds the \$10,000 prize value — including upgrades or unforeseen site-related expenses — will be offered to the winner as an optional paid addition. A written breakdown will be provided prior to scheduling installation.

## 6. Publicity Consent & Content Usage

By entering, participants grant FenceUSA and Nick Amechi a **perpetual, worldwide, royalty-free license** to record, photograph, and publicly share their name, story, likeness, voice, property, and fence project in any and all media — including but not limited to Facebook, Instagram, TikTok, YouTube, FenceUSA.com, and paid advertisements.

All content remains the sole and exclusive property of FenceUSA LLC and may be used for promotional purposes without further compensation or notice.

## 7. Taxes & Financial Responsibility

Winner is responsible for all applicable federal, state, or local taxes associated with the prize. If required, winner may receive a **Form 1099-MISC** reflecting the fair market value of the prize. FenceUSA will not provide tax advice — consult a tax professional.

## 8. Communications Consent

By entering, participants agree to receive communications from FenceUSA, including contest updates, project scheduling, and promotional offers. Message and data rates may apply. Entrants may unsubscribe at any time.

## 9. Release of Liability

By entering, participants agree to hold harmless and release FenceUSA LLC, Nick Amechi, employees, affiliates, partners, and agents from any claims, liabilities, injuries, damages, or losses arising out of or relating to:

- Participation in the giveaway,
- Acceptance, installation, or use of the prize,
- Site work, fence installation, or property access,
- Delays, cancellations, technical issues, or third-party actions,
- Personal, property, emotional, or financial damages,
- Content usage or publicity.

## 10. Fraud, Interference & Termination Rights

FenceUSA reserves the right to:

- Disqualify anyone suspected of tampering with the entry process,

- Reject entries containing false or misleading information,
- Cancel, suspend, or modify the giveaway due to technical failures or unforeseen events that compromise fairness.

This promotion is governed by the laws of the **State of New Jersey**. Any disputes shall be resolved **exclusively through binding arbitration** in Camden County, NJ. Class actions and jury trials are **waived**.
