



# Terms of Service

## Webinar System DFY

## 1. Agreement to Terms

By purchasing, signing up for, or using the Webinar System DFY package ("Service") provided by **JHM Systems LLC** ("Provider," "we," "our," or "us"), you ("Client," "you," or "your") agree to be bound by these Terms of Service ("Terms"). If you do not agree to these Terms, do not use the Service.

## 2. Service Description

Provider will build, launch, and manage a complete webinar system for Client, including but not limited to:

- Funnel development and automation setup
- Webinar registration and follow-up workflows
- Ad campaign strategy, setup, and launch
- CRM integration and pipeline configuration

Estimated delivery is **7–10 business days** from the date all required assets are received from Client. Delays in Client deliverables may extend timelines.

## 3. Payment Terms & Refund Policy

All payments under this Agreement are **non-refundable**.

Payment is due promptly upon invoice as outlined in the agreed service proposal or contract.

Failure to pay on time may result in suspension or termination of services and access to systems.

## 4. Buyout Option

If applicable, Client may buy out the system at any time by paying a one-time fee agreed upon by both parties in writing. Once the buyout is completed:

- Full ownership of the webinar funnel, assets, ad accounts, and configurations will transfer to Client.
  - Provider will no longer be responsible for ongoing management, maintenance, or updates.

## 5. Client Responsibilities

Client agrees to:

- Provide accurate business information, assets, and timely approvals.
  - Maintain functional payment processing systems and advertising accounts.
  - Accurately report performance data when requested for optimization purposes.
  - Ensure all offers, webinars, and advertising materials comply with applicable laws and regulations.

## 6. Intellectual Property & Ownership

Until a buyout or full payment is completed, all assets created by Provider—including but not limited to funnels, ads, automations, designs, and scripts—remain the sole property of **JHM Systems LLC**.

Client receives a limited, revocable license to use these assets solely for the operation of the webinar system during the active service period.

The Service is provided “as is” and “as available.”

Provider does not guarantee specific sales results, audience attendance, lead quality, or profitability. Performance depends on multiple factors including Client’s offer, ad spend, and market conditions.

## 8. Limitation of Liability

  - Provider’s total liability under these Terms shall not exceed the total amount paid by Client to Provider within the preceding three (3) months.
