Your pre-recorded video/audio presentation should last 20-30 minutes (45 max) and can be either:

- Recorded by you referencing your own work, signature frameworks and tools for practicing consent
- A podcast-style conversation with me (recorded over zoom at a mutually convenient date and time)

The content should be informative and engaging – you may refer to your own work/products/services, but please don't turn it into a sales pitch – stay on theme.

NOTE: All finalised presentation recordings received by 1st November.

I will upload all the presentations to the IDoConsent24 Summit web pages (hosted by my company Irregular Inc Ltd).

Leading up to the IDoConsent Summit, we'll have two weeks of promotion (18<sup>th</sup> November onwards). I'll send you some copy and graphics for your promotional emails and social media, to make it as easy as possible for you.

- Create your own solo recording. Please structure your content in a way that allows attendees to walk away feeling like they've really learned something. By all means use slides, no slides (just your lovely face), or a mixture of the two

I Do Consent Summit will have exclusive use of your presentation content until 14<sup>th</sup> December, after which you are free to use your presentation however you'd like in the future.
