PART 1: NOT VACCINES, NOT NECESSARY & NOT JUSTIFIED

Ch. 1 Safe and Effective? The Most Divisive & Urgent Issue

We should be able to trust our government, the media and the vaccine manufacturers when it comes to matters as important as our health, especially when the stakes are literally life or death. How then do we explain why countless thousands of experienced physicians, scientists and other experts worldwide have been willing to risk their reputations, their professional licenses and credentials, and therefore their livelihoods, by daring to claim that the COVID shots are neither safe nor effective, but are actually very dangerous-and should be halted immediately?

If the COVID vaccines are safe, how do you explain the following data? (Other examples besides these are also included at the very beginning of the book)

- **50,239 deaths** within 14 days of COVID-19 shots among Americans 65 and older as of the summer of 2021 (several months after the rollout) according to the CMS database (compiled by a whistleblower).
- Data from the CDC's Vaccine Adverse Events Reporting System (VAERS) (for U.S. only) comparing adverse event (AE) reports (including deaths) following COVID-19 shots for even just 1 yr with the COMBINED TOTAL of AEs reported for ALL other vaccines over the previous 30 yrs show that the COVID shots are by far the most dangerous vaccine ever released.
- 2/3 of the 4,526 children in Pfizer's clinical trial for 6 mos. through 4-yr-olds did not finish the trial. Why not?
- % of increase among the military in 2021 over the previous 5-yr average (DMED data) (increases for several more conditions are included in Part 2 of the book)
 - o 2,181% increase in Hypertension
 - o **1,000% increase** in neurological cases (83,000/yr to 863,000/yr)
 - o 680% increase in cases of multiple sclerosis
 - o 551% increase in cases of Guillain Barré
 - o 624% increase in cases of malignant neoplasm of digestive organs

This book provides an overview of four key issues:1) Was a vaccine even necessary? 2) Are the COVID shots really safe? 3) Have they been effective? 4) What is the "big picture" that "all things COVID" fits into that is crucial to understanding what is really going on in the world?

Ch. 2 A Word of Caution & Encouragement

Some of the information in this book might be quite disturbing and difficult to accept for those who have trusted the government, Big Pharma, the major media, and others in the medical industrial complex to tell them the truth about matters that literally involve life or death. The truth may be difficult to accept, but the consequences of being unaware or deceived are even more challenging.

Many readers may experience a wide range of negative emotions while reading certain portions of this book as they discover how they have been lied to by people they trusted on matters of such great importance. However, any emotional and mental impacts caused by discovering the truth, as well as from the trauma suffered because of the physical injuries following the shots, can be healed and overcome as well. Truth is the key. To the extent that health care professionals are not able to provide effective treatments for full recovery, nothing is impossible for our Creator, God, the "Great Physician."

Ch. 3 The COVID Shots are Not True Vaccines

None of the COVID vaccines meet the FDA's definition or the traditional and legal definitions of a "vaccine." But calling them "vaccines" instead of what they really are gave the manufacturers three huge advantages – all of which were detrimental to the public.

Ch. 4 Was a Vaccine Even Necessary?

A vaccine was never necessary to end COVID, for at least 4 main reasons (besides the superiority of natural immunity over vaccine immunity), two of which are: 1) the extremely high COVID survival rate, and 2) the availability of adequate, safe and highly effective treatments for COVID. Also, the claim of "95% effectiveness" was extremely misleading and does not represent anything close to what people were led to believe. If a vaccine was not even necessary, why have those in the medical industrial complex been so hellbent on getting everyone on the planet vaccinated? By the end of the book, you will know why.

Ch. 5 Were the Emergency Use Requirements Met?

None of the COVID "vaccines" have been "approved" or "licensed" by the FDA. They were only "authorized" for "Emergency Use," meaning they were experimental. There are 4 basic requirements for a drug or device to qualify for and to maintain Emergency Use Authorization (EUA), but in our opinion, arguably none were actually met or maintained, but it only takes the absence of one to invalidate an EUA.

Ch. 6 Why Many Have Not Heard This Information Before: Reason #1:

The first of 3 main reasons why many people even in the health care community have not heard this information before is because of massive censorship and suppression of important data, and lies and coverups by the medical industrial complex, including the major media and social media giants, and the medical governing boards which threatened doctors' licenses for spreading what they considered to be "misinformation."

NOTE: To really comprehend the severity and nature of the problems described in this chapter and the chapters about the other two reasons, it is important to be aware of some of the details about these problems, such as those described in the book. They paint a picture that shows why we can no longer trust the people behind the push to get everyone on the planet "vaccinated" and to keep them coming back for regular boosters.

PART 2: DANGERS & GREAT HARM CAUSED BY THE SHOTS

Ch. 7 The "Most Dangerous Medicinal Product in History"

How can a vaccine be said to be "safe and effective" over the long term with only a few months of clinical trial data and NO long-term studies?

Dr. Peter A. McCullough has described the COVID-19 "vaccine" campaign as the "most dangerous biological medicinal product rollout in human history." Other doctors who themselves got the shots now strongly advise against them and are questioning how much longer other doctors will fail to see the connection between the vaccines and the ever-growing number of healthy younger people suddenly dropping dead or suffering debilitating injuries. Even former pharmaceutical company employees have expressed concerns about the shots. Various ways have been identified as to how the shots cause injury.

Ch. 8 VAERS, V-Safe and Regulatory Agency Failures

The CDC has been continually claiming that the COVID vaccines have been subject to the "most intense safety monitoring program in U.S. history," but their own admissions show that is not true. Two major safety warning systems have been blaring warning signals from the beginning about the COVID shots, but the government has ignored them all. It has also withheld important safety data from the public. Yet the shots still have not been halted. *Why not?* Despite requirements for health care providers to report vaccine-related injuries and deaths, even if they are not sure of the causal connection, the vast majority are not reporting them.

Ch. 9 VAERS: The Under-Reporting Factor & Causality

Adverse events from vaccines are *grossly under-reported*. Reasonable estimates by experts as to the extent of the under-reporting factor (URF) vary from 10 (very conservatively) to 100 or more. Dr. Peter McCullough says: "It is beyond any shadow of a doubt that the vaccines are causing large numbers of deaths."

Ch. 10 VAERS Data Comparisons

Many comparisons of VAERS reports between COVID vaccine data with all other vaccines for the *prior* 30 years combined reveal that the COVID shots are by far the most dangerous "vaccine" ever released to the general public. Compare the CDC's response in 1976 to reports of a relatively small number of injuries and deaths following the rollout of the Swine flu vaccine and ask what has happened to the regulatory agencies to cause such a vastly different response to far worse reports following the COVID shots.

The estimated death rate of Americans following COVID "vaccines," applying a reasonable underreporting factor, would probably astonish those who have believed that the shots are safe and effective.

Ch. 11 Early Pfizer Documents: "75-Year Delay" & 1st 3-mo. Report

In response to a FOIA request for documents relating to the FDA's alleged "approval" of Pfizer's Comirnaty COVID "vaccine" in August 2021, the FDA requested a timeline that would have given it up to 75 years to release all of the documents. Pfizer's 1st 3-month report showed adverse events data that should have led to the shots being stopped very shortly after the rollout. *Why were these data ignored?*

Ch, 12 Adverse Impacts on Pregnancy & Breastfeeding

A "golden rule" is that an experimental drug should never, ever be administered to pregnant women. The shocking results from Pfizer's 1st 3-month report confirm why that "rule" exists, but the government continued to recommend the shots for pregnant women, despite the disastrous pregnancy outcomes from Pfizer's own data.

Ch. 13 Devastating Impacts on the Military

The military is being decimated by the COVID shots and the mandates. Military whistleblowers have boldly come forth, even in Senate hearings before Sen. Ron Johnson, to reveal alarming increases in diseases and other adverse health conditions after the vaccine rollout. They have also provided other important information that would anger most Americans about how the military has handled the COVID shots.

Ch. 14 Data for Those 65 and Older

A whistleblower for the Centers for Medicare and Medicaid (CMS) provided data to attorney Tom Renz in 2021 that showed very large numbers of deaths occurred among the 65+ age group within the 1st 14 days after receiving a COVID vaccination during the first several months of 2021.

Ch. 15 Dangers of Giving COVID Shots to Children

Many groups and doctors have adamantly warned against giving COVID shots to children, but governments have ignored the warnings. The data show the shots have done much more harm than good and are affecting future generations.

Ch, 16 Adverse Impacts on Athletes

There has been a staggering increase in the number of deaths among athletes since the vaccine rollout. This chapter also gives an example comparing athletic performance before and after vax, and between vaxxed and unvaxxed. Needless to say, the unvaxxed fared much better.

Ch. 17 Dangers of the Spike Protein

Dr. Michael Yeadon, Ph.D., a former Pfizer V.P. and scientist, explains why the spike protein was a poor choice on which to base the COVID shots. Experts say that the spike protein itself is toxic, and is responsible for much of the damage people are experiencing. There are also serious issues as to how the spike protein is affecting fertility and various organs in the body.

Ch. 18 Destructive Impact on the Natural Immune System

The COVID shots are having a destructive impact on people's natural immune system. It appears there are several ways in which this is happening.

Ch. 19 "Future Framework" for New COVID Vaccine Formulations

Since the summer of 2022, the FDA has been approving new formulations of COVID vaccines *without any human clinical trials*. This should be a huge red flag to anyone recommending, administering or taking any new COVID vaccines, especially in light of what we know and don't know about earlier COVID shots.

Ch, 20 Pfizer Documents Show Other Irregularities

Pfizer documents show significant misrepresentations of the seriousness of many adverse events. Correspondence shows that the European Medicines Agency (Europe's "FDA") made several critical objections prior to authorization that experts say could not possibly have been resolved before authorization was granted in late 2020. A whistleblower also revealed many serious concerns about the Pfizer clinical trials that were never addressed before Emergency Use Authorization was granted.

Ch. 21 Moderna's Improprieties

Moderna had its share of improprieties as well. What the FDA let Moderna get away with is troubling.

Ch. 22 Problems with the Johnson & Johnson COVID Shots

J & J has also suffered a lot of problems. They had to throw away hundreds of millions of doses for various reasons. The FDA's conduct concerning J & J also raises serious questions that affect safety.

Ch. 23 Other Evidence That Raises Concerns About Safety

There has been a very wide variation in the safety profile across different batches of the vaccines, even from the same manufacturer. In other words, the ingredients were not uniform or consistent as they should

have been. A vast majority of serious adverse reactions and deaths came from a relatively small percentage of the batches. Dr. Michael Yeadon, a former Pfizer V.P. and scientist, has expressed several other serious concerns affecting the vaccines' safety, as has another former Pfizer employee.

PART 3: INEFFECTIVENESS & OTHER IMPACTS

Ch. 24 General Issues Concerning Effectiveness

The CDC has used a very misleading definition of "unvaccinated" to include persons who have actually received at least one shot, but are counted as "unvaccinated" until 14 days after their full primary series. This totally skews the data for all vaccinated persons who have been hospitalized or died within the 1st 14 days after receiving the shots. There are various reasons why U.S. vaccine injury and death data are unreliable.

Ch. 25 Breakthrough Cases

The number of breakthrough cases shows that the vaccines have not only not been effective at preventing infection, transmission, hospitalization and death, but they increase a person's chances of the same.

Ch. 26 Boosters and Variants

The more COVID shots a person gets, the worse their health is. Since at least mid-2021, there have been more COVID cases, hospitalizations and deaths among vaccinated persons than among unvaccinated.

Ch. 27 Risk/Benefit Analyses

Risk/benefit analyses by several experts reveals no health benefit to the shots, and that the "cure" (i.e., the shot) is actually worse than the disease. The vaccinated are more likely to get COVID and suffer other health problems than the unvaccinated.

Ch. 28 & Ch. 29: Clinical Trial Data Reveal a Decline in Health and Natural Immunity is Superior to Vaccine Immunity

These chapter titles speak for themselves.

Ch. 30 Reports from Autopsies, the Funeral Industry, and Life Insurance Companies

If more autopsies were performed, it would become much more apparent that the shots are causing a large number of deaths. Embalmers all across the country are finding never-seen-before strange rubbery, white fibrous clot-like substances in the vascular systems of deceased vaccinated persons. Casket orders, especially for children's sizes, have skyrocketed since the vaccine rollout. Life insurance companies started noticing unheard-of increases in deaths among working age adults in 2021.

Ch. 31 Other Impacts: D-dimer Tests, the Story That Backfired & Who Needs to Be Protected From Whom? Elevated D-dimer test results have been reported among the vaccinated. The health and safety of the unvaxxed are adversely affected by the vaxxed in various ways, including "shedding" (or transmission) of something (maybe the spike protein) onto unvaxxed persons by close contact with a vaxxed person.

Ch. 32 Why Many Have Not Heard This Information Before: Reason #2

The second of three reasons why many even in the health care community have not heard this information before is because of the deep and widespread corruption and collusion involving Big Pharma, the government, the major media, and other players in the medical industrial complex. That is why they have to massively lie, deceive, and censor those who speak out against the official narrative. Again, the information in the three chapters why many have not heard this information before is very important in

order to comprehend how bad the problem is and why we can no longer trust the people orchestrating the vaccine push on *any subject*, not just on COVID-related matters or other health matters.

PART 4: THE "BIG PICTURE" & WHAT IS IN THE VACCINES

Ch. 33 Why Many Have Not Heard This Information Before: Reason #3

The third reason is that the world's wealthy elites have a much bigger agenda behind "all things COVID" that has nothing to do with protecting public health. One of the top people among the wealthy elites has clearly admitted in his published memoirs that they have, in fact, been conspiring and seeking to do exactly what the media has labeled as "conspiracy *theory*." Their actions and activities go beyond "mere" corruption and collusion and all of the lies, deception and censorship to cover it up. "All things COVID" are part of a much bigger picture that is **not in the best interests** of the public.

Ch. 34 The "Great Reset" & the Globalists' New World Order

A book entitled *COVID-19* and the *Great Reset* by Klaus Schwab, founder and Executive Chairman of the World Economic Forum (WEF), one of the elites' leading organizations, reveals the connection between COVID and the vision of the wealthy elites for the world. Other statements by Schwab and his close advisor Yuval Noah Harari reveal that their plans for mankind are extremely radical concerning humanity's future.

Ch. 35 Advancing the Globalist Agenda by Deception

The globalist elites can only succeed in advancing their bigger, hidden agenda to the extent they can deceive people. The wealthy elite follow Hitler's strategy of telling BIG lies because most people find it easier to believe BIG lies than small ones. It is very important to be aware of the "big picture" in order to avoid being deceived and making choices you later regret.

Ch. 36 Can the COVID Vaccines Change a Person's DNA?

There is evidence that needs to be carefully examined on this issue because it appears that the shots, or at least this technology, have this potential.

Ch. 37 Technologies Relating to DNA & Genetic Editing

There are certain technologies that already exist that people need to be aware of that threaten the existence of humanity as we have known it. Beware: the Biden administration issued an Executive Order in September 2022 promoting genetic engineering technologies. Though such technology may have many beneficial applications, can we really trust the wealthy elite not to use such technology for nefarious purposes? Can we trust the government not to force it on people (directly or by pressuring large employers) or not to subject anyone to penalties for non-compliance, as they did with the COVID vaccines?

Ch. 38 Contents of the Vaccine Vials: General Concerns & Blood Samples

There are various general concerns about what may be in the vaccines, reflected in other parts of the book, such as research by many experts, the way clinical trials were manipulated, the fact these are not true "vaccines," etc. Certain damage done by the vaccines can be evidenced by analysis of a person's blood.

Ch. 39 Dangers of Certain Disclosed Ingredients

Even some of the disclosed ingredients are considered toxic by many experts. That raises the issue: why are such ingredients in a "vaccine"?

Ch. 40 Undisclosed Substances – General Concerns

There are several general concerns about undisclosed substances relating to various points mentioned elsewhere in the book, such as concerns about the manufacturing process, what is known about the elites' agenda, current available technologies, the elites' expressed intent to use certain technologies, etc.

Ch. 41 Strange Objects and Structures

Researchers from many countries have done various kinds of examinations of the contents of different manufacturers' vaccine vials and have found several kinds of strange objects and structures that should not be in a "vaccine."

Ch. 42 Graphene: Is it in the COVID Shots?

Despite the manufacturers' denials, there is significant evidence from many sources that the vaccines from several different manufacturers contain some form of graphene. Its likely purposes have nothing to do with prevention or lessening the severity of infection or disease, and there are also serious issues as to its toxicity.

Ch. 43 5G Issues

There is a connection between graphene and 5G and its purposes. There are also significant similarities in symptoms between COVID and radiation poisoning.

Ch. 44 Reflections on Part 4

Where should the line be drawn between legitimate and beneficial biomedical applications of technology, on the one hand, and irresponsible, dangerous and abusive applications by ruthless authorities with political power and a dangerous radical agenda, without consent of the people, on the other hand?

Ch. 45 This is a War

The refusal of the medical industrial complex even to acknowledge the unprecedented injuries and deaths from these shots, and their continued efforts to promote them as safe and effective, along with many other revelations about COVID and the vaccines, reveals that we are, effectively, in a war. But it is not a war against a virus. At its root, it is a spiritual war of good vs evil. There are many similarities between what has been happening the past few years and what happened in Nazi Germany during the 1930's and WWII.

Ch. 46 Conclusion

This war against evil requires everyone to choose which side they will align with: those who are trying to "play God" by seeking to change what it means to be human and to control the rest of humanity according to their vision of "life," or those who choose to connect with God in a personal relationship, and experience the power of His love, healing, protection, provision and restoration. Nothing is impossible for Him. Which will you choose: the elites' Great Reset or God's Great Awakening? The book tells how everyone, including those who are not health care professionals, can play a part in bringing an end to COVID.

Ch. 47 Call to Action From Two Doctors on the Front Lines

This chapter lists several actions steps that health care professionals can take to end COVID and be prepared for what the elites have planned for the future, if they succeed in further advancing their agenda.
