MOBILE MESSAGING TERMS AND CONDITIONS

Boomer Press, “we”, or “us” operates a mobile messaging program (within the “SoulSoftware”) subject to these Mobile Messaging Terms and Conditions. The Program and our collection and use of your personal information is also subject to our Privacy Policy and our Terms of Service (TOS). By enrolling, signing up, or otherwise agreeing to participate in the Program, you accept and agree to these Mobile Messaging Terms and Conditions, our Privacy Policy and our TOS.

- 1. Program Description:** We may send promotional and transactional mobile messages in various formats through the Program. Promotional messages advertise and promote our products and services and may include promotions, specials, other marketing offers, and reminders. Transactional messages relate to an existing or ongoing transaction and may include confirmations of processed payments.
