We still raised about \$1750 with cards. Ugly: -No one made a call on playing the final after rain | Proposed solution- Have a policy that captains of each team make the decision if the commish isn't present. -Announcements were not heard by all | Proposed solution-Always have a dedicated PA/person for announcements and commentating. -Booths/Activities not checked on regularly | Proposed solution- Volunteer division leaders are assigned to check on and manage each division throughout the event. -Live feeds were inconsistent/not all games | Proposed solution- Ask City for hard-line internet, have dedicated videographers/commentators. Proposed Updates: -Dedicated hard-line internet. -Volunteer shift signup forms. -Coffee/donuts for set-up volunteers. -Always budget for volunteer shirts for events (huge hit). -Raise tournament entry fees to then pass out tournament shirts and team shirts. -Have dedicated volunteers for selling raffle tickets and split the pot. -Have separate meal tickets to sell. -Volunteer division leads. -Dedicated PA for announcements and commentating. -Policy for captains' decisions on playing if commish is absent. -Dedicated live feed volunteers. -Week-of-event training on anything technical for volunteers (maybe make videos to use as training). -Move the
