

Your Senior Advocate LLC Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to yoursenioradvocatellc.com and Your Senior Advocate LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Your Senior Advocate LLC include yoursenioradvocatellc.com. The Your Senior Advocate LLC website is an Online training, webinars, consults and training materials site. By using the Your Senior Advocate LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information Your Senior Advocate LLC may collect personally identifiable information, such as your First and Last Name and Email Address.

If you purchase Your Senior Advocate LLC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Sharing Information with Third Parties

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Your Senior Advocate LLC.
